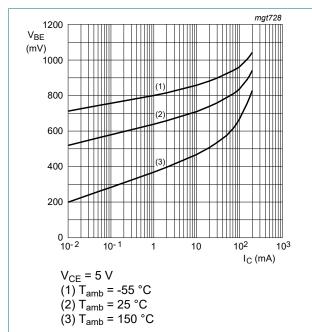
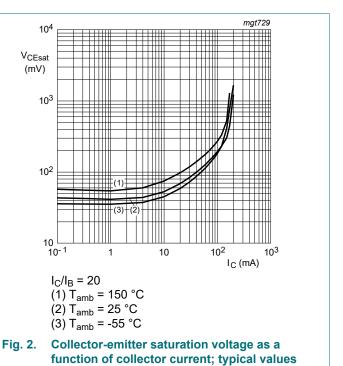
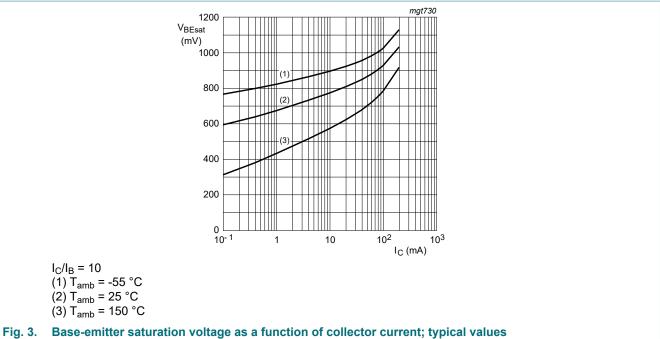


Fig. 1. Base-emitter voltage as a function of collector current; typical values

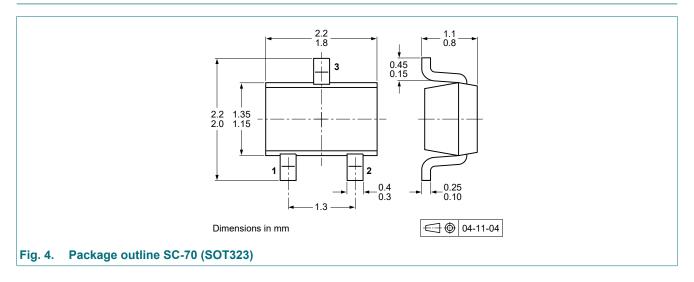

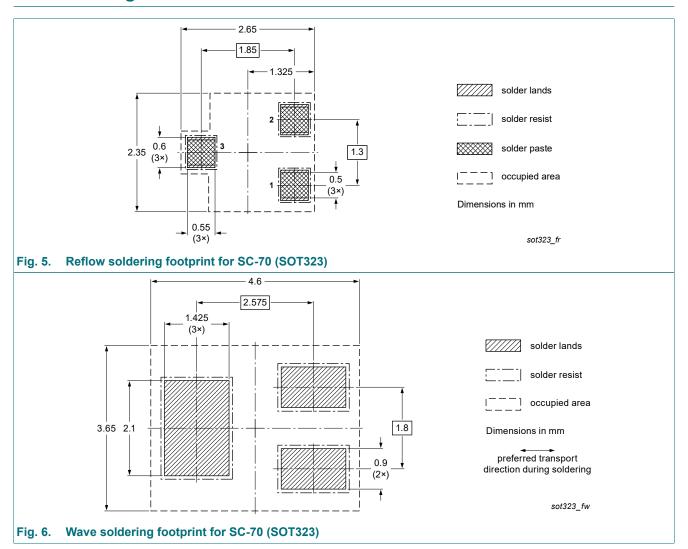

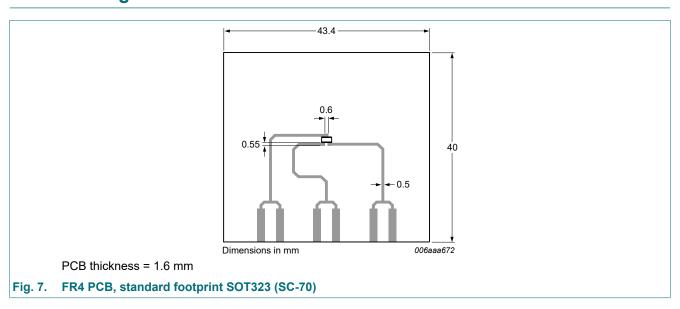
