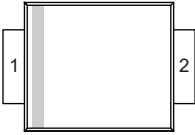
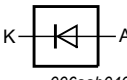

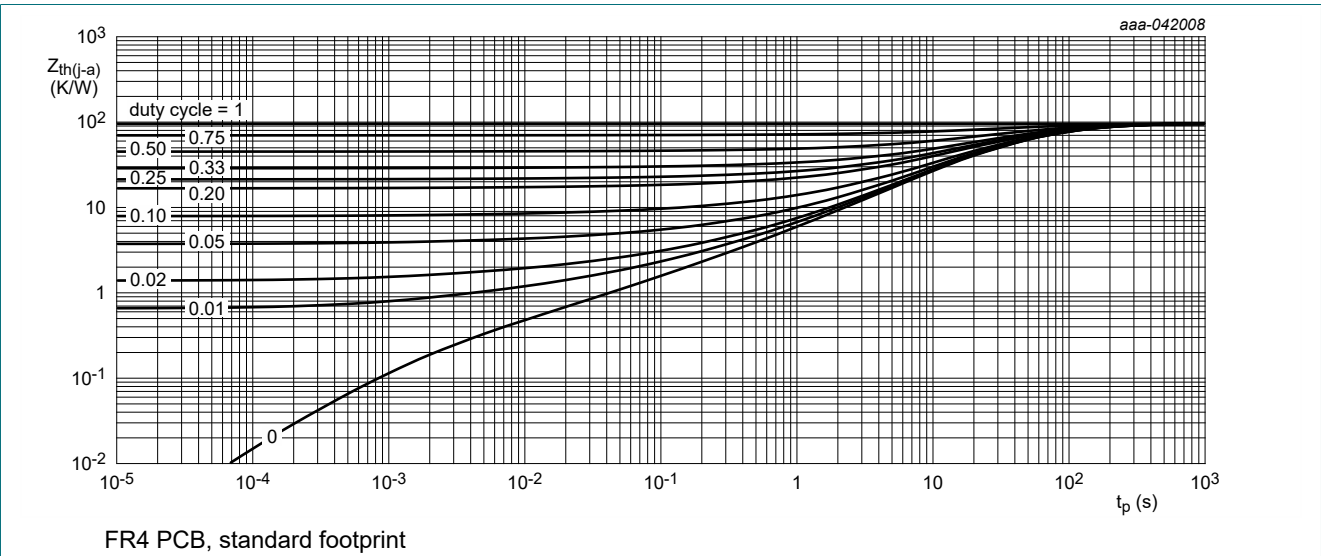


Fig. 1. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

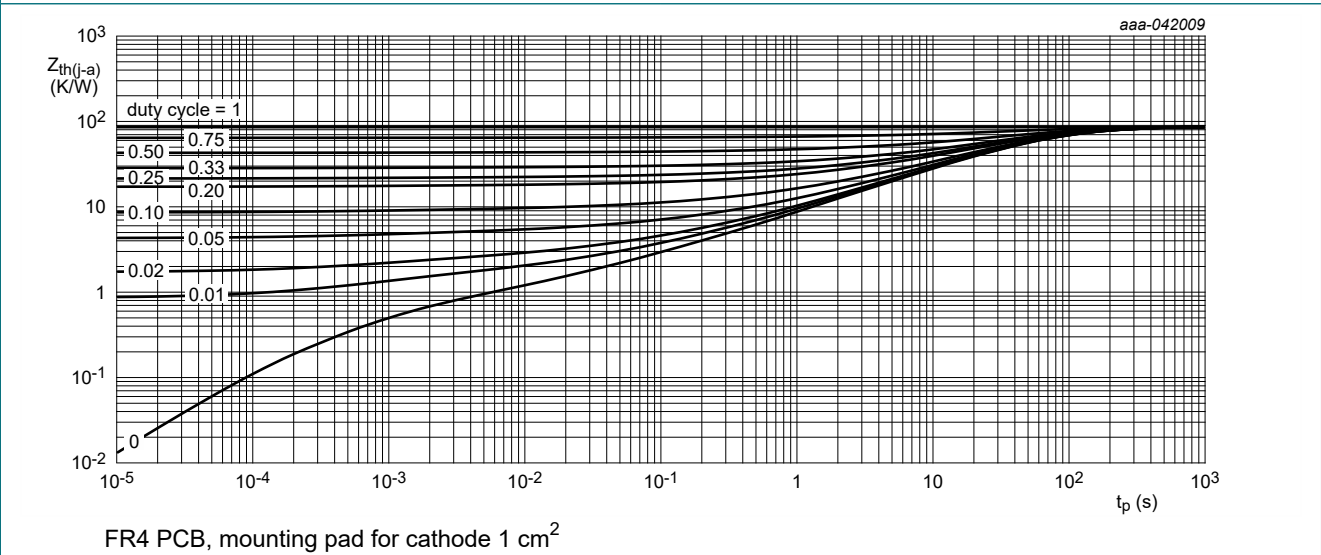


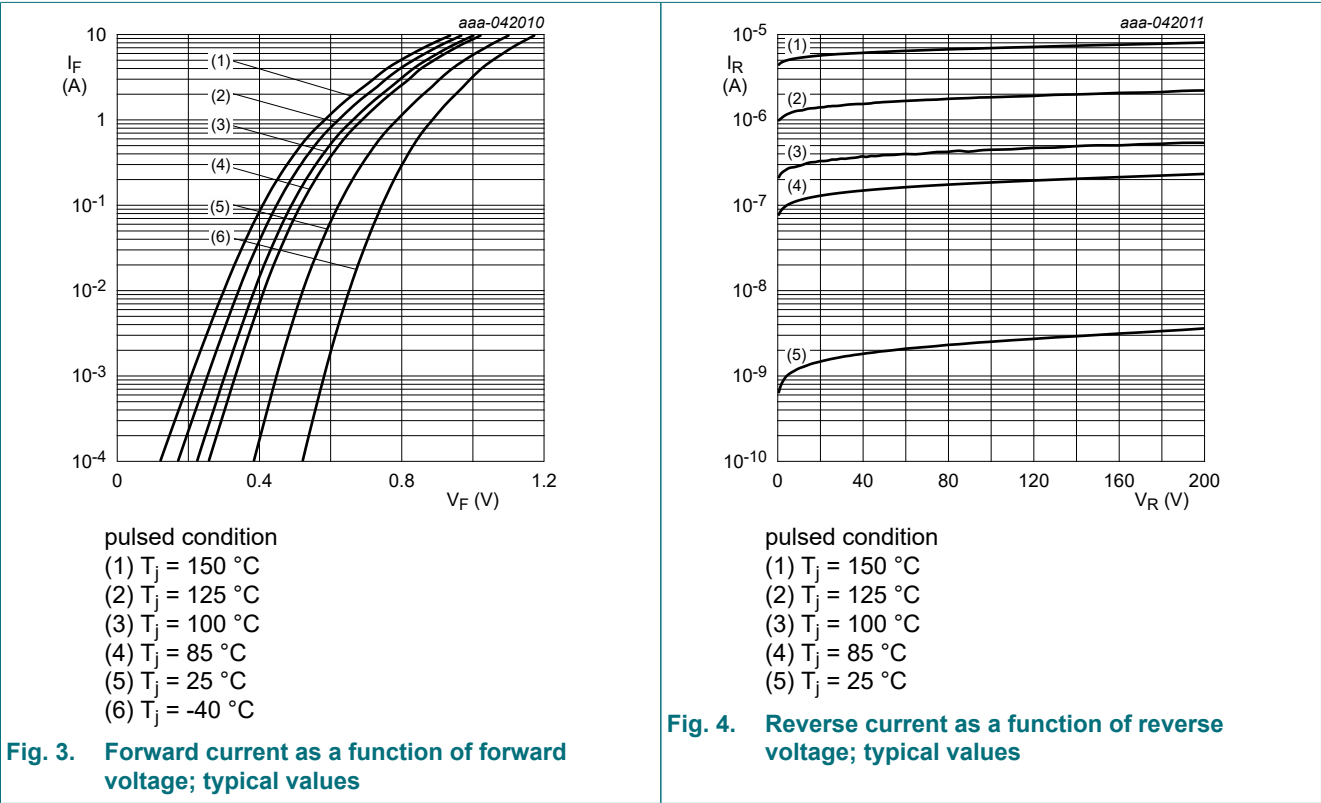
Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

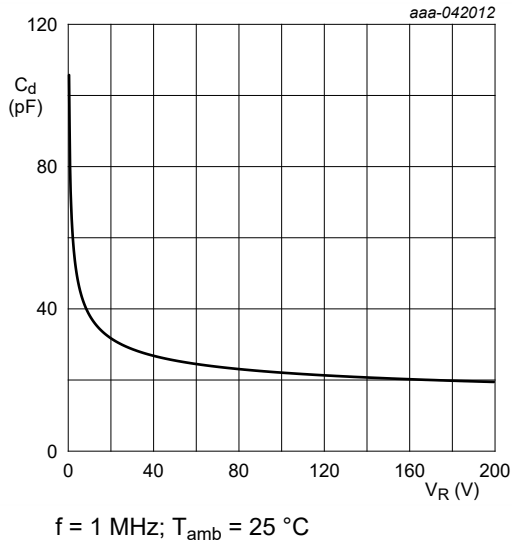


Fig. 5. Diode capacitance as a function of reverse voltage; typical values

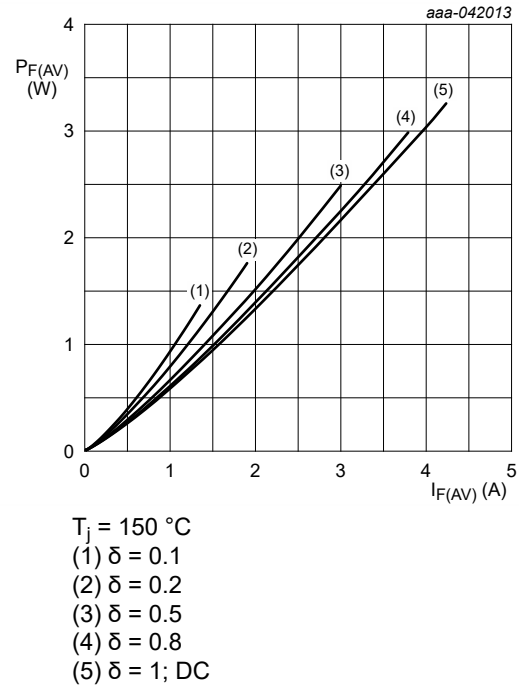


Fig. 6. Average forward power dissipation as a function of average forward current; typical values

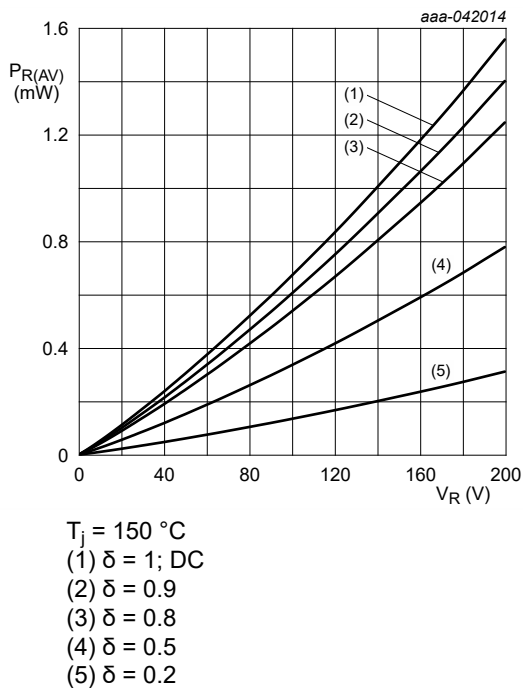


Fig. 7. Average reverse power dissipation as a function of reverse voltage; typical values

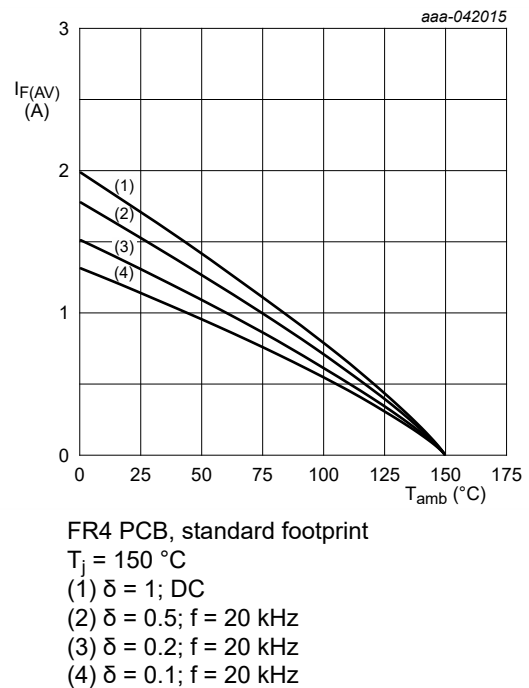
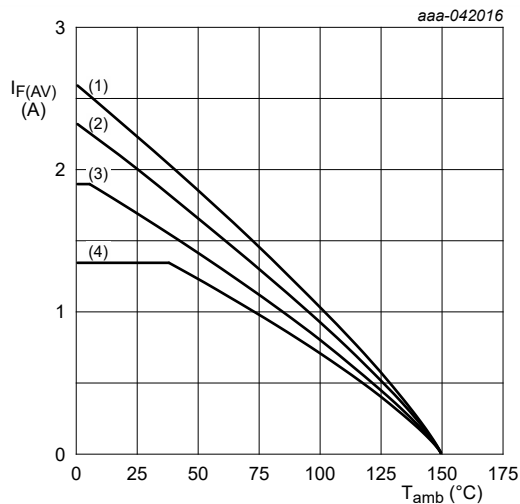
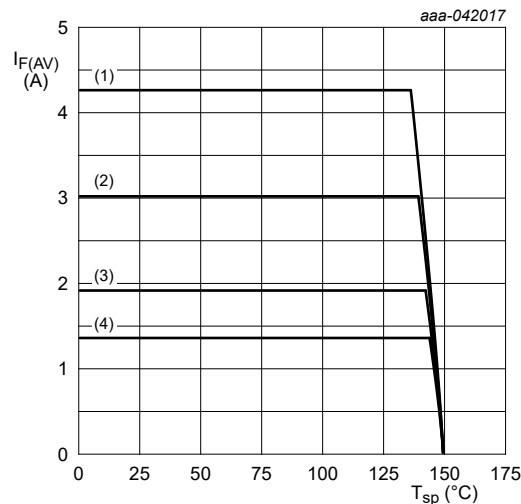


Fig. 8. Average forward current as a function of ambient temperature; typical values

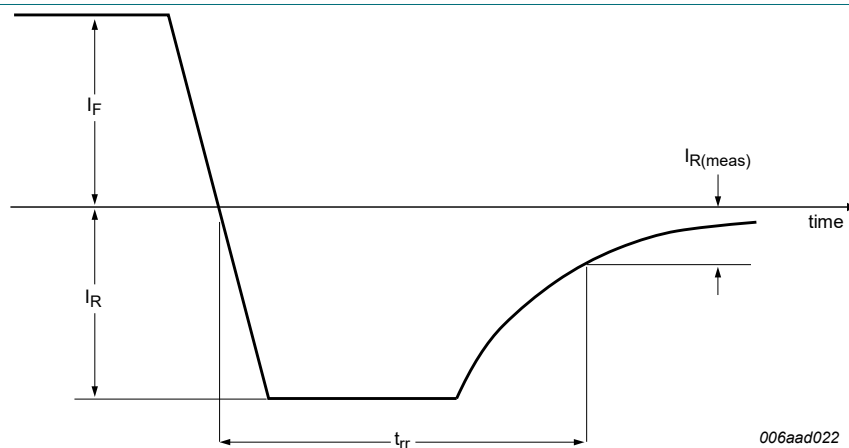


Fig. 11. Reverse recovery definition

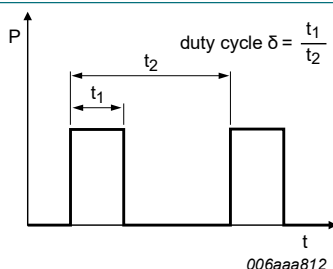


Fig. 12. Duty cycle definition

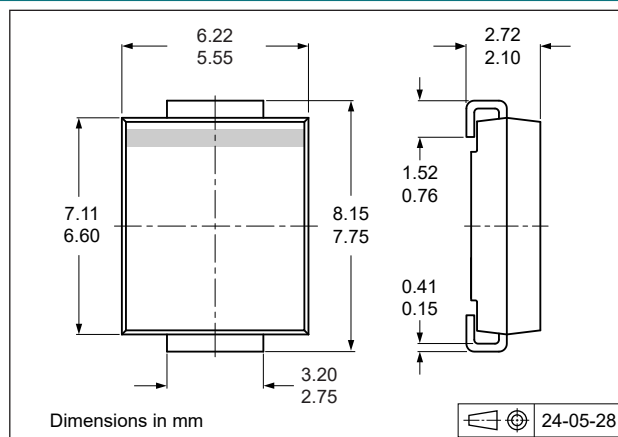


Fig. 13. Package outline SMC (SOD1003-1)

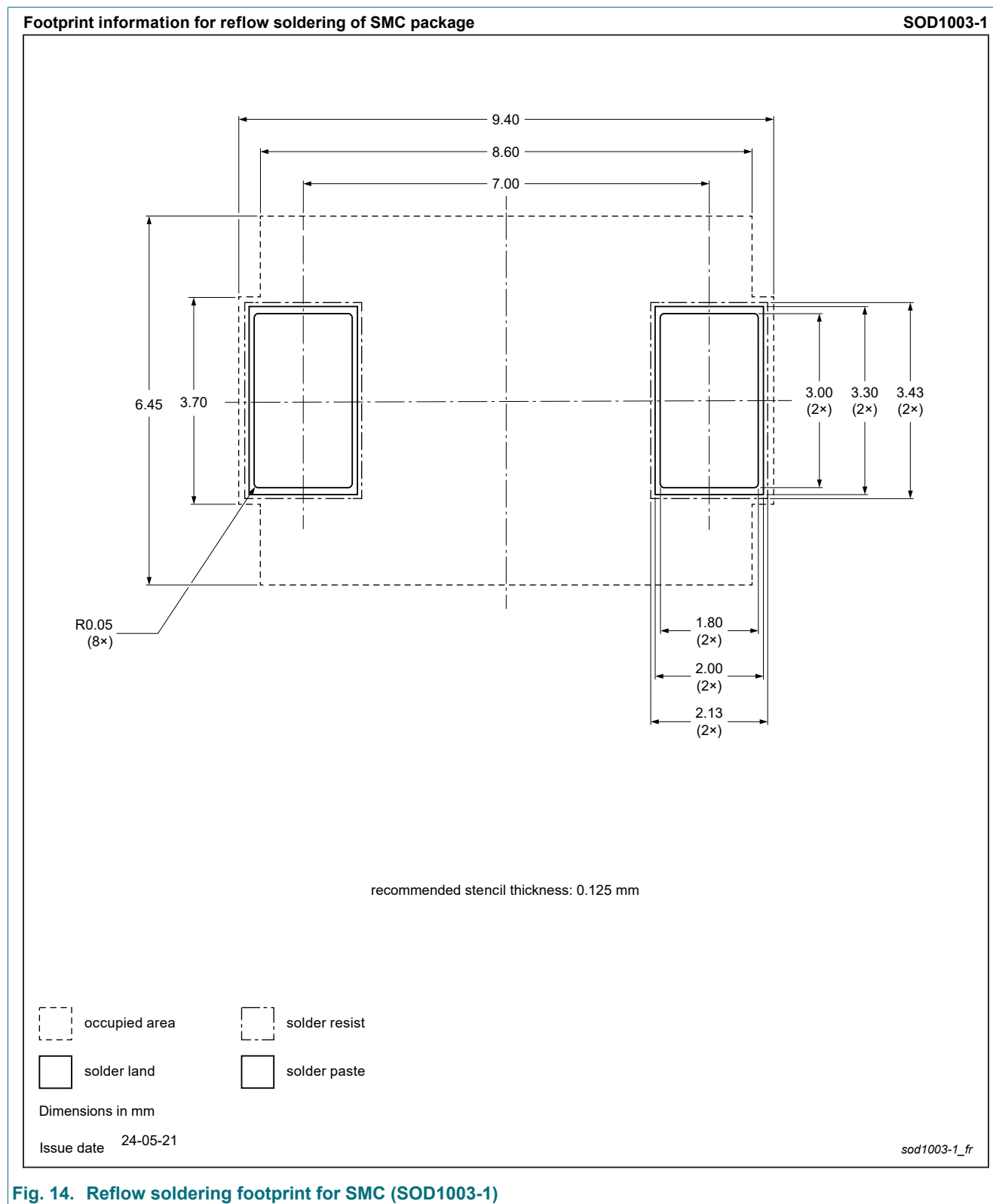


Fig. 14. Reflow soldering footprint for SMC (SOD1003-1)
