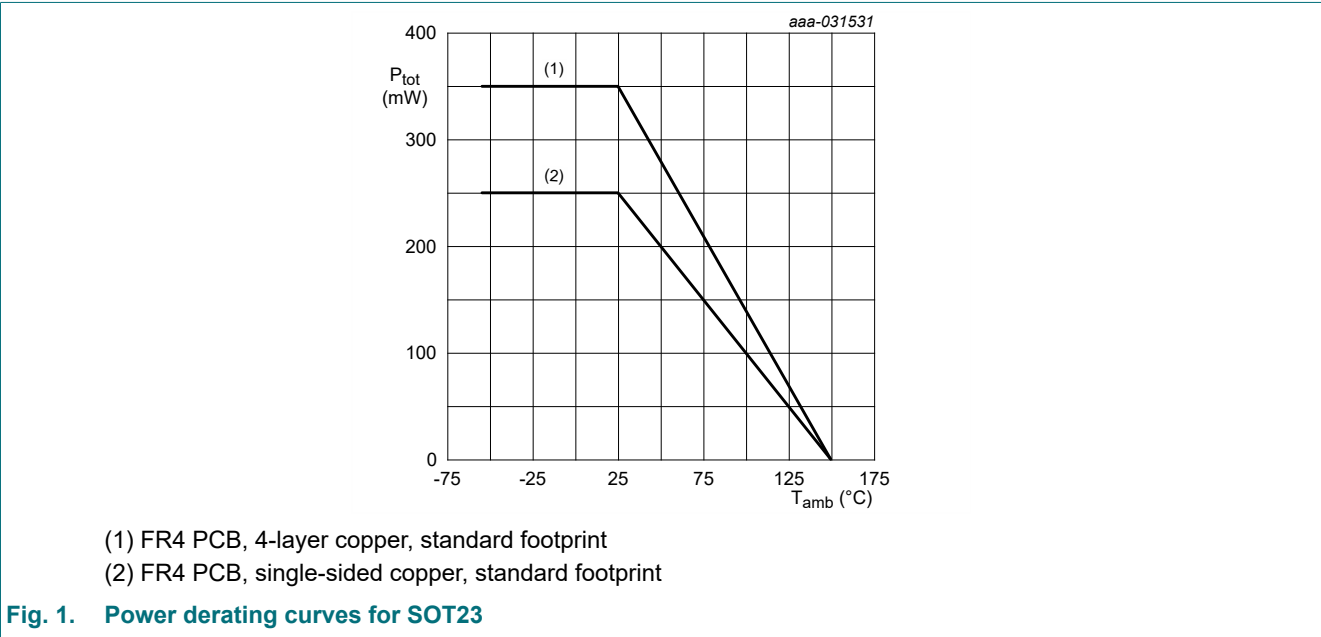

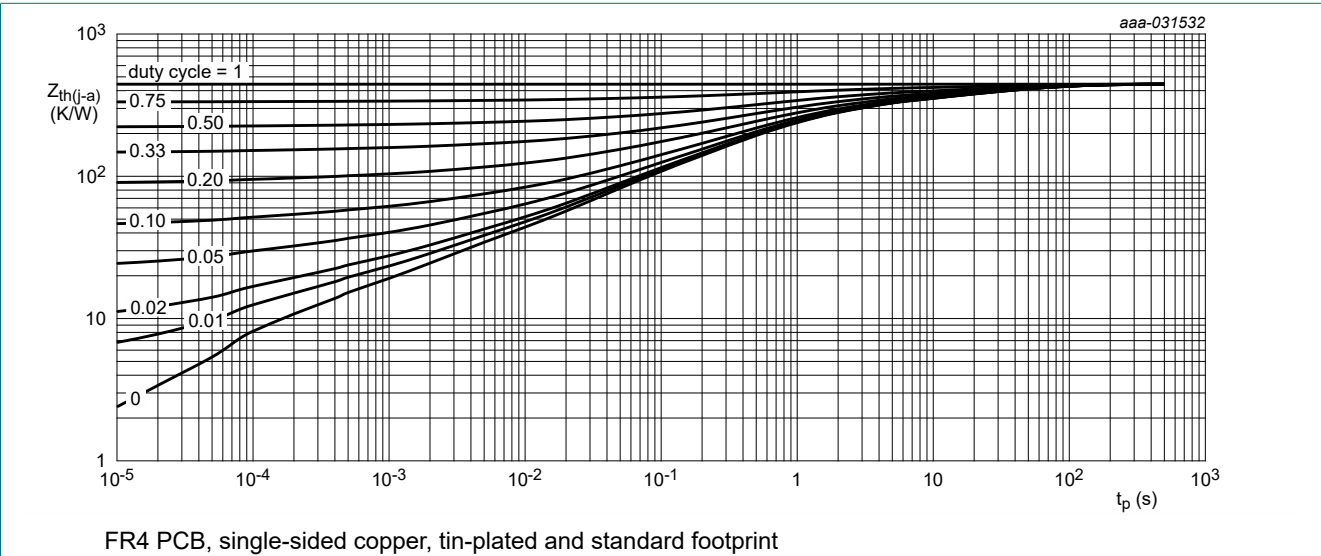


Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

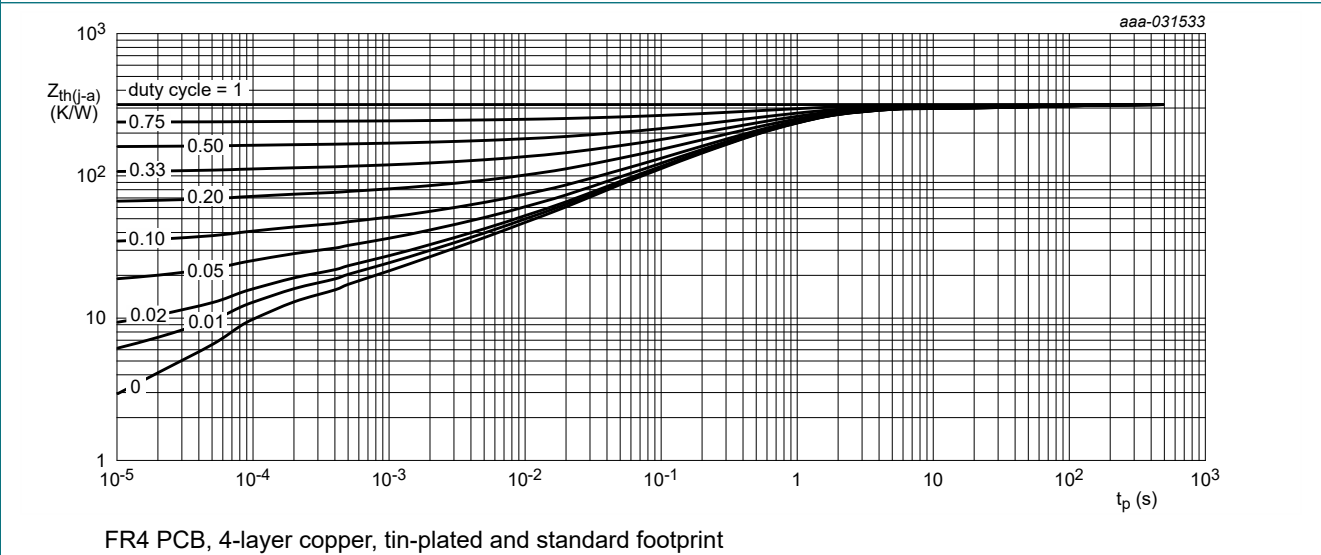


Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

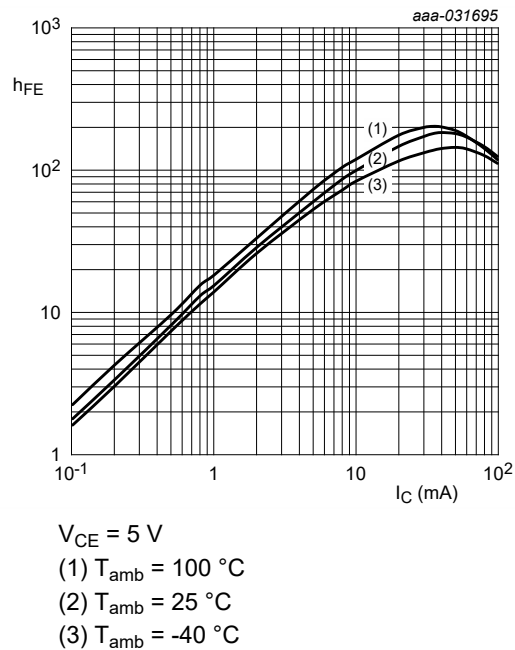


Fig. 4. NHDTC114ET-Q: DC current gain as a function of collector current; typical values

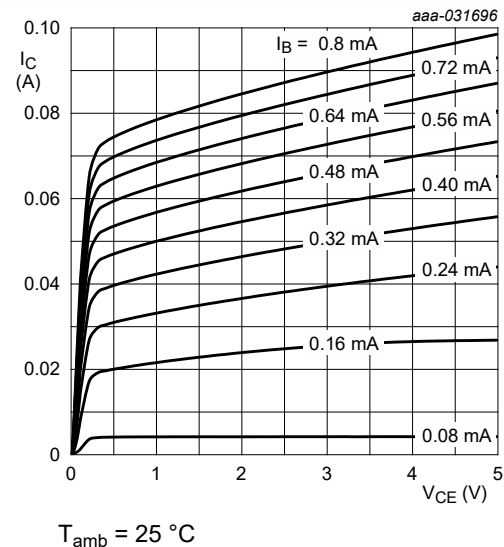


Fig. 5. NHDTC114ET-Q: Collector current as a function of collector-emitter voltage; typical values

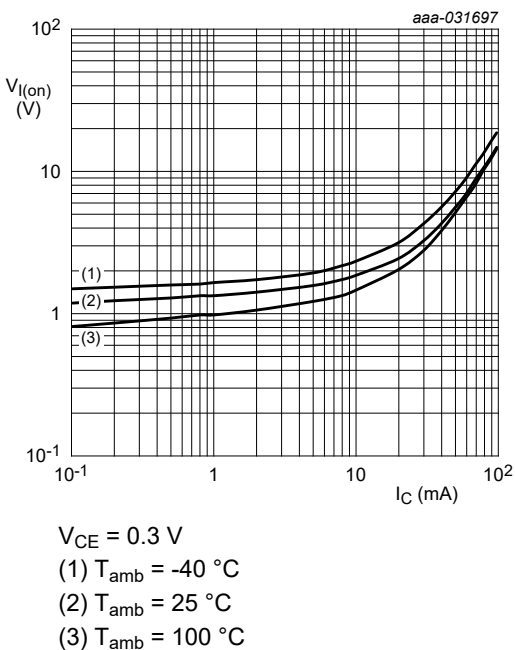


Fig. 6. NHDTC114ET-Q: On-state input voltage as a function of collector current; typical values

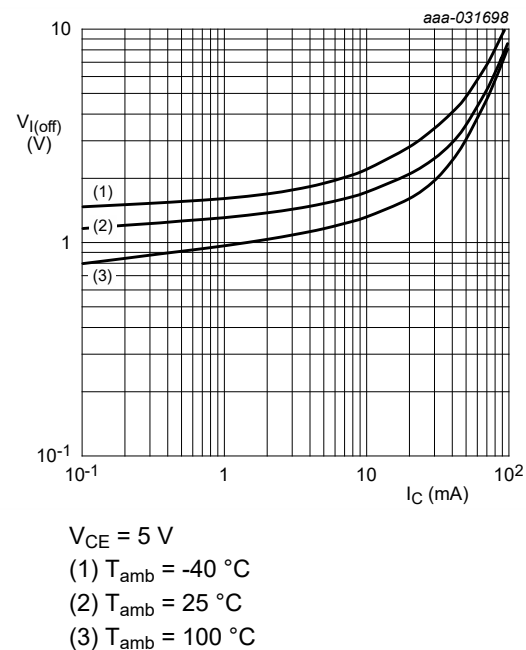
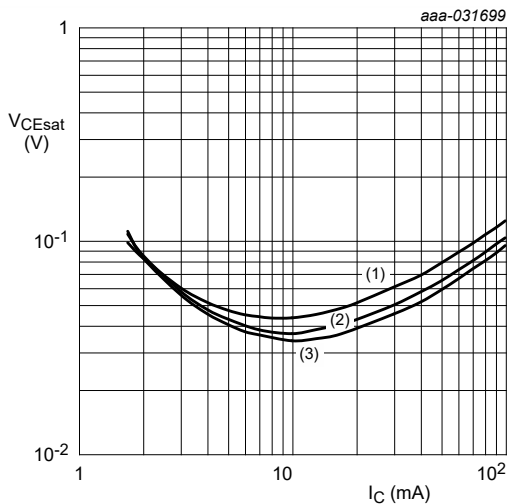
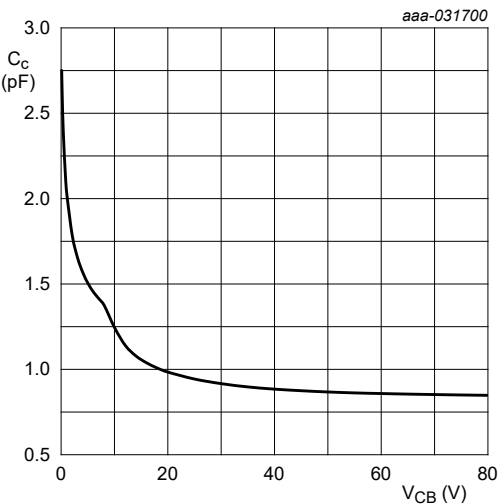


Fig. 7. NHDTC114ET-Q: Off-state input voltage as a function of collector current; typical values



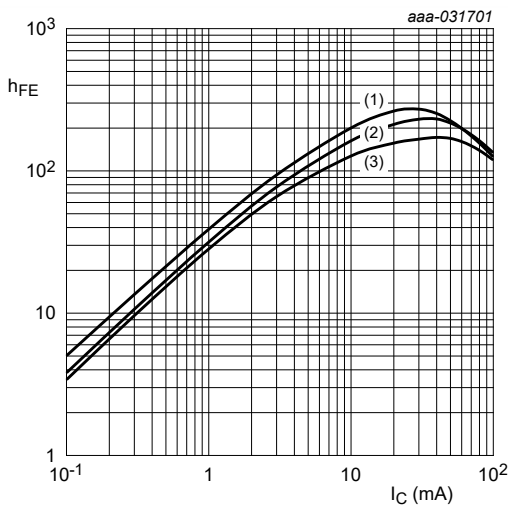

Fig. 8. NHDTC114ET-Q: Collector-emitter saturation voltage as a function of collector current; typical values



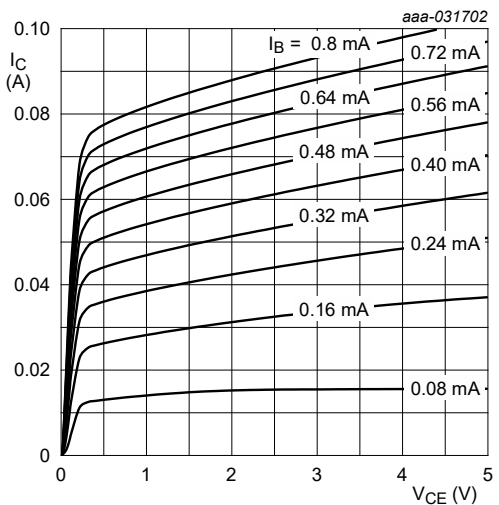

Fig. 11. NHDTC124ET-Q: Collector current as a function of collector-emitter voltage; typical values

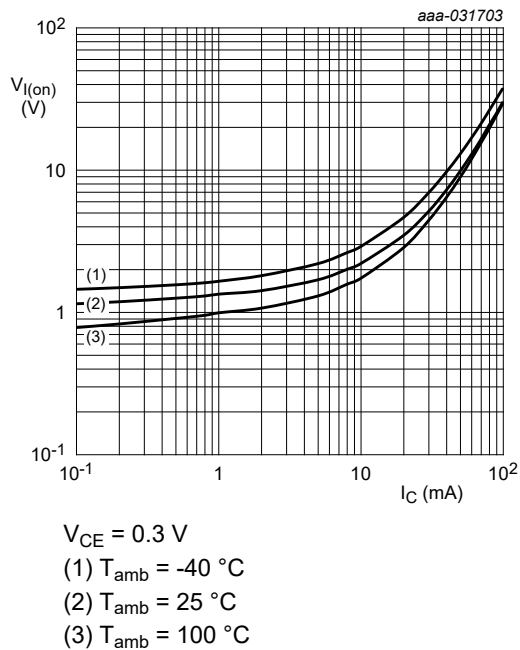


Fig. 12. NHDTC124ET-Q: On-state input voltage as a function of collector current; typical values

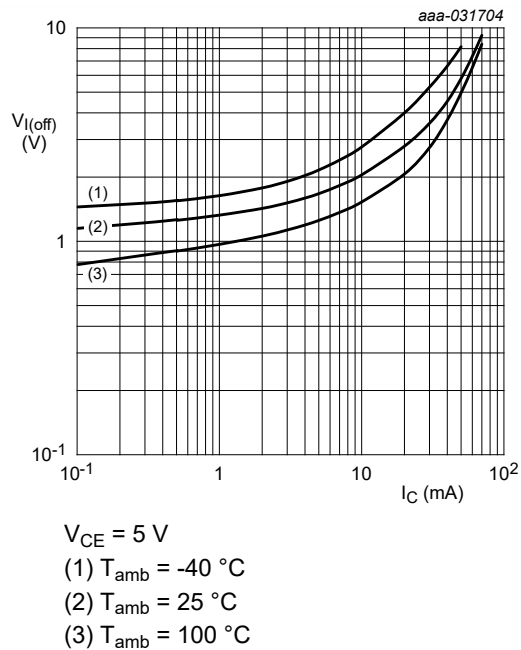


Fig. 13. NHDTC124ET-Q: Off-state input voltage as a function of collector current; typical values

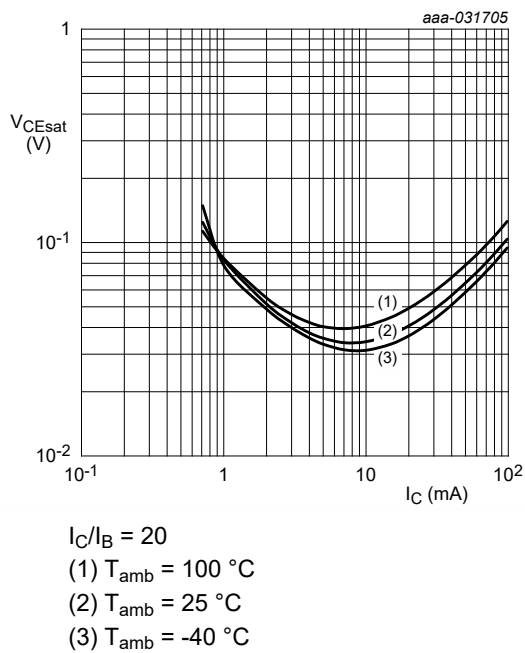


Fig. 14. NHDTC124ET-Q: Collector-emitter saturation voltage as a function of collector current; typical values

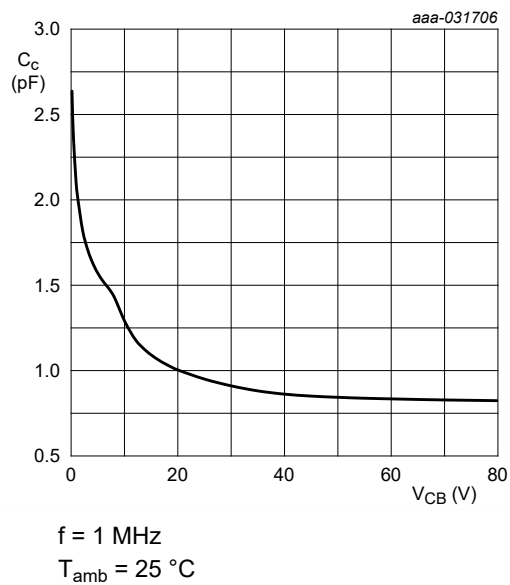


Fig. 15. NHDTC124ET-Q: Collector capacitance as a function of collector-base voltage; typical values

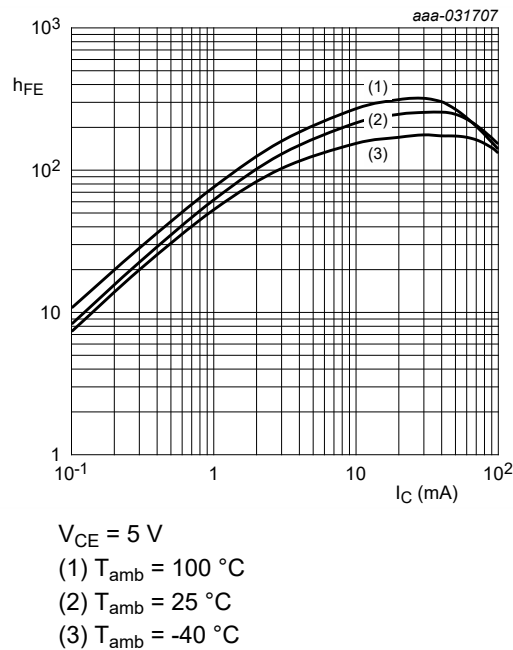


Fig. 16. NHDTC144ET-Q: DC current gain as a function of collector current; typical values

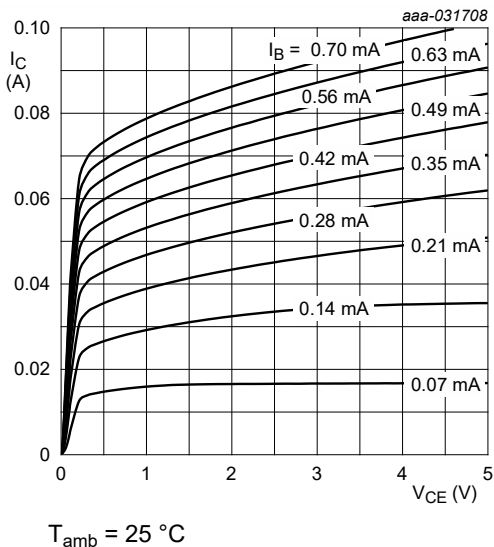


Fig. 17. NHDTC144ET-Q: Collector current as a function of collector-emitter voltage; typical values

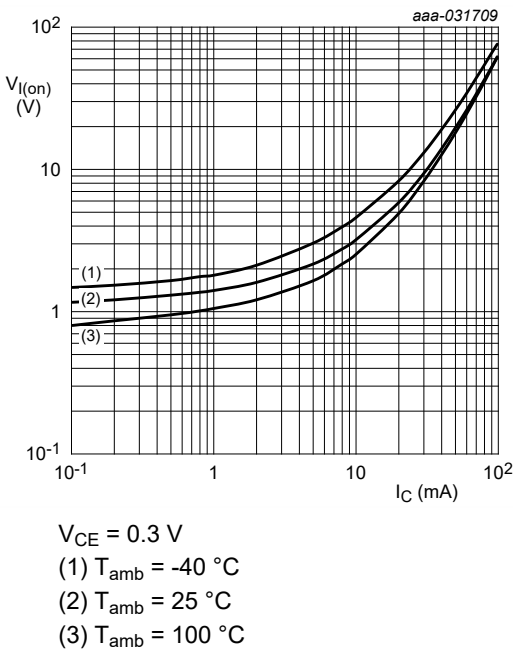


Fig. 18. NHDTC144ET-Q: On-state input voltage as a function of collector current; typical values

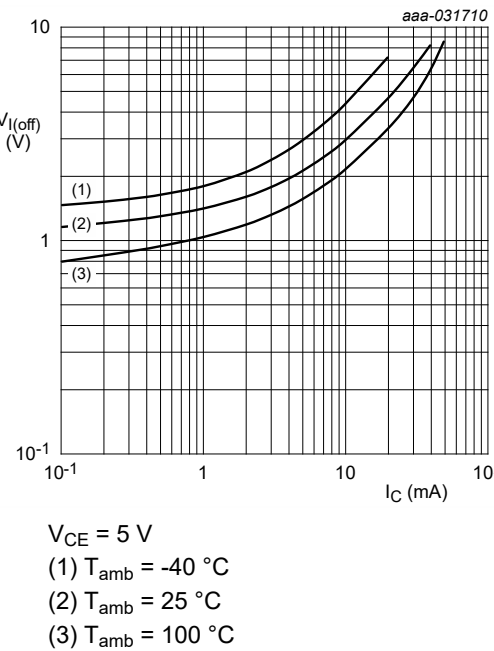
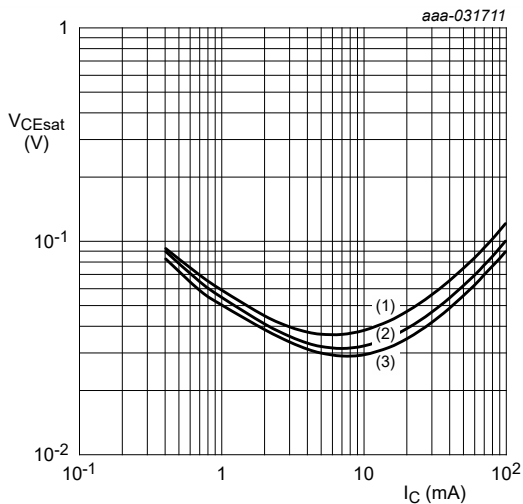
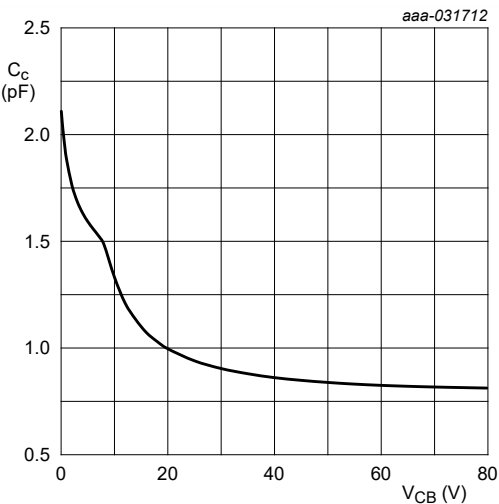


Fig. 19. NHDTC144ET-Q: Off-state input voltage as a function of collector current; typical values



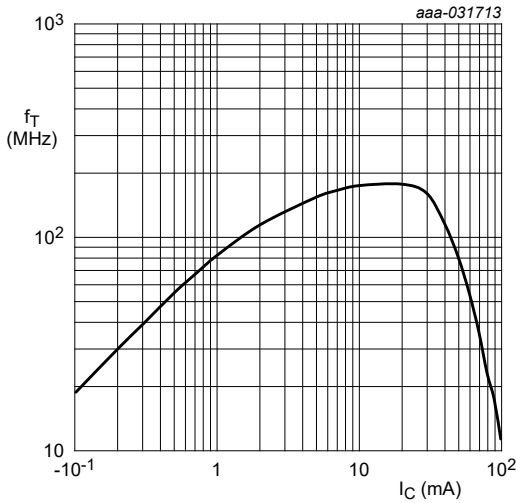

$$\frac{R2}{R1} = \frac{V(I_4) - V(I_3)}{R1 \cdot (I_4 - I_3)} - 1$$

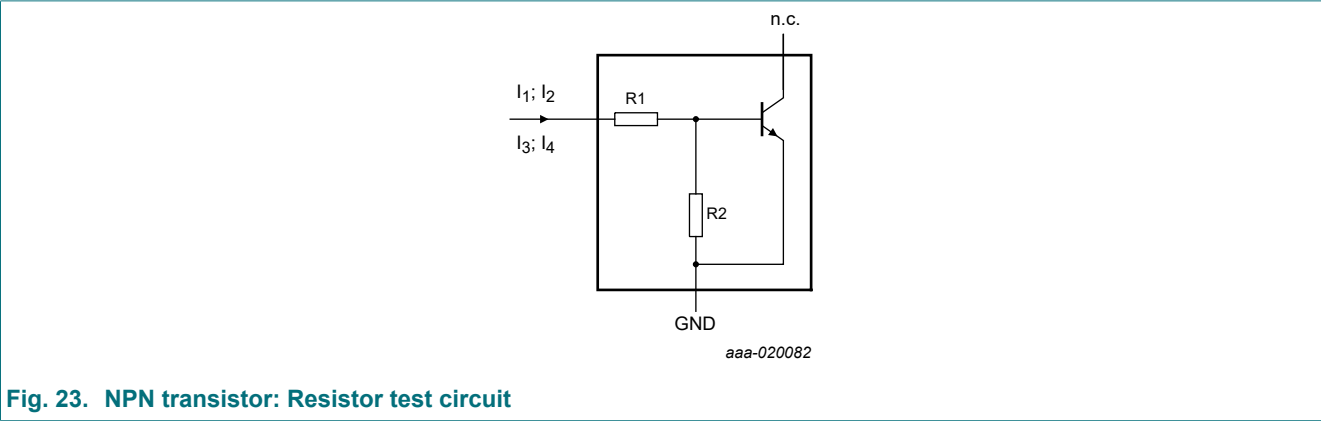


Fig. 23. NPN transistor: Resistor test circuit

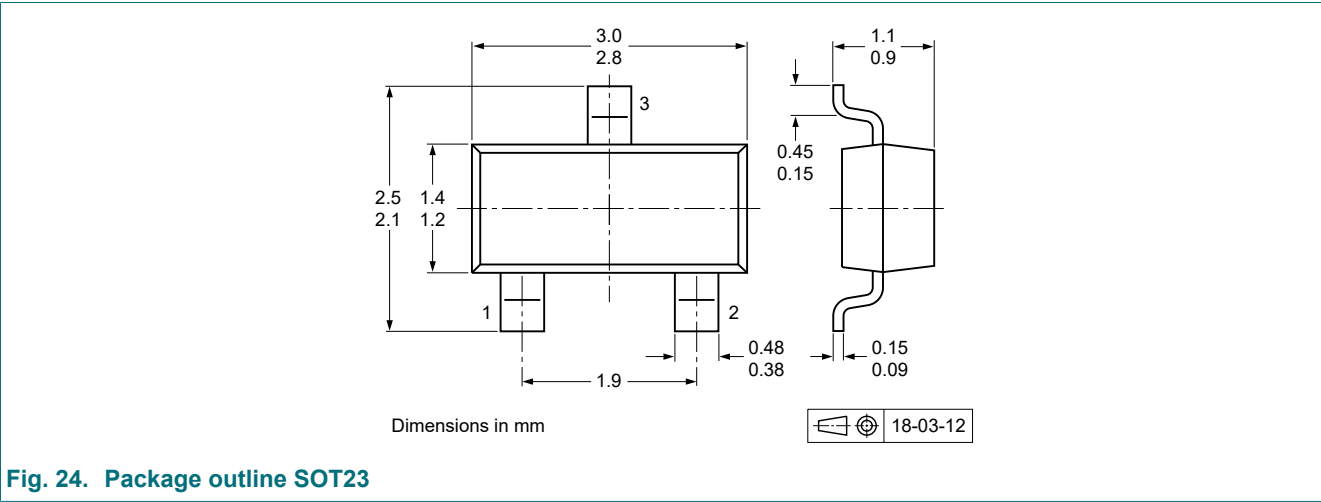


Fig. 24. Package outline SOT23

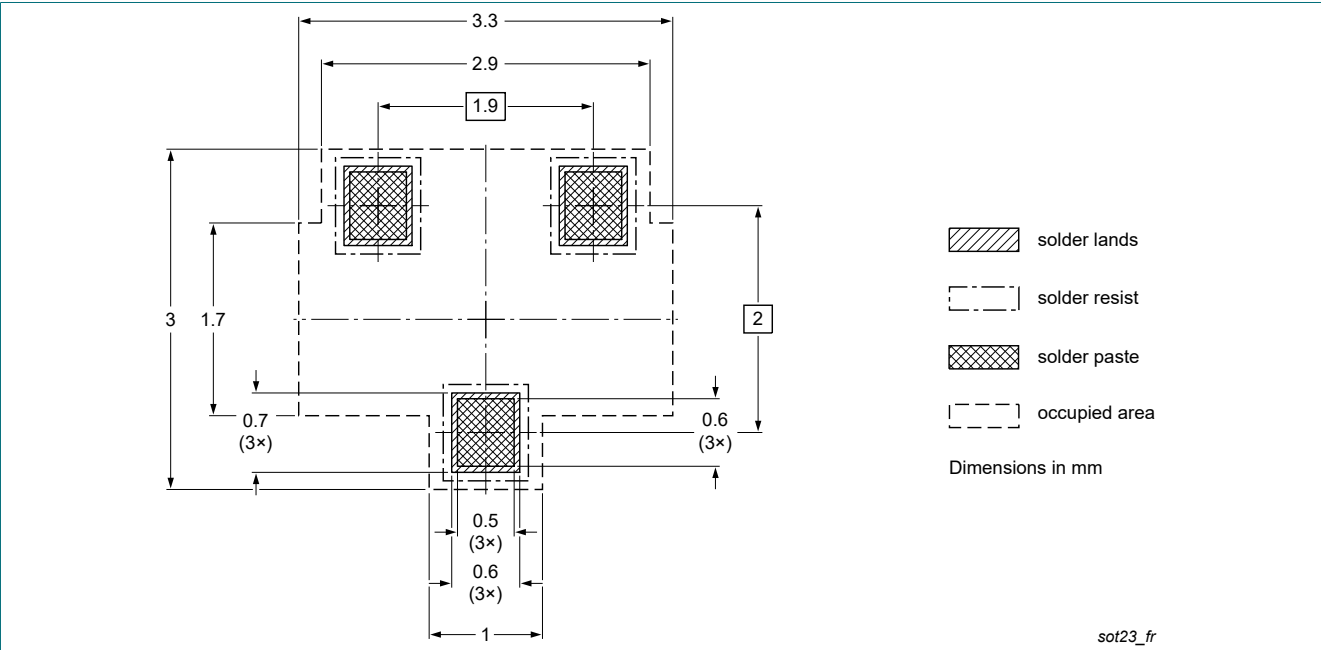


Fig. 25. Reflow soldering footprint for SOT23

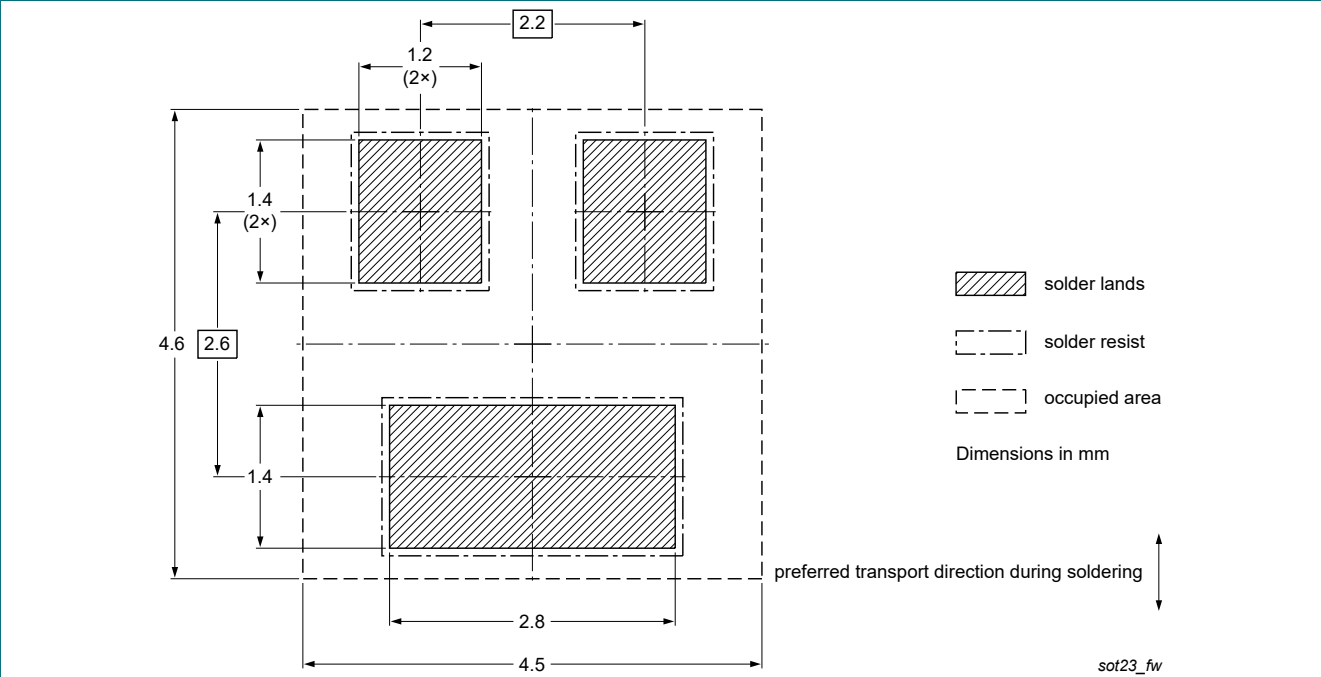


Fig. 26. Wave soldering footprint for SOT23
