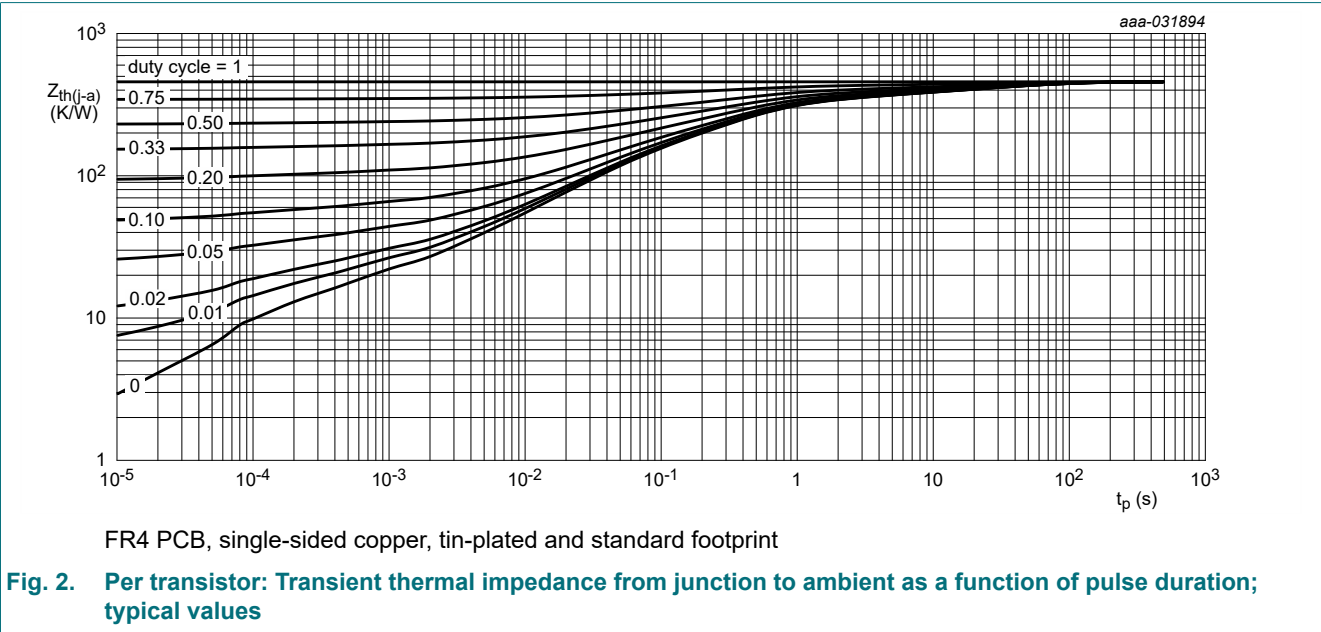

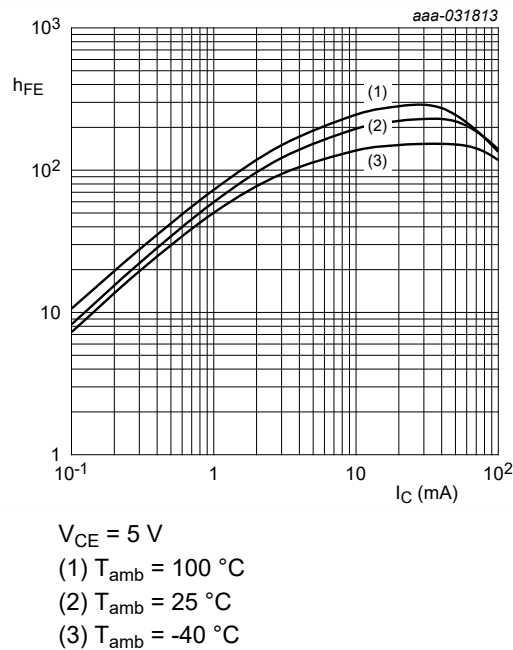


Fig. 3. NHUMH10-Q: DC current gain as a function of collector current; typical values

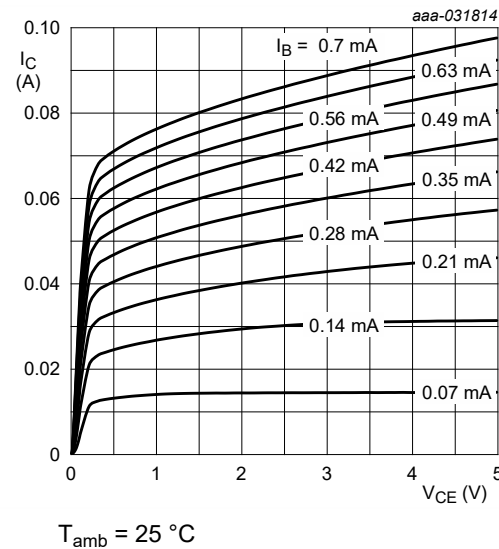


Fig. 4. NHUMH10-Q: Collector current as a function of collector-emitter voltage; typical values

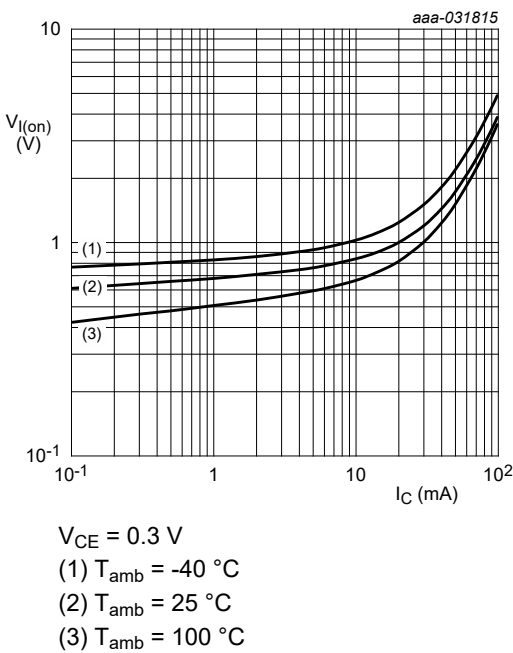


Fig. 5. NHUMH10-Q: On-state input voltage as a function of collector current; typical values

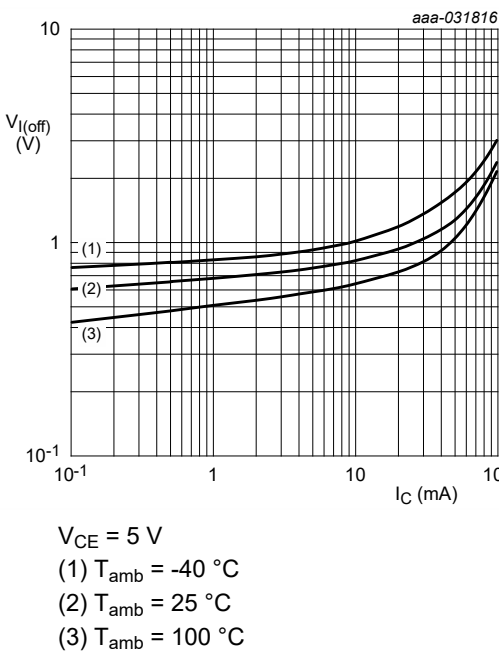


Fig. 6. NHUMH10-Q: Off-state input voltage as a function of collector current; typical values

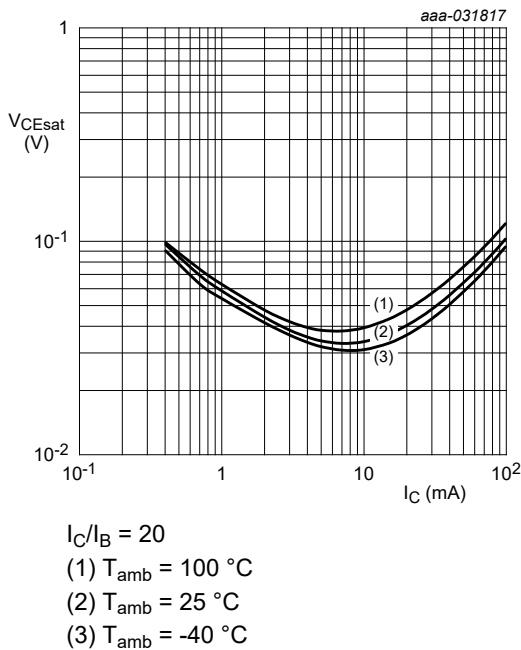


Fig. 7. NHUMH10-Q: Collector-emitter saturation voltage as a function of collector current; typical values

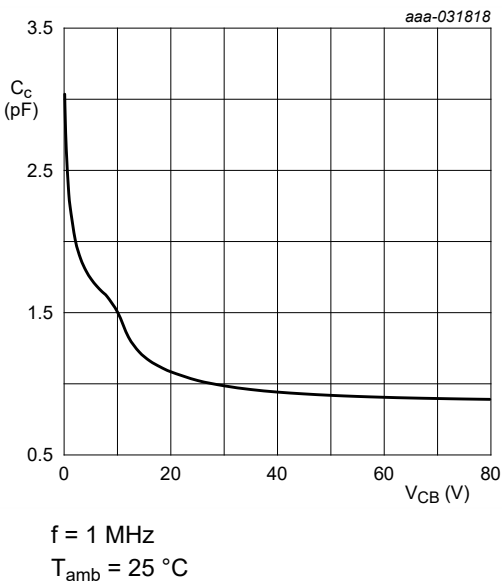


Fig. 8. NHUMH10-Q: Collector capacitance as a function of collector-base voltage; typical values

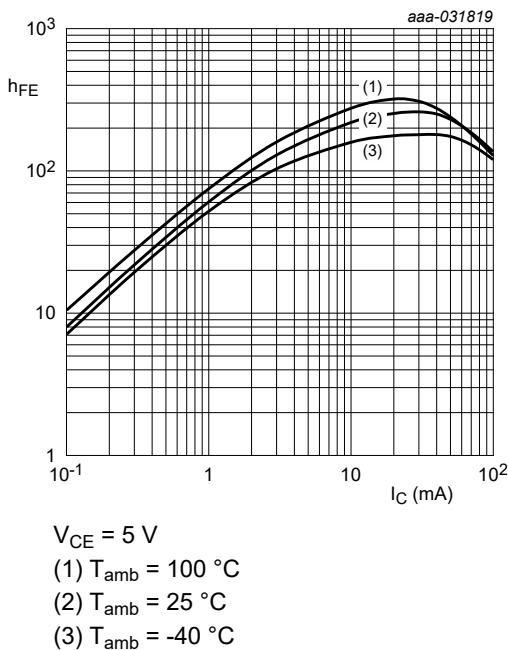


Fig. 9. NHUMH13-Q: DC current gain as a function of collector current; typical values

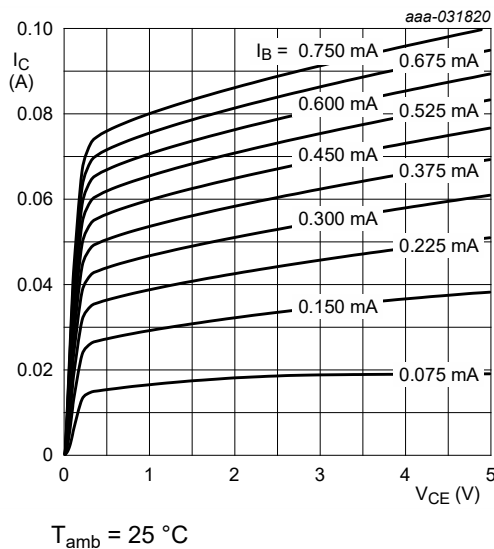


Fig. 10. NHUMH13-Q: Collector current as a function of collector-emitter voltage; typical values

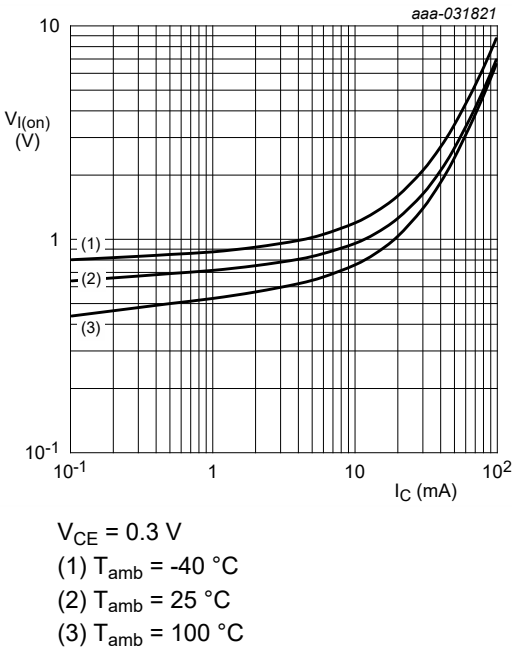


Fig. 11. NHUMH13-Q: On-state input voltage as a function of collector current; typical values

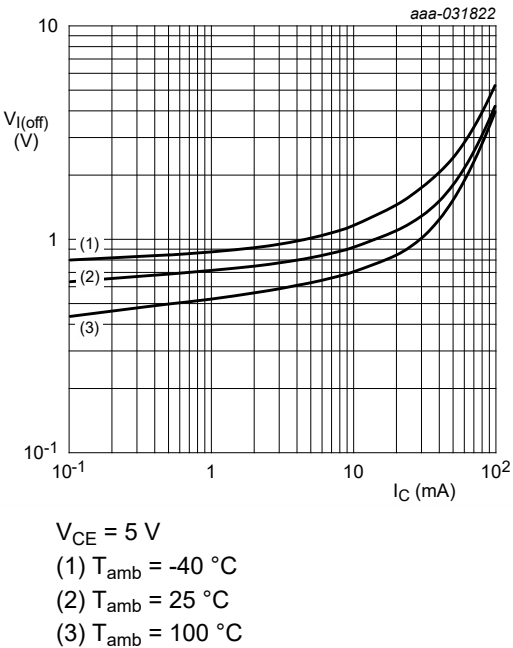


Fig. 12. NHUMH13-Q: Off-state input voltage as a function of collector current; typical values

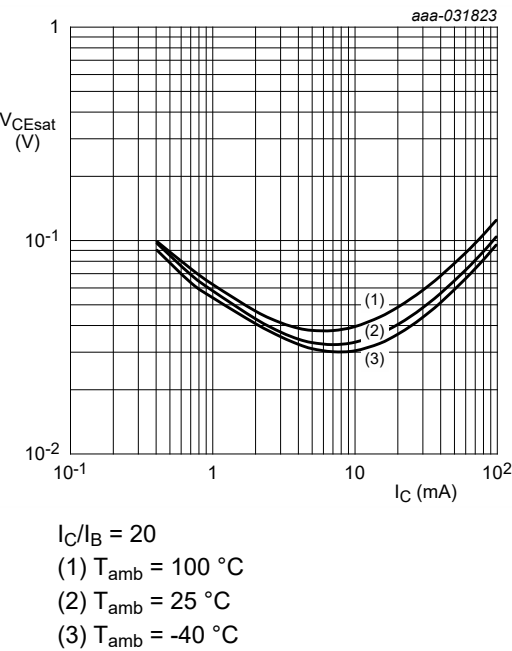


Fig. 13. NHUMH13-Q: Collector-emitter saturation voltage as a function of collector current; typical values

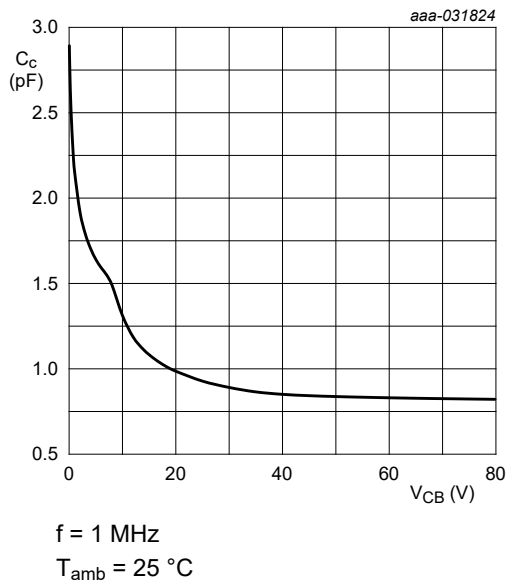


Fig. 14. NHUMH13-Q: Collector capacitance as a function of collector-base voltage; typical values

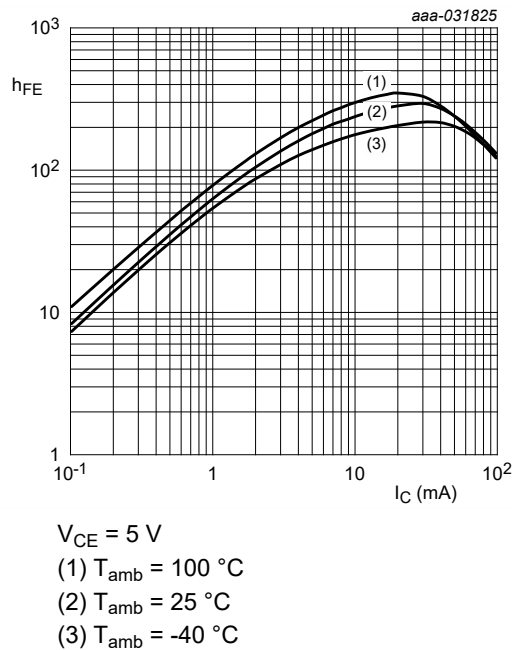


Fig. 15. NHUMH9-Q: DC current gain as a function of collector current; typical values

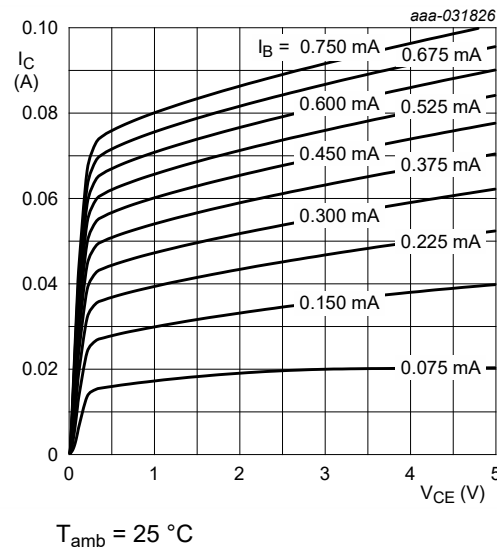


Fig. 16. NHUMH9-Q: Collector current as a function of collector-emitter voltage; typical values

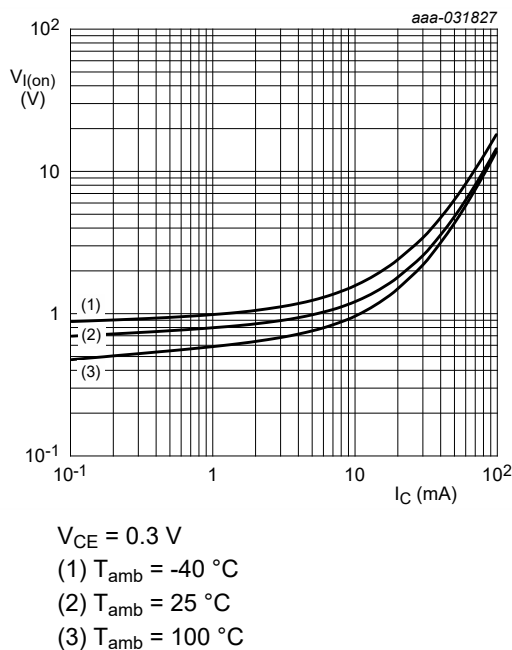


Fig. 17. NHUMH9-Q: On-state input voltage as a function of collector current; typical values

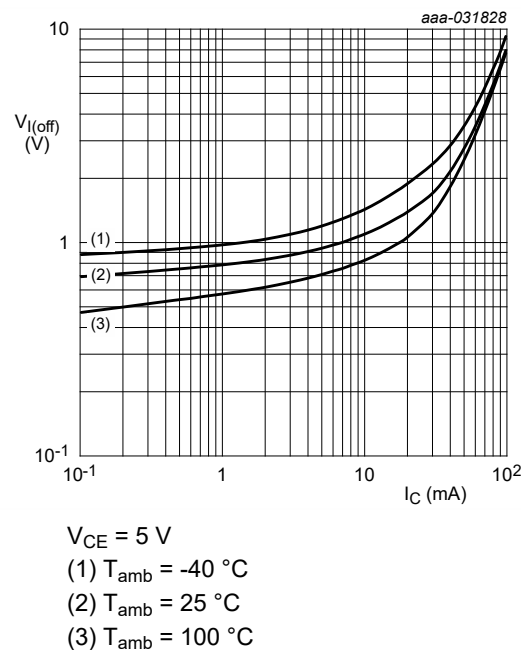


Fig. 18. NHUMH9-Q: Off-state input voltage as a function of collector current; typical values

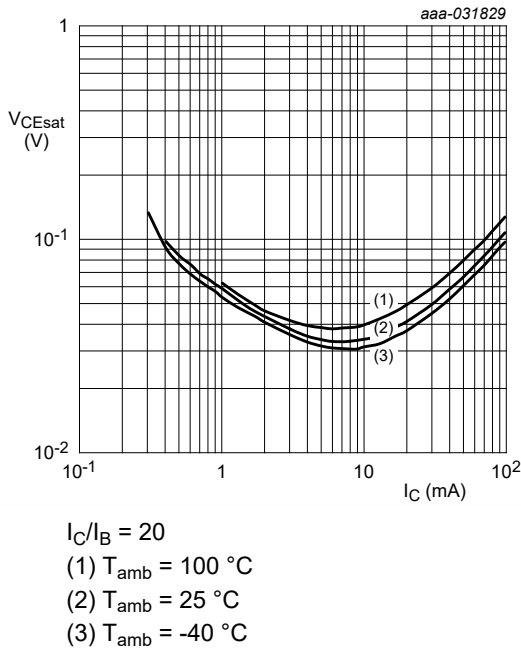


Fig. 19. NHUMH9-Q: Collector-emitter saturation voltage as a function of collector current; typical values

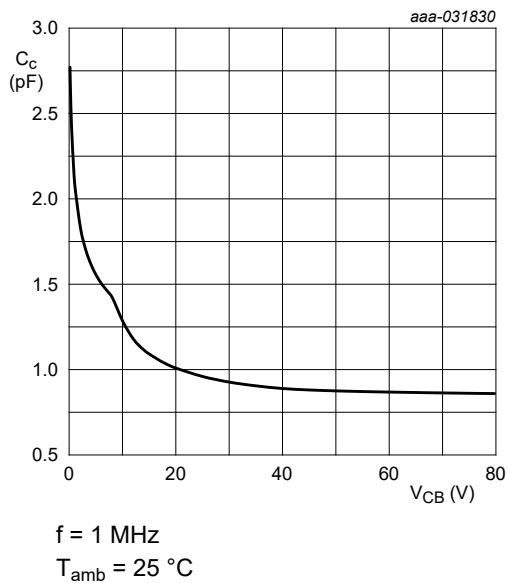
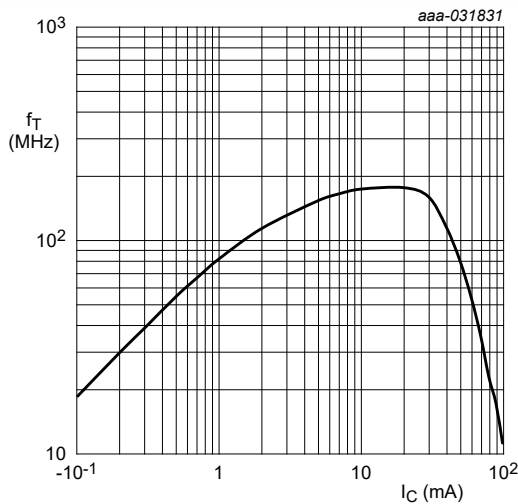


Fig. 20. NHUMH9-Q: Collector capacitance as a function of collector-base voltage; typical values

$$\frac{R2}{R1} = \frac{V(I_4) - V(I_3)}{R1 \cdot (I_4 - I_3)} - 1$$

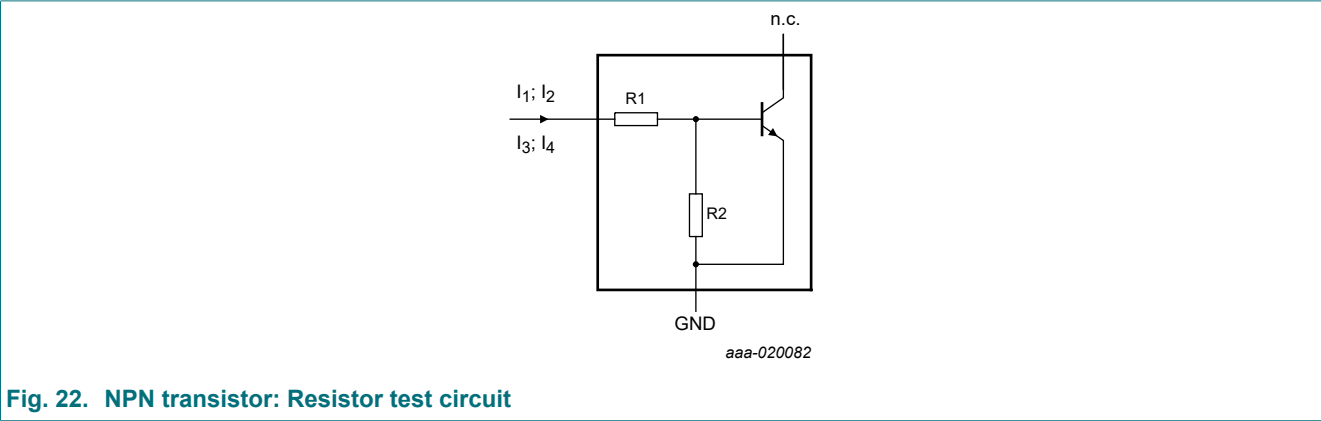


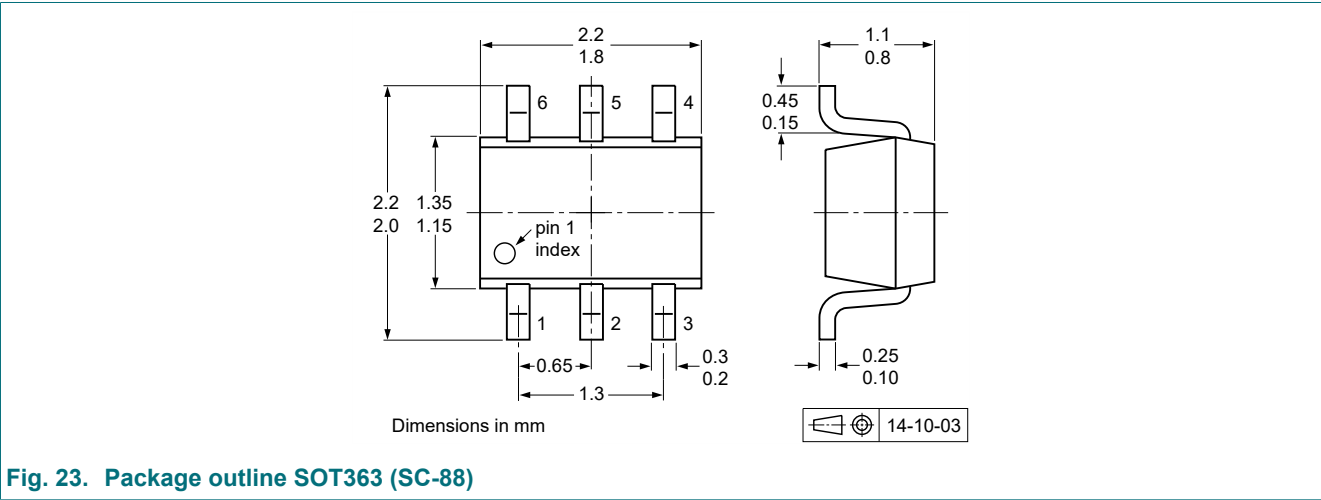
Fig. 22. NPN transistor: Resistor test circuit

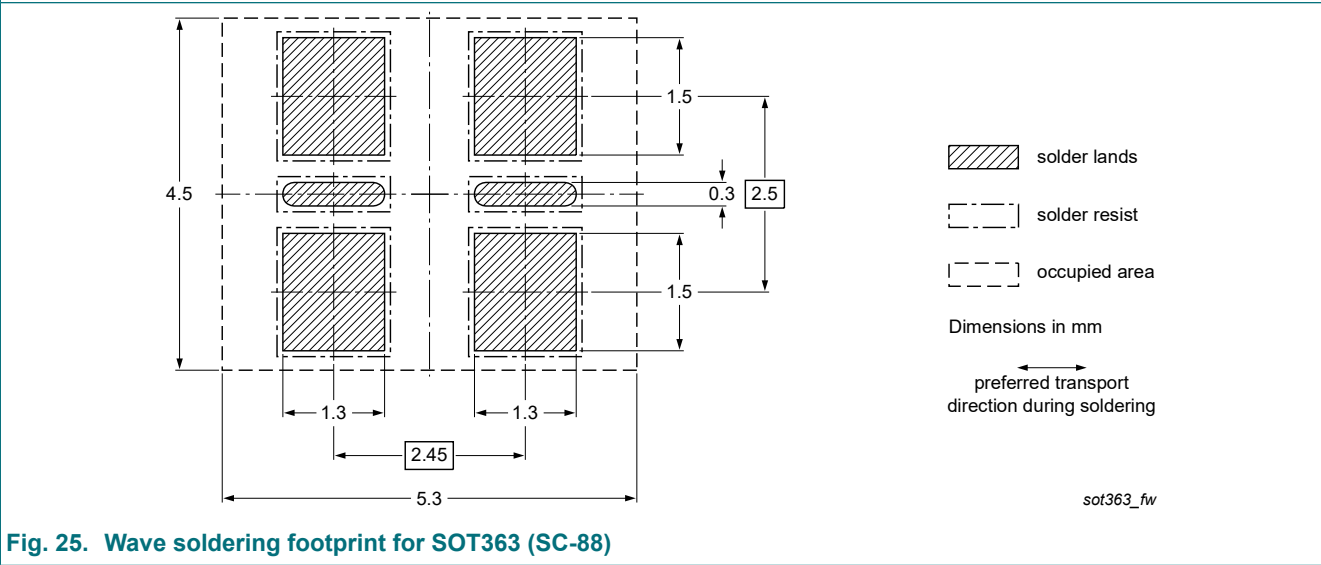
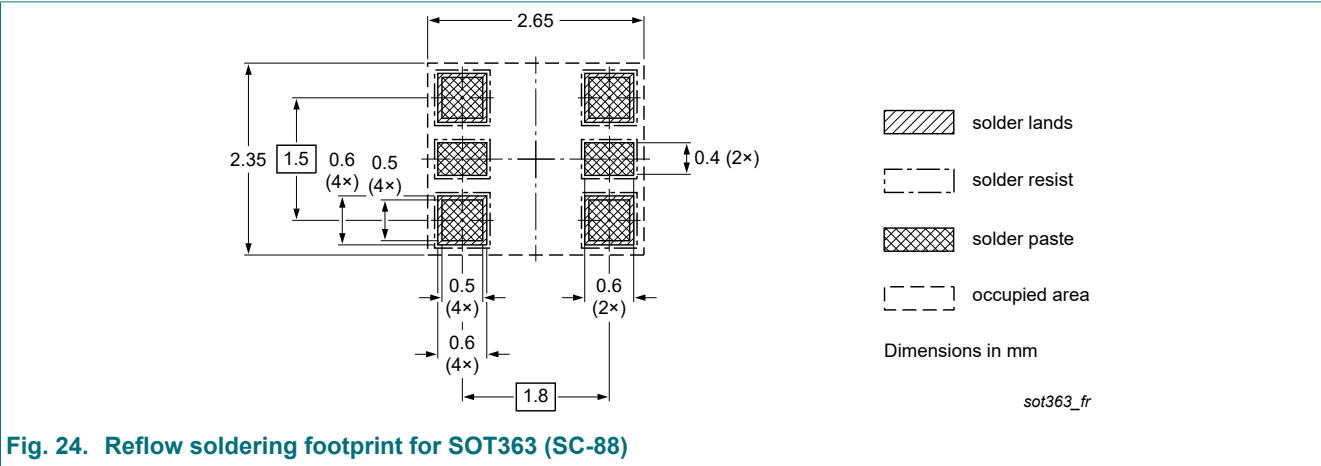
