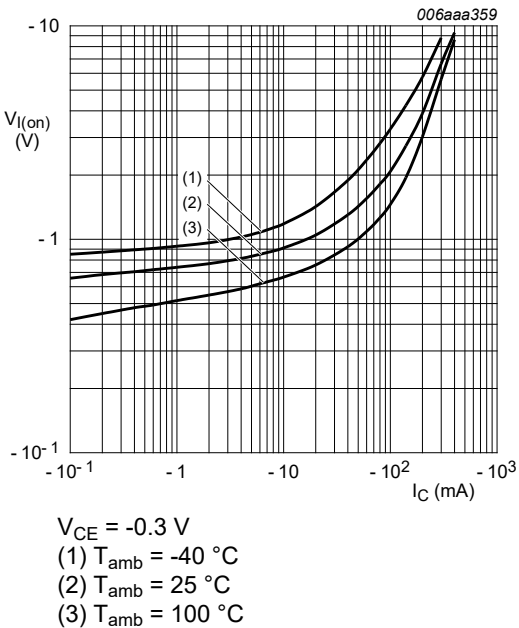


Fig. 6. On-state input voltage as a function of collector current; typical values

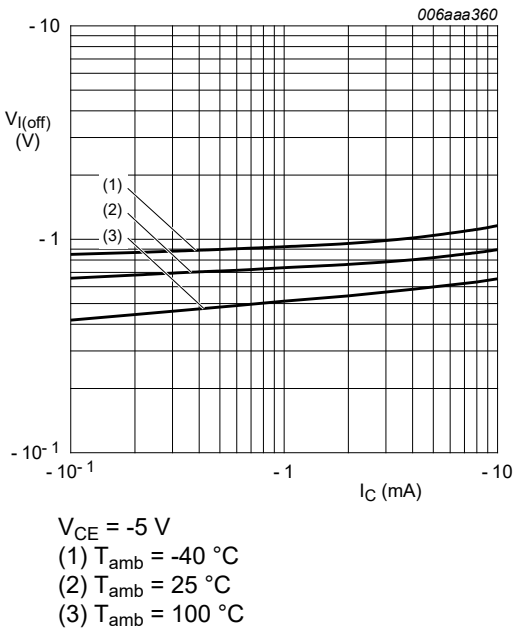


Fig. 7. Off-state input voltage as a function of collector current; typical values

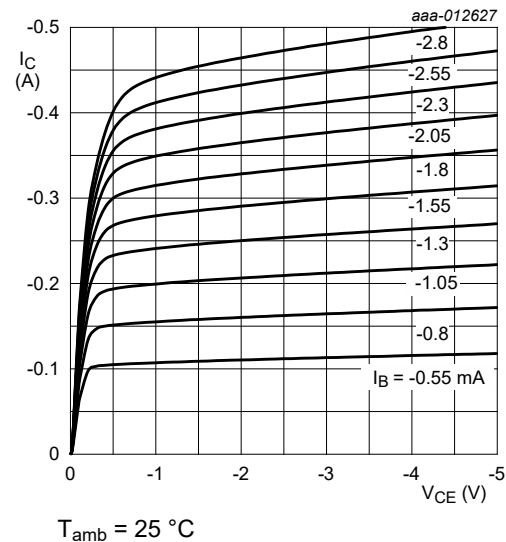


Fig. 8. Collector current as a function of collector-emitter voltage, typical values

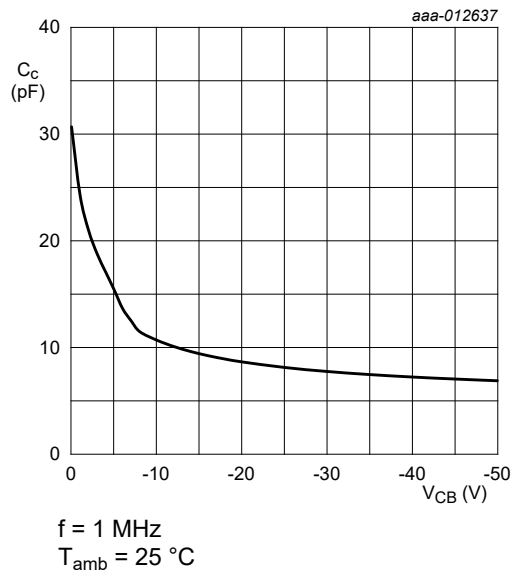
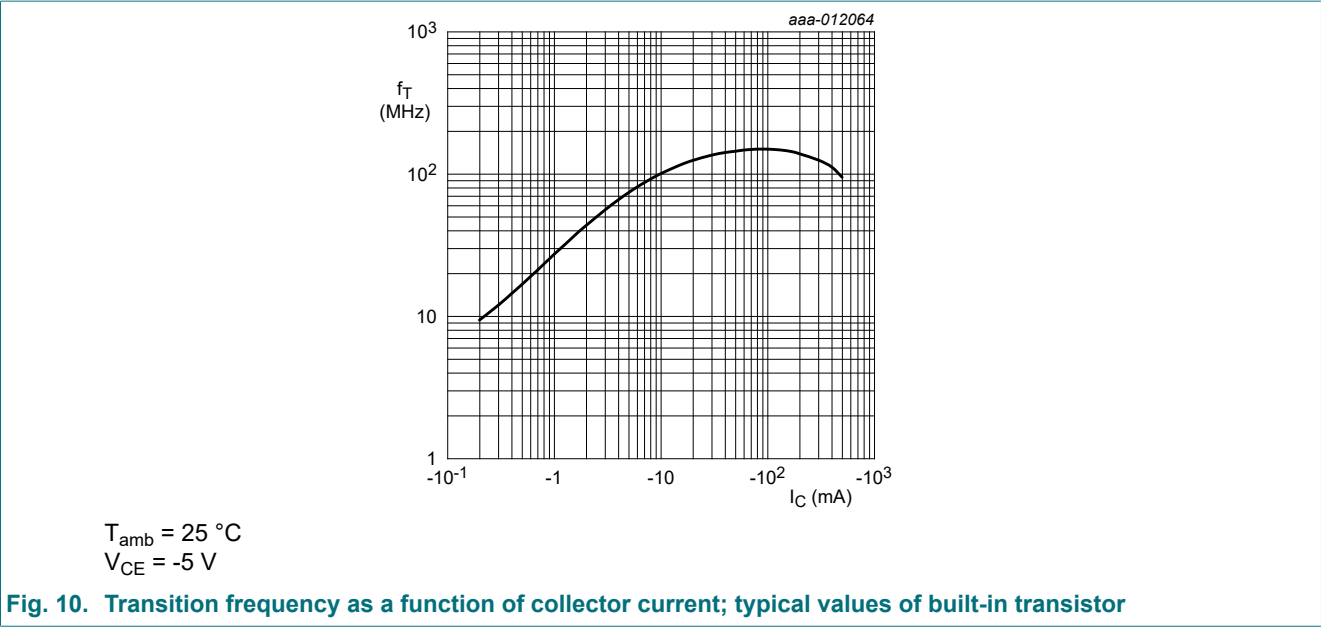


Fig. 9. Collector capacitance as a function of collector-base voltage; typical values

$$\frac{R_2}{R_1} = \frac{V(I_4) - V(I_3)}{R_1 \cdot (I_4 - I_3)} - 1$$

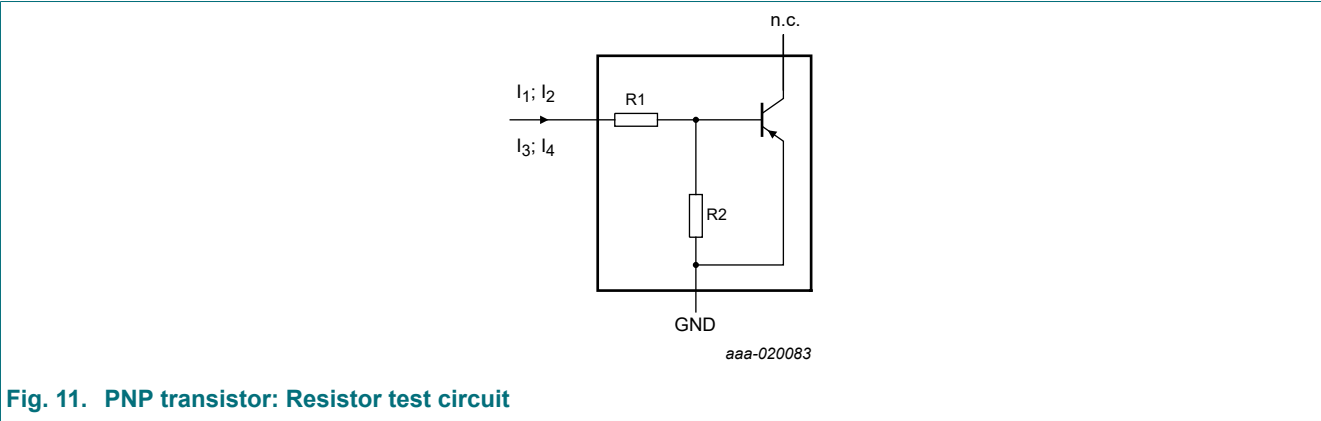


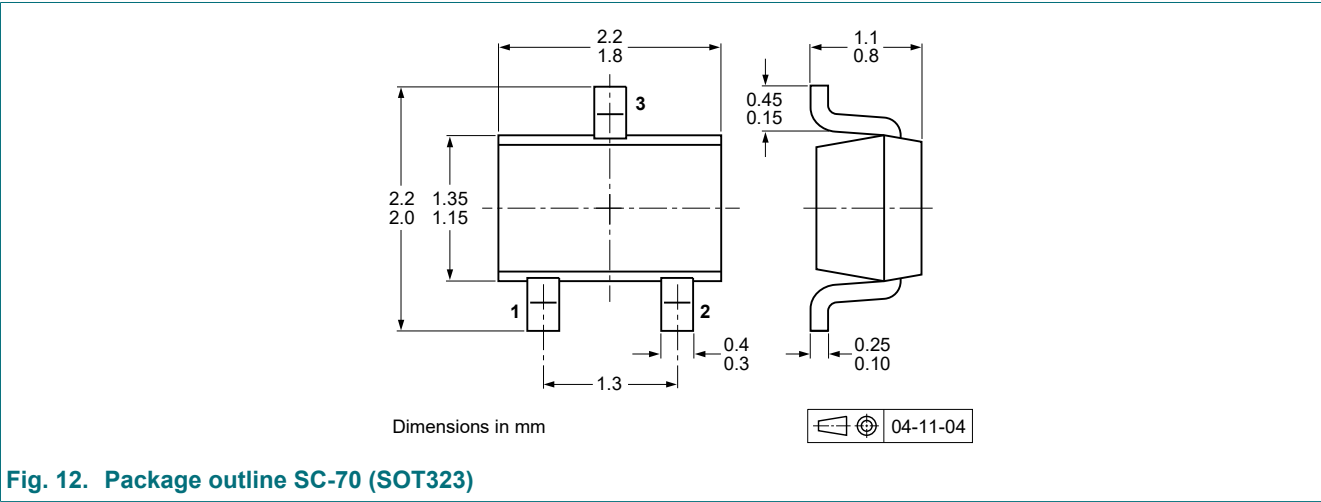
Fig. 11. PNP transistor: Resistor test circuit

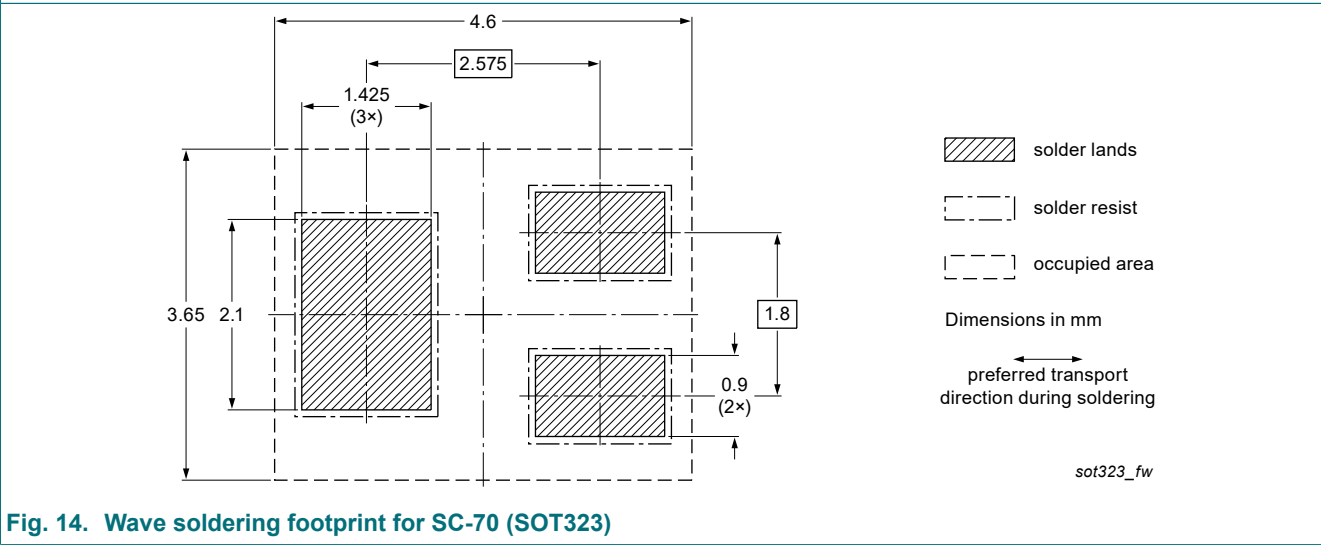
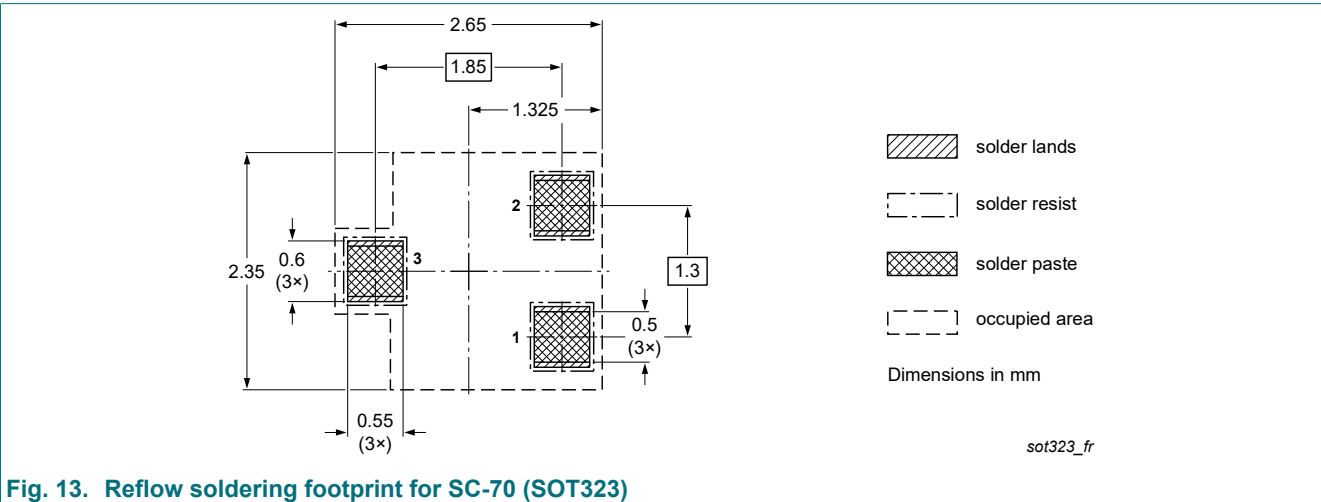
