## 1. General description

ESD protection device in a small SOT323 (SC70) Surface-Mounted Device (SMD) plastic package, designed to protect two automotive in-vehicle network bus lines from the damage caused by ElectroStatic Discharge (ESD) and other transients.

## 2. Features and benefits

- Reverse stand-off voltage:  $V_{RWM} = 27\text{ V}$
- Low clamping voltage:  $V_{CL} = 34\text{ V}$  at  $I_{PP} = 1\text{ A}$
- ESD protection up to 15 kV (IEC 61000-4-2)
- Ultra low capacitance:  $C_d = 4.0\text{ pF}$
- ESD protection up to 15 kV (ISO 10605;  $C = 150\text{ pF}$ ;  $R = 330\text{ }\Omega$ )
- High temperature capability:  $T_j = 175\text{ }^\circ\text{C}$
- Qualified according to AEC-Q101 and recommended for use in automotive applications

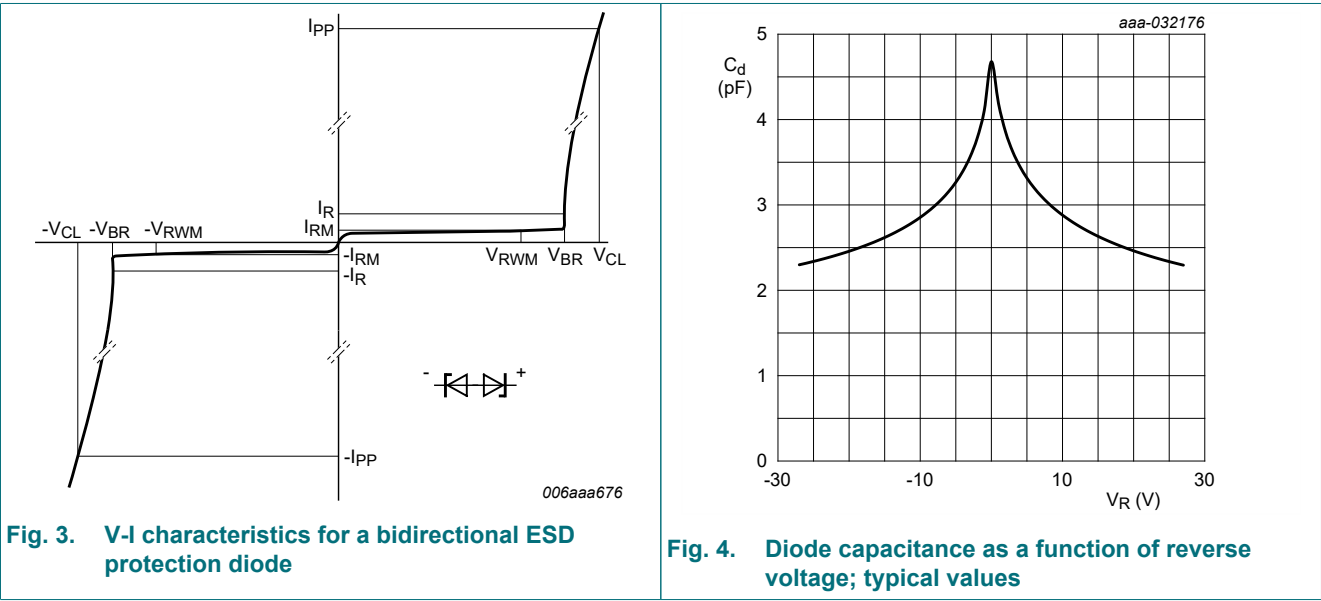

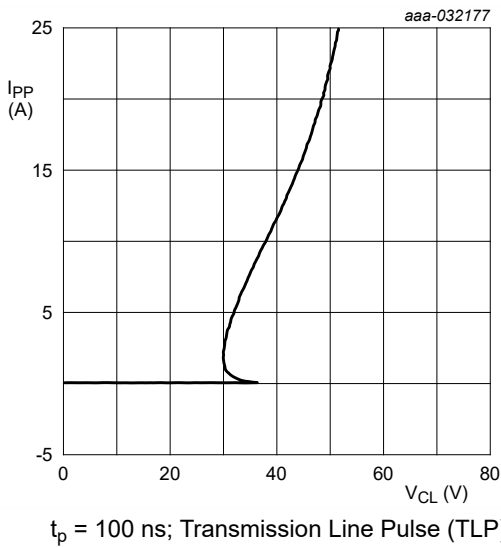


Fig. 5. Positive clamping voltage (TLP); typical values

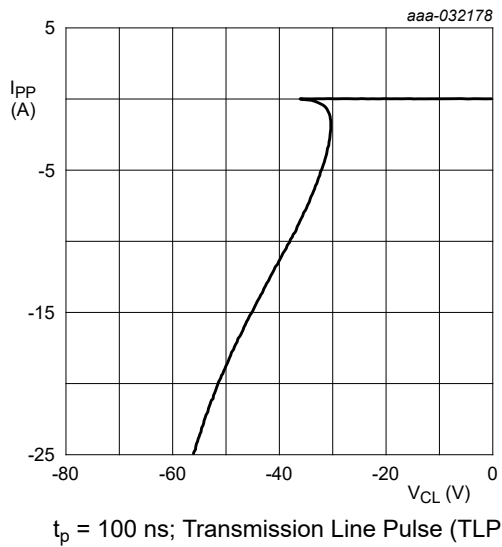


Fig. 6. Negative clamping voltage (TLP); typical values

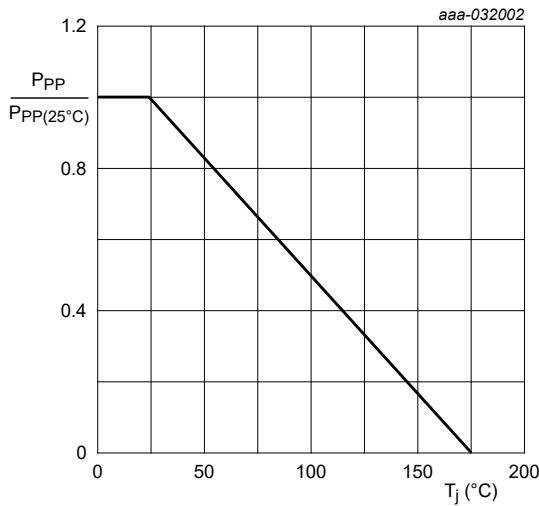
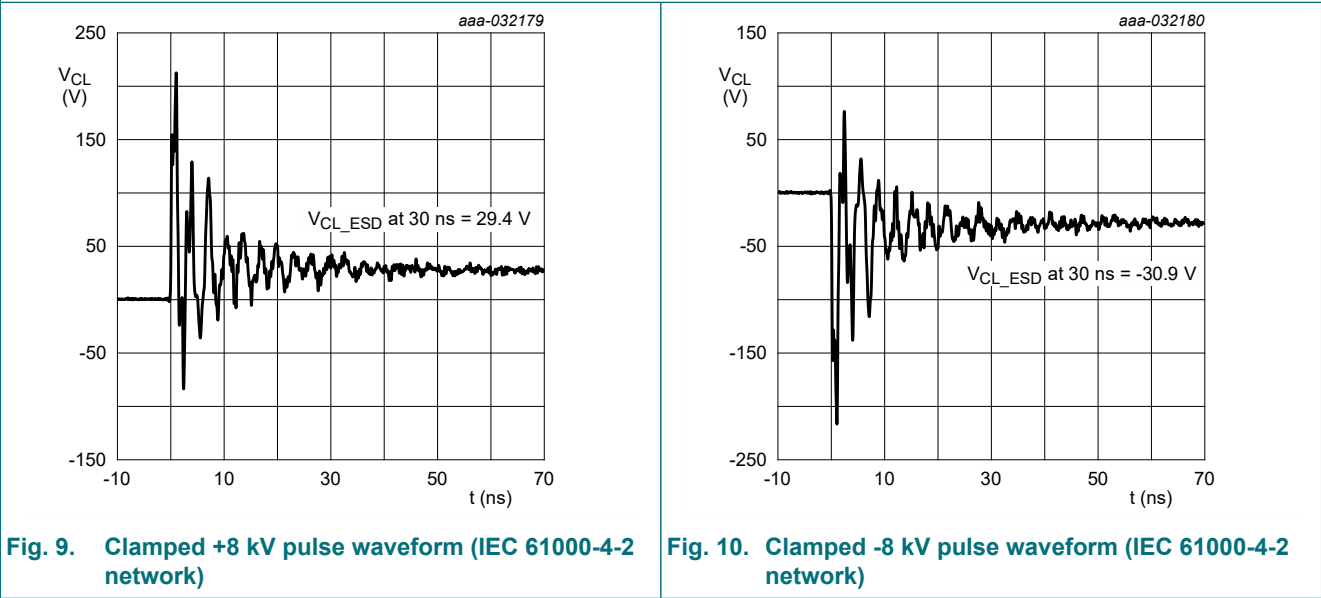


Fig. 7. Relative variation of peak pulse power as a function of junction temperature; typical values

## 10. Application information

The device is designed for the protection of two automotive in-vehicle bus lines, e.g. CAN (FD), from the damage caused by ESD and surge pulses.

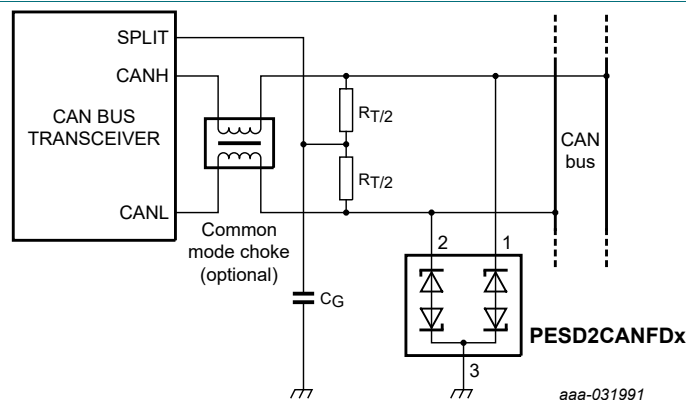


Fig. 11. Typical application: ESD protection of two automotive CAN bus lines

### Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

## 11. Test information

### Quality information

This product has been qualified in accordance with the Automotive Electronics Council (AEC) standard Q101 - *Stress test qualification for discrete semiconductors*, and is suitable for use in automotive applications.

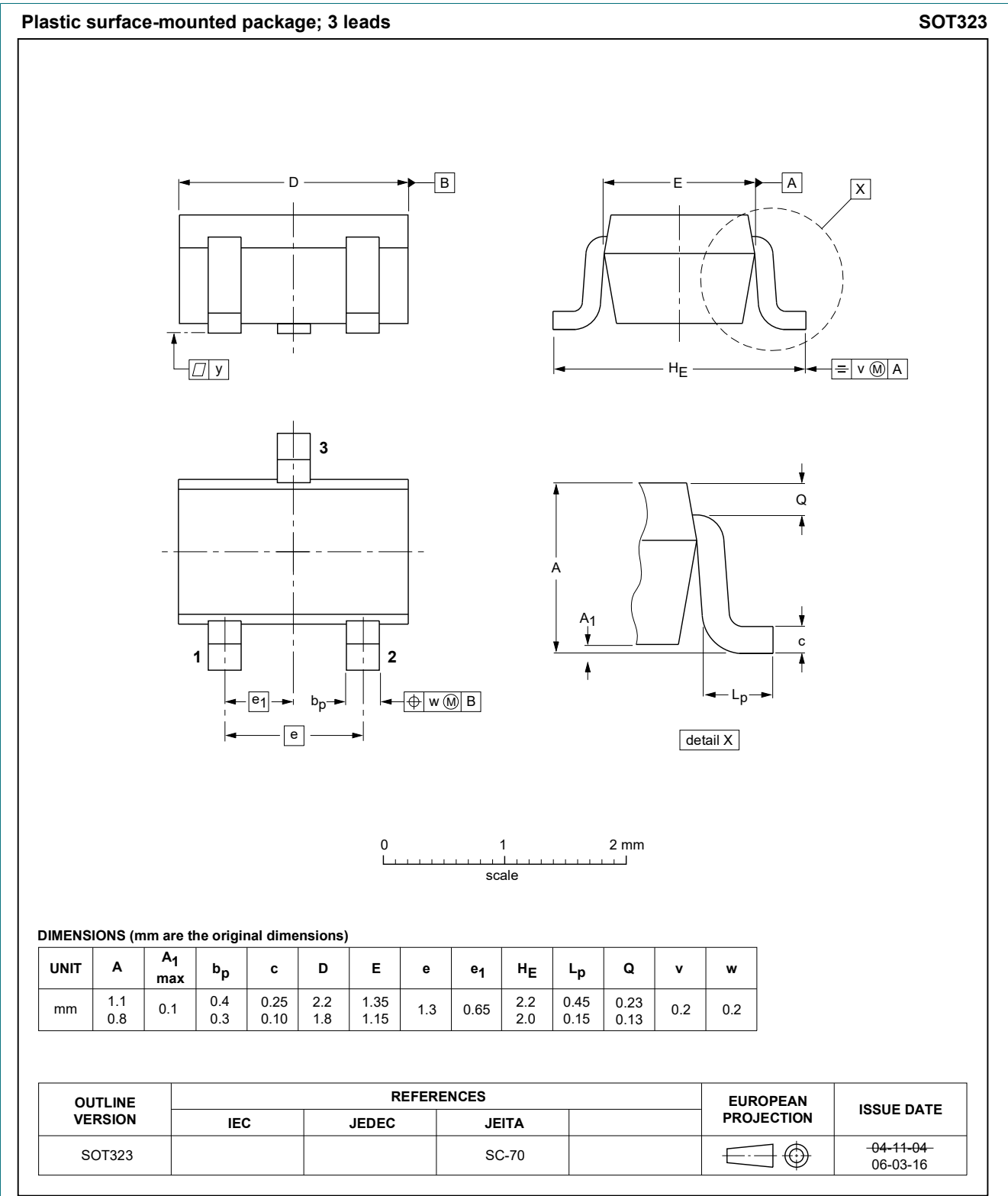


Fig. 12. Package outline SC-70 (SOT323)

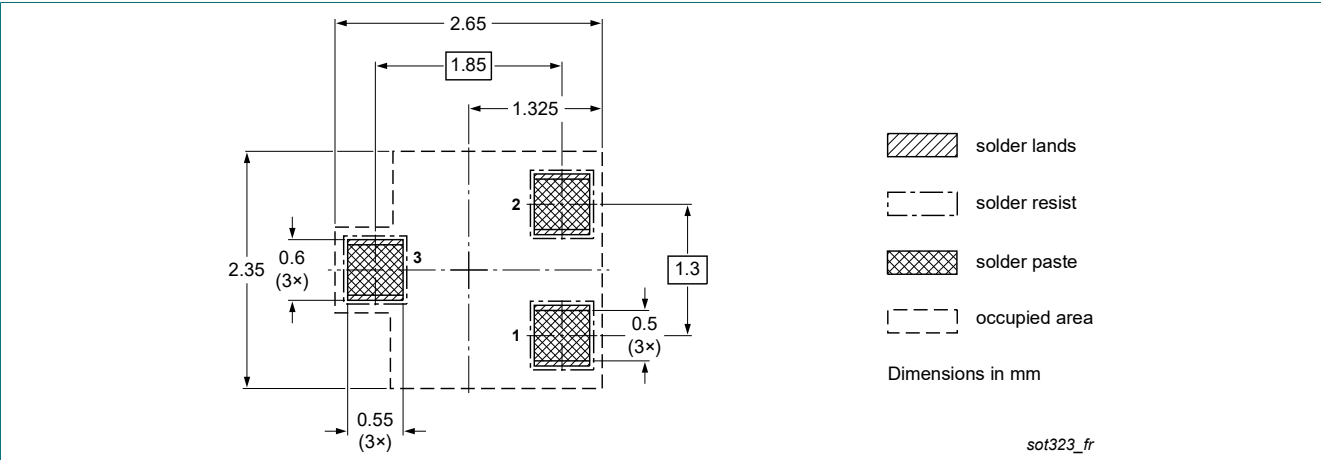


Fig. 13. Reflow soldering footprint for SC-70 (SOT323)

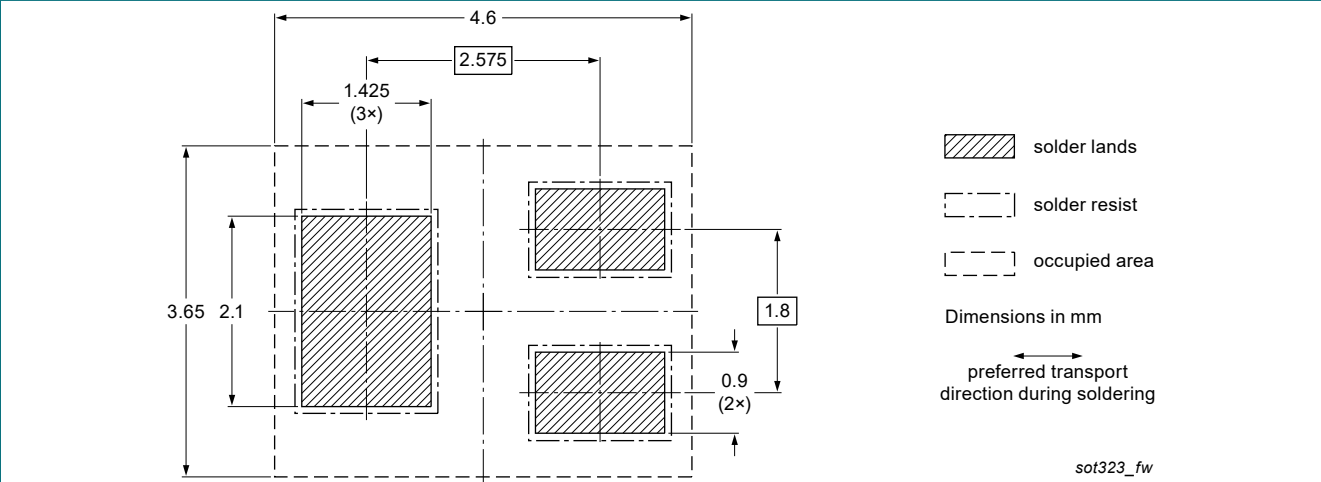


Fig. 14. Wave soldering footprint for SC-70 (SOT323)
