## 1. General description

ESD protection device in an ultra-small DFN1110D-3 (SOT8015) leadless Surface-Mounted Device (SMD) plastic package with side wettable flanks, designed to protect two automotive in-vehicle network bus lines from the damage caused by Electro-Static Discharge (ESD) and other transients.




Fig. 1. 8/20 µs pulse waveform according to IEC 61000-4-5




Fig. 2. ESD pulse waveform according to IEC 61000-4-2




Fig. 3. Transient characteristics for a bidirectional ESD protection device




Fig. 4. Diode capacitance as a function of reverse voltage; typical values




Fig. 5. Positive clamping voltage (TLP); typical values






Fig. 7. Positive clamping voltage; typical values



Transmission Line Pulse (TLP);  $t_p = 100 \text{ ns}$ ;  $t_r = 1 \text{ ns}$ 


Fig. 6. Negative clamping voltage (TLP); typical values

# 10. Application information

The device is designed for the protection of two automotive in-vehicle bus lines, e.g. CAN (FD), from the damage caused by ESD and surge pulses.



#### Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

- 1. Place the device as close to the input terminal or connector as possible.
- 2. Minimize the path length between the device and the protected line.
- 3. Keep parallel signal paths to a minimum.
- 4. Avoid running protected conductors in parallel with unprotected conductors.
- 5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
- 6. Minimize the length of the transient return path to ground.
- 7. Avoid using shared transient return paths to a common ground point.
- 8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

### 11. Test information

#### **Quality information**

This product has been qualified in accordance with the Automotive Electronics Council (AEC) standard Q101 - *Stress test qualification for discrete semiconductors*, and is suitable for use in automotive applications.




Fig. 10. Package outline DFN1110D-3 (SOT8015)




Fig. 11. Reflow soldering footprint for DFN1110D-3 (SOT8015)
