The SiC Schottky diode encapsulated in a Real-2-Pin D2PAK R2P (TO-263-2) Surface-Mounted Device (SMD) power plastic package offers temperature independent capacitive turn-off, zero recovery switching behavior combined with an outstanding figure-of-merit ($Q_C \times V_F$). The Merged PiN Schottky (MPS) diode improves the robustness expressed in a high I_{FSM} .




Fig. 1. Transient thermal impedance as a function of pulse duration; maximum values




Fig. 2. Power dissipation; maximum values





Fig. 3. Forward current as a function of case temperature; maximum values







Fig. 7. Diode capacitance as a function of reverse voltage; typical values






Fig. 8. Capacitance stored energy as a function of reverse voltage; typical values




