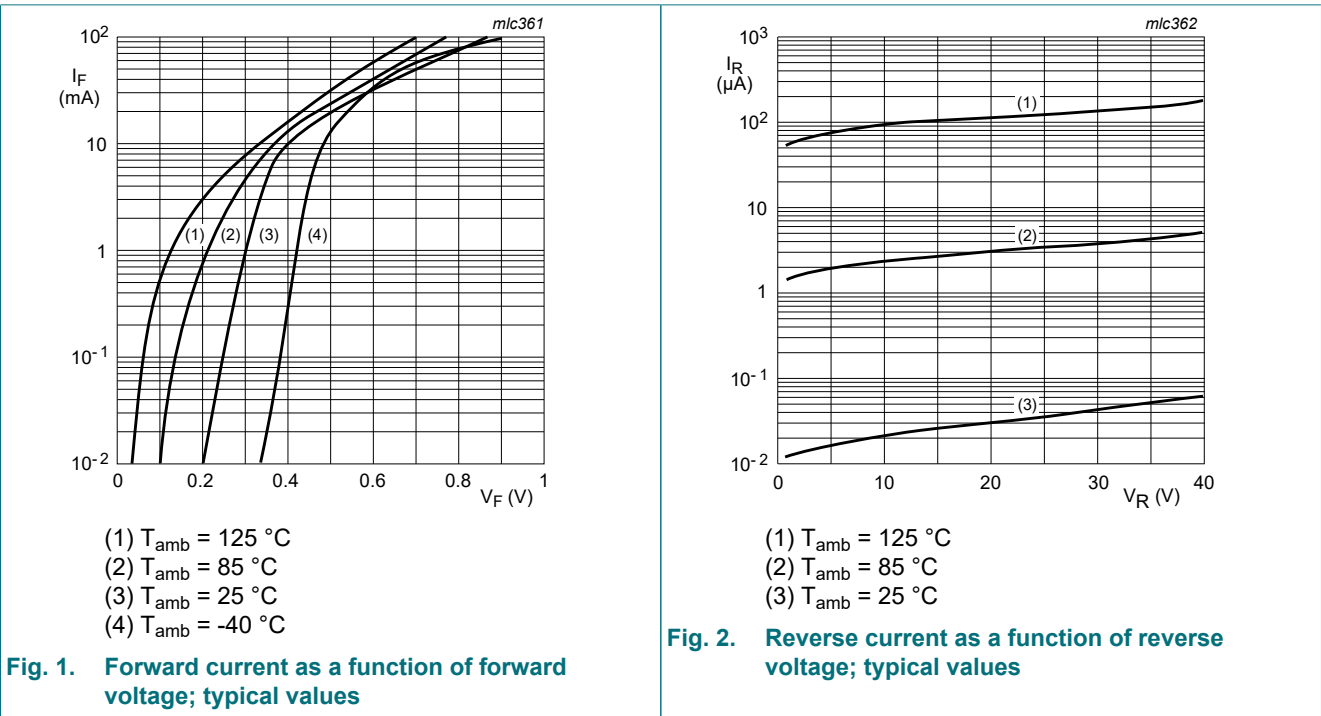

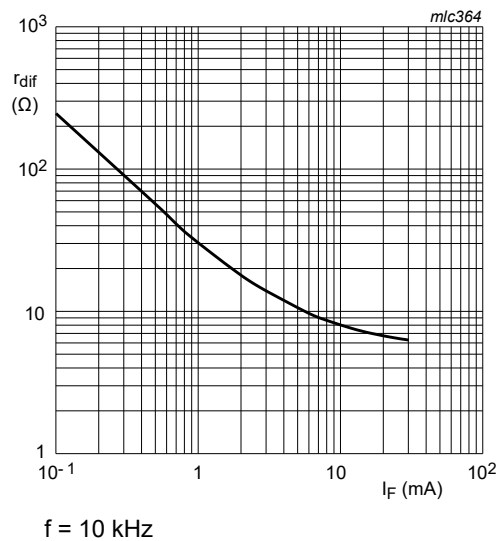


Fig. 3. Differential resistance as a function of forward current; typical values

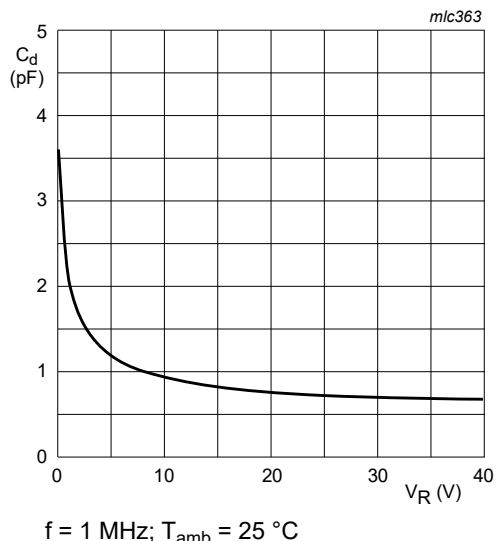


Fig. 4. Diode capacitance as a function of reverse voltage; typical values

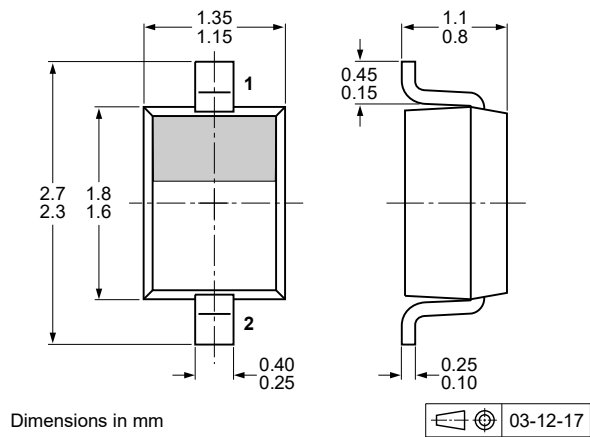


Fig. 5. Package outline SOD323

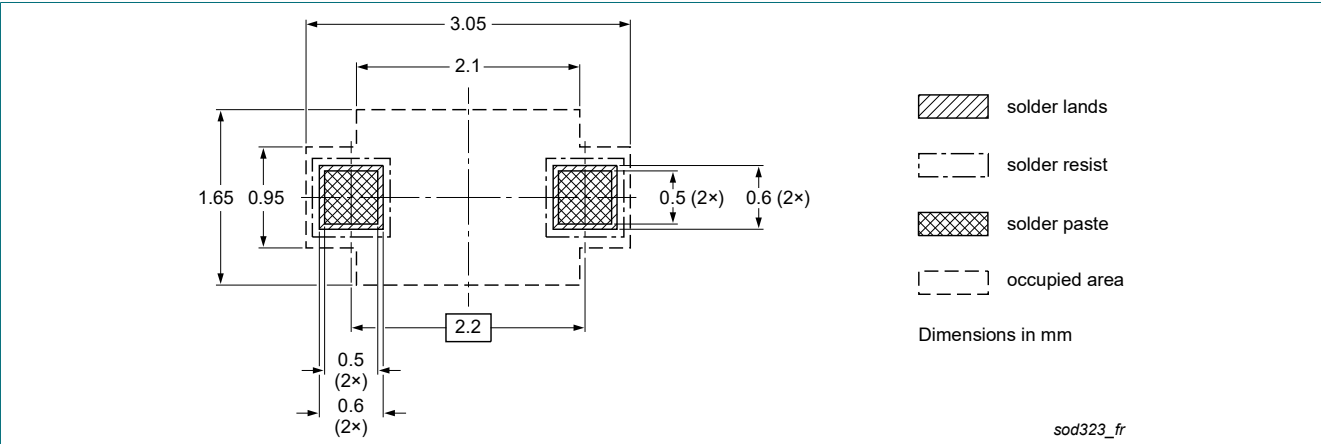


Fig. 6. Reflow soldering footprint for SOD323

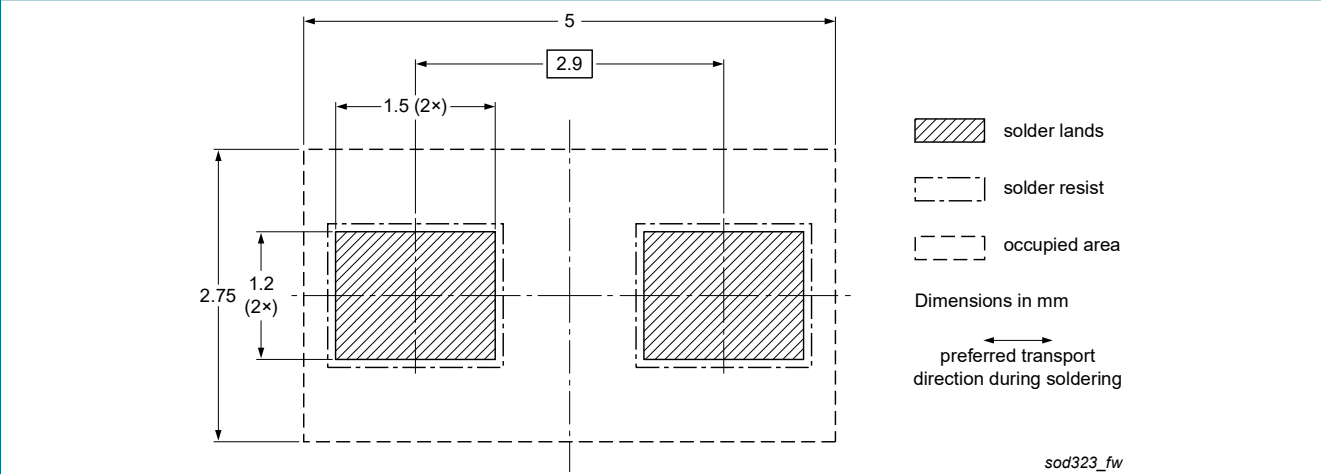


Fig. 7. Wave soldering footprint for SOD323
