relation to the aim of the investigation. Data should not be presented in more than one form. All tables and figures must be referred to in the text.

Discussion. This should contain a critical review of the results of the study in the light of relevant work published previously by the author(s) and/or other investigators.

Conclusion. The manuscript should end with a brief conclusion (not more than 200 words).

Acknowledgements. Detail in no more than 50 words those contributions which require acknowledgement but do not justify authorship, acknowledgements of technical help or other assistance. Acknowledgements of financial or material support should appear on the title page.

References

References should be numbered consecutively in the order in which they are first mentioned in the text. Identify references in the text, tables and legends by arabic numerals in parentheses. References cited in tables or in legends to figures should be numbered in accordance with a sequence established by the first identification in the text of the particular table or illustration. The style of the references is that of the *Index Medicus*. Example of correct forms of references are given below.

Artwork

Figures must be numbered and referred to in the text, and their approximate position should be indicated in the margin of the manuscript. The (first) author's name, figure number and, if necessary, an arrow clarifying orientation, should be appended to the reverse of each illustration. Line drawings (including graphs) must be in black ink on white paper, or be sharp photo-prints on glossy paper. The lettering should be large enough to permit photographic reduction. Actual magnification of photo-micrographs should be indicated by a

micronbar or in the legend. Halftone illustrations should be submitted as black and white prints on glossy paper and have as much contrast as possible. Figure legends should be typed on a separate sheet of paper.

 Λ charge of £300 a page is made for 4-colour figures. Inability to meet these costs will not prevent publication of essential colour figures if, in the opinion of the Publishers, the circumstances so merit.

Tables

Tables should be typed in double spacing on separate sheets. Each table should have a brief title and should be numbered in arabic numerals in the order of appearance in the manuscript. Vertical rules should not be used. The position of each table should be indicated in the margin of the manuscript.
