Manuscript Submission

Online Manuscript Submission

BioMetals has a fully web-enabled manuscript submission and review system. This system offers authors the option of tracking in real time the review process of their manuscripts. The online manuscript and review system offers easy and straightforward log-in and submission procedures. It supports a wide range of submission file formats, including Word, WordPerfect, RTF, TXT and LaTeX for article text and TIFF, EPS, PS, GIF, JPEG and PPT for figures. PDF is not a recommended format.

Authors are requested to download the Consent to Publish and Transfer of Copyright form from this system.

Please send a completed and signed form either by mail or fax to the BioMetals Office.

Authors of reviews are requested to contact the Editor-in-Chief to discuss suitability before submitting their manuscript.

NOTE: By using the online manuscript submission and review system, it is NOT necessary to submit the manuscript also as printout + disk. In case you encounter any difficulties while submitting your manuscript online, please get in touch with the responsible Editorial Assistant by clicking on "CONTACT US" from the toolbar.

Electronic figures

Electronic versions of your figures must be supplied. For vector graphics, EPS is the preferred format. For bitmapped graphics, TIFF is the preferred format. The following resolutions are optimal: line figures - 600 – 1200 dpi; photographs - 300 dpi; screen dumps - leave as is. Colour figures can be submitted in the RGB colour system. Font-related problems can be avoided by using standard fonts such as Times Roman, Courier and Helvetica.

Colour figures

Colour figures may be printed at the author's expense. Please indicate at submission which figures should be printed in colour, the number of colour pages you prefer and to which address we can send the invoice. The standard price per article is ϵ 950/\$1150.

Language

We appreciate any efforts that you make to ensure that the language is corrected before submission. This will greatly improve the legibility of your paper if English is not your first language.

Style and Presentation

Manuscripts should be written in clear, grammatical, idiomatic English, following US spelling conventions according to Webster's International Dictionary. Authors whose mother tongue is not English are urged to have their manuscript read by a colleague with Native English prior to submission. Incomplete or imperfect manuscripts will be returned immediately. Authors should supply two copies of both text and the illustrations.

Data should be presented simply and concisely. The manuscript should be typed on one side of the page with double spacing throughout allowing ample margins with consecutive numbering of all pages.

The typescript should be arranged in the following order: title; full names of all authors; the address(es) where the work was carried out; running title; abstract of not more than 250 words; three to five keywords for indexing purposes; text of paper; appendices (if any); tables; each on a separate page; legends for all illustrations, grouped together on the same paper; and illustrations.

It is understood that papers submitted for publications have not been published previously and are not simultaneously offered to any other journal.

Text

The text of the paper should be divided up into the following sections: Introduction, Materials and Methods, Results, Discussion, Acknowledgements and References.

The Introduction should be concise and define the scope of the work in relation to other work done in the same field. An exhaustive review of the literature is not necessary: reference should only be made to recent and relevant publications.

Materials and methods should provide enough information to permit exact repetition of the experimental work. Where appropriate, suppliers' names should be given. Location (e.g. Sigma, St Louis, MO, USA) are not necessary to mention.

Results should be clear and precise; interpretations or references to other work or related results should appear only in the Discussion section, although, where appropriate, the two sections may be combined. Subheadings may be inserted in the main text, but these should not be numbered or lettered. The appropriate location for each table and illustration should be indicated. Simple chemical formulae or mathematical equations should be presented in a form that allows their reproduction in single horizontal lines of type; complicated chemical structures should be provided as line figures.

Latin species names should be in italics (or underlined in the manuscript) and written out in full only at first mention. Single-letter abbreviations may be used subsquently. The genus name should be in italics when referring to the whole genus but in roman (not underlined) when used trivially. Anglicised versions should be in roman with initial capitals. Strains should be designated by capital letters and numbers. *Drug names* should be given as generic names only, since trade names may vary from country to country.

References

References should be cited in the text by means of the author-date system. Where there are more than two authors, only the first author should be named, followed by et al. Where several references come together they should be arranged in date order: (Warburg 1949, Harrison et al. 1974, Theil Aisen 1987).

The references should be given in alphabetical order in a double-spaced list. Where there are more than six authors only the names and initials of the first three should be listed, followed by et al. Full publication details, including journal titles abbreviated according to Index Medicus, should be given as in the following examples:

Papers in press and personal communications:

Papers in press may be listed among the references with the journal name and tentative year of publication. Only papers which have been accepted for publication should be cites as "in press."

Personal communications should not be listed among the references and should be used only if permission for publication and verification of the wording of the citation have be obtained.

Responsibility for accuracy of references rest with the author.

Tables and Illustrations

Tables should be kept to a minimum and should not repeat information already in the text. Tables should be numbered consecutively with Arabic numbers and cited in the text. Each table should have a descriptive title and each column an appropriate heading, including units of measurement where relevant.

Line illustrations should be supplied as glossy prints or high-quality artwork and should allow for reduction to about 70% of their original size. Lettering on figures, should be kept to a minimum and explanations restricted to the legends. Half-tone illustrations should be supplied as sharp, wellcontrasted prints of a suitable size for reproduction without excessive enlargements or reduction.

Figure legends should provide only essential information and not repeat details in the text.

Copyright

Copyright in articles published in their journal is the property of Springer. Authors are responsible for obtaining permission to reproduce copyright material from other sources.

Proofs

Proofs will be sent to the corresponding author by e-mail (if no e-mail address is available or appears to be out of order, proofs will be sent by regular mail).

Your response, with or without corrections, should be sent within 72 hours. Please do not make any corrections to the PDF file.

Minor corrections (+/-10) should be sent as an e-mail attachment to: proofscorrection@springer.com. Always quote the four-letter journal code and article number and the DO No. from your proof in the subject field of your e-mail.

Extensive corrections must be clearly marked on a printout of the PDF file and should be sent by firstclass mail (airmail overseas).

Offprints

Fifty offprints of each article will be provided free of charge. Additional offprints (both hard copies and PDF files) can be ordered by means of an offprint order form supplied with the proofs.

Page Charges and Colour Figures

No page charges are levied on authors or their institutions except for colour pages. The author will be contacted regarding costs and invoicing if the manuscript includes colour figures.

Springer Open Choice
