Announcement and Call For Papers

The fifth Pharmaceutical Technology Conference (formerly the British Pharmaceutical Technology Conference) is to take place in the beautiful spa town of Harrogate, England in April 1986. A large number of original research and general industrial pharmaceutical papers will be presented at the Conference. The aim will be to review all modern aspects of pharmaceutical technology, including contemporary trends in dosage form design and solid dosage technology. Powder technology, bioavailability, pharmacokinetics, good manufacturing practice and drug stability will also be included. A number of plenary lectures by acknowledged international experts will be delivered at the conference and a full social program has been arranged.

Offers of Papers and/or Short Communications and Posters

Offers of papers or posters are invited for presentation at this established Conference. Manuscripts should be in the broad area of pharmaceutical technology and may deal with original research work or be of a general industrial pharmaceutical nature. Manuscripts will be accepted for:

(a) Presentation only at the Conference

OR

(b) Presentation at the Conference with consideration for publication in the International Journal DRUG DEVELOPMENT & INDUSTRIAL PHARMACY (immediately after the Conference).

All articles should include the title, the full name of the author(s) and the name of the research laboratory or institution. Authors

should also state under what category (a) or (b) they wish their manuscripts to be considered.

Closing Date

The closing date for summaries is November 1st 1985, final drafts by February 1st 1986. Summaries should not be longer than 1500 words and no special format is required.
