Submission of three copies of manuscripts, including figures, will expedite the review. *Publication Policy:* All papers will be reviewed for their technical merit, and decisions to publish will be made independently of an author's ability or willingness to pay charges. Voluntary page charges of \$70 per printed page will be requested for papers of five pages or less. Page charges of \$100 per page are mandatory for each page in excess of five printed pages. Also, the MTT-S Administrative Committee has established a quota for the number of pages printed in each issue of this *TRANSACTIONS* whose costs are not defrayed by payment of page charges. Papers not covered by page charges may be delayed until space in an issue is available. The Editor can waive the quota requirement for exceptional papers or because of other extenuating circumstances.
