Voluntary page charges of \$95 per printed page will be requested for papers of five pages or less. Page charges of \$100 per page are mandatory for each page in excess of five printed pages. Also, the MTT-S Administrative Committee has established a quota for the number of pages printed in each issue of this TRANSACTIONS whose costs are not defrayed by payment of page charges.
