

## INFORMATION FOR AUTHORS

### Submitting Manuscripts for Publication

Manuscripts for review should be submitted in pdf format as an email attachment to the Editor, David Rutledge, at **rutledge@caltech.edu**. The manuscript should be single-spaced with figures and captions included within the text. The maximum file size is 1MB. It is best to make the pdf file with a word-processing program. Figures should be easily viewed on a computer screen. Shading and color should be avoided for the reviewers who print the manuscripts. Use large lettering and label axes carefully. Fonts that might not be on reviewers' computers should be embedded in the pdf file. If you have difficulty making the file, please contact Dale Yee at **dale@caltech.edu**. Each manuscript must include an abstract of 200 words or less, and a short list of key words for indexing. The transmittal email should include the name, mailing address, FAX number, and telephone number for the corresponding author. Authors may suggest one or two reviewers. Please include their email addresses.

Manuscripts of more than 20 pages are likely to be returned without review. Papers are accepted as either full-length or short papers. Short papers describe extensions of previous work, new experimental results, or other material of limited scope. Letters are limited to comments on previously published material and errata. This TRANSACTIONS will consider papers that are related to material published in symposium digests only if the paper is substantially expanded over the symposium publication. The author must notify the editor at the time of submission if the paper contains material that has been previously published or submitted for publication.

### Final Manuscript

Upon final acceptance of the manuscript, the author must submit the final version of the manuscript in electronic form on floppy disks or CDs, clearly marked with operating system and software, together with two identical paper copies. For the final manuscript, the preferred word processors are TeX and LaTeX, but Word, WordPerfect, and other programs are acceptable, even though equations will be re-keyed into a TeX format at IEEE. Please note that pdf and Postscript are **not** acceptable formats for final manuscript submission to IEEE Periodicals. Figures, tables, and photos should be submitted in an electronic form (PostScript, EPS, TIFF) on separate floppy disks or CDs, or as hard copies in camera-ready form. Photos should be black-and-white glossies. Note that virtually all figures will be reduced to a width of 75 mm or less, and unless care is taken in their preparation, detail will be lost. Shading and color should be avoided. Figures should be similarly sized and drawn with dark lines. Use large lettering and label axes carefully. The final version must include a list of figure captions on a separate page. ### Copyright

It is the policy of the IEEE to own the copyright to the technical contributions it publishes. To comply with the IEEE copyright policy, authors are required to sign an IEEE Copyright Form before publication.

### Clearance of Manuscripts

The IEEE must assume that material submitted to its publications is available for general dissemination. It is the responsibility of the author, not the IEEE, to determine whether disclosure of the material requires prior consent of other parties and, if so, to obtain it.

### Page Charges

Papers will be reviewed for their technical merit, and decisions to publish will be made independently of an author's ability to pay page charges. Page charges of \$110 (U.S.) per printed page will be assessed on papers of five printed pages or less. Overlength page charges of \$200 per page are mandatory for each page in excess of five pages. If the author's organization agrees to honor the total page charge, which includes the page charges on the first five pages plus the mandatory overlength charge, the author will receive 100 reprints. If the supporting organization honors only the mandatory charge, no free preprints will be sent.
