CR-SUBMANIFOLDS OF A KAEHLER MANIFOLD. I

BANG-YEN CHEN

1. Introduction

Let \tilde{M} be a Kaehler manifold with complex structure J, N a Riemannian manifold isometrically immersed in \tilde{M} , and \mathfrak{D}_x the maximal holomorphic subspace of the tangent space T_xN of N. If the dimension of \mathfrak{D}_x is the same for all x in N, \mathfrak{D}_x gives a holomorphic distribution \mathfrak{D} on N.

Recently, A. Bejancu [1] introduced the notion of a CR-submanifold of \tilde{M} as follows. A submanifold N in a Kaehler manifold \tilde{M} is called a CR-submanifold if there exists on N a differentiable holomorphic distribution \mathfrak{D} such that its orthogonal complement \mathfrak{D}^{\perp} is a totally real distribution, i.e., $J\mathfrak{D}^{\perp}_{r} \subseteq T_{r}^{\perp}N$.

In this series of papers, we shall obtain some fundamental properties of *CR*-submanifolds in Kaehler manifolds.

2. Preliminaries

Let \tilde{M} be a complex *m*-dimensional Kaehler manifold with complex structure J, and N a real n-dimensional Riemannian manifold isometrically immersed in \tilde{M} . We denote by $\langle \ , \ \rangle$ the metric tensor of \tilde{M} as well as that induced on N. Let ∇ and $\tilde{\nabla}$ be the covariant differentiations on N and \tilde{M} , respectively. Then the Gauss and Weingarten formulas for N are given respectively by

(2.1)
$$\tilde{\nabla}_X Y = \nabla_X Y + \sigma(X, Y),$$

$$\tilde{\nabla}_X \xi = -A_{\xi} X + D_X \xi$$

for any vector fields X, Y tangent to N and any vector field ξ normal to N, where σ denotes the second fundamental form, and D the linear connection, called the normal connection, induced in the normal bundle $T^{\perp}N$. The second fundamental tensor A_{ξ} is related to σ by

$$\langle A_{\xi}X, Y \rangle = \langle \sigma(X, Y), \xi \rangle.$$

For any vector field X tangent to N, we put

$$(2.4) JX = PX + FX,$$

where PX and FX are the tangential and normal components of JX, respectively. Then P is an endomorphism of the tangent bundle TN, and F is a normal-bundle-valued 1-form on TN.

For any vector field ξ normal to N, we put

$$(2.5) J\xi = t\xi + f\xi,$$

where $t\xi$ and $f\xi$ are the tangential and normal components of $J\xi$, respectively. Then f is an endomorphism of the normal bundle $T^{\perp}N$, and t is a tangent-bundle-valued 1-form on $T^{\perp}N$.

A Kaehler manifold N is called a *complex-space-form* if it is of constant holomorphic sectional curvature. We denote by $\tilde{M}(c)$ (or $\tilde{M}^m(c)$) a complex m-dimensional complex-space-form of constant holomorphic sectional curvature c. Then the curvature tensor \tilde{R} of $\tilde{M}(c)$ is given by

(2.6)
$$\tilde{R}(X, Y)Z = \frac{c}{4} \{ \langle Y, Z \rangle X - \langle X, Z \rangle Y + \langle JY, Z \rangle JX - \langle JX, Z \rangle JY + 2\langle X, JY \rangle JZ \}$$

for any vector fields X, Y and Z tangent to $\tilde{M}(c)$. We denote the curvature tensors associated with ∇ and D by R and R^{\perp} respectively.

For the second fundamental form σ , we define the covariant differentiation $\overline{\nabla}$ with respect to the connection in $(TN) \oplus (T^{\perp}N)$ by

(2.7)
$$(\overline{\nabla}_X \sigma)(Y, Z) = D_X(\sigma(Y, Z)) - \sigma(\nabla_X Y, Z) - \sigma(Y, \nabla_X Z)$$

for any vector fields X, Y and Z tangent to N.

The equations of Gauss, Codazzi, and Ricci are then given respectively by [4]

(2.8)
$$R(X, Y; Z, W) = \widetilde{R}(X, Y; Z, W) + \langle \sigma(X, W), \sigma(Y, Z) \rangle - \langle \sigma(X, Z), \sigma(Y, W) \rangle.$$

(2.9)
$$(\tilde{R}(X, Y)Z)^{\perp} = (\overline{\nabla}_X \sigma)(Y, Z) - (\overline{\nabla}_Y \sigma)(X, Z),$$

$$\tilde{R}(X, Y; \xi, \eta) = R^{\perp}(X, Y; \xi, \eta) - \langle [A_{\xi}, A_{\eta}]X, Y \rangle,$$

where $R(X, Y; Z, W) = \langle R(X, Y)Z, W \rangle, \cdots$, etc., X, Y, Z, W are tangent to N, ξ and η are normal to N, and $^{\perp}$ in (2.9) denotes the normal component.

Definition 2.1. A submanifold N of Kaehler manifold \tilde{M} is called a CR-submanifold if there is a differentiable distribution $\mathfrak{D}: x \to \mathfrak{D}_x \subseteq T_x N$ on N satisfying the following conditions:

(a)
$$\mathfrak D$$
 is holomorphic, i.e., $J\mathfrak D_x=\mathfrak D_x$ for each $x\in N$, and

(b) the complementary orthogonal distribution $\mathfrak{D}^{\perp} \colon x \to \mathfrak{D}_{x}^{\perp} \subseteq T_{x}N$ is totally real, i.e., $J\mathfrak{D}_{x}^{\perp} \subset T_{n}^{\perp}N$ for each $x \in N$.

If dim $\mathfrak{D}_x^{\perp} = 0$ (respectively, dim $\mathfrak{D}_x = 0$), then the *CR*-submanifold *N* is a holomorphic submanifold [11] (respectively, totally real submanifold [8]). If dim $\mathfrak{D}_x^{\perp} = \dim T_x^{\perp} N$, then the *CR*-submanifold is an anti-holomorphic submanifold [3] (or generic submanifold [12]). A *CR*-submanifold is called a proper *CR*-submanifold if it is neither holomorphic nor totally real.

We shall always denote by h the complex dimension of \mathfrak{D}_x and by p the real dimension of \mathfrak{D}_x^{\perp} , i.e., $h = \dim_C \mathfrak{D}_x$ and $p = \dim_{\mathbf{R}} \mathfrak{D}_x^{\perp}$.

We denote by ν the complementary orthogonal subbundle of $J \mathfrak{D}^{\perp}$ in $T^{\perp}N$. Hence we have

$$(2.11) T^{\perp}N = J\mathfrak{N}^{\perp} \oplus \nu, \quad J\mathfrak{N}^{\perp} \perp \nu.$$

3. Some basic lemmas

In this section we shall give some basic lemmas for later use.

Let \tilde{M} be a Kaehler manifold. Then we have $\tilde{\nabla}J = 0$. If N is a CR-submanifold of \tilde{M} , then (2.1) and (2.2) give

(3.1)
$$J\nabla_{U}Z + J\sigma(U, Z) = -A_{JZ}U + D_{U}JZ$$

for U tangent to N and Z in \mathfrak{D}^{\perp} .

Lemma 3.1. Let N be a CR-submanifold of a Kaehler manifold \tilde{M} . Then we have

$$\langle \nabla_U Z, X \rangle = \langle J A_{JZ} U, X \rangle,$$

$$(3.3) A_{JZ}W = A_{JW}Z,$$

$$(3.4) A_{J\xi}X = -A_{\xi}JX,$$

for U tangent to N, X in \mathfrak{D} , Z and W in \mathfrak{D}^{\perp} , and ξ in ν .

Proof. (3.2) and (3.3) follow immediately from (3.1).

(3.4) follows from the fact that $\langle \sigma(JX, Y), \xi \rangle = \langle \tilde{\nabla}_Y JX, \xi \rangle = \langle J\sigma(X, Y), \xi \rangle$.

Lemma 3.2. Let N be a CR-submanifold of a Kaehler manifold \tilde{M} . Then for any Z, W in \mathfrak{D}^{\perp} we have

$$(3.5) D_{W}JZ - D_{Z}JW \in J \mathfrak{D}^{\perp}.$$

Proof. For any ξ in ν and Z, W in \mathfrak{D}^{\perp} , we have

$$\langle A_{J\xi}Z, W \rangle = -\langle \tilde{\nabla}_Z J\xi, W \rangle = \langle D_Z \xi, JW \rangle = -\langle \xi, D_Z JW \rangle.$$

Thus we obtain

$$\langle \xi, D_W J Z - D_Z J W \rangle = \langle A_{J \xi} Z, W \rangle - \langle A_{J \xi} W, Z \rangle = 0.$$

Since this is true for all ξ in ν , (3.5) holds.

From Lemma 3.1 it follows that we have $J[Z, W] = J(\nabla_Z W - \nabla_W Z) = D_Z J W - D_W J Z$. Thus by Lemma 3.2 we obtain

Lemma 3.3. The totally real distribution \mathfrak{I}^{\perp} of a CR-submanifold in a Kaehler manifold is integrable.

This theorem has been generalized to CR-submanifolds in a locally conformal almost Kaehler manifolds in [3].

For the holomorphic distribution n we have, [1], [3],

Lemma 3.4. Let N be a CR-submanifold of a Kaehler manifold \tilde{M} . Then $\mathfrak D$ is integrable if and only if

$$\langle \sigma(X, JY), JZ \rangle = \langle \sigma(JX, Y), JZ \rangle$$

for any vectors X, Y in \mathfrak{D} , and Z in \mathfrak{D}^{\perp} .

From (3.2) we obtain, [2],

Lemma 3.5. For a CR-submanifold N in a Kaehler manifold \tilde{M} , the leaf N^{\perp} of \mathfrak{D}^{\perp} is totally geodesic in N if and only if

$$\langle \sigma(\mathfrak{D}, \mathfrak{D}^{\perp}), J\mathfrak{D}^{\perp} \rangle = 0.$$

The following lemma can be obtained easily from Lemma 3.4.

Lemma 3.6. If (3.6) holds and \mathfrak{D} is integrable, then for any X in \mathfrak{D} and ξ in $J \mathfrak{D}^{\perp}$, we have

$$(3.7) A_{\xi}JX = -JA_{\xi}X.$$

Let P, F, t and f be the endomorphisms and vector-valued 1-forms defined by (2.4) and (2.5). Put

(3.8)
$$(\overline{\nabla}_U P) V = \nabla_U (PV) - P \nabla_U V,$$

(3.9)
$$(\overline{\nabla}_U F) V = D_U(FV) - F(\nabla_U V),$$

(3.10)
$$(\overline{\nabla}_U t) \xi = \nabla_U (t\xi) - t D_U \xi,$$

(3.11)
$$(\overline{\nabla}_U f) \xi = D_U (f \xi) - f D_U \xi$$

for U, V tangent to N, and ξ normal to N. Then the endomorphism P (respectively, endomorphism f, 1-forms F or t) is parallel if $\overline{\nabla}P = 0$ (respectively, $\overline{\nabla}f = 0$, $\overline{\nabla}F = 0$, or $\overline{\nabla}t = 0$).

From (2.1), (2.2) and (2.4) we obtain

(3.12)
$$(\overline{\nabla}_U P) V = t\sigma(U, V) + A_{FV} U.$$

4. CR-products in Kaehler manifolds

According to Lemma 3.3, every CR-submanifold N of a Kaehler manifold is foliated by totally real submanifolds. In 4-7 we shall study the problem

when a CR-submanifold N is a Riemannian product of a holomorphic submanifold and a totally real submanifold?

Definition 4.1. A CR-submanifold N of a Kaehler manifold \tilde{M} is called a CR-product if it is locally a Riemannian product of a holomorphic submanifold N^T and a totally real submanifold N^\perp of \tilde{M} .

First we give the following characterization of CR-products.

Theorem 4.1. A CR-submanifold of a Kaehler manifold \tilde{M} is a CR-product if and only if P is parallel, i.e., $\overline{\nabla} P = 0$.

Proof. If P is parallel, (3.12) gives

$$(4.1) t\sigma(U, V) = -A_{FV}U$$

for any vectors U, V tangent to N. In particular, if $X \in \mathfrak{D}$, then FX = 0. Hence (4.1) implies $t\sigma(U, X) = 0$, i.e.,

$$(4.2) A_{JZ}X \equiv 0,$$

for any Z in \mathfrak{D}^{\perp} , and X in \mathfrak{D} . Thus by Lemmas 3.4 and 3.5 we know that \mathfrak{D} is integrable and the leaf N^{\perp} of \mathfrak{D}^{\perp} is totally geodesic in N. Let N^{T} be a leaf of \mathfrak{D} . For any X, Y in \mathfrak{D} , and Z in \mathfrak{D}^{\perp} , (4.2) and Lemma 3.1 give

$$0 = \langle A_{JZ}Y, X \rangle = \langle JA_{JZ}Y, JX \rangle = \langle \nabla_Y Z, JX \rangle = -\langle Z, \nabla_Y JX \rangle.$$

From this we may conclude that N^T is totally geodesic in N, and N is a CR-product in \tilde{M} .

Conversely, if N is a CR-product, then $\nabla_U Y \in \mathfrak{N}$ for any Y in \mathfrak{N} and U tangent to N. Thus by (2.1) and (2.2), we may obtain $J\sigma(U,Y) = \sigma(U,JY)$. From this, together with (2.1) and (3.8), we may prove that $(\overline{\nabla}_U P)Y = 0$. Similarly, from $\nabla_U Z \in \mathfrak{N}^\perp$ for any Z in \mathfrak{N}^\perp and U tangent to N, we may also prove that $(\overline{\nabla}_U P)Z = 0$.

From the proof of Theorem 4.1 we have the following.

Lemma 4.2. A CR-submanifold N in a Kaehler manifold \tilde{M} is a CR-product if and only if $A_{I \oplus 1} = 0$.

Remark 4.1. In [2] Bejancu-Kon-Yano proved that if N is an anti-holomorphic submanifold and $\overline{\nabla} P = 0$, then N is a CR-product.

Lemma 4.3. Let N be a CR-product of a Kaehler manifold \tilde{M} . Then for any unit vectors X in $\mathfrak D$ and Z in $\mathfrak D^{\perp}$ we have

$$\tilde{H}_B(X, Z) = 2\|\sigma(X, Z)\|^2,$$

where $\tilde{H}_B(X, Z) = \tilde{R}(X, JX; JZ, Z)$ is the holomorphic bisectional curvature of $X \wedge Z$.

Proof. Let N be a CR-product in \tilde{M} . Then we have (4.2) for any Z in \mathfrak{D}^{\perp} and X in \mathfrak{D} . Thus by equation (2.9) of Codazzi we obtain

(4.3)
$$\tilde{R}(X, JX; Z, JZ) = \langle D_X \sigma(JX, Z) - D_{JX} \sigma(X, Z), JZ \rangle,$$

where we have used the fact that N^T is totally geodesic in N. Since $\langle \sigma(\mathfrak{D}, \mathfrak{D}^{\perp}), J\mathfrak{D}^{\perp} \rangle = 0$, (4.2) and (4.3) imply

$$\tilde{R}(X, JX; Z, JZ) = \langle \sigma(X, Z), D_{JX}JZ \rangle - \langle \sigma(JX, Z), D_{X}JZ \rangle
(4.4) = \langle \sigma(X, Z), J\tilde{\nabla}_{JX}Z \rangle - \langle \sigma(JX, Z), J\tilde{\nabla}_{X}Z \rangle
= \langle \sigma(X, Z), J\sigma(JX, Z) \rangle - \langle \sigma(JX, Z), J\sigma(X, Z) \rangle.$$

Thus by (4.2) and Lemma 3.6 we obtain the lemma.

Theorem 4.4. Let \tilde{M} be a Kaehler manifold with negative holomorphic bisectional curvature. Then every CR-product in \tilde{M} is either a holomorphic submanifold or a totally real submanifold. In particular, there exists no proper CR-product in any complex hyperbolic space $\tilde{M}^m(c)$ (c < 0).

Corollary 4.5. Let \tilde{M}^m be a Kaehler manifold with $\tilde{H}_B > 0$, and N a proper CR-product in \tilde{M} . Then (1) N is not an anti-holomorphic submanifold, and (2) $\sigma(\mathfrak{P}, \mathfrak{P}^\perp) \neq 0$; hence N is not totally geodesic in \tilde{M} .

Theorem 4.4 and Corollary 4.5 follow immediately from Lemma 4.3.

Theorem 4.6. Every CR-product N in \mathbb{C}^m is the Riemannian product of a holomorphic submanifold in a linear complex subspace \mathbb{C}^N and a totally real submanifold of a \mathbb{C}^{m-N} locally, i.e.,

$$N = N^T \times N^{\perp} \subset \mathbb{C}^N \times \mathbb{C}^{m-N} = \mathbb{C}^m.$$

Proof. Since N is a CR-product in \mathbb{C}^m , Lemma 4.3 implies

$$\sigma(\mathfrak{D},\,\mathfrak{D}^{\perp})=0.$$

Thus by applying a lemma of Moore [10] we see that $N = N^T \times N^{\perp}$ is a product submanifolds in $\mathbb{R}^r \times \mathbb{R}^{2m-r}$. Since N^T is a holomorphic submanifold of \mathbb{C}^m , we may choose \mathbb{R}^r to be a complex linear subspace of \mathbb{C}^m .

5. Standard CR-products

In this section we shall derive the smallest codimension of CR-product in complex projective spaces and classify CR-product in complex projective spaces with smallest codimension.

First we shall give examples of CR-products in $\mathbb{C}P^m$. Let $\mathbb{C}P^m$ denote the complex m-dimensional complex projective space with constant holomorphic sectional curvature 4. We define a mapping

$$S_{hp}: \mathbb{C}P^h \times \mathbb{C}P^p \to \mathbb{C}P^{h+p+hp}$$

by

$$(z_0, \cdots, z_h; \eta_0, \cdots, \eta_p) \rightarrow (z_0, \eta_0, \cdots, z_i, \eta_i, \cdots, z_h, \eta_p),$$

where (z_0, \dots, z_h) (respectively, (η_0, \dots, η_p)) are the homogeneous coordinates of $\mathbb{C}P^h$ (respectively, $\mathbb{C}P^p$). It is easy to see that $S_{h,p}$ is a Kaehler

imbedding of the Riemannian product $\mathbb{C}P^h \times \mathbb{C}P^p$ into $\mathbb{C}P^{h+p+hp}$. Let N^\perp be a p-dimensional totally real submanifold of $\mathbb{C}P^p$. Then $\mathbb{C}P^h \times N^\perp$ induced a natural CR-product in $\mathbb{C}P^{h+p+hp}$ via $S_{h,p}$, in which $N^T = \mathbb{C}P^h$ is a totally geodesic submanifold, and N^\perp is a totally real submanifold of $\mathbb{C}P^{h+p+hp}$.

Definition 5.1. A CR-product $N = N^T \times N^{\perp}$ in $\mathbb{C}P^m$ is called a *standard CR-product* if

- (1) m = h + p + hp and
- (2) N^T is a totally geodesic holomorphic submanifold of $\mathbb{C}P^m$, where $h = \dim_{\mathbb{C}} \mathfrak{D}_x$ and $p = \dim_{\mathbb{R}} \mathfrak{D}_x^{\perp}$.

We shall prove that m = h + p + hp is in fact the smallest dimension of $\mathbb{C}P^m$ for admitting a $\mathbb{C}R$ -product. First we shall prove the following lemma.

Lemma 5.1. Let N be a CR-product in CP^m . Then

$$\{\sigma(X_i, Z_\alpha)\}\ i=1,\cdots,2h, \alpha=1,\cdots,p$$

are orthonormal vectors in v $(T^{\perp}N = J \mathfrak{D}^{\perp} \oplus v)$, where X_1, \dots, X_{2h} and Z_1, \dots, Z_n are orthonormal bases for \mathfrak{D}_x and \mathfrak{D}_x^{\perp} respectively.

Proof. Since $\mathbb{C}P^m$ is of constant holomorphic sectional curvature 4 and N is a $\mathbb{C}R$ -product, Lemma 4.2 gives

(5.2)
$$\|\sigma(X, Z)\| = 1$$
,

for any unit vector X in $\mathfrak D$ and Z in $\mathfrak D^{\perp}$. Hence we may obtain by linearity that

(5.3)
$$\langle \sigma(X_i, Z), \sigma(X_j, Z) \rangle = 0, \quad i \neq j.$$

Moreover, by Lemma 4.2 we see that $\sigma(X, Z)$ is a normal vector in ν . Hence, if $\dim_{\mathbb{R}} \mathfrak{D}_{x}^{\perp} = 1$, the lemma is proved.

If $\dim_{\mathbf{R}} \mathfrak{D}_x^{\perp} = p \ge 2$, then from (5.3) it follows that

$$(5.4) \qquad \langle \sigma(X_i, Z_\alpha), \sigma(X_i, Z_\beta) \rangle + \langle \sigma(X_i, Z_\beta), \sigma(X_i, Z_\alpha) \rangle = 0$$

for $i \neq j$, $\alpha \neq \beta$.

On the other hand, because $N = N^T \times N^{\perp}$ is a CR-product, we have

$$(5.5) R(X_i, X_j; Z_{\alpha}, Z_{\beta}) = 0.$$

Moreover, by Theorem 6.1 of [3] we obtain

(5.6)
$$\tilde{R}(X_i, X_i; Z_\alpha, Z_\beta) = 0.$$

Therefore by (2.8), (5.5) and (5.6) we get

$$(5.7) \qquad \langle \sigma(X_i, Z_{\alpha}), \sigma(X_j, Z_{\beta}) \rangle = \langle \sigma(X_i, Z_{\beta}), \sigma(X_j, Z_{\alpha}) \rangle.$$

Combining (5.4) with (5.7) gives the lemma.

As immediate consequence of Lemma 5.1 we obtain the following.

Theorem 5.2. Let N be a CR-product in CP^m . Then

$$(5.8) m \geqslant h + p + hp.$$

Remark 5.1. Since the standard CR-products in CP^m satisfies the equality sign of (5.8). The estimate of m given in (5.8) is best possible.

The following result seem to be remarkable.

Theorem 5.3. Every CR-product N in $\mathbb{C}P^m$ with m = h + p + hp is a standard CR-product.

Proof. Let N be a CR-product in $\mathbb{C}P^m$ with m = h + p + hp. Then for any X, Y, Z in \mathfrak{D} and W in \mathfrak{D}^{\perp} we have, from (2.8),

$$(5.9) \quad 0 = \tilde{R}(X, Y; Z, W) + \langle \sigma(X, W), \sigma(Y, Z) \rangle - \langle \sigma(X, Z), \sigma(Y, W) \rangle.$$

On the other hand, by (2.6) we obtain

$$\tilde{R}(X, Y; Z, W) = 0.$$

Thus (5.9) gives

$$(5.10) \qquad \langle \sigma(X, W), \sigma(Y, Z) \rangle = \langle \sigma(X, Z), \sigma(Y, W) \rangle.$$

In particular, if Y = JX, then Lemmas 3.1, 3.6, 4.2, and (5.10) imply

(5.11)
$$\langle \sigma(X, Z), \sigma(JX, W) \rangle = \langle \sigma(JX, Z), \sigma(X, W) \rangle$$

$$= \langle J\sigma(X, Z), \sigma(X, W) \rangle$$

$$= -\langle \sigma(X, Z), \sigma(JX, W) \rangle,$$

from which we get

$$\langle \sigma(X, Z), \sigma(JX, W) \rangle = 0.$$

Combining (5.11) with (5.12) yields

$$\langle \sigma(X, Z), \sigma(X, W) \rangle = 0$$

for any X, Z in \mathfrak{D} and W in \mathfrak{D}^{\perp} . Thus by linearity we have

$$\langle \sigma(X, Z), \sigma(Y, W) \rangle + \langle \sigma(Y, Z), \sigma(X, W) \rangle = 0.$$

Combining this with (5.10), we obtain, for any X, Y, Z in \mathfrak{D} and W in \mathfrak{D}^{\perp} ,

(5.13)
$$\langle \sigma(X, Z), \sigma(Y, W) \rangle = 0.$$

Now since m = h + p + hp, Lemma 5.1 and (5.13) show that $\sigma(X, Z)$ lies in $J \mathfrak{D}^{\perp}$ for any X, Z in \mathfrak{D} . On the other hand, Lemma 4.2 shows that $\sigma(X, Z)$ must lie in ν . Consequently, we have $\sigma(\mathfrak{D}, \mathfrak{D}) = 0$. Therefore by the fact that N is a CR-product, N^T must be totally geodesic in N. Thus N is totally geodesic in CP^m .

As an immediate consequence of Theorem 5.3 we have the following.

Theorem 5.4. Let $M=M_1\times M_2$ be the Riemannian product of two Kaehler manifolds with $\dim_{\mathbf{C}} M_1=h$ and $\dim_{\mathbf{C}} M_2=p$. Then $M_1\times M_2$ admits a Kaehler immersion in ${\mathbf{C}} P^{h+p+hp}$ if and only if both M_1 and M_2 are

complex-space-forms of constant holomorphic sectional curvature 4. Moreover h + p + hp is the smallest dimension of $\mathbb{C}P^m$ which admits such Kaehler immersions, and M_1 and M_2 are both totally geodesic in $\mathbb{C}P^m$, and any such immersion is obtained by the Segre imbedding.

6. Length of second fundamental form

The main purpose of this section is to prove the following.

Theorem 6.1. Let N be a CR-product in $\mathbb{C}P^m$. Then we have

where $h = \dim_{\mathbb{C}} \mathfrak{D}_x$ and $p = \dim_{\mathbb{R}} \mathfrak{D}_x^{\perp}$. If the equality sign of (6.1) holds, then N^T and N^{\perp} are both totally geodesic in $\mathbb{C}P^m$. Moreover, the immersion is rigid. In this case N^T is a complex-space-form of constant holomorphic sectional curvature 4, and N^{\perp} is a real-space-form of constant sectional curvature 1.

Proof. Since $\mathbb{C}P^m$ is of constant holomorphic sectional curvature 4 and N is a CR-product, Lemma 4.3 gives

(6.2)
$$||\sigma(X, Z)|| = 1$$

for any unit vectors X in \mathfrak{D} and Z in \mathfrak{D}^{\perp} . Thus we have

(6.3)
$$\|\sigma\|^2 = 4hp + \sum_{A,B=1}^{2h} \|\sigma(X_A, X_B)\|^2 + \sum_{\alpha,\beta=1}^p \|\sigma(Z_\alpha, Z_\beta)\|^2,$$

where $\{X_1, \dots, X_{2h}\}$ (respectively, $\{Z_1, \dots, Z_p\}$) is an orthonormal basis of \mathfrak{D} (respectively, \mathfrak{D}^{\perp}). From (6.3) we obtain (6.1).

If the equality sign of (6.1) holds, (6.3) implies

(6.4)
$$h(\mathfrak{D}, \mathfrak{D}) = 0$$
 and $h(\mathfrak{D}^{\perp}, \mathfrak{D}^{\perp}) = 0$.

Since N^T and N^\perp are both totally geodesic in N, (6.4) implies that N^T and N^\perp are both totally geodesic in $\mathbb{C}P^m$. Consequently, equation (2.8) of Gauss shows that N^T is a complex-space-form of constant holomorphic sectional curvature 4, and N^\perp is a real-space-form of constant sectional curvature 1.

Now we shall prove that the immersion is rigid if $\|\sigma\|^2 = 4hp$.

Since $N = N^T \times N^\perp$ is a Riemannian product of N^T and N^\perp , we may assume that $\{X_1, \dots, X_h, JX_1, \dots, JX_h\}$ is an orthonormal basis of \mathfrak{D} such that $X_1, \dots, X_h, JX_1, \dots, JX_h$ are parallel along \mathfrak{D}^\perp , and $\{Z_1, \dots, Z_p\}$ is an orthonormal basis of \mathfrak{D}^\perp , which are parallel along \mathfrak{D} . Thus we have

(6.5)
$$\nabla_{X_A} Z_\alpha = 0, \ \nabla_{Z_\alpha} X_A = 0, A, B, C, \dots = 1, \dots, 2h; \ \alpha, \beta, \gamma = 1, \dots, p,$$

where $X_{h+i} = JX_i$, $i = 1, \dots, h$. If we put

(6.6)
$$\xi_{(A,\alpha)} = \sigma(X_A, Z_\alpha),$$

then Lemma 5.1 implies that

(6.7)
$$JZ_{\alpha}, \, \xi_{(A,\beta)}, \quad \alpha, \, \beta = 1, \, \cdots, \, p; \, A = 1, \, \cdots, \, 2h,$$

are orthonormal vectors in $T^{\perp}N$. Let

$$\mu = \operatorname{Span}\{\xi_{(A,\alpha)}|A=1,\cdots,2h; \alpha=1,\cdots,p\}.$$

Then μ_x , $x \in N$, is a 2hp-dimensional linear subspace of ν_x .

Denote by μ_x^{\perp} the complementary orthogonal subspace of μ_x in ν_x . Then

$$T^{\perp}N = J \mathfrak{D}^{\perp} \oplus \mu \oplus \mu^{\perp},$$

where $J \mathfrak{D}^{\perp}$, μ and μ^{\perp} are mutually orthogonal.

From Lemma 4.2, (6.4) and (6.6) it follows that

(6.8)
$$\operatorname{Im} \sigma = \mu,$$

and $TN \oplus J \mathfrak{D}^{\perp} \oplus \mu$ is a complex vector bundle over N.

We prove the following lemmas.

Lemma 6.2. $J \mathfrak{D}^{\perp} \oplus \mu$ is a parallel normal subbundle, i.e., $D_U \xi \in J \mathfrak{D}^{\perp} \oplus \mu$ for any U in TN and any ξ in $J \mathfrak{D}^{\perp} \oplus \mu$.

Proof. Let U be any vector in TN, Z in \mathfrak{D} and η in μ^{\perp} . Then (6.8) implies

$$0 = \langle \sigma(U, Z), \eta \rangle = \langle \tilde{\nabla}_{U} J Z, J \eta \rangle = \langle D_{U} J Z, J \eta \rangle.$$

Hence

$$(6.9) D_U(J^{\mathfrak{N}^{\perp}}) \subseteq J^{\mathfrak{N}^{\perp}} \oplus \mu,$$

for any U tangent to N.

From (2.6), (2.9), (6.6) and (6.8) we have

$$0 = \tilde{R}(X_A, Z_\alpha; Z_\beta, \eta) = -\langle D_{Z_\alpha} \xi_{(A,\beta)}, \eta \rangle,$$

$$0 = \tilde{R}(X_A, Z_\alpha; X_B, \eta) = \langle D_{X_A} \xi_{(B,\alpha)}, \eta \rangle.$$

Consequently, we have $D_U \mu \subseteq J \mathfrak{D}^{\perp} \oplus \mu$, which together with (6.9) gives the lemma.

Combining (6.8) with Lemma 6.2 we may conclude that N is in fact lies in a totally geodesic $\mathbb{C}P^{h+p+hp}$ of $\mathbb{C}P^m$.

Now we put

(6.10)
$$\nabla_{X_A} X_B = \sum_{\alpha} \Gamma_{AB}^C X_C, \nabla_{Z_{\alpha}} Z_{\beta} = \sum_{\alpha} \Gamma_{\alpha\beta}^{\gamma} Z_{\gamma}.$$

Then from (2.9), (6.4), (6.5), (6.6) and (6.8) we have that

$$0 = \tilde{R}(X_A, Z_\alpha; Z_\beta, \xi_{(\beta, \gamma)})$$

= $\langle \sigma(X_A, \nabla_{Z_\alpha} Z_\beta) - D_{Z_\alpha} \xi_{(A, \beta)}, \xi_{(B, \gamma)} \rangle$,

which implies that

(6.11)
$$\langle D_{Z_{\alpha}} \xi_{(A,\beta)}, \xi_{(B,\gamma)} \rangle = \Gamma_{\alpha\beta}^{\gamma} \delta_{AB}.$$

Similarly, by considering $\tilde{R}(Z_{\alpha}, X_A; X_B, \xi_{(C,\beta)})$, $\tilde{R}(X_A, Z_{\alpha}; Z_{\beta}, JZ_{\gamma})$, and $\tilde{R}(Z_{\alpha}, X_A; X_B, JZ_{\beta})$, respectively, we obtain

(6.12)
$$\langle D_{X_{A}}\xi_{(B,\alpha)}, \xi_{(C,\beta)}\rangle = \Gamma_{AB}^{C}\delta_{\alpha\beta},$$

$$\langle D_{Z_{\alpha}}\xi_{(A,\beta)}, JZ_{\gamma} \rangle = 0,$$

(6.14)
$$\langle D_{X_A} \xi_{(B,\alpha)}, JZ_{\beta} \rangle = \langle X_A, JX_B \rangle \delta_{\alpha\beta}.$$

Moreover, from (6.8) it follows that

$$(6.15) D_U J Z_{\alpha} = J \tilde{\nabla}_U Z_{\alpha} = J \nabla_U Z_{\alpha} + J \sigma(U, Z_{\alpha}).$$

Since $N = N^T \times N^{\perp}$ is a CR-product of a complex-space-form N^T of constant holomorphic sectional curvature 4 and a real-space-form N^{\perp} of constant sectional curvature 1, the Riemannian structure of N is completely determined. From (6.4), (6.6), and (6.8), the second fundamental form of N in CP^m is also determined completely. Moreover, from (6.11)–(6.15) and Lemma 6.2, we see that the normal connection D on $T^{\perp}N$ is also completely determined. Hence the immersion is rigid.

Remark 6.1. Let $\mathbb{R}P^p$ be a totally geodesic, totally real submanifold of $\mathbb{C}P^p$. Then the composition of the immersions

$$\mathbb{C}P^h \times \mathbb{R}P^p \to \mathbb{C}P^h \times \mathbb{C}P^p \xrightarrow{S_{h,p}} \mathbb{C}P^{h+p+hp} \to \mathbb{C}P^m$$

gives a CR-product in $\mathbb{C}P^m$ with $\|\sigma\|^2 = 4hp$. Theorem 6.1 tells us that it is in fact the only CR-product in $\mathbb{C}P^m$ with $\|\sigma\|^2 = 4hp$.

As a consequence of Theorem 6.1, we have

Corollary 6.2. If N is a minimal CR-product in $\mathbb{C}P^m$, then the scalar curvature ρ of N satisfies

$$(6.16) \rho \leq 4h^2 + 4h + p^2 - p,$$

where the equality sign holds if and only if $\|\sigma\|^2 = 4hp$.

Proof. Since N is a minimal CR-product, the Ricci tensor S of N satisfies

$$S(X, X) = (2h + p + 2)||X||^2 - \sum ||A_{\xi}X||^2, \quad X \in \mathcal{D},$$

$$S(Z, Z) = 2h + p - 1 - \sum ||A_{\xi}Z||^2, \quad Z \in \mathcal{D}^{\perp},$$

which imply that

(6.17)
$$\rho = 4h^2 + 4h + p^2 - p - ||\sigma||^2 + 4hp.$$

Combining (6.1) with (6.17) we obtain (6.16). It is clear that the equality sign of (6.16) holds if and only if $\|\sigma\| = 4hp$.

7. CR-products in Hermitian symmetric spaces

First we give the following.

Lemma 7.1. Let \tilde{M}^m be a nonpositively curved Kaehler manifold, and N a CR-product in \tilde{M}^m . If N is anti-holomorphic, then

(1) the Ricci tensors of \tilde{M} and N^T satisfy

(7.1)
$$\tilde{S}(X, Y) = S^{T}(X, Y)$$

for any vectors X, Y tangent to N^T , and

(2) N^T is totally geodesic in \tilde{M}^m .

Proof. Since N is a CR-product and \tilde{M} is nonpositively curved, Lemma 4.3 implies

(7.2)
$$\tilde{K}(X,Z) = \tilde{K}(X,JZ) = \sigma(X,Z) = 0$$

for any X in $\mathfrak D$ and Z in $\mathfrak D^\perp$. On the other hand, since N is anti-holomorphic, Lemma 4.2 gives

$$(7.3) \sigma(\mathfrak{D}, \mathfrak{D}) = 0.$$

Thus N^T is a totally geodesic submanifold of \tilde{M} . Consequently, we have

(7.4)
$$\tilde{K}(X, Y) = K^{T}(X, Y).$$

for any orthonormal vectors X, Y tangent to N^T , where K^T denotes the sectional curvature of N^T . Combining (7.2) with (7.4), we obtain (7.1).

Theorem 7.2. Let \tilde{M}^m be a Hermitian symmetric space of noncompact type, and N a complete CR-product in \tilde{M}^m . If N is anti-holomorphic, then

- (1) N^T is also a Hermitian symmetric space of noncompact type.
- (2) there exists another Hermitian symmetric space M^{\perp} of noncompact type such that
 - (2a) \tilde{M} is the Riemannian product of N^T and M^{\perp} , and
 - (2b) N^T is a totally real submanifold of M^{\perp} .

Proof. Since \tilde{M}^m is a Hermitian symmetric space of noncompact type, \tilde{M}^m is nonpositively curved [9]. By Lemma 7.1, we have (7.1) and N^T is totally geodesic in \tilde{M}^m . Hence from equation (2.8) of Gauss we have

$$(7.5) S^{T}(X,X) = \tilde{S}(X,X) - \sum_{\alpha=1}^{p} \left\{ \tilde{R}(Z_{\alpha},X;X,Z_{\alpha}) + \tilde{R}(JZ_{\alpha},X;X,JZ_{\alpha}) \right\}$$

for any orthonormal basis $Z_1, \dots, Z_p, JZ_1, \dots, JZ_p$ of $T^{\perp}N^T$ in \tilde{M}^m . Since (7.1) holds and \tilde{M} is nonpositively curved, (7.5) implies

(7.6)
$$\tilde{K}(X,Z) = \tilde{K}(X,JZ) = 0,$$

for any X in TN^T and Z in $T^{\perp}N^T$. From these we may obtain the theorem by using the same argument as we gave in the last part of the proof of Theorem 1 of [5].

As an immediate consequence of Theorem 7.2 we have the following.

Theorem 7.3. Let \tilde{M}^m be an irreducible Hermitian symmetric space of noncompact type. If \tilde{M}^m admits a proper CR-product N, then N is not anti-holomorphic.

Remark 7.1. Although the complex hyperbolic space admits no proper CR-product (Theorem 4.3), other irreducible Hermitian symmetric spaces of noncompact type admit CR-products in general (see, Chen-Nagano [7]). For example, the rank 2 irreducible Hermitian symmetric space $SU(2, m)/S(U_2 \times U_m)$, admits a proper CR-product N for any $h = \dim_{\mathbb{C}} \mathfrak{P}$ satisfying 0 < h < m.

8. CR-submanifolds with $\overline{\nabla} F = 0$

Let N be a CR-submanifold in a Kaehler manifold \tilde{M} . Then it associates a canonical normal-bundle-valued 1-form F on TN and a tangent-bundle-valued 1-form t on $T^{\perp}N$. In this section we shall classify CR-submanifolds with parallel F (or t).

Lemma 8.1. For any vectors U, V tangent to N and ξ normal to N, we have

(8.1)
$$(\overline{\nabla}_U t) \xi = A_{f\xi} U - P A_{\xi} U,$$

(8.2)
$$(\overline{\nabla}_{U}f)\xi = -FA_{\xi}U - \sigma(U, t\xi),$$

(8.3)
$$(\overline{\nabla}_{U}F)V = f\sigma(U, V) - \sigma(U, PV).$$

Proof. From (2.1) and (2.2), we have

(8.4)
$$\tilde{\nabla}_{U}J\xi = \tilde{\nabla}_{U}t\xi + \tilde{\nabla}_{U}f\xi = \nabla_{U}t\xi + \sigma(U, t\xi) - A_{f\xi}U + D_{U}f\xi$$

$$= J\tilde{\nabla}_{U}\xi = -PA_{\xi}U - FA_{\xi}U + tD_{U}\xi + fD_{U}\xi.$$

Comparing the tangential and normal components of both sides of (8.4) yields

(8.5)
$$\nabla_{U}(t\xi) - tD_{U}\xi = A_{f\xi}U - PA_{\xi}U,$$

(8.6)
$$D_U f \xi - f D_U \xi = -F A_{\xi} U - \sigma(U, t \xi).$$

Since the left-hand sides of (8.5) and (8.6) are nothing but $(\overline{\nabla}_U t)\xi$ and $(\overline{\nabla}_U t)\xi$, respectively, we have (8.1) and (8.2).

Similarly, for any U, V tangent to N, (2.1) and (2.2) give

$$\begin{split} \tilde{\nabla}_{U}JV &= \nabla_{U}PV + \sigma(U,PV) - A_{FV}U + D_{U}FV \\ &= P\nabla_{U}V + F\nabla_{U}V + t\sigma(U,V) + f\sigma(U,V). \end{split}$$

Thus

$$D_U FV - F(\nabla_U V) = f\sigma(U, V) - \sigma(U, PV),$$

which is nothing but (8.3).

Proposition 8.2. Let N be a CR-submanifold of a Kaehler manifold \tilde{M} . Then $\overline{\nabla} F = 0$ if and only if $\overline{\nabla} t = 0$.

Proof. From Lemma 8.1, we see that $\overline{\nabla}t = 0$ if and only if, for any U, V tangent to N, ξ normal to N,

$$\langle A_{f\xi}U,V\rangle = \langle PA_{\xi}U,V\rangle,$$

i.e.,

$$\langle \sigma(U, V), J\xi \rangle = -\langle \sigma(U, PV), \xi \rangle,$$

which is equivalent to

$$\sigma(U, PV) = f\sigma(U, V)$$
, i. e., $\overline{\nabla} F = 0$.

Lemma 8.3. Let N be a CR-submanifold in a Kaehler manifold. Then $\overline{\nabla} F = 0$ if and only if

- (1) N is a CR-product, and
- (2) $A_{\nu} \mathfrak{D}^{\perp} = 0$.

Proof. By Lemma 8.1, $\overline{\nabla}F = 0$ if and only if

(8.7)
$$\sigma(U, PV) = f\sigma(U, V).$$

Thus for any Z in \mathfrak{D}^{\perp} we have $f\sigma(U, Z) = 0$, which is equivalent to (2). Moreover, for any X in \mathfrak{D} , (8.7) gives

$$\sigma(U,JX) = f\sigma(U,X) \in \nu.$$

Thus $A_{J \oplus^{\perp}} \mathfrak{D} = 0$. Consequently by Lemma 4.2, N is a CR-product. Conversely, if $A_{J \oplus^{\perp}} \mathfrak{D} = 0$ and $A_{\mathfrak{p}} \mathfrak{D}^{\perp} = 0$, then (8.7) holds by Lemma 3.6.

Lemma 8.4. Let N be a CR-submanifold in a Kaehler manifold. If $\overline{\nabla} F = 0$, then

(8.8)
$$\tilde{H}_{\mathbf{B}}(\mathfrak{D}, \mathfrak{D}^{\perp}) = 0,$$

(8.9)
$$\sigma(\mathfrak{D}, \mathfrak{D}^{\perp}) = 0.$$

Proof. (8.9) follows from Lemmas 4.2 and 8.3, and (8.8) from Lemmas 4.3 and (8.9).

From Theorem 4.6 and Lemma 8.4 we obtain the following.

Theorem 8.5. Let N be a proper CR-submanifold in a complete simply-connected complex-space-form $\tilde{M}^m(c)$. If $\overline{\nabla} F = 0$, then c = 0, i.e., $\tilde{M}^m(c) = \mathbb{C}^m$. Moreover, N is the Riemannian product of a holomorphic submanifold N^T of a \mathbb{C}^{m-p} and a totally real submanifold N^\perp of a \mathbb{C}^p locally, where $p = \dim_{\mathbb{R}} N^\perp$.

Proof. From Lemma 8.4 it follows that $\tilde{M}^m(c)$ is \mathbb{C}^m . Thus by Theorem 4.6 we see that N is the Riemannian product of a holomorphic submanifold N^T in a \mathbb{C}^N and a totally real submanifold in a \mathbb{C}^{m-N} locally.

Using Lemma 8.3 and the fact that N^{\perp} is totally geodesic in N, we obtain from Theorem 2 of [6] that N^{\perp} is in fact lies in a complex p-dimensional linear complex subspace \mathbb{C}^p of \mathbb{C}^m as a totally real submanifold.

Remark 8.1. Let N^T be a holomorphic submanifold of a Kaehler manifold M^T , and N^{\perp} a totally real submanifold of a Kaehler manifold M^{\perp} . Then it is easy to verify that $N = N^T \times N^{\perp}$ is a CR-submanifold in $\tilde{M} = M^T \times M^{\perp}$ with $\overline{\nabla} F = 0$. From this we may conclude that the rank-2 irreducible Hermitian symmetric spaces $SU(2, m)/S(U_2 \times U_m)$ and $SU(2+m)/S(U_2 \times U_m)$ both admit proper CR-submanifolds with $\overline{\nabla} F = 0$.

Remark 8.2. From (8.2) it is easy to see that a proper CR-submanifold N satisfies $\overline{\nabla} f = 0$ if and only if $J \mathfrak{D}^{\perp}$ is parallel (or $A_{\bullet} \mathfrak{D}^{\perp} = 0$).

9. Mixed foliate CR-submanifolds

Definition 9.1. A CR-submanifold N in a Kaehler manifold is said to be mixed foliate if

- (1) n is integrable and
- $(2) \sigma(\mathfrak{N}, \mathfrak{N}^{\perp}) = 0.$

Lemma 9.1. Let N be a mixed foliate CR-submanifold in a Kaehler manifold \tilde{M} . Then for any unit vectors X in \mathfrak{D} and Z in \mathfrak{D}^{\perp} we have

(9.1)
$$\tilde{H}_{B}(X, Z) = -2||A_{JZ}X||^{2}.$$

Proof. If N is mixed foliate CR-submanifold, then

$$(9.2) \sigma(\mathfrak{D}, \mathfrak{D}^{\perp}) = 0, [\mathfrak{D}, \mathfrak{D}] \subset \mathfrak{D}, \sigma(X, JY) = \sigma(JX, Y)$$

for any X, Y in \mathfrak{D} . Thus for any X in \mathfrak{D} and Z in \mathfrak{D}^{\perp} , the equation of Codazzi gives

$$\begin{split} \tilde{H}_{B}(X,Z) &= \langle \sigma(JX, \nabla_{X}Z), JZ \rangle - \langle \sigma(X, \nabla_{JX}Z), JZ \rangle. \\ &= \langle A_{JZ}JX, \nabla_{X}Z \rangle - \langle A_{JZ}X, \nabla_{JX}Z \rangle. \end{split}$$

Hence by Lemma 3.1 we have

$$\tilde{H}_B(X, Z) = \langle A_{JZ}JX, JA_{JZ}X \rangle - \langle A_{JZ}X, JA_{JZ}JX \rangle$$
$$= -2||A_{JZ}X||^2.$$

Theorem 9.2. Let \tilde{M} be a Kaehler manifold with $\tilde{H}_B > 0$. Then \tilde{M} admits no mixed foliate proper CR-submanifolds.

This theorem follows immediately from Lemma 9.1.

Corollary 9.3 (Bejancu-Kon-Yano [2]). A complex-space-form $\tilde{M}^m(c)$ with c > 0 admits no mixed foliate proper CR-submanifolds.

Remark 9.1. Geodesic spheres of $\mathbb{C}P^m$ are real hypersurfaces with $\sigma(\mathfrak{D}, \mathfrak{D}^{\perp}) = 0$.

Theorem 9.3. Let N be a CR-submanifold in \mathbb{C}^m . Then N is mixed foliate if and only if N is a CR-product.

Proof. Let N be a CR-submanifold in \mathbb{C}^m . If N is mixed foliate, Lemma 9.1 implies

$$A_{J\mathfrak{D}^{\perp}}\mathfrak{D}=0.$$

So by Lemma 4.2, N is a CR-product.

Conversely, if N is a CR-product, then (9.3) holds. Thus by Lemma 4.2 and 4.3, we get $\sigma(\mathfrak{D}, \mathfrak{D}^{\perp}) = 0$. Hence N is mixed foliate.

Remark 9.2. For an anti-holomorphic submanifold N, Theorem 9.3 is due to Bejancu-Kon-Yano [2].

CR-submanifolds in Hermitian symmetric spaces of compact type

Using Lemma 9.1 we obtain

Theorem 10.1. Let \tilde{M} be a compact (type) Hermitian symmetric space and N a mixed foliate CR-submanifold in \tilde{M} . Then

- (1) N is CR-product,
- $(2) \, \tilde{K}(\mathfrak{D}, \, \mathfrak{D}^{\perp}) = 0, \, \tilde{K}(\mathfrak{D}, J \, \mathfrak{D}^{\perp}) = 0,$
- $(3) A_{J\mathfrak{D}^{\perp}}\mathfrak{D} = 0.$

Proof. If N is a mixed foliate CR-submanifold in a compact Hermitian symmetric space \tilde{M} , then \tilde{M} is nonnegatively curved [9], and hence by Lemma 9.1 we have

$$\tilde{H}_{R}(X, Z) = \tilde{K}(X, Z) + \tilde{K}(X, JZ) = 0, \quad A_{IZ}X = 0,$$

which imply (2) and (3). Statement (1) follows from (3) and Lemma 4.2.

Remark 10.1. Although $\mathbb{C}P^m$ admits no mixed foliate proper $\mathbb{C}R$ -submanifolds (Corollary 9.3), other irreducible compact Hermitian symmetric spaces admit mixed foliate proper $\mathbb{C}R$ -submanifolds in general. For example the rank-2 irreducible compact Hermitian symmetric space $SU(2+m)/S(U_2 \times U_m)$ admit such submanifolds N for any $h=\dim_{\mathbb{C}} \mathbb{O}$ satisfying 0 < h < m.

In view of Remark 10.1 it seems to be interesting to give the following.

Theorem 10.2. Let N be a complete mixed foliate CR-submanifold in a compact type Hermitian symmetric space \tilde{M}^m . If N is anti-holomorphic, then

(1) N is a CR-product $N^T \times N^{\perp}$,

- (2) N^T is also a compact type Hermitian symmetric space,
- (3) there is another compact type Hermitian symmetric space M^{\perp} such that
- (3.1) \tilde{M} is the Riemannian product $N^T \times M^{\perp}$,
- (3.2) N^{\perp} is a totally real submanifold of M^{\perp} .

Proof. (1) follows from Theorem 10.1. Let N^T be a leaf of the holomorphic distribution \mathfrak{D} . Then, since N^T is totally geodesic in N, Theorem 10.1 implies that N^T is a totally geodesic holomorphic submanifold of \tilde{M}^m . Thus N^T is also a compact type Hermitian symmetric space, and (2) is proved.

Using (2) of Theorem 10.1, the equation of Gauss, and the fact that N^T is a totally geodesic submanifold of \tilde{M}^m , we obtain that

$$(10.1) ST(X, Y) = \tilde{S}(X, Y)$$

for any vectors X, Y tangent to N^T . Thus by applying Theorem 2 of [5] we arrive at (3).

The following is an immediate consequence of Theorem 10.2.

Corollary 10.3. Every irreducible compact type Hermitian symmetric space admits no mixed foliate proper anti-holomorphic submanifolds.

Remark 10.2. Although Theorem 10.1 shows that every mixed foliate CR-submanifold in a compact Hermitian symmetric space is a CR-product, and Theorem 9.3 shows that a mixed foliate CR-submanifold in C^m is nothing but a CR-product, CR-products in compact Hermitian symmetric spaces are not mixed foliate in general. For example, the standard CR-products in CP^m are not mixed foliate.

11. Remarks

- 11.1. The classification of mixed foliate CR-submanifolds in complex hyperbolic spaces and the classification of CR-submanifolds with semi-flat normal connection together with other results on CR-submanifolds will be given in the second part of this series.
