

Banquet in Marine Dining Room of Edgewater Beach To Mark the 21st Annual Fall Meeting of the Society

WITH a banquet in the gala Marine dining room of the Edgewater Beach Hotel as its high point socially the 21st annual fall meeting of the American Oil Chemists' Society will open on October 20 in Chicago for three days of technical papers and good fellowship on the part of members and guests.

Attendance is estimated to run close to 600, according to the hotel chairman, C. E. Morris. The Governing Board will meet at 3 p.m. on Sunday, October 19, with President R. T. Milner of Peoria in the chair. Preceding will be a 1 o'clock meeting of the Refining Committee, of which H. S. Mitchell of Chicago is chairman. Other committees which will meet include the Nominating and Election Committee, headed by S. O. Sorensen of Minneapolis, and the Vitamin Committee, under the direction of N. D. Embree of Rochester,

N. Y. Advance registration is announced for Sunday from 2 to 7 p.m. A printed program containing abstracts of the papers will be available at the registration desk.

Entertainment for the ladies, as planned by Mrs. Morris, comprises the following schedule: Monday—broadcast over WBBM from 2:30 to 3:20 p.m., followed by a tour of the Chicago Tribune or a visit to the Wrigley building tower, dinner at Ricketts, and a performance of "Carousel" at the Shubert theater; Tuesday—a tour of city north to Winnetka and south to the Midway, beginning at 10 a.m., and luncheon at the Palm Grove restaurant; Wednesday—open for shopping or tour of Marshall Field's and fashion show.

Fees for the meeting are as follows: registration—\$3 for members, \$4 for non-members; \$3 for smoker; and \$5.50 for dinner. Charges for the ladies' entertainment will be \$1 for dinner at Ricketts and \$4 for "Carousel" tickets; other events will be complementary on the part of the Chicago committee.

The program, in addition to the titles published in the September issue, will include a paper by H. A. Schuette and J. G. Kane of the University of Wisconsin entitled "Solidification Point Curves of Ternary Systems in Saturated Fatty Acid Series," which will be given on Monday morning. A business session will be held at the close of the Wednesday morning meeting. Starting time has been changed to 9:30 a.m. on Monday and 9:00 a.m. on Tuesday and Wednesday.

will exhibit at the fall meeting. Exhibits will be on display in the West lounge, meetings will be held in the East lounge, the smoker on Monday evening will be in the Grand ballroom, and the ladies' parlor will be the Sheridan room.
