

REGULARITY PROPERTIES OF CERTAIN FAMILIES OF CHANCE VARIABLES*

Let t vary in any simply ordered set, and let $\{x_t\}$ be a family of chance variables. We shall say that the chance variables have the property $\mathcal{E}$ if whenever $t_1 < \cdots < t_{n+1}$,

$$E[x_{t_1}, \cdots, x_{t_n}; x_{t_{n+1}}] = x_{t_n}, \dagger$$

with probability 1. The subscript n here is any positive integer. It will always be supposed that the given chance variables have expectations, so that the conditional expectations involved in the definition of the property $\mathcal{E}$ will always exist.

We shall first make a few introductory remarks on the general family of chance variables with the property $\mathcal{E}$. Then in §1 it will be supposed that t takes on integral values, and the convergence properties of such sequences of chance variables will be discussed in detail. In §3 it will be supposed that t runs through the real numbers. Before discussing this case, it is necessary to investigate the justification for the use of such descriptive terms as *continuity*, *boundedness*, and so on, as applied to the random function x_t . This investigation is made in §2, in the general case, without the hypothesis of the property $\mathcal{E}$, and it is found that the above terms can always be made meaningful, and given their usual meanings, at the cost, however, in some cases, of introducing infinite-valued functions.

In the following, we shall always suppose that the x_t are measurable functions defined on a space Ω , on certain sets of which a measure function is defined. That this can always be done, and how this is to be done, was shown by Kolmogoroff [5, pp. 27–30]. The space Ω , following Kolmogoroff, will be taken to be the space of real-valued functions of t . Integration in terms of probability measure will be denoted by $\int \cdots dP$, and integration will be over all space, unless the domain of integration is otherwise specified. The quali-

fication "with probability 1" will be used interchangeably with "almost everywhere on Ω ." Let I be any set of t -values. A P -measurable set Λ (that is, an Ω -set whose probability is defined) will be said to be an x_t -set with $t \in I$, or a set depending only on t for t in I , if it is in the Borel field of Ω -sets determined by the sets of the form

$$\{x_{t_j} < k_j, j = 1, \dots, n\}$$

(n any integer, $k_1, \dots, k_n$ any n numbers, $t_1, \dots, t_n$ any n distinct t -values) or if it differs from an Ω -set in this field by an Ω -set of P -measure 0. If I includes all t -values, the Ω -sets in question are all the P -measurable sets.

THEOREM 0.1. *Let $\{x_t\}$ be a family of chance variables with the property $\mathcal{E}$. If I is any t -set, and if $t \leq s_1, s_2$ for all t in I , then*

$$(0.1.1) \quad E[x_t, t \in I; x_{s_1}] = E[x_t, t \in I; x_{s_2}],$$

with probability 1. If I has a last element s , and if $\sigma > s$,

$$(0.1.2) \quad E[x_t, t \in I; x_\sigma] = x_s,$$

with probability 1.

This theorem extends the defining property $\mathcal{E}$, which states the conclusion of Theorem 0.1 for I a finite set. By definition of conditional expectations, $E[x_t, t \in I; x_{s_j}], j=1, 2$, is a function measurable with respect to the P -measurable Ω -sets depending only on x_t for t in I , and such that, if Λ is an Ω -set of this type,

$$(0.1.3) \quad \int_{\Lambda} E[x_t, t \in I; x_{s_j}] dP = \int_{\Lambda} x_{s_j} dP, \quad j = 1, 2.$$

Suppose that the P -measurable set M depends only on t for $t=t_1, \dots, t_n$, with $t_j \in I, j \leq n, t_1 < \dots < t_n$. Then, using the fact that the chance variables $x_{t_1}, \dots, x_{t_n}, x_{s_j}$ have the property $\mathcal{E}$,

$$(0.1.4) \quad \int_M x_{s_j} dP = \int_M E[x_{t_1}, \dots, x_{t_n}; x_{s_j}] dP = \int_M x_{t_n} dP, \quad j = 1, 2.$$

Thus

$$(0.1.5) \quad \int_M x_{s_1} dP = \int_M x_{s_2} dP,$$

and therefore, using (0.1.3),

$$(0.1.6) \quad \int_M E[x_t, t \in I; x_{s_1}] dP = \int_M E[x_t, t \in I; x_{s_2}] dP.$$

Since any P -measurable set which depends only on t for $t \in I$ can be approximated arbitrarily closely by a set M , (0.1.6) must hold with the general Λ in place of M . Since the integrands are measurable with respect to the field of sets Λ , the integrands are necessarily equal, with probability 1, as was to be proved. If I has a last element s , $E[x_t, t \in I; x_s] = x_s$, with probability 1, from the definition of conditional expectations, so in that case both terms of (0.1.1) are equal to $E[x_t, t \in I; x_s] = x_s$, with probability 1. The last statement of the theorem is merely a rewording of this fact.

THEOREM 0.2. *Let x, y be chance variables whose expectations exist, and suppose that $E[x; y] = x$, with probability 1. Then $E[x] = E[y]$, and $E|x| \leq E|y|$.*

If $E[x; y] = x$, with probability 1, the expectations of the two chance variables $E[x; y]$, x are equal: $E[y] = E[x]$. Moreover $|x| \leq E[x; |y|]$ with probability 1, and, taking expectations of the two sides of this inequality, we obtain $E|x| \leq E|y|$.

COROLLARY. *If $\{x_t\}$ is a family of chance variables with the property $\mathcal{E}$, $E x_t$ is independent of t , and $E|x_t|$ is a non-decreasing function of t .*

THEOREM 0.3. *Let $\{x_t\}$ be a family of chance variables with the property $\mathcal{E}$. Then for each t_0 , the x_t with $t \leq t_0$ are uniformly integrable.**

We show first that

$$(0.3.1) \quad \lim_{k \rightarrow \infty} P\{|x_t| \geq k\} = 0,$$

uniformly for $t \leq t_0$. This fact is implied by the following inequality (in which $t \leq t_0$):

$$(0.3.2) \quad \begin{aligned} kP\{|x_t| \geq k\} &\leq \int_{\{x_t \geq k\}} x_t dP - \int_{\{x_t \leq -k\}} x_t dP \\ &= \int_{\{x_t \geq k\}} x_{t_0} dP - \int_{\{x_t \leq -k\}} x_{t_0} dP \leq \int |x_{t_0}| dP. \end{aligned}$$

We are using here the fact that if $t \leq t_0$, $E[x_t; x_{t_0}] = x_t$ with probability 1. Now if $t \leq t_0$,

$$(0.3.3) \quad \begin{aligned} \int_{\{|x_t| \geq k\}} |x_t| dP &= \int_{\{x_t \geq k\}} x_t dP - \int_{\{x_t \leq -k\}} x_t dP \\ &= \int_{\{x_t \geq k\}} x_{t_0} dP - \int_{\{x_t \leq -k\}} x_{t_0} dP \leq \int_{\{|x_t| \geq k\}} |x_{t_0}| dP, \end{aligned}$$

* This means that $\lim_{k \rightarrow \infty} \int_{\{|x_t| \geq k\}} |x_t| dP = 0$ uniformly in t for $t \leq t_0$.

and, as $k \rightarrow \infty$, the right side goes to 0 uniformly in t (from (0.3.1)), so the left side goes to 0 uniformly in t , as was to be proved.

1. **Sequences of chance variables with the property $\mathcal{E}$.** We first prove the following theorem.

THEOREM 1.1. *Let $\cdots, x_{-1}, x_0, \cdots, x$ be chance variables with the property $\mathcal{E}$.^{*} Let m, n be integers with $m \leq n$, and define the sets Λ, M by*

$$\Lambda = \left\{ \text{L.U.B. } x_j \geq k \right\}_{m \leq j \leq n}, \quad M = \left\{ \text{G.L.B. } x_j \leq k \right\}_{m \leq j \leq n}.$$

Then if N is any P -measurable $(\cdots, x_{m-1}, x_m)$ -set,

$$(1.1.1) \quad \int_{\Lambda \cdot N} x dP \geq kP\{\Lambda \cdot N\}, \quad \int_{M \cdot N} x dP \leq kP\{M \cdot N\}. \dagger$$

To prove (1.1.1), define the sets $\Lambda_m, \cdots$ as follows:

$$\begin{aligned} \Lambda_m &= \{x_m \geq k\}, \\ \Lambda_{m+1} &= \{x_m < k, x_{m+1} \geq k\}, \cdots, \\ \Lambda_n &= \{x_m < k, x_{m+1} < k, \cdots, x_{n-1} < k, x_n \geq k\}. \end{aligned}$$

Then the Λ_i are disjunct with sum Λ , and Λ_i depends only on $x_m, \cdots, x_i$. Since $E[\cdots, x_i; x] = x_i$, with probability 1 (Theorem 0.1),

$$(1.1.2) \quad \begin{aligned} \int_{\Lambda \cdot N} x dP &= \sum_m^n \int_{\Lambda_j \cdot N} x dP = \sum_m^n \int_{\Lambda_j \cdot N} x_j dP \\ &\geq k \sum_m^n P(\Lambda_j \cdot N) = kP(\Lambda \cdot N), \end{aligned}$$

giving the first inequality of (1.1.1), and the second can be proved in the same way, or by changing the x_i, x to their negatives, and applying the result already obtained.

THEOREM 1.2. *Let $\cdots, x_{-1}, x_0$ be a sequence of chance variables with the property $\mathcal{E}$. Then $\lim_{n \rightarrow -\infty} x_n = x$ exists with probability 1, and the chance variables $x, \cdots, x_{-1}, x_0$ have the property $\mathcal{E}$. The chance variables $\{x_i\}$ are uniformly integrable, and $E|x_0| \geq E|x_{-1}| \geq \cdots \geq E|x|$; $E|x_n| \rightarrow E|x|$.*

Unless $\liminf_{n \rightarrow -\infty} x_n = \limsup_{n \rightarrow -\infty} x_n$ with probability 1, there are numbers k_1, k_2 with $k_2 > k_1$, such that

$$(1.2.1) \quad \liminf_{n \rightarrow -\infty} x_n < k_1 < k_2 < \limsup_{n \rightarrow -\infty} x_n,$$

with positive probability η . Let the $(\cdots, x_0)$ -set on which (1.2.1) is true be Λ . We can choose $-n_1$ so large that $\text{L.U.B.}_{n_1 \leq j} \{x_j\} \geq k_2$ on an $(\cdots, x_0)$ -set Λ_1 with $P(\Lambda \cdot \Lambda_1) > \eta(1-2^{-1})$. We can choose $n_2 < n_1$ such that $\text{G.L.B.}_{n_2 \leq j \leq n_1} \{x_j\} \leq k_1$ on an $(\cdots, x_0)$ -set Λ_2 with $P(\Lambda \cdot \Lambda_2) > \eta(1-2^{-2})$. In general, if $n_1, \cdots, n_{r-1}$ have already been chosen, and if r is odd, we can choose $n_r < n_{r-1}$ such that $\text{L.U.B.}_{n_r \leq j \leq n_{r-1}} \{x_j\} \geq k_2$ on an $(\cdots, x_0)$ -set Λ_r with $P(\Lambda \cdot \Lambda_r) > \eta(1-2^{-r})$; or if r is even, we can choose $n_r < n_{r-1}$ such that $\text{G.L.B.}_{n_r \leq j \leq n_{r-1}} \{x_j\} \leq k_1$ on an $(\cdots, x_0)$ -set Λ_r with $P(\Lambda \cdot \Lambda_r) > \eta(1-2^{-r})$. Then if $\Lambda'_n = \prod_{n=1}^{\infty} \Lambda_j$,

$$(1.2.2) \quad P(\Lambda'_n) > \eta - \eta 2^{-n} - \eta 2^{-n-1} - \cdots = \eta(1 - 2^{-n+1}).$$

According to Theorem 1.1, if r is odd,

$$(1.2.3) \quad \int_{\Lambda'_r} x_0 dP \geq k_2 P(\Lambda'_r)$$

and if r is even

$$(1.2.4) \quad \int_{\Lambda'_r} x_0 dP \leq k_1 P(\Lambda'_r).$$

As $r \rightarrow \infty$, Λ'_r increases to a set Λ' of measure not less than η ; (1.2.3) and (1.2.4) become

$$(1.2.5) \quad k_2 P(\Lambda') \leq \int_{\Lambda'} x_0 dP \leq k_1 P(\Lambda'),$$

which is impossible, because $k_1 < k_2$. We have thus proved that $\lim_{n \rightarrow -\infty} x_n = x$ exists, with probability 1. According to Theorem 0.3, the x_j are uniformly integrable. Then their limit x is integrable, and term by term integration of x_j or $|x_j|$ is legitimate. This means that $E|x_n| \rightarrow E|x|$. The fact that $E|x_0| \geq E|x_{-1}| \geq \cdots$ follows from the corollary to Theorem 0.2. To show that the chance variables $x, \cdots, x_{-1}, x_0$ have the property $\mathcal{E}$, it is only necessary to show that if $m \leq n \leq r \leq 0$, $E[x, x_m, \cdots, x_n; x_r] = x_n$, with probability 1, and that $E[x; x_r] = x$, with probability 1. To prove the first, we must prove that if Λ is a set depending only on $x, x_m, \cdots, x_n$, then

$$(1.2.6) \quad \int_{\Lambda} x_n dP = \int_{\Lambda} x_r dP.$$

Now Λ evidently depends only on $\cdots, x_{n-1}, x_n$; so (1.2.6) follows from the fact that $E[\cdots, x_n; x_r] = x_n$, with probability 1 (Theorem 0.1). If Λ is a set

depending only on x , (1.2.6) is true for all $n \leq r$, and becomes, if $n \rightarrow -\infty$,

$$\int_{\Lambda} x dP = \int_{\Lambda} x_r dP,$$

that is, $E[x; x_r] = x$, with probability 1.

THEOREM 1.3. *Let $x_1, x_2, \dots$ be a sequence of chance variables with the property $\mathcal{E}$. Then $E|x_1| \leq E|x_2| \leq \dots$. If $\lim_{n \rightarrow \infty} E|x_n| = l < \infty$, then $\lim_{n \rightarrow \infty} x_n = x$ exists, with probability 1, and $E|x| \leq l$. If the x_i are uniformly integrable, $\lim_{n \rightarrow \infty} x_n = x$ exists, with probability 1, and the chance variables $x_1, x_2, \dots, x$ have the property $\mathcal{E}$.*

Ville has studied sequences of non-negative chance variables with the property $\mathcal{E}$. Since, by the corollary to Theorem 0.2, Ville's hypotheses imply that

$$Ex_1 = Ex_2 = \dots = E|x_1| = E|x_2| = \dots,$$

the hypotheses of the first part of Theorem 1.3 are satisfied, in Ville's case. Ville proved* that in his case L.U.B. $_{j \geq 1} |x_j| < \infty$, with probability 1 (implied by our conclusion that $\lim_{n \rightarrow \infty} x_n$ exists with probability 1, and that the limit is integrable), and applied this fact to the study of certain games of chance.

Proof of Theorem 1.3. According to the corollary to Theorem 0.2, $E|x_n|$ is monotone non-decreasing. Suppose that $\lim_{n \rightarrow \infty} E|x_n| = l < \infty$. Unless $\liminf_{n \rightarrow \infty} x_n = \limsup_{n \rightarrow \infty} x_n$, with probability 1, there are numbers k_1, k_2 , with $k_1 < k_2$, such that

$$(1.3.1) \quad \liminf_{n \rightarrow \infty} x_n < k_1 < k_2 < \limsup_{n \rightarrow \infty} x_n$$

with positive probability η . Let the $(x_1, x_2, \dots)$ -set on which this is true be Λ . We can choose n_1 so large that L.U.B. $_{j \leq n_1} \{x_j\} \geq k_2$ on an $(x_1, x_2, \dots)$ -set Λ_1 with $P(\Lambda \cdot \Lambda_1) > \eta(1 - 3^{-1})$. We can then choose $n_2 > n_1$ so large that G.L.B. $_{n_1 \leq j \leq n_2} \{x_j\} \leq k_1$ on an $(x_1, x_2, \dots)$ -set Λ_2 with $P(\Lambda \cdot \Lambda_2) > \eta(1 - 3^{-2})$. In general if $n_1, \dots, n_{r-1}$ have already been chosen, and if r is odd, we can find $n_r > n_{r-1}$ so large that L.U.B. $_{n_{r-1} \leq j \leq n_r} \{x_j\} \geq k_2$ on an $(x_1, x_2, \dots)$ -set Λ_r with $P(\Lambda \cdot \Lambda_r) > \eta(1 - 3^{-r})$; or if r is even, we can find $n_r > n_{r-1}$ so large that G.L.B. $_{n_{r-1} \leq j \leq n_r} \{x_j\} \leq k_1$ on an $(x_1, x_2, \dots)$ -set Λ_r with $P(\Lambda \cdot \Lambda_r) > \eta(1 - 3^{-r})$. Then if $\Lambda'_n = \prod_{i=1}^n \Lambda_i$,

$$(1.3.2) \quad P(\Lambda'_n) > \eta - \eta/3 - \eta/3^2 - \dots = \eta/2.$$

According to Theorem 1.1, if $m \geq n_{2r}$,

$$(1.3.3) \quad \int_{\Lambda'_{2r}} x_m dP \leq k_1 P(\Lambda'_{2r}), \quad \int_{\Lambda'_{2r-1}} x_m dP \geq k_2 P(\Lambda'_{2r-1}).$$

Then if $M_r = \Lambda'_{2r-1} - \Lambda_{2r}$

$$(1.3.4) \quad \int_{M_r} x_m dP \geq k_2 P(\Lambda'_{2r-1}) - k_1 P(\Lambda'_{2r}) = (k_2 - k_1) P(\Lambda'_{2r-1}) + k_1 P(M_r).$$

Now the M_r are disjunct, so if m is sufficiently large (depending on q),

$$(1.3.5) \quad \begin{aligned} \sum_{r=1}^q \int_{M_r} x_m &\geq (k_2 - k_1) \sum_{r=1}^q P(\Lambda'_{2r-1}) + k_1 \sum_{r=1}^q P(M_r) \\ &\geq \frac{q(k_2 - k_1)}{2} \eta - |k_1|. \end{aligned}$$

But this is impossible, since then

$$(1.3.6) \quad l \geq \int |x_m| dP \geq \sum_{r=1}^q \int_{M_r} x_m dP \geq \frac{q\eta}{2} (k_2 - k_1) - |k_1|,$$

that is,

$$(1.3.7) \quad l \geq (1/2)q\eta(k_2 - k_1) - |k_1|,$$

for all q . We have thus proved that $\lim_{n \rightarrow \infty} x_n = x$ exists with probability 1. By Fatou's lemma, $E|x| \leq l$, and the fact that $E|x| < \infty$ implies that x is finite, with probability 1. If the x_j are supposed uniformly integrable, it follows that the sequence $\{E|x_j|\}$ is uniformly bounded. Then $\lim_{n \rightarrow \infty} x_n = x$ exists with probability 1. Because of the uniform integrability, term by term integration of the sequence $\{x_n\}$ is allowed on any P -measurable set, and we can readily verify that the sequence of chance variables $x_1, x_2, \dots, x$ has the property $\mathcal{E}$. In fact, all that need be proved is that $E[x_{\alpha_1}, \dots, x_{\alpha_n}; x] = x_{\alpha_n}$ with probability 1, if $\alpha_1 < \dots < \alpha_n$. This will follow if it can be shown that whenever Λ is an $(x_1, x_2, \dots)$ -set depending only on $x_{\alpha_1}, \dots, x_{\alpha_n}$, then

$$(1.3.8) \quad \int_{\Lambda} x dP = \int_{\Lambda} x_{\alpha_n} dP.$$

Since the chance variables $x_1, x_2, \dots$ have the property $\mathcal{E}$, (1.3.8) is true if x is replaced by x_m with $m > \alpha_n$. Then if $m \rightarrow \infty$, we obtain (1.3.8).

COROLLARY. *Let $y_1, y_2, \dots$ be a sequence of chance variables whose expectations exist, and suppose that $E[y_1, \dots, y_n; y_{n+1}] = 0$, $n = 1, 2, \dots$, with probability 1. Then $E|\sum_1^n y_j|$ is monotone non-decreasing with n , and if $\lim_{n \rightarrow \infty} E|\sum_1^n y_j| < \infty$, the series $\sum_1^\infty y_j$ is convergent, with probability 1.*

For if $x_n = \sum_1^n y_i$, $n = 1, 2, \dots$, the x_n have the property $\mathcal{E}$, and Theorem 1.3 is applicable, giving the result of the corollary.

Lévy [8, pp. 247–248] has discussed series of chance variables $\sum_1^\infty y_i$, with $E[y_1, \dots, y_n; y_{n+1}] = 0$, $n = 1, 2, \dots$, with probability 1, relating the convergence of the given series to that of their conditional dispersions.

An important particular case of this corollary is that in which the y_i are mutually independent. The hypothesis on the conditional expectations becomes in this case the hypothesis that $Ey_1 = Ey_2 = \dots = 0$, and the corollary has been deduced in this case.* In this special case it has also been shown that the partial sums $\{x_j\}$ are necessarily uniformly bounded by a chance variable whose expectation exists. It follows that in this case the x_j are always uniformly integrable.

The following example shows that the hypotheses of the first part of Theorem 1.3 do not imply that the sequence $x_1, x_2, \dots, x$ has the property $\mathcal{E}$. Let $x_0 = 1$ with probability 1. Let $x_1 = 1/2$ with probability $(1 - 4^{-1})$ and $x_1 = 5/2$ with probability $1/4$. In general if $x_1, \dots, x_r$ have already been determined, we determine x_{r+1} as follows. The values of x_{r+1} depend only on those of x_r , and if $x_r = a$, we set $x_{r+1} = 2^{-r-1}$ with probability $(1 - 4^{-r-1})$ and $x_{r+1} = \xi$ with probability 4^{-r-1} , choosing ξ to make the expectation of x_{r+1} (with $x_r = a$) equal to 0:

$$\frac{\xi}{4^{r+1}} + \frac{1}{2^{r+1}} \left(1 - \frac{1}{4^{r+1}} \right) = a.$$

Then it is easily verified that $x_n = 2^{-n}$ with probability $(1 - 4^{-n})$, if $n \geq 1$, so that $x_n \rightarrow x = 0$, with probability 1. The chance variables are all positive and the hypotheses of the first part of Theorem 1.3 are satisfied. The sequence $x_1, x_2, \dots, x$ certainly does not have the property $\mathcal{E}$.

The following theorem is essentially the converse of the second part of Theorem 1.3.

THEOREM 1.4. *Let $x_1, x_2, \dots, x'$ be chance variables with the property $\mathcal{E}$. Then*

- (a) $\lim_{n \rightarrow \infty} x_n = E[x_1, x_2, \dots; x']$ with probability 1;
- (b) the chance variables $x_1, x_2, \dots, x, x'$ have the property $\mathcal{E}$;
- (c) if x' is a function of $x_1, x_2, \dots$, $\lim_{n \rightarrow \infty} x_n = x'$, with probability 1.

Lévy [8, p. 129] proved part (c) of this theorem, under the hypothesis that x only takes on the values 1 and 0. His proof can be extended to cover Theorem 1.4. He puts the result in the following form (we are dropping his restriction on the values taken on by x'); let $y_1, y_2, \dots$ be a sequence of

chance variables and let x' be a chance variable dependent upon them. Then if $x_n = E[y_1, \dots, y_n; x']$, he proves that $x_n \rightarrow x'$ with probability 1. Since $x_1, x_2, \dots, x'$ have the property $\mathcal{E}$, this is exactly our Theorem 1.4(c).

Proof of (a), (b). According to Theorem 0.3, the x_i are uniformly integrable. Then Theorem 1.3 states that $\lim_{n \rightarrow \infty} x_n = x$ exists with probability 1, and that the chance variables $x_1, \dots, x$ have the property $\mathcal{E}$. If we show that the chance variables $x_1, \dots, x, x'$ have the property $\mathcal{E}$, it will follow (because of Theorem 0.1) that $x = E[x_1, \dots; x']$ with probability 1. To show that the chance variables $x_1, \dots, x, x'$ have the property $\mathcal{E}$ it is sufficient to show that if $\alpha_1 < \dots < \alpha_n$, then $E[x_{\alpha_1}, \dots, x_{\alpha_n}, x; x'] = x$ with probability 1, that is, that if Λ is any set depending on $x_{\alpha_1}, \dots, x_{\alpha_n}, x$,

$$(1.4.1) \quad \int_{\Lambda} x' dP = \int_{\Lambda} x dP.$$

Now Λ is a set depending on $x_1, x_2, \dots$ (because $x_n \rightarrow x$ with probability 1). Equation (1.4.1) is certainly true for Λ depending only on a finite number of the x_i (because if x_n is the last of these x_i , both integrals are equal to the integral of x_n over Λ : $x_1, \dots, x'$ and $x_1, \dots, x$ have the property $\mathcal{E}$). Then (1.4.1) is true in the general case because the general Λ can be approximated arbitrarily closely by the special ones.

Proof of (c). If x' is a function of $x_1, x_2, \dots$, $E[x_1, x_2, \dots; x'] = x'$ with probability 1, so that $x = x'$ with probability 1.

THEOREM 1.5. *Let $x_1, x_2, \dots, x$ be chance variables with the property $\mathcal{E}$. Suppose that $E|x \log |x|| < \infty$. There is then a number K depending only on $E|x \log |x||$, and such that $E[\text{L.U.B.}_{n \geq 1} |x_n|] < K$.*

Let $\xi = \text{L.U.B.}_{n \geq 1} \{x_n\}$, and let $\Lambda = \{\xi \geq k\}$, $k > 0$. According to Theorem 1.1,

$$(1.5.1) \quad \int_{\Lambda} x dP \geq kP(\Lambda).$$

Now

$$(1.5.2) \quad \int_{\Lambda \cdot \{|x| < k/2\}} |x| dP \leq \frac{k}{2} P(\Lambda),$$

so

$$(1.5.3) \quad \int_{\{|x| \geq k/2\}} |x| dP \geq \int_{\Lambda \cdot \{|x| \geq k/2\}} x dP \geq \frac{k}{2} P(\Lambda) = \frac{k}{2} P\{\xi \geq k\}.$$

This inequality, together with the fact that $E|x \log |x|| < \infty$, has been

used in an analogous discussion (Wiener [10, pp. 17–18]) to show that $E\xi \leq K_1$, where K_1 only depends on $E|x \log |x||$. Applying this result to $-x_1, -x_2, \dots, -x$, completes the proof of the theorem.

We have seen above in the discussion of the corollary to Theorem 1.3 that if the x_j are the partial sums of a series of mutually independent chance variables having zero expectations, the hypothesis that $E|x \log |x|| < \infty$ is unnecessary in Theorem 1.5.

2. One-parameter families of chance variables. In this section we shall consider a one-parameter family of chance variables $\{x_t\}$, $-\infty < t < \infty$, or $0 \leq t < \infty$. The probability relations are those derived from certain elementary probabilities: if $t_1, \dots, t_n$ are distinct t -values, and if $k_1, \dots, k_n$ are any real numbers, $P\{x_{t_j} < k_j, j \leq n\}$ is given. The mathematical setup appropriate to the study of the probability relations of the x_t is the following. Let Ω^* be the space of all real-valued functions of t . A probability measure is determined on Ω^* by the measures of certain elementary sets, which we shall call neighborhoods: a set Λ of functions $x(t)$ satisfying

$$a_j < x(t_j) < b_j, \quad j = 1, \dots, n, \quad -\infty \leq a_j < b_j \leq +\infty,$$

will be called a neighborhood, and we define a measure of Λ , $P^*(\Lambda)$, setting

$$P^*(\Lambda) = P\{a_j < x_{t_j} < b_j, j \leq n\}. \dagger$$

If $x_s(\omega)$ is the function of $\omega \in \Omega^*$ which for $\omega = \omega_0$: $x_0(t)$ assumes the value $x_0(s)$ (so that we can write, somewhat loosely, $x_s(\omega) = x(s)$), $x_s(\omega)$ is a P^* -measurable function (s fixed), and the probability relations of the $\{x_t\}$ become measure relations of the corresponding $\{x_t(\omega)\}$. The outer measure $\bar{P}^*(\Lambda)$ of an Ω^* -set Λ is defined as the lower limit of $P^*(\Lambda')$ where $\Lambda' \supset \Lambda$ and Λ' is P^* -measurable.‡ The inner measure of an Ω^* -set Λ is defined as $1 - \bar{P}^*(\Lambda_1)$, where Λ_1 is the complement of Λ . It is usually convenient to use a subspace Ω of Ω^* (with $\bar{P}^*(\Omega) = 1$) instead of Ω^* itself. The P^* -measure on Ω^* determines P -measure on Ω , and

$$P^*\{x(t_j) < k_j, j = 1, \dots, n\} = P\{x(t_j) < k_j, j = 1, \dots, n\}.$$

We are using $x(t_j)$ to denote the P -measurable function $x_{t_j}(\omega)$, which in turn represents the original chance variable x_{t_j} , and we shall continue to use this notation where there is no danger of confusion. The symbol $x(t)$ thus may represent either a point ω of Ω^* , that is, a function of t , or, if we are fixing t , a function of ω : $x_t(\omega)$.

In discussions of continuity and related questions, it is desirable to con-

sider $\text{L.U.B.}_{t \in I} x_t$, $\text{G.L.B.}_{t \in I} x_t$, where I is a t -interval. It was pointed out by Kolmogoroff [5, p. 26] that the probability that $\text{L.U.B.}_{t \in I} x_t \leq k$ or that $\text{G.L.B.}_{t \in I} x_t \leq k$ cannot be derived from the given probabilities. Since we are giving a complete treatment of the problem here, we shall prove a somewhat stronger result, pointed out to the writer by Dr. P. R. Halmos.

THEOREM 2.1. *Let Ω^* and P^* -measure be defined as explained above. Then the ω -set $\{\text{L.U.B.}_{t \in I} x(t) \leq k\}$ has inner measure 0, for any nondenumerable set I and real number k .*

This theorem shows that the ω -set $\{\text{L.U.B.}_{t \in I} x(t) \leq k\}$, if it is P^* -measurable, must have measure 0, irrespective of the P^* -measure. If the complement of the ω -set in question is Λ , it will be sufficient to show that $\bar{P}^*(\Lambda) = 1$. The Ω^* -set Λ is the set of all $x(t)$ with $x(t_0) > k$ for some t_0 in I . Let $\Gamma \subset \Omega^*$ be any denumerable sum of neighborhoods, with $\Gamma \supset \Lambda$. It will be sufficient to show that $P^*(\Gamma) = 1$, and in fact we shall show that $\Gamma = \Omega^*$. Let $t_1, t_2, \dots$ be the t -values used in defining the Γ_j . Let $x_0(t)$ be any element of Ω^* . There is surely a function $x_1(t)$, with $x_1(t_j) = x_0(t_j)$ for all j , and such that for some s in I , $x_1(s) > k$. Then $x_1(t) \in \Lambda \subset \Gamma$, so $x_0(t) \in \Gamma$ also, because $x_1(t_j) = x_0(t_j)$ ($j \geq 1$). Thus $\Gamma = \Omega^*$, as was to be proved.

Two ways have been suggested, to define $P\{\text{L.U.B.}_{t \in I} x_t \leq k\}$ and $P\{\text{G.L.B.}_{t \in I} x_t \leq k\}$. Khintchine [4, pp. 68–69] considers a sequence $\{t_j\}$ of t -values in I . The probability $P\{\text{L.U.B.}_{j \geq 1} x_{t_j} \leq k\}$ is already determined, and Khintchine defines $P\{\text{L.U.B.}_{t \in I} x_t \leq k\}$ as the greatest lower bound of these probability numbers, for all denumerable sets $\{t_j\}$ in I ; $P\{\text{G.L.B.}_{t \in I} x_t \leq k\}$ can be defined similarly. With this definition, the “L.U.B.” in “ $\text{L.U.B.}_{t \in I} x_t$ ” is not taken literally, necessarily not, since x_t is not a single function of t and since the problem has not been reduced to one of studying functions of t . The second way is to find a subspace Ω of Ω^* , of outer measure 1, such that there is a denumerable set $\{s_j\}$ for which, if $x(t) \in \Omega$, and if I is an open interval,

$$(2.1.1) \quad \text{L.U.B.}_{t \in I} x(t) = \text{L.U.B.}_{s_j \in I} x(s_j), \quad \text{G.L.B.}_{t \in I} x(t) = \text{G.L.B.}_{s_j \in I} x(s_j).$$

If there is such an Ω , the $x(t)$ -set $\{\text{L.U.B.}_{t \in I} x(t) \leq k\}$ becomes a P -measurable set:

$$(2.1.2) \quad P\left\{\text{L.U.B.}_{t \in I} x(t) \leq k\right\} = P\left\{\text{L.U.B.}_{s_j \in I} x(s_j) \leq k\right\},$$

and similarly for the G.L.B. Evidently the two methods of definition give the same numerical values to $P\{\text{L.U.B.}_{t \in I} x_t \leq k\}$. It must be stressed that in (2.1.2) the set $\{\text{L.U.B.}_{t \in I} x(t) \leq k\}$ is a subset of Ω , whose P -measure is equal

to that of the set on the right since the sets are identical. The P -measure of the set on the right is equal to the P^* -measure of the Ω^* -set $\{\text{L.U.B.}_{s_j \in I} x(s_j) \leq k\}$, by the definition of P -measure, and may be any number between 0 and 1, depending on k and the particular characteristics of the given P^* -measure. On the other hand, Theorem 2.1 shows that the Ω^* -set $\{\text{L.U.B.}_{t \in I} x(t) \leq k\}$ necessarily has inner measure 0.

A process with a space Ω as just described is called quasi-separable. Let I be any open t -interval (of length $|I|$) containing the point s . Define $x_*(s)$, $x^*(s)$ by

$$(2.1.3) \quad x_*(s) = \lim_{|I| \rightarrow 0} \text{G.L.B.}_{s_j \in I} x(s_j), \quad x^*(s) = \lim_{|I| \rightarrow 0} \text{L.U.B.}_{s_j \in I} x(s_j).$$

Then the condition that Ω be the space of a quasi-separable process is equivalent to the condition that if $x(t) \in \Omega$, and if $\{s_j\}$ is an everywhere dense denumerable t -set,

$$(2.1.4) \quad x_*(t) \leq x(t) \leq x^*(t)$$

for all t .† It has been shown (Doob [1]) that many given probability measures on Ω^* are such that there is a quasi-separable process. It will be shown below that every probability measure has this property, if infinite-valued functions are allowed. Applications will then be made in §3 to P^* -measures in which the chance variables $\{x_t\}$ have the property $\mathcal{E}$.

In order to treat the problems below it will sometimes be necessary to allow our functions $x(t)$ to take on the values $\pm \infty$. Kolmogoroff's proof [5, pp. 27–30] that the elementary given probabilities determine a probability measure needs no change to cover this case. All distributions will be finite: for each t , $|x(t)| < \infty$ with probability 1. It is easily shown that the set of everywhere finite-valued functions $x(t)$ has outer measure 1, and inner measure 0.

Let I be an open t -interval, and let $\{t_j\}$ be a sequence in I . Then $\text{L.U.B.}_{j \geq 1} x(t_j)$ is a chance variable, that is, a P^* -measurable function on Ω^* . We shall show below that there is a sequence $\{\bar{t}_j\}$ in I such that if $\{t_j\}$ is any sequence in I ,

$$\xi = \text{L.U.B.}_{j \geq 1} x(\bar{t}_j) \geq \text{L.U.B.}_{j \geq 1} x(t_j)$$

with probability 1. The (possibly infinite-valued) chance variable ξ will be called the generalized upper bound of $x(t)$ in I , and will be denoted by $U_I[x(t)]$. The generalized lower bound $L_I[x(t)]$ is defined in a similar fashion. To demonstrate the existence of the $\{\bar{t}_j\}$, we note that the values of

$E[\arctan \text{L.U.B.}_{j \geq 1} x(t_j)]^\dagger$ for $\{t_j\}$ a sequence in I , have a least upper bound M . There are sequences $\{t_j^{(k)}\}$, $k=1, 2, \dots$, such that

$$E\left[\arctan \text{L.U.B.}_{j \geq 1} x(t_j^{(k)})\right] \rightarrow M.$$

Let $\bar{t}_1, \bar{t}_2, \dots$ be the $t_j^{(k)}$, $j, k \geq 1$, arranged in some order. Then evidently

$$E\left[\arctan \text{L.U.B.}_{j \geq 1} x(\bar{t}_j)\right] = M.$$

Now let $\{t_j\}$ be any sequence in I . We shall show that it is impossible that $\text{L.U.B.}_{j \geq 1} x(t_j) > \text{L.U.B.}_{j \geq 1} x(\bar{t}_j)$ with positive probability, that is, on an Ω^* -set of positive P^* -measure. If this inequality were possible with positive probability, the inequality would still be true if the sequence $\{t_j\}$ were augmented to include the $\bar{t}_j$. Then, supposing this has been done,

$$\arctan \text{L.U.B.}_{j \geq 1} x(t_j) \geq \arctan \text{L.U.B.}_{j \geq 1} x(\bar{t}_j)$$

for all ω , and there is actual inequality with positive probability. This implies that

$$E\left[\arctan \text{L.U.B.}_{j \geq 1} x(t_j)\right] > E\left[\arctan \text{L.U.B.}_{j \geq 1} x(\bar{t}_j)\right] = M,$$

contradicting the definition of M . Thus the $\bar{t}_j$ have the required property. Evidently $U_I[x(t)]$ is not a uniquely determined function, but is determined up to an Ω^* -set of P^* -measure 0, in the sense that two generalized upper bounds are equal almost everywhere on Ω^* .

THEOREM 2.2. *There is a sequence $\{s_j\}$, independent of the open interval I , such that, for each I ,*

$$(2.2.1) \quad \text{L.U.B.}_{s_j \in I} x(s_j) = U_I[x(t)], \quad \text{G.L.B.}_{s_j \in I} x(s_j) = L_I[x(t)],$$

with probability 1.

We have seen that to each I correspond sequences $\{t'_j\}$, $\{t''_j\}$, such that

$$(2.2.2) \quad \text{L.U.B.}_{j \geq 1} x(t'_j) = U_I[x(t)], \quad \text{G.L.B.}_{j \geq 1} x(t''_j) = L_I[x(t)],$$

with probability 1. Let $\{s_j\}$ be any sequence including all these t'_j , t''_j , for every I with rational end points. Then evidently (2.2.1) is true, with probability 1, if I is such an interval. Let I be any open t -interval, and let $I_1, I_2, \dots$

[†] We define $\arctan \pm \infty$ as $\pm \pi/2$.

be intervals with rational end points, such that $I_1 \subset I_2 \subset \dots$ and that $\sum_1^\infty I_j = I$. Then

$$(2.2.3) \quad \text{L.U.B.}_{s_j \in I_n} x(s_j) = U_{I_n}[x(t)],$$

with probability 1. Let $\{\sigma_j\}$ be a sequence of t -values, including the s_j . This inclusion implies that

$$(2.2.4) \quad \text{L.U.B.}_{s_j \in I_n} x(s_j) = U_{I_n}[x(t)] = \text{L.U.B.}_{\sigma_j \in I_n} x(\sigma_j)$$

with probability 1. Let the $\{\sigma_j\}$ also be so inclusive that

$$(2.2.5) \quad U_I[x(t)] = \text{L.U.B.}_{\sigma_j \in I} x(\sigma_j)$$

with probability 1. Then if $n \rightarrow \infty$ in (2.2.4), we find that

$$(2.2.6) \quad \text{L.U.B.}_{s_j \in I} x(s_j) = \text{L.U.B.}_{\sigma_j \in I} x(\sigma_j)$$

with probability 1, and (2.2.5), (2.2.6) taken together imply the first part of (2.2.1). The second part is proved in the same way.

LEMMA 2.3. *If a sequence $\{s_j\}$ is chosen as described in Theorem 2.2, and if $x^*(t)$, $x_*(t)$ are the upper and lower limiting functions of $x(t)$ on $\{s_j\}$, as defined in (2.1.3), then for each value of t ,*

$$(2.3.1) \quad x_*(t) \leq x(t) \leq x^*(t)$$

with probability 1.

For if $x^*(s_0) < x(s_0)$ for some t -value s_0 , on an Ω^* -set of positive measure, and if I is an open interval containing s_0 ,

$$(2.3.2) \quad U_I[x(t)] = \text{L.U.B.}_{j \geq 1} x(s_j) < x(s_0)$$

on an Ω^* -set of positive measure, if I is sufficiently small, contradicting the definition of $U_I[x(t)]$. Thus the second half of the inequality is proved, and the first is proved in the same way.

COROLLARY. *For each value of t , $x_*(t) < \infty$, $x^*(t) > -\infty$, with probability 1.*

It has not been necessary, as yet, to utilize a subspace Ω of Ω^* , rather than Ω^* itself. As Theorem 2.1 shows, such a transition is necessary, in discussing quasi-separable processes.

THEOREM 2.4. *Whatever the given P^* -measure, there is a space Ω of a quasi-separable process. In some cases it is necessary to allow infinite-valued functions in Ω .*

This theorem states that we can find a space on which the generalized upper and lower bounds become actual upper and lower bounds. It will be utilized to show that a regularity property of $x(t)$ known to be true when t is restricted to denumerable sets implies the same type of regularity for all t , for the functions of a suitably chosen space Ω . (Compare Theorems 2.7, 2.8, 2.9.)

Proof of Theorem 2.4. Let $\{s_j\}$ be a sequence as described in Theorem 2.2. Define $x_*(t)$, $x^*(t)$ as in (2.1.3). Let Ω be the space of all $x(t)$ with

$$(2.4.1) \quad x_*(t) \leq x(t) \leq x^*(t)$$

identically in t . If $x_*(t) = +\infty$, this means that $x(t) = +\infty$, and if $x^*(t) = -\infty$, this means that $x(t) = -\infty$. To prove the theorem, we need only show that $\bar{P}^*(\Omega) = 1$. Let $\Gamma = \sum_1^\infty \Gamma_n$ be any denumerable sum of neighborhoods with $\Gamma \supset \Omega$. It will be sufficient to show that $P^*(\Gamma) = 1$. Let $t_1, t_2, \dots$ be the t -values used in defining the Γ_j . Let Ω_1 be the space of all $x(t)$ satisfying (2.4.1) for $t = t_1, t_2, \dots$. Then by Lemma 2.3, $P^*(\Omega_1) = 1$, so it will be sufficient to prove that $\Gamma \supset \Omega_1$. Let $\xi(t)$ be any element in Ω_1 . We show that $\xi(t) \in \Gamma$. We have, since $\xi(t) \in \Omega_1$,

$$(2.4.2) \quad \xi_*(t_j) \leq \xi(t_j) \leq \xi^*(t_j), \quad j = 1, 2, \dots$$

Now there is an $x_0(t)$ in Ω such that $x_0(t_j) = \xi(t_j)$, $j \geq 1$: we need only define $x_0(t)$ so that

$$(2.4.3) \quad \xi_*(t) \leq x_0(t) \leq \xi^*(t), \quad t \notin \{t_j\}.$$

Then $x_0(t) \in \Omega \subset \Gamma$ so $\xi(t)$ is in Γ (because $\xi(t_j) = x(t_j)$, $j \geq 1$), as was to be proved. An example will be given below to show that the introduction of infinite-valued functions may be essential in some cases. Evidently it must be known that $x^*(t)$, $-x_*(t)$ are (simultaneously for all t) not equal to $+\infty$, with probability 1, if infinite-valued functions are to be avoided.

We pass to the discussion of measurable processes. A process with space Ω is said to be measurable if the function $x_s(\omega)$ ($= x(s)$) is measurable as a function of the two variables s, ω , with $\omega \in \Omega$.†

THEOREM 2.5. *Let P^* -measure be such that there is a measurable process. Then there is a space Ω of a quasi-separable measurable process. In some cases it is necessary to allow infinite-valued functions in Ω .*

Define the function $\phi_n(t)$ by

$$(2.5.1) \quad \phi_n(t) = k2^{-n}, \quad \text{if } (k-1)2^{-n} < t \leq k2^{-n}, \quad k = 0, \pm 1, \dots, \\ n = 1, 2, \dots$$

Then since there is a measurable process with the given P^* -measure, there is a constant c , and a sequence of integers $\{a_n\}$, such that for t fixed, not in some set e of Lebesgue measure 0,

$$(2.5.2) \quad \lim_{n \rightarrow \infty} x[c + \phi_{a_n}(t)] = x(c + t),$$

with probability 1.† Let $\{\sigma_j\}$ be the sequence of all numbers $\{c + k2^{-n}\}$, $k=0, \pm 1, \dots, n=1, 2, \dots$. Define $x^{**}(t)$, $x_{**}(t)$ by

$$(2.5.3) \quad x^{**}(t) = \limsup_{n \rightarrow \infty} x[c + \phi_{a_n}(t)], \quad x_{**}(t) = \liminf_{n \rightarrow \infty} x[c + \phi_{a_n}(t)].$$

Then for each t not in e , $x_{**}(t) = x(t) = x^{**}(t)$, with probability 1. Let $\{s_j\}$ be a sequence of numbers with the properties described in Theorem 2.2. We can suppose that the sequence $\{s_j\}$ includes the $\{\sigma_j\}$, since any sequence including the sequence $\{s_j\}$ also has the properties described in Theorem 2.2. Defining $x_*(t)$, $x^*(t)$ as in (2.1.3),

$$(2.5.4) \quad x_*(t) \leq x_{**}(t) \leq x^{**}(t) \leq x^*(t),$$

and for each t , we have seen that

$$(2.5.5) \quad x_*(t) \leq x(t) \leq x^*(t),$$

with probability 1. Let Ω be the set of all functions $x(t)$ satisfying

$$(2.5.6) \quad x_{**}(t) \leq x(t) \leq x^{**}(t)$$

for $t \notin e$, and (2.5.5) for $t \in e$. (We are allowing $x(t)$ to take on infinite values.) Then if $x(t) \in \Omega$, $x(t)$ satisfies (2.5.5) identically in t . This means, according to the definition of quasi-separability, that if $\bar{P}^*(\Omega) = 1$, Ω is the space of a quasi-separable process. To prove the theorem, it will therefore be sufficient to prove that $\bar{P}^*(\Omega) = 1$ and that the function $x_s(\omega)$ is a measurable function of (s, ω) , ($\omega \in \Omega$). Let $\Gamma = \sum_1^\infty \Gamma_n$ be any denumerable sum of neighborhoods with $\Gamma \supset \Omega$. To show that $\bar{P}^*(\Omega) = 1$, we shall show that $P^*(\Gamma) = 1$. Let $t_1, t_2, \dots$ be the t -values used in defining the neighborhoods. Let Ω be the space of all $x(t)$ such that (2.5.6) is true for the $t_j \notin e$, and (2.5.5) for the $t_j \in e$. Then $P^*(\Omega_1) = 1$, so it will be sufficient to show that $\Gamma \supset \Omega_1$. Let $\xi(t)$ be any function in Ω_1 :

$$(2.5.7) \quad \begin{aligned} \xi_{**}(t_j) &\leq \xi(t_j) \leq \xi^{**}(t_j), & t_j \notin e, \\ \xi_*(t_j) &\leq \xi(t_j) \leq \xi^*(t_j), & t_j \in e. \end{aligned}$$

Now there is an $x_0(t)$ in Ω such that $x_0(t_j) = \xi(t_j)$, $j \geq 1$: we need only have $x_0(t)$ satisfy

$$(2.5.8) \quad \xi_{**}(t) \leq x_0(t) \leq \xi^{**}(t), \quad t \notin \{t_j\}.$$

Then $x_0(t) \in \Omega \subset \Gamma$. This means that $\xi(t) \in \Gamma$ (because $x_0(t_j) = \xi(t_j)$, $j \geq 1$). Then $\Gamma \supset \Omega_1$: $P^*(\Gamma) = 1$. To complete the proof we must show that $x_s(\omega)$ is (s, ω) -measurable ($\omega \in \Omega$). It is readily verified that $x[c + \phi_{a_n}(s)]$, which is $x_\sigma(\omega)$ with $\sigma = c + \phi_{a_n}(s)$ is (s, ω) -measurable, and it follows that $x_s^{**}(\omega)$, $x_{s**}(\omega)$ (defined in terms of $x^{**}(t)$, $x_{**}(t)$ as $x_s(\omega)$ is in terms of $x(t)$) are (s, ω) -measurable. Then since if $s \notin e$, and if $\omega \in \Omega$ (rewriting (2.5.6))

$$x_{s**}(\omega) \leq x_s(\omega) \leq x_s^{**}(\omega),$$

and since the extremes are equal ($s \notin e$) for almost all $\omega \in \Omega$, the extremes are equal for almost all (s, ω) . Then $x_s(\omega) = x_s^{**}(\omega) = x_{s**}(\omega)$ for almost all (s, ω) ($\omega \in \Omega$), and so $x_s(\omega)$ is (s, ω) -measurable ($\omega \in \Omega$), as was to be proved.

COROLLARY. *The hypotheses of Theorem 2.5 imply the following stronger conclusion. There is a space Ω of a stochastic process, and a denumerable everywhere dense t -set $\{s_j\}$ such that, defining $x_*(t)$, $x^*(t)$ by (2.1.3), and $y_*(t)$, $y^*(t)$ by*

$$(2.5.9) \quad y_*(t) = \liminf_{s_j \downarrow t} x(s_j), \quad y^*(t) = \limsup_{s_j \downarrow t} x(s_j),$$

if $x(t) \in \Omega$,

$$(2.5.10) \quad x_*(t) \leq x(t) \leq x^*(t)$$

for all t , and, except for a t -set e_1 (independent of the function $x(t)$) of Lebesgue measure 0,

$$(2.5.11) \quad y_*(t) \leq x(t) \leq y^*(t).$$

The set e_1 contains no point t' with the property that whenever $\{t_n\}$ is a sequence converging to t' from above: $t_n \downarrow t'$, then

$$(2.5.12) \quad \liminf_{n \rightarrow \infty} x(t_n) \leq x(t') \leq \limsup_{n \rightarrow \infty} x(t_n)$$

with probability 1.

The proof of Theorem 2.5 actually proves most of the corollary. Using the notation of that proof, we have

$$y_*(t) \leq x_{**}(t) \leq x^{**}(t) \leq y^*(t).$$

This means that, to prove the corollary, we need only modify the definition of Ω , as follows. The space Ω is now to include all functions $x(t)$ satisfying (2.5.6) for all $t \notin e$, as before, and also for $t = t' \in e$, if t' is as described in the statement of the corollary; otherwise $x(t)$ is to satisfy (2.5.5) for $t \in e$. The proof then goes through essentially as before.

The following example of a stochastic process illustrates the application of the preceding theorem. We shall restrict t to be non-negative. Define P^* -measure as follows. Let $x(0)=0$ with probability 1. The chance variable $x(t+l)-x(t)$ ($l>0$) has a distribution taking on only integral values, and

$$P^*\{x(t+l)-x(t)=\nu\}=\frac{e^{-l}l^\nu}{\nu!}, \quad \nu=0, 1, 2, \dots$$

If $0 \leq t_0 < \dots < t_n$, the chance variables

$$x(t_1)-x(t_0), \dots, x(t_n)-x(t_{n-1})$$

are to be mutually independent. According to Theorem 2.4, there is a space Ω of a quasi-separable process. Let $\{s_j\}$ be the denumerable set involved in the definition of quasi-separability, so that (2.1.4) is true for all t , if $x(t) \in \Omega$. We can assume that $t=0 \in \{s_j\}$. Evidently $x(t)$, considering t only in $\{s_j\}$ is monotone non-decreasing, starting from 0, and increasing only by jumps of unit magnitude, with probability 1. Then except for an Ω -set of P -measure 0, the functions in Ω are monotone non-decreasing, and continuous except for jumps of magnitude 1, these jumps being the only points of increase. It is easily verified that Ω is the space of a measurable process.[†] According to the corollary to Theorem 2.5, there is even a space Ω_1 of a stochastic process all of whose functions are continuous on the right. In fact the set e_1 of that corollary is empty, because for any t , $t_n \downarrow t$ implies that $x(t_n) \rightarrow x(t)$ with probability 1. In this case infinite-valued functions need not be introduced, but we shall use this example to derive another, in which the introduction of infinite-valued functions is essential, in discussing quasi-separable processes. For each $x(t) \in \Omega_1$, as defined above, we define a function $\xi(t)$, to be 0 at $t=t_0$ if $x(t)$ has a jump there, and otherwise to be $1/|t_1-t_0|$, where t_1 is the closest point to t_0 where there is a jump. The probability relations for the $\xi(t)$ are derived from those of the $x(t)$. For each t , $\xi(t)=\xi_t(\omega)$ is a P -measurable function, and the one-parameter family of chance variables $\{\xi_t(\omega)\}$ determines a new stochastic process. The particular functions $\xi(t)$ we have defined above form a space Ω_ξ , which can be shown to be of outer measure 1 in terms of the new probability measure,[‡] but we shall not need this fact. Evidently if $\xi(t) \in \Omega_\xi$, $\xi(t)$ is continuous except at an isolated denumerable set. If $\{s_j\}$ is any everywhere dense denumerable set, and if $\xi_*(t)$, $\xi^*(t)$ are defined as usual, $\xi_*(t)=+\infty$ at some point in any given interval of length l with probability $(1-e^{-l})$. Thus

$$P\left\{\max_{0 \leq t < \infty} \xi_*(t) = +\infty\right\} = 1$$

and the introduction of infinite-valued functions is necessary to obtain a quasi-separable process for the $\xi(t)$. The space Ω_ξ is not that of a quasi-separable process, but it can be shown that if each $\xi(t)$ in Ω_ξ is altered to $+\infty$ where it vanishes, the resulting $\xi(t)$ are the functions of a quasi-separable process.

THEOREM 2.6. *Suppose that there is a t -set E such that whenever $t_n \downarrow t \in E$ $x(t_n)$ approaches a limit in probability. Then there is a denumerable set $D \subset E$ such that if $t \in E - D$, $x(t+h) \rightarrow x(t)$ in probability as $h \rightarrow 0$.*

Define a metric on the space of P^* -measurable functions $f(\omega)$, by defining the distance between f_1 and f_2 to be

$$d(f_1, f_2) = \int |\arctan f_1 - \arctan f_2| dP,$$

so that $d(f, f_n) \rightarrow 0$ means $f_n \rightarrow f$ in probability, and conversely, if f is finite-valued. Then for each t , the ω -function $x_t(\omega)$ becomes a point of this space, and as t varies we obtain a function of t . This function of t , $\Phi(t)$, has the property that if $t \in E$, $\lim_{t_n \uparrow t} \Phi(t_n)$ exists. Then if $t \in E$, $\lim_{t' \downarrow t} \Phi(t')$ exists. It is well known that a function with this property can have at most a denumerable number of discontinuities on E , and this set of discontinuities is the D of the theorem.

THEOREM 2.7. *Suppose that there is a t -set E such that whenever $t_n \downarrow t \in E$ $\lim_{n \rightarrow \infty} x(t_n)$ exists, with probability 1. Then there is a denumerable set $D' \subset E$, such that if $t \in E - D'$, $t_n \rightarrow t$ implies that $x(t_n) \rightarrow x(t)$ with probability 1. If Ω is the space of a quasi-separable process, each $x(t)$ in Ω is continuous almost everywhere on E with probability 1, and if $t_0 \in E - D'$, $x(t)$ is continuous at t_0 , with probability 1.†*

Since convergence almost everywhere on Ω^* implies convergence in measure (that is, in probability) on Ω^* , Theorem 2.6 implies that there is a denumerable t -set $D \subset E$, such that $t \in E - D$, $t_n \downarrow t$ implies that $x(t_n) \rightarrow x(t)$ in probability, and since $\lim_{n \rightarrow \infty} x(t_n)$ exists with probability 1, this limit must be $x(t)$. Let S be an everywhere dense denumerable t -set. The hypothesis of Theorem 2.7 implies that if $t \in E - D$, $\lim_{t' \downarrow t} x(t')$ exists with probability 1, if t' is restricted to lie in S .‡ Let ν be any positive integer. Then if $t_0 \in E - D$, there is an open interval $I(t_0)$ with t_0 as left-hand end point, such that the oscillation of $x(t)$ ($t \in S$) on $I(t_0)$ is not greater than $1/\nu$, neglecting an Ω^* -set of measure not greater than $1/\nu$. The intervals $I(t)$ cover E except possibly

for an at most denumerable set $D^{(\nu)}$: for the $I(t)$ with $t \in E$, and t not covered, are nonoverlapping intervals, and so are at most denumerable. Moreover if $t_0 \in E - D^{(\nu)}$, the oscillation of $x(t)$ ($t \in S$) at t_0 is not greater than $1/\nu$, neglecting a possible Ω^* -set (depending on t_0) of measure not greater than $1/\nu$. Then if $t_0 \in E - D_1$, where $D_1 = \sum_1^\infty D^{(\nu)}$, the oscillation of $x(t)$ ($t \in S$) is 0, neglecting a possible Ω^* -set of measure 0. This means that if $t_0 \in E - D'$, where $D' = D + D_1$, $\lim_{t \rightarrow t_0} x(t) = x(t_0)$ ($t \in S$), with probability 1. Now let Ω be the space of a quasi-separable process (Theorem 2.4 states that there always is such a space), and let S be a set of t -values such that (2.1.4) is satisfied for all t . It follows that if $t \in E - D'$, $\dagger x(t)$ (in Ω) is continuous at t , with probability 1. This means, in particular, that if $t_n \rightarrow t \in E - D'$, then $x(t_n) \rightarrow x(t)$ with probability 1 in Ω , and therefore in Ω^* . The theorem will be completely proved when it is shown that $x(t)$ (in Ω) is continuous almost everywhere in E , with probability 1. To show this, let $x_s^*(\omega)$ [$x_{s*}(\omega)$] be the function of $\omega: x(t)$ which for $\omega = \omega_0: x_0(t)$ takes on the value $x_0^*(s)$ [$x_{0*}(s)$]. We can then write $x_s^*(\omega) = x^*(s)$, $x_{s*}(\omega) = x_*(s)$. The functions $x_s^*(\omega)$, $x_{s*}(\omega)$ are easily seen to be measurable functions of (s, ω) for $\omega \in \Omega$, and for $s \in E - D'$ are equal almost everywhere on Ω . Then by Fubini's theorem, they are equal almost everywhere on $E - D'$ (that is, almost everywhere on E) for almost all $\omega: x(t)$. The equality of $x^*(t_0)$, $x_*(t_0)$ means the continuity of $x(t)$ at t_0 ; so the theorem is now completely proved.

THEOREM 2.8. *Suppose that P^* -measure has the property that, whatever the denumerable set S , almost every $x(t)$ in Ω^* has the property that $\lim_{t \downarrow t_0} x(t)$ ($t \in S$) exists for all t_0 . Let D_1 (D_2) be the t -set on which it is not true that $t_n \downarrow t$ ($t_n \uparrow t$) implies that $x(t_n) \rightarrow x(t)$ with probability 1. Then D_1, D_2 are denumerable. Let Ω be the space of a quasi-separable process. Then for almost all $x(t)$ in Ω , $\lim_{h \downarrow 0} x(t+h)$ exists, for all t , and $x(t)$ is continuous except perhaps for a denumerable number of discontinuities (varying with the function $x(t)$ in Ω). There is a quasi-separable process with space Ω_1 , for which, in addition to the above, $x(t)$ in Ω_1 is continuous on the right: $x(t+0) = x(t)$ for all $t \notin D_1$.*

The hypotheses imply that if $t_n \downarrow t$, $\lim_{n \rightarrow \infty} x(t_n)$ exists with probability 1. Then according to Theorem 2.7, D_1 and D_2 are denumerable. Let Ω be the space of a quasi-separable process, and let S be a sequence of t -values such that (2.1.4) is satisfied for all t . Then since, according to the hypotheses, $\lim_{h \downarrow 0} x^*(t+h)$, $\lim_{h \downarrow 0} x_*(t+h)$ exist and are equal for all t , with probability 1, it follows that if $x(t) \in \Omega$ and is not in an exceptional ω -set of probability 0, $\lim_{h \downarrow 0} x(t+h)$ exists, for all t . A function with this property has at most a denumerable number of discontinuities. According to the corollary to Theorem 2.5 there must be a space Ω_1 , of a stochastic process, that is, with

$\dagger$ The set D' depends on S .

$\bar{P}^*(\Omega_1) = 1$, all of whose elements are functions continuous on the right if $t \notin D_1$.

This theorem, which sounds somewhat clumsy, has been phrased with the applications in mind. It is applicable, for example, to any differential process: one in which if $t_0 < t_1 < \cdots < t_n$, the chance variables

$$x_{t_1} - x_{t_0}, \cdots, x_{t_n} - x_{t_{n-1}}$$

are mutually independent.† The first example given above was one of such a process.

THEOREM 2.9. *Suppose that P^* -measure has the property that, whatever the denumerable t -set S , almost every $x(t)$ in Ω^* coincides on S with an everywhere continuous function $f_\omega(t)$. Then there is a space Ω of a (quasi-separable) process, whose functions $x(t)$ are everywhere continuous.*

According to Theorem 2.4, there is a quasi-separable process. Evidently almost all the functions involved in this process are everywhere continuous, so the continuous functions themselves can be taken as the functions of a process.

In many applications, the following situation arises. There is given a P^* -measure, and a one-parameter family of P^* -measurable functions $\{f_t(\omega)\}$, $-\infty < t < +\infty$. Let Ω_y^* be the space of all functions $y(t)$. We define a P^* -measure on Ω_y^* by setting

$$P_y^*\{y(t_j) < k_j, j = 1, \cdots, n\} = P^*\{f_{t_j}(\omega) < k_j, j = 1, \cdots, n\}.$$

In other words, we use the family of chance variables $\{f_t(\omega)\}$ to define a new stochastic process. The $y(t)$ of Ω_y^* are the elements of a stochastic process whose measure relations are those given by the $x(t)$. It is frequently desirable to restrict the $x(t)$ to some space Ω (to obtain a quasi-separable or measurable process) and to consider only the $y(t)$ given by

$$y(t) = f_t(\omega), \quad \omega \in \Omega, \quad -\infty < t < \infty.$$

It is known that the space Ω_y of these $y(t)$ has outer P_y^* -measure 1, and so is the space of a stochastic process,‡ but it is also desirable to know that this process has further properties, such as quasi-separability or measurability. In the application to be made in the next section, $f_t(\omega)$ is only determined, for each t , up to an ω -set of measure 0, and this is the usual case. We can then vary Ω_y by changing $f_t(\omega)$ for each t on an ω -set of measure 0. We shall show that by doing this we can (i) *make Ω_y the space of a quasi-separable process, or*

(ii) (if the P_v^* -measure is such that there is a measurable process) we can make Ω_v the space of a quasi-separable measurable process.

Proof of (i). Let $\{s_n\}$ be a t -set with the properties described in Theorem 2.2, using P_v^* -measure. Define $f_{t*}(\omega), f_t^*(\omega)$ by

$$f_{t*}(\omega) = \lim_{|I| \rightarrow 0} \text{G.L.B.}_{s_j \in I} f_{s_j}(\omega), \quad f_t^*(\omega) = \lim_{|I| \rightarrow 0} \text{L.U.B.}_{s_j \in I} f_{s_j}(\omega),$$

where I is an open interval, containing t , of length $|I|$. Then according to Lemma 2.3, for each t ,

$$f_{t*}(\omega) \leq f_t(\omega) \leq f_t^*(\omega)$$

almost everywhere on Ω . There is a subspace $\Omega_0 \subset \Omega$ of P -measure 1, such that these inequalities are satisfied for all $\omega \in \Omega_0$ if $t \in \{s_j\}$. If $f_{t_0}(\omega_0)$ does not satisfy this inequality for $\omega_0 \in \Omega_0$, redefine $f_{t_0}(\omega_0)$ as any number between $f_{t_0*}(\omega_0)$ and $f_{t_0}^*(\omega_0)$. We thus change $f_{t_0}(\omega)$ on at most an ω -set of measure 0, and incidentally may introduce some infinite values. The new function $g_t(\omega)$ has the properties

$$\begin{aligned} g_{s_j}(\omega) &= f_{s_j}(\omega), & j \geq 1, \omega \in \Omega_0, \\ f_{t*}(\omega) &= g_{t*}(\omega) \leq g_t(\omega) \leq g_t^*(\omega) = f_t^*(\omega). \end{aligned}$$

Let $g_t(\omega) = 0$ if $\omega \in \Omega - \Omega_0$. Then the functions $y(t): y(t) = g_t(\omega)$, $\omega \in \Omega$, determine a space Ω_v of the desired quasi-separable process.

The proof of (ii) is along the same lines, and will be omitted. The result can be extended in the same way that Theorem 2.5 was extended in its corollary.

3. One-parameter families of chance variables with the property $\mathcal{E}$. In this section, we shall apply the results of §2 to the special case in which the chance variables $\{x_t(\omega)\}$ defined in §2 have the property $\mathcal{E}$.† An important example of the kind of process being considered here is the following. Let Ex_t exist for all $t \geq 0$, and suppose that $Ex_t \equiv 0$; suppose also that if $0 \leq t_0 < \dots < t_n$, the chance variables

$$x_{t_1} - x_{t_0}, \dots, x_{t_n} - x_{t_{n-1}}$$

are mutually independent. The chance variables $\{x_t(\omega)\}$, $t \geq 0$, then have the property $\mathcal{E}$ if x_0 is set identically 0 at $t=0$. In this case, the qualitative characteristics of the random function x_t , as given by P. Lévy [6, 7], are well known: x_t can be considered continuous except for discontinuities of the first kind (jumps), or, in the terminology of the present paper, there is a space Ω

of a stochastic process with the given P^* -measure, whose functions $x(t)$ are continuous except for jumps.† It will be seen below that much of this regularity is true in the more general case now under discussion.

Suppose that the chance variables $\{x_t(\omega)\}$ have the property $\mathcal{E}$. Let $t_n \rightarrow t$ and suppose that the sequence $\{t_n\}$ is monotone increasing. Then the chance variables $x_1, x_2, \dots, x'$, with $x_n = x(t_n)$, $x' = x(t)$ satisfy the hypotheses of Theorem 1.4, so $\lim_{n \rightarrow \infty} x(t_n) = x_t(t)$ exists, with probability 1, and the variables $x(t_1), x(t_2), \dots, x_t(t), x(t)$ have the property $\mathcal{E}$. The limit $x_t(t)$ is independent of the sequence $\{t_n\}$ (neglecting Ω^* -sets of zero P^* -measure), since two sequences can be combined into a single one, and evidently $t_n \uparrow t$ implies that $x(t_n) \rightarrow x_t(t)$ with probability 1, even if the sequence $\{t_n\}$ is not monotone. Similarly, using Theorem 1.2, $t_n \downarrow t$ implies that $\lim_{n \rightarrow \infty} x(t_n) = x_r(t)$ exists, with probability 1, and is independent of the sequence $\{t_n\}$, neglecting Ω^* -sets of zero P^* -measure. By Theorem 2.7, $x_t(t) = x_r(t) = x(t)$ with probability 1, if t is not in some set D which is at most denumerable. It also follows from Theorem 1.2 that there is a chance variable $x(-\infty)$ such that if $t_n \rightarrow -\infty$ then $x(t_n) \rightarrow x(-\infty)$ with probability 1. The family of chance variables $\{x(t)\} = \{x_t(\omega)\}$ augmented by the newly defined $x_t(t), x_r(t), x(-\infty)$, and ordered in the natural way, has the property $\mathcal{E}$. By the corollary to Theorem 0.2, $E|x(t)|$ is a monotone non-decreasing function of t . If $E|x(t)|$ is a bounded function, Theorem 1.3 shows that there is a chance variable $x(+\infty)$ such that if $t_n \rightarrow +\infty$, $x(t_n) \rightarrow x(+\infty)$, with probability 1. Theorem 0.3 states that the chance variables $x_t(\omega)$, for t in any set bounded on the right, are uniformly integrable.

THEOREM 3.1. *Let $\{x_t\}$, $-\infty < t < +\infty$, be chance variables with the property $\mathcal{E}$. Define Λ, M by*

$$\Lambda = \{U_I[x_t] > k\}, \quad M = \{L_I[x_t] < k\},$$

where I is the interval $a \leq t \leq b$. Then if $s \geq b$,

$$(3.1.1) \quad \int_{\Lambda} x_s dP \geq kP(\Lambda), \quad \int_M x_s dP \leq kP(M). \ddagger$$

If $E|x_b \log |x_b|| < \infty$, $E\{U_I[|x_t|]\} < \infty$.

We have shown that

$$U_I[x_t] = \text{L.U.B.}_{j \geq 1} x_{s_j}, \quad L_I[x_t] = \text{G.L.B.}_{j \geq 1} x_{s_j}$$

for a suitably chosen sequence s_j in the interval I . By Theorem 1.1, if

$$\Lambda_n = \left[\text{L.U.B.}_{j \leq n} x_{s_j} \geq k + 1/n \right],$$

it follows that

$$\int_{\Lambda_n} x_s dP \geq kP(\Lambda_n), \quad s \geq b.$$

If n becomes infinite, this becomes the first inequality in (3.1.1), and the second is proved in the same way. If $E|x_b \log |x_b|| < \infty$, there is, according to Theorem 1.5, a constant K , depending only on this expectation, such that $E\{\text{L.U.B.}_{j \leq n} |x_{s_j}|\} \leq K$. If $n \rightarrow \infty$ we find that $E\{U_I|x_t|\} \leq K$, as was to be proved.

If the chance variables $\{x_t(\omega)\}$ have the property $\mathcal{E}$, we have seen that $t_n \rightarrow t$ implies that $x(t_n) \rightarrow x(t)$ with probability 1, unless t is in an exceptional set which is at most denumerable. There is then a measurable process.[†] According to Theorem 2.5, there is a quasi-separable measurable process. By Theorem 3.1, if I is any finite interval, $U_I[|x(t)|] < \infty$, with probability 1. Then it is unnecessary to use infinite-valued functions in discussing quasi-separable processes. Let $D_1 \subset D$ be the (at most denumerable) set of t -values where $x(t)$, $x_r(t)$ are different on Ω^* -sets of positive measure. The main result of this section is that there is a space Ω of a stochastic process with the given probability measure whose elements are continuous except possibly on a denumerable t -set, and everywhere continuous on the right, except perhaps at points of D_1 (the limit $\lim_{t' \downarrow t} x(t')$ existing even on D_1). In order to prove this, we shall need several preliminary results.

LEMMA 3.2. *Let $u_\alpha(\omega)$ be a measurable function of ω , where ω varies on some space on which a measure function is defined. The subscript α ranges through the ordinals of the first and second classes. Suppose that for each ω if $\alpha_2 > \alpha_1$, $u_{\alpha_2}(\omega) > u_{\alpha_1}(\omega)$ unless $u_\beta(\omega) = u_{\alpha_1}(\omega)$ for all $\beta > \alpha$. Let $u(\omega) = \text{L.U.B.}_{\alpha \geq 1} u_\alpha(\omega)$. Then there is a subscript ν such that $u_\nu(\omega) = u(\omega)$ for almost all ω .*

We shall only need this lemma if the $\{u_\alpha(\omega)\}$ are uniformly bounded and if the ω -measure is finite-valued, so only this case will be proved, but the extension to the general case can easily be done. Let ϵ be any positive number. We shall prove first that there is a subscript $\beta = \beta_\epsilon$ such that if $\gamma > \beta$, $u_\gamma - u_\beta < \epsilon$ except possibly on a set (depending on γ), of measure less than ϵ . If this is not so there are pairs (β_1, γ_1) , (β_2, γ_2) , $\dots$ with $\beta_1 < \gamma_1 < \beta_2 < \gamma_2 < \dots$ such that $\mu_{\gamma_n}(\omega) - \mu_{\beta_n}(\omega) \geq \epsilon$ on an ω -set Λ_n of measure not less than ϵ . The set of points Λ in infinitely many Λ_n has measure at least ϵ . Now this is impossible, since

[†] Doob [1, p. 118].

then $u(\omega) = +\infty$ on Λ_n , and we have supposed that the u_α are uniformly bounded. There are therefore subscripts $\beta_1, \beta_2, \dots, \beta_1 < \beta_2 < \dots$ such that (we are choosing ϵ successively as $1/2, 1/3, \dots$ in the above result) if $\gamma > \beta_n$

$$u_\gamma - u_{\beta_n} < 1/n,$$

except possibly on a set of measure less than $1/n$. The sequence $\{\mu_{\beta_n}(\omega)\}$ is monotone; let $\lim_{n \rightarrow \infty} u_{\beta_n} = u_\infty$. Let ν be any ordinal of the second class, beyond $\beta_1, \beta_2, \dots$. Then $\mu_\nu \geq \mu_{\beta_n}, n \geq 1$, so $u_\nu \geq u_\infty$ for almost all ω . On the other hand, $u_\nu \leq u_{\beta_n} + 1/n$, except possibly on a set of measure not greater than $1/n$. Therefore $u_\nu \leq u_\infty$ for almost all ω . It follows that $u_\nu = u_\infty$ for almost all ω and, since ν was any ordinal of the second class beyond $\beta_1, \beta_2, \dots, u_{\nu+1} = u_\infty$, for almost all ω also. Thus except for an ω -set Λ_0 of zero measure, $u_{\nu+1} = u_\infty$. This implies that if $\omega \notin \Lambda_0, u_\nu = u_{\nu+1} = \dots = u$, as was to be proved.

LEMMA 3.3. *Suppose that P^* -measure has the property that for almost all $t, t_n \rightarrow t$ implies that $x(t_n) \rightarrow x(t)$ with probability 1. There is then a space Ω of a quasi-separable measurable process. Let $\phi(\omega)$ be an Ω -measurable function and let $\phi_n(\omega) = \nu/n$, where*

$$(\nu - 1)/n \leq \phi(\omega) < \nu/n, \quad \nu = 0, \pm 1, \dots, n = 1, 2, \dots$$

Then $x[s + \phi_n(\omega)], x[s + \phi(\omega)]^\dagger$ are measurable (s, ω) -functions ($\omega \in \Omega$) and $x[s + \phi_n(\omega)] \rightarrow x[s + \phi(\omega)]$ almost everywhere on (s, ω) -space ($\omega \in \Omega$).

According to Theorem 2.4, there is a quasi-separable process with the given P^* -measure. The hypotheses have been shown to imply that any quasi-separable process is measurable.[†] Let Ω be the space of a quasi-separable measurable process. To show that $x[s + \phi(\omega)]$ is (s, ω) -measurable ($\omega \in \Omega$), we must show that for any $k, \{x[s + \phi(\omega)] > k\}$ is an (s, ω) -measurable set. Since $x_s(\omega)$ is (s, ω) -measurable ($\omega \in \Omega$), because of the measurability of the process with space Ω , we need only show that if Λ is an (s, ω) -measurable set, the points (s, ω) with $(s + \phi(\omega), \omega) \in \tilde{\Lambda}$ constitute an (s, ω) -measurable set. Denote this image of $\tilde{\Lambda}$ by $\tilde{\Lambda}_1$. We shall show that the transformation $\tilde{\Lambda} \rightarrow \tilde{\Lambda}_1$ takes measurable sets into measurable sets. Suppose first that $\tilde{\Lambda} = I \times \Lambda$: the direct product of an s -interval $a \leq s \leq b$ and a measurable Ω -set Λ . Then $\tilde{\Lambda}_1$ is a simple ordinate set: the (s, ω) points "over" Λ determined by the inequalities

$$a - \phi(\omega) \leq s \leq b - \phi(\omega),$$

and an ordinate set of this type is known to be measurable. It follows that if Λ

[†] The function $x[s + \phi(\omega)]$ is the function $x_\sigma(\omega)$, where $\sigma = s + \phi(\omega)$, and $x[s + \phi_n(\omega)]$ is defined similarly.

[‡] Doob [1, p. 118].

is in the Borel field $\mathcal{F}$ of sets determined by the sets which are direct products of s -intervals and Ω -measurable sets, the corresponding $\tilde{\Lambda}_1$ is (s, ω) -measurable. In particular suppose that $\tilde{\Lambda} \in \mathcal{F}$ and that $\tilde{\Lambda}$ has measure 0. Then for almost all ω_0 the s -set $\{(s, \omega_0) \in \tilde{\Lambda}\}$ is of measure 0. This same fact will certainly be true of the s -set $\{(s + \phi(\omega_0), \omega_0) \in \tilde{\Lambda}\}$ so the set $\tilde{\Lambda}_1$ will have measure 0. Since any (s, ω) -measurable set of measure 0 can be included in some set of $\mathcal{F}$ which is of measure 0, it follows that whenever $\tilde{\Lambda}$ is measurable and has measure 0, the same is true of $\tilde{\Lambda}_1$. Now the most general (s, ω) -measurable set $\tilde{\Lambda}$ differs from some set $\tilde{M}$ of $\mathcal{F}$ at most by a set of measure 0, so the corresponding $\tilde{\Lambda}_1$ will differ from $\tilde{M}_1$ by at most a set of measure 0: $\tilde{\Lambda}_1$ is measurable, as was to be proved. We have thus proved that $x[s + \phi(\omega)]$ (and therefore $x[s + \phi_n(\omega)]$) is (s, ω) -measurable ($\omega \in \Omega$). According to Theorem 2.7, if $x(t) \in \Omega$, $x(t)$ is continuous for almost all t , with probability 1. Then if ω is fixed, $x[s + \phi_n(\omega)] \rightarrow x[s + \phi(\omega)]$ for almost all s , with probability 1. This implies that $x[s + \phi_n(\omega)] \rightarrow x[s + \phi(\omega)]$ for almost all (s, ω) , which is the final conclusion of the lemma.

LEMMA 3.4. *Let $u(\omega)$ be an ω -measurable function, defined on the space Ω of a stochastic process whose chance variables $\{x_t(\omega)\}$ have the property $\mathcal{E}$. Suppose that $u(\omega)$ takes on only a finite number of values: $u(\omega) = \lambda_j$ on Λ_j , $j = 1, 2, \dots$. Suppose that for each j , $\{u(\omega) = \lambda_j\}$ is an ω -set depending on $\omega: x(t)$ for $t < \lambda_j$. Then the chance variables $\{y_t\}$, $y_t = x[t + u(\omega)]$ (that is, $y_t = x_\sigma(\omega)$, $\sigma = t + u(\omega)$), have the property $\mathcal{E}$, for $t > 0$.*

To prove this fact, we need only show that if M is a P^* -measurable set depending on the $y(t)$ for $t = t_1, \dots, t_v$, $0 < t_1 < \dots < t_v < t_v + h$, then

$$(3.4.1) \quad \int_M y_{t_v+h} dP = \int_M y_{t_v} dP.$$

Now

$$(3.4.2) \quad \int_M y_{t_v+h} dP = \sum_j \int_{\Lambda_j \cdot M} y_{t_v+h} dP = \sum_j \int_{\Lambda_j \cdot M} x(t_v + h + \lambda_j) dP.$$

The conditions on the $y(t_i)$ determining M are, on Λ_j , conditions on $x(t_i + \lambda_j)$, $i = 1, \dots, v$, so $\Lambda_j \cdot M$ is a set depending on t -values for $t \leq t_v + \lambda_j$. Because of the fact that

$$E[x_t, t \leq t_v + \lambda_j; x_{t_v+\lambda_j+h}] = x_{t_v+\lambda_j},$$

with probability 1 (Theorem 0.1), we find that

$$(3.4.3) \quad \int_{\Lambda_j \cdot M} x(t_v + \lambda_j + h) dP = \int_{\Lambda_j \cdot M} x(t_v + \lambda_j) dP = \int_{\Lambda_j \cdot M} y_{t_v} dP.$$

Summing over j gives

$$(3.4.4) \quad \int_{\mathbf{M}} y_{t, t+h} dP = \int_{\mathbf{M}} x(t_v + u + h) dP = \int_{\mathbf{M}} y_{t_v} dP,$$

or (3.4.1), as was to be proved.

LEMMA 3.5. *Let $u(\omega)$ be a bounded ω -measurable function, defined on the space Ω of a stochastic process whose chance variables $x_t(\omega)$ have the property $\mathcal{E}$. Suppose that for each number c , $\{u(\omega) \geq c\}$ is an ω -set depending on $\omega: x(t)$ for $t < c$. Let S be any everywhere dense denumerable set. Then $\lim_{s \rightarrow 0} x[s+u(\omega)]^\dagger$ ($s \in S$) exists with probability 1.*

Let $u_n(\omega) = v/n$ where

$$(v-1)/n \leq u(\omega) < v/n, \quad v = 0, \pm 1, \dots, n = 1, 2, \dots$$

Then $u_n(\omega)$ satisfies the hypotheses of Lemma 3.4. Let $y_n(s) = x[s+u_n(\omega)]$, $y(s) = x[s+u(\omega)]$. We show first that, for fixed n and $s > 0$, if $T > s + L.U.B._{\omega} u(\omega)$, then

$$(3.5.1) \quad E[y_n(s); x(T)] = y_n(s),$$

with probability 1, that is, that the ordered pair of chance variables $y_n(s)$, $x(T)$ has the property $\mathcal{E}$. Let Λ be any ω -set depending on y_n , that is, determined by some condition imposed on y_n . It must be shown that

$$(3.5.2) \quad \int_{\Lambda} y_n(s) dP = \int_{\Lambda} x(T) dP.$$

Let $\Lambda_{n,j} = \{u_n = j/n\}$. Then

$$(3.5.3) \quad \int_{\Lambda} y_n(s) dP = \sum_j \int_{\Lambda \cdot \Lambda_{n,j}} x(s + j/n) dP.$$

Now the ω -set $\Lambda_{n,j}$ depends only on t -values less than j/n , and on $\Lambda_{n,j}$ the condition on y_n determining Λ becomes one on $x(s+j/n)$, so $\Lambda \cdot \Lambda_{n,j}$ depends only on t -values not greater than $s+j/n$. This means that, using the property $\mathcal{E}$,

$$(3.5.4) \quad \int_{\Lambda} y_n(s) dP = \sum_j \int_{\Lambda \cdot \Lambda_{n,j}} x(T) dP = \int_{\Lambda} x(T) dP,$$

or (3.5.1), as was to be shown. Now if n varies, it follows that the $y_n(s)$ are uniformly integrable, from the proof of Theorem 0.3: in fact, the proof of that theorem did not use the full property $\mathcal{E}$, but only the fact that, for

$\dagger$ The function $x[s+u(\omega)]$ is the function $x_{\sigma}(\omega)$, where $\sigma = s+u(\omega)$.

$t \leq t_0$, $E[x_t; x_{t_0}] = x_t$ with probability 1. This corresponds to the fact that $E[y_n; x(T)] = y_n$, $n = 1, 2, \dots$, with probability 1.

Having these preliminary facts in mind, we proceed to prove Lemma 3.1. We enlarge S to include the rational numbers, and so that S contains the number $s_1 + s_2$ if it contains s_1 and s_2 . Let δ_1, δ_2 be positive numbers, with $\delta_1 < \delta_2$. According to Lemma 3.4, the $y_n(s)$ for $s > 0$ (n fixed) have the property $\mathcal{E}$. Then it can be verified at once that the chance variables $y_n(s) - y_n(\delta_1)$, for $s > \delta_1$ (n fixed) have the property $\mathcal{E}$. Using Theorem 3.1, we find that

$$(3.5.5) \quad P \left\{ \text{L.U.B.}_{\delta_1 < s < \delta_2} [y_n(s) - y_n(\delta_1)] > \epsilon \right\} \leq \frac{1}{\epsilon} \int_{\Lambda} [y_n(\delta_2) - y_n(\delta_1)] dP, \quad s \in S,$$

where Λ is the set on the left, and

$$(3.5.6) \quad P \left\{ \text{G.L.B.}_{\delta_1 < s < \delta_2} [y_n(s) - y_n(\delta_1)] < -\epsilon \right\} \leq \frac{1}{\epsilon} \int_{\mathbf{M}} [y_n(\delta_2) - y_n(\delta_1)] dP, \quad s \in S,$$

where $\mathbf{M}$ is the set on the left. Then surely

$$(3.5.7) \quad \begin{aligned} P \left\{ \text{L.U.B.}_{\delta_1 < s < \delta_2} [y_n(s) - y_n(\delta_1)] > \epsilon \right\} &\leq \frac{1}{\epsilon} \int |y_n(\delta_2) - y_n(\delta_1)| dP, \\ P \left\{ \text{G.L.B.}_{\delta_1 < s < \delta_2} [y_n(s) - y_n(\delta_1)] < -\epsilon \right\} &\leq \frac{1}{\epsilon} \int |y_n(\delta_2) - y_n(\delta_1)| dP, \end{aligned} \quad s \in S,$$

so that

$$(3.5.8) \quad P \left\{ \text{L.U.B.}_{\delta_1 < s < \delta_2} |y_n(s) - y_n(\delta_1)| > \epsilon \right\} \leq \frac{2}{\epsilon} \int |y_n(\delta_2) - y_n(\delta_1)| dP, \quad s \in S,$$

which implies that

$$(3.5.9) \quad P \left\{ \text{L.U.B.}_{\delta_1 < s', s'' < \delta_2} |y_n(s') - y_n(s'')| > 2\epsilon \right\} \leq \frac{2}{\epsilon} \int |y_n(\delta_2) - y_n(\delta_1)| dP, \quad s', s'' \in S.$$

Now if ξ_n denotes the quantity on the left in (3.5.9),

$$(3.5.10) \quad \begin{aligned} \xi_n &= \sum_{\nu} P \left\{ \text{L.U.B.}_{\delta_1 < s', s'' < \delta_2} |x(s' + \nu/n) - x(s'' + \nu/n)| > 2\epsilon; u_n = \nu/n \right\} \\ &= \sum_{\nu} P \left\{ \text{L.U.B.}_{\delta_1 + \nu/n < s', s'' < \delta_2 + \nu/n} |x(s') - x(s'')| > 2\epsilon; u_n = \nu/n \right\}, \\ &\geq P \left\{ \text{L.U.B.}_{\delta_1 + u + 1/n < s', s'' < \delta_2 + u} |x(s') - x(s'')| > 2\epsilon \right\}, \quad s', s'' \in S. \end{aligned}$$

It is easily verified that all the sets involved are ω -measurable. When n becomes infinite, we obtain

$$(3.5.11) \quad \liminf_{n \rightarrow \infty} \xi_n \geq P \left\{ \text{L.U.B.}_{\delta_1+u < s', s'' < \delta_1+u} |x(s') - x(s'')| > 2\epsilon \right\}, \quad s', s'' \in S.$$

It was shown in Lemma 3.3 that $y_n(s) \rightarrow y(s)$ for almost all (s, ω) . Then except for some s -set e of measure 0, $y_n(s) \rightarrow y(s)$ for almost all ω . Choose δ_1, δ_2 not in e . Combining (3.5.9), (3.5.10), (3.5.11), we find that

$$(3.5.12) \quad P \left\{ \text{L.U.B.}_{\delta_1+u < s', s'' < \delta_1+u} |x(s') - x(s'')| > 2\epsilon \right\} \leq \frac{2}{\epsilon} \int_{s', s'' \in S} |y(\delta_2) - y(\delta_1)| dP,$$

We can integrate to the limit because the y_n have been shown to be uniformly integrable. Now let $\delta_1 \rightarrow 0$ along a sequence of values remaining out of the set e . By Theorem 1.2, $y(\delta)$ approaches a limit with probability 1, say $y(0+)$, and we can integrate term by term, so that

$$(3.5.13) \quad P \left\{ \text{L.U.B.}_{u < s', s'' < \delta_1+u} |x(s') - x(s'')| > 2\epsilon \right\} \leq \frac{2}{\epsilon} \int_{s', s'' \in S} |y(\delta_2) - y(0+)| dP,$$

If now $\delta_2 \rightarrow 0$ along the same sequence of values, the integral goes to 0. This means that the oscillation of $x(t)$ at $t=u(\omega)$ on the right (only considering the function $x(t)$ defined on S) is not greater than 2ϵ , with probability 1. Since ϵ is arbitrary, the lemma follows at once from this fact.

THEOREM 3.6. *Suppose that the chance variables $\{x_t\}$ have the property $\mathcal{E}$. Let D_1 be the (at most denumerable) set of t -values for which $x(t), x_r(t)$ are not identical with probability 1. There is a space Ω of a quasi-separable measurable stochastic process whose elements $x(t)$ have the following properties: each element $x(t)$ is continuous except possibly at a denumerable set of t -values (which may vary with the element $x(t)$); $\lim_{h \downarrow 0} x(t+h)$ exists for all t , and the limit is $x(t)$ if $t \notin D_1$; $\lim_{h \downarrow 0} x(t+h) = x_r(t)$, $\lim_{h \uparrow 0} x(t+h) = x_l(t)$ with probability 1, at each t -value.[†]*

The results obtained in this theorem are less strong than those obtained in the case of a differential process, discussed above, in which the increments of $x(t)$ in nonoverlapping intervals are independent chance variables. In the differential case, the only discontinuities are jumps, whereas here the elements $x(t)$ can apparently have complicated discontinuities on the left (of probability 0 at any fixed t -value, however, except where $x_l(t), x_r(t)$ are not

equal with probability 1, and there the discontinuity is a jump, with probability 1). Some such difference might have been suspected, since the property $\mathcal{E}$ is essentially unsymmetric in t .

Proof of Theorem 3.6. Let S be any everywhere dense denumerable set, and let ϵ be any positive number. Consider the t -set $E[x(t)]$ where the oscillation of $x(t)$ ($t \in S$) is not less than ϵ . This is a closed set. The ω -set

$$(3.6.1) \quad \prod_{\nu=1}^{\infty} \sum_{|s'-s''| < 1/\nu, a-1/\nu < s', s'' < b+1/\nu} \{ |x(s') - x(s'')| \geq \epsilon - 1/\nu \}, \quad s', s'' \in S,$$

is the set of elements $x(t)$ for which E has at least one point in $a \leq t \leq b$. This set is evidently P^* -measurable. Let k be any positive integer. For each $x(t)$ define $u[x(t)]$ as the first value of t with $-k \leq t \leq k$ in $E[x(t)]$ at which the discontinuity on the right is greater than 0;† if there is no such point, let $u = k$. The points s of $E[x(t)]$ with $-k \leq s < u[x(t)]$ define a set $F[x(t)]$ with the following properties: there is no sequence $s_1, s_2, \dots$ in $F[x(t)]$ with $s_1 > s_2 > \dots$; $F[x(t)]$ is at most denumerable. Then if $F[x(t)]$ is not empty, and is ordered from left to right, it is a well-ordered set, whose ordinal number is in the first or second class. If α is any ordinal number in the first or second class, define $u_\alpha[x(t)]$ as the α th point of $F[x(t)]$ (or $u_\alpha = u$, if there is no α th point). Then if $\beta > \alpha$, $u_\beta[x(t)] > u_\alpha[x(t)]$ unless $u_\alpha[x(t)] = u_{\alpha+1}[x(t)] = \dots = u[x(t)]$, and for each function $x(t)$ there will be an α such that the above equalities are true. Concluding this preliminary discussion, we come to the proof of the theorem, which we shall divide into three parts.

I. Let k_1, k_2 be any numbers with $k_1 < k_2$. Let $v[x(t)]$ be the first point of $E[x(t)]$ in the interval $k_1 \leq t \leq k_2$, or if there is no such point let $v[x(t)] = k_2$. Then we prove that

- (i) $v[x(t)]$ is a measurable function of ω ,
- (ii) the ω -set $v \geq c$, for any number c , depends only on t for $t < c$, and
- (iii) the oscillation of $x(t)$ ($t \in S$) on the right at $v[x(t)]$ is 0.

To prove (i) it is sufficient to note that $k_1 \leq v \leq k_2$ and that the (measurable) ω -set (3.6.1) with $a = k_1$, $k_1 < b < k_2$, is the set $\{v \leq b\}$. To prove (ii) we note first (from (3.6.1) with $a = k_1$, $b = c - \eta$) that the ω -set $\{v \leq c - \eta\}$ ($k_1 < c < k_2$) depends only on t -values less than $c - \eta/2$, for any $\eta > 0$. Letting $\eta \rightarrow 0$, we find that the ω -set $\{v < c\}$ and therefore also $\{v \geq c\}$ depends only on t -values less than c . It then follows that (ii) holds for all c . Lemma 3.5 can now be applied to show that $\lim_{s \downarrow v} x(s)$ ($s \in S$) exists with probability 1, that is, that (iii) is true.

† The discontinuity on the right at t_0 is defined as $\lim_{\delta \rightarrow 0} \text{L.U.B.}_{t_0 < s', s'' < t_0 + \delta} |x(s') - x(s'')|$ ($s', s'' \in S$).

II. We next prove that for each α

(i) $u_\alpha[x(t)]$ is a measurable function of ω and

(ii) $\{u_\alpha[x(t)] \geq c\}$, for any number c , depends only on t -values for $t < c$.

The proof will be given by transfinite induction. Consider the case $\alpha = 1$. Let $v[x(t)]$ be the first point of $E[x(t)]$ in the interval $-k \leq t \leq k$, or let $v = k$ if there is no such point. Then I shows that $v = u_1$ with probability 1, and that u_1 has the properties (i) and (ii) since v has. Suppose that (i) and (ii) are true for some α . We shall show that they are then true for $\alpha + 1$. Let $w[x(t)]$ be the first point of $E[x(t)]$ in the interval $u_\alpha[x(t)] < t \leq k$; let $w = k$, if there is no such point or if $u_\alpha = k$. We can obtain w as follows: for each rational number $r < k$ determine the ω -set $\{u_\alpha < r\}$; on this set w is the first point of $E[x(t)]$ beyond r , and not greater than k , or $w = k$ if there is no such point; if $u_\alpha = k$, $w = k$ also. This makes it obvious, using I, that $w = u_{\alpha+1}$ with probability 1. Properties (i), (ii) are true for $u_{\alpha+1}$ since they are true for w (as can be seen using I and the fact that (i), (ii) are known to be true for u_α). To finish the induction proof of (i), (ii), we must show that if $\alpha_1 < \alpha_2 < \dots$, and if α is the first ordinal beyond the α_j , then (i), (ii) are true for u_α if they are supposed true for $u_{\alpha_1}, u_{\alpha_2}, \dots$. Let $w = \lim_{j \rightarrow \infty} u_{\alpha_j}$. Then w is a P^* -measurable function, $w \leq u$, and if $w[x(t)] < k$, $w[x(t)]$ is certainly a point of $E[x(t)]$. Moreover, since (ii) is true for $u_{\alpha_1}, u_{\alpha_2}, \dots$, it follows easily that (ii) is true for $w[x(t)]$. Lemma 3.5 now shows that $x(t)$ has 0 oscillation on the right ($t \in S$) at w , with probability 1, so that $w[x(t)] = u_\alpha[x(t)]$, with probability 1. Therefore u_α has the properties (i) and (ii), since w has. We have thus proved that (i), (ii) hold for all α .

III. The functions $\{u_\alpha(\omega)\}$ satisfy the hypotheses of Lemma 3.2, so there is an index ν such that $u_\nu = \text{L.U.B.}_\alpha u_\alpha = u$ except possibly on an ω -set of measure 0. It is impossible that $u_\nu = u < k$ on an ω -set of positive measure, because u_ν is a point with 0 oscillation of $x(t)$ ($t \in S$) on the right, with probability 1 (Lemma 3.5), whereas u is by hypothesis a point where the oscillation on the right is positive, if $u < k$. Then $u_\nu = u = k$ almost everywhere on Ω^* . The indices $\alpha \leq \nu$ are denumerable, at most, so we have proved that if an ω -set of measure 0 is excluded, $\lim_{t' \downarrow t} x(t')$ ($t' \in S$) exists for all t , with $|t| \leq k$, where the oscillation of $x(t)$ ($t \in S$) is at least ϵ . If we apply this result letting ϵ run through the values $1, 1/2, 1/3, \dots$ and k through the values $1, 2, \dots$, we find that neglecting some ω -set of measure 0, $\lim_{t' \downarrow t} x(t')$ ($t' \in S$) exists for all t . Theorem 2.8 can now be applied to give the conclusion of the present theorem, except that part involving $\lim_{h \downarrow 0} x(t+h)$, $\lim_{h \uparrow 0} x(t+h)$ (t fixed), $\lim_{t \rightarrow \infty} x(t)$, $\lim_{t \rightarrow -\infty} x(t)$. We have seen above, in our preliminary discussion of continuous stochastic processes whose chance variables $\{x_t(\omega)\}$ have the property $\mathcal{E}$, that if $t_n \downarrow t$, $x(t_n) \rightarrow x_\tau(t)$ with probability 1. This implies that if S

is any denumerable set, $\lim_{t' \downarrow t} x(t') = x_r(t)$ ($t' \in S$), with probability $1 \dagger$; so if the process is quasi-separable, $\lim_{h \downarrow 0} x(t+h) = x_r(t)$, with probability 1. The other cases are treated similarly.

THEOREM 3.7. *Let P^* -measure be arbitrary, and let x be any chance variable depending on the x_t (that is, a P^* -measurable function) whose expectation exists. Let Ω be the space of a stochastic process with this P^* -measure. Then if $y(t) = E[x_s, s \leq t; x]$, $\ddagger$ these conditional expectations can be defined so that for ω fixed, in Ω , not in some set of probability 0, $y(t)$ is continuous except possibly on a denumerable set, and even on this set $\lim_{h \downarrow 0} y(t+h)$ exists; moreover $\lim_{t \rightarrow +\infty} y(t)$ exists, and $\lim_{t \rightarrow +\infty} y(t) = x$.*

The chance variables $y(t)$ have the property $\mathcal{E}$. This theorem follows readily from Theorem 3.6, using the discussion of families of P^* -measurable functions at the end of §2. The fact that the limit as $t \rightarrow +\infty$ is x follows from Theorem 1.4.
