

SPECTRAL TYPE OF THE SHIFT TRANSFORMATION OF DIFFERENTIAL PROCESSES WITH STATIONARY INCREMENTS⁽¹⁾

1. **Introduction.** Before discussing our problems on stochastic processes, we shall define two kinds of equivalence of groups of measure preserving set transformations following J. v. Neumann and P. R. Halmos [8]⁽²⁾. By a *measure preserving set transformation* we understand a mapping from the system of measurable sets of one measure space onto that of another measure space modulo null sets which preserves measure and set operations such as countable sum and complement. Given a measure space $\Omega(\mathbf{B}, m)$ and a one-parameter group $\{T_\tau\}$ of measure preserving set transformations from $\mathbf{B}$ onto itself, let $\mathbf{H}$ denote the L^2 -space over Ω . The above group $\{T_\tau\}$ will induce a group $\{U_\tau\}$ of unitary operators on $\mathbf{H}$ such that

$$(1.1) \quad U_\tau \chi_M = \chi_{M[\tau]}$$

where M is any set of finite m -measure, $M[\tau] = T_\tau M$, and χ_A denotes the characteristic function of a set A . We consider another measure space $\bar{\Omega}(\bar{\mathbf{B}}, \bar{m})$ associated with a group of measure preserving set transformations $\{\bar{T}_\tau\}$ and we define $\bar{\mathbf{H}}$ and $\{\bar{U}_\tau\}$ correspondingly. If there exists a measure preserving set transformation S from $\mathbf{B}$ onto $\bar{\mathbf{B}}$ such that

$$(1.2) \quad \bar{T}_\tau = S T_\tau S^{-1},$$

then we say that $\{\bar{T}_\tau\}$ and $\{T_\tau\}$ are of the same *spatial type*. We shall also introduce another classification of transformation groups which is rougher than the above. If there exists an isometric linear mapping V from $\mathbf{H}$ onto $\bar{\mathbf{H}}$ such that

$$(1.3) \quad \bar{U}_\tau = V U_\tau V^{-1},$$

then we say that $\{\bar{T}_\tau\}$ and $\{T_\tau\}$ are of the same *spectral type*.

Let $X(t, \omega)$, $-\infty < t < \infty$, be a measurable (in two variables t and ω) differential process with stationary increments on a probability space $\Omega(\mathbf{B}, P)$. For any finite interval $I = (s, t]$ we shall define the increment $\Delta X(I, \omega)$ as $X(t, \omega) - X(s, \omega)$. By $\mathbf{B}_X$ we denote the Borel system of subsets of Ω generated

by all the sets of the form $\{\omega; \Delta X(I, \omega) < c\}$, and we shall consider the measure space $\Omega(\mathbf{B}_X, P)$ and the L^2 -space over it, say $\mathbf{H}_X$. Now we shall define a one-parameter group $\{T_\tau\}$ of measure preserving set transformations (*shift transformation*) on $\mathbf{B}_X$ by

$$(1.4) \quad T_\tau\{\omega; \Delta X(I, \omega) < c\} = \{\omega; \Delta X(I + \tau, \omega) < c\},$$

where $I + \tau$ is the interval $\{x + \tau; x \in I\}$. The possibility of this definition follows from the definition of differential processes with stationary increments. From $\{T_\tau\}$ we can derive a group $\{U_\tau\}$ of unitary operators on $\mathbf{H}_X$ as above.

The purpose of this paper is to determine the spectral type of this group $\{T_\tau\}$. In §2 we shall summarize some known facts on differential processes as preliminaries. In §3 and §4 we shall introduce a *multiple Wiener integral* which will play an important role in our theory. Our aim will be attained in §5. The fundamental theorem established there generalizes Kakutani's theorem [6] on the spectra of the flow of Brownian motion and implies that the transformation groups induced by different processes are of the same spectral type. But it is still an open question whether they are of the same spatial type or not.

2. Independent random measure associated with a measurable differential process with stationary increments. Let Ξ be a *measurable space* on which a class of sets called *measurable*, $\mathbf{B}'_\Xi$, is assigned so that (1) the empty set $\emptyset \in \mathbf{B}'_\Xi$, (2) $E_1, E_2 \in \mathbf{B}'_\Xi$ implies $E_1 \cup E_2, E_1 - E_2 \in \mathbf{B}'_\Xi$, and (3) any decreasing sequence in $\mathbf{B}'_\Xi$ has its limit set in $\mathbf{B}'_\Xi$; we do not assume that the whole space Ξ belongs to $\mathbf{B}'_\Xi$.

A system of random variables $f(E) = f(E, \omega)$ depending on a set $E \in \mathbf{B}'_\Xi$ with a probability parameter ω is called an *independent random measure* if $f(E_1), f(E_2), \dots, f(E_n)$ are independent and

$$(2.1.a) \quad f\left(\bigcup_{i=1}^n E_i\right) = \sum_{i=1}^n f(E_i)$$

for every finite system $\{E_i\}$ of disjoint sets in $\mathbf{B}'_\Xi$ and if

$$(2.1.b) \quad f(E_n) \rightarrow 0 \text{ (convergence in probability)}$$

for every decreasing sequence $\{E_n\}$ in $\mathbf{B}'_\Xi$ tending to the empty set. We can easily show that the above conditions imply that (2.1.b) holds in the sense of almost everywhere convergence. A *normal random measure* [4] is a special case of an independent random measure.

Let $X(t, \omega)$ be a measurable differential process with stationary increments. By taking Doob's separable modification [1] of this process, we may assume that $X(t, \omega)$ is continuous in t except for discontinuities of the first kind with probability 1. We also assume, as we may, that $X(\tau, \omega)$ is continuous on the right in τ with probability 1. By a theorem of P. Lévy [7], $\Delta X(I, \omega)$

is subject to an infinitely divisible law whose characteristic function $\phi_I(z)$ is given by

$$(2.2) \quad \log \phi_I(z) = |I| \left[i\gamma z + \int_{-\infty}^{\infty} \left(e^{izu} - 1 - \frac{izu}{1+u^2} \right) \frac{1+u^2}{u^2} d\beta(u) \right]$$

where $|I|$ means the length of I , γ is a real constant, and $d\beta$ is a bounded measure on $(-\infty, \infty)$.

We shall consider a plane π on which a coordinate system (t, u) is assigned. Let $\mathbf{B}_\pi$ denote the class of all Borel subsets of π . We shall consider two measures ν, μ on $\pi(\mathbf{B}_\pi)$ by

$$(2.3) \quad \nu(E) = \iint_E \frac{1+u^2}{u^2} dt d\beta(u),$$

$$(2.4) \quad \mu(E) = \iint_E (1+u^2) dt d\beta(u) = \iint_E u^2 d\nu(t, u).$$

It is clear that μ is the product of the one-dimensional measures dt and $d\mu'(u) = (1+u^2)d\beta(u)$. Let $\tilde{\mathbf{B}}_\pi$ be the totality of bounded Borel subsets of π whose distance from the t -axis is positive. We may consider $\pi(\tilde{\mathbf{B}}_\pi)$ as a measurable space. If we define $N(E, \omega)$, $E \in \tilde{\mathbf{B}}_\pi$, to be the number of points $(t, u) \in E$ for which $X(t, \omega) - X(t-0, \omega) = u$. Then $N(E, \omega)$ is subject to Poisson distribution with mean $\nu(E)$ for E fixed and the system $\{N(E, \omega), E \in \tilde{\mathbf{B}}_\pi\}$ is an independent random measure. Further we have the following expression of $X(t, \omega)$:

$$(2.5) \quad \Delta X(I, \omega) = \gamma |I| + \sigma \Delta B(I, \omega) + \lim_{n \rightarrow \infty} \int_{t \in I} \int_{n^{-1} < |u| < n} \left[u dN(t, u) - \frac{u}{1+u^2} d\nu(t, u) \right]$$

where $\sigma^2 = \beta(+0) - \beta(-0)$ and $B(t, \omega)$ is a Wiener process which is independent of the system $\{N(E, \omega); E \in \tilde{\mathbf{B}}_\pi\}$. We can easily deduce these facts from the results stated in [3].

Next we shall introduce another independent random measure $M(E)$. Let $\mathbf{B}_\pi^*$ be the class of all Borel subsets of π whose μ -measure is finite. For E in $\mathbf{B}_\pi^*$ we define $M(E)$ by

$$M(E) = M(E, \omega) = \int_{E(0)} \sigma \cdot dB(t) + \lim_{n \rightarrow \infty} \iint_{(t, u) \in E(n)} [u dN(t, u) - u d\nu(t, u)],$$

where

$$E(n) = \{(t, u) \in E; n^{-1} < |u| < n\}, \quad n = 1, 2, \dots, \\ E(0) = \{t; (t, 0) \in E\}$$

and the integral based on $dB(t)$ is the Wiener integral [1, IX, 2].

It is to be noted that $N(E)$, $\Delta B(I)$ and $M(E)$ belong to $\mathbf{H}_X$ for E and I fixed. Also the expectation of $M(E)$ is 0.

3. Definition of multiple Wiener integral based on dM . Let $M(E, \omega)$, $E \in \mathbf{B}_\pi^*$, be the independent random measure defined in §2. We can easily verify the following properties:

$$(3.1) \quad (M(E_1), M(E_2)) = \mu(E_1 \cap E_2),$$

$$(3.1') \quad \|M(E)\|^2 = \mu(E),$$

$$(3.2) \quad (M(E), 1) = 0.$$

In this section we shall make use of the following property of μ :

Continuity: For every $E \in \mathbf{B}_\pi^*$ and every $\epsilon > 0$, there exists a finite subdivision of E : $E = E_1 \cup E_2 \cup \cdots \cup E_n$ such that $\mu(E_i) < \epsilon$, $1 \leq i \leq n$.

Let π^ρ be the product measure space $[\pi(\mathbf{B}_\pi, \mu)]^\rho$ and let L_p^2 be the L^2 -space over π^ρ . We shall denote points of π by $\xi = (t, u)$, $\xi' = (t', u')$, $\xi_i = (t_i, u_i)$, etc. For any $f \in L_p^2$ we shall define the *symmetrized function* $\tilde{f}$ of f to be

$$(3.3) \quad \tilde{f}(\xi_1, \cdots, \xi_p) = \frac{1}{p!} \sum_{(\epsilon)} f(\xi_{\epsilon(1)}, \cdots, \xi_{\epsilon(p)})$$

where $(\epsilon) = (\epsilon(1), \cdots, \epsilon(p))$ runs over all arrangements of $(1, 2, \cdots, p)$. It is clear that $f(\xi_1, \cdots, \xi_p)$ is symmetric in $(\xi_1, \cdots, \xi_p)$ if and only if it coincides with $\tilde{f}$. $\tilde{f}$ is symmetric. We have also

$$(3.4) \quad \|\tilde{f}\| \leq \|f\|, \quad \|\cdot\| \text{ being the norm in } L_p^2.$$

Let C_p denote the class of all functions of the form:

$$(3.5) \quad c_p(\xi_1, \xi_2, \cdots, \xi_p) = \chi(\xi_1, E_1) \chi(\xi_2, E_2) \cdots \chi(\xi_p, E_p)$$

where E_i , $i = 1, 2, \cdots, p$, are disjoint sets in $\mathbf{B}_\pi^*$ and $\chi(\xi, E)$ denotes the characteristic function of the set E . Let S_p denote the class of all linear combinations of functions in C_p . The continuity of μ implies that S_p is dense in L_p^2 [4, Theorem 2.1].

Now we shall define the multiple Wiener integral of the p th degree based on the independent random measure M and denote it by

$$(3.6) \quad I_p(f) = \int \cdots \int f(\xi_1, \cdots, \xi_p) dM(\xi_1) \cdots dM(\xi_p).$$

We define

$$(3.7) \quad I_p(c_p) = M(E_1) \cdots M(E_p)$$

for the c_p of (3.5), then $I_p(s)$ for s in S_p by linearity and finally $I_p(f)$ for f in L_p^2 by continuity. For convenience of notation we shall denote by L_0^2 the com-

plex number field (one-dimensional Hilbert space) and define $I_0(c) = c$ if $c \in L_0^2$. In exactly the same way as in the case of normal random measure [4] we can show that the definition is possible and that the following theorem holds.

THEOREM 1.

$$(I.1) \quad I_p(f) = I_p(\bar{f}),$$

$$(I.2) \quad I_p(af + bg) = aI_p(f) + bI_p(g),$$

$$(I.3) \quad (I_p(f), I_p(g)) = p! \cdot (\bar{f}, \bar{g}),$$

$$(I.3') \quad \|I_p(f)\| = (p!)^{1/2} \|\bar{f}\| \leq (p!)^{1/2} \|f\|,$$

$$(I.4) \quad (I_p(f), I_q(g)) = 0 \quad (p \neq q).$$

4. Completeness of multiple Wiener integrals. Let $\tilde{L}_p^2$ denote the class of all symmetric functions in L_p^2 . $\tilde{L}_p^2$ is clearly a closed linear manifold of L_p^2 . By (I.1) in Theorem 1 we see that the image of $\tilde{L}_p^2$ by I_p coincides with that of L_p^2 , which we shall denote by $H_X^{(p)}$. Since the mapping:

$$(4.1) \quad V_p: \tilde{L}_p^2 \ni f_p \rightarrow (p!)^{-1/2} I_p(\bar{f}_p) \in H_X$$

is isometric by (I.3'), $H_X^{(p)}$ is a closed linear manifold of H_X isomorphic with $\tilde{L}_p^2$ by V_p . By (I.4) we see that the $H_X^{(p)}$, $p=0, 1, 2, \dots$, are orthogonal to each other.

We shall establish the following theorem which implies the completeness of $\{I_p(\bar{f}_p); \bar{f}_p \in \tilde{L}_p^2, p=0, 1, 2, \dots\}$.

THEOREM 2.

$$H_X = \sum_{p \geq 0} \oplus H_X^{(p)} \quad (\sum \oplus \text{ means 'direct sum'}).$$

Proof. 1°. We shall first prove the following lemma.

LEMMA 1. *All the elements of the following form constitute a fundamental set in H_X :*

$$(4.2) \quad N(E_1)^{p_1} \cdots N(E_m)^{p_m} \Delta B(I_1)^{q_1} \cdots \Delta B(I_n)^{q_n},$$

where $m, n=1, 2, \dots$, $p_i, q_j=0, 1, 2, \dots$, and $\{E_i\}$ and $\{I_j\}$ are each disjoint.

Proof⁽³⁾. It is clear that an element of the form (4.2) belongs to H_X , since it has a finite norm. By the definition of H_X we can easily see that the totality of the elements of H_X of the following form constitute a fundamental set in H_X :

$$(4.3) \quad Y = f(\Delta X(I_1), \dots, \Delta X(I_n)),$$

where $n=1, 2, \dots$, $\{I_i\}$ are disjoint and f is a bounded continuous function. By the expression of (2.5), $\Delta X(I)$ is the limit of linear combinations of $\{N(E)\}$ and $\{\Delta B(I)\}$. Therefore the elements of the following form also constitute a fundamental set in $\mathbf{H}_X$:

$$(4.4) \quad Z = f(N(E_1), \dots, N(E_m), \Delta B(I_1), \dots, \Delta B(I_n))$$

where the E_i are pairwise disjoint, the I_j are also pairwise disjoint and f is a bounded continuous function.

Let $\mathfrak{M} = \mathfrak{M}(E_1, \dots, E_m, I_1, \dots, I_n)$ be the closed linear manifold spanned by the polynomials in $N(E_1), \dots, N(E_m), \Delta B(I_1), \dots, \Delta B(I_n)$. To prove the lemma it is enough to show that Z in (4.4) belongs to $\mathfrak{M}$. We put

$$Z = U + V = g(N(E_1), \dots, \Delta B(I_n)) + h(N(E_1), \dots, \Delta B(I_n))$$

where $U \in \mathfrak{M}$, $V \perp \mathfrak{M}$, and both g and h are Baire functions. It is enough to show $V=0$. To avoid trivial complications we consider the case that $m=n=1$. It is sufficient to derive $h(N(E), \Delta B(I))=0$ for almost all ω from the following conditions:

$$(4.5) \quad (h(N(E), \Delta B(I)), N(E)^p \Delta B(I)^q) = 0, \quad p, q = 0, 1, 2, \dots$$

We denote by σ_1 and σ_2 respectively the distribution of $N(E)$ (Poisson distribution) and that of $\Delta B(I)$ (normal distribution). Then (4.5) can be written as

$$(4.5') \quad \iint h(x, y) x^p y^q d\sigma_1(x) d\sigma_2(y) = 0.$$

But we have

$$\begin{aligned} & \iint e^{i tx + i s y} |h(x, y)| d\sigma_1(x) d\sigma_2(y) \\ & \leq \left(\iint |h(x, y)|^2 d\sigma_1(x) d\sigma_2(y) \right)^{1/2} \left(\iint e^{2|tx| + 2|sy|} d\sigma_1(x) d\sigma_2(y) \right)^{1/2} \\ & = \|h(N(E), B(I))\| \left(\int e^{2|tx|} d\sigma_1(x) \int e^{2|sy|} d\sigma_2(y) \right)^{1/2} \\ & < \infty. \end{aligned}$$

Therefore (4.5') will imply

$$\iint h(x, y) e^{i(tx+sy)} d\sigma_1(x) d\sigma_2(y) = 0, \quad -\infty < t, s < \infty.$$

Thus we have $h(x, y) = 0$ for almost all (x, y) with respect to the measure $d\sigma_1(x)d\sigma_2(y)$, that is, $h(N(E), \Delta B(I)) = 0$ for almost all ω .

2°. LEMMA 2. *The elements of the following form constitute a fundamental set in H_X :*

$$(4.6) \quad Y = N(E_1) \cdots N(E_m) \Delta B(I_1) \cdots \Delta B(I_n),$$

where the E_i are pairwise disjoint and the I_j are also pairwise disjoint.

Proof. Making use of the fact that the independence of X and Y implies $\|XY\| = \|X\| \cdot \|Y\|$, we can easily see the following fact:

(*) Let $\{X_1, X_2, \dots\}$ and $\{Y_1, Y_2, \dots\}$ be two independent sequences of random variables. If $X_n \rightarrow X$ and $Y_n \rightarrow Y$ in $L^2(\Omega)$, then $X_n Y_n \rightarrow XY$ in $L^2(\Omega)$.

Let N denote the closed linear manifold in H_X spanned by the elements of the form $N(E_1)N(E_2) \cdots N(E_m)$ with pairwise disjoint E_i and let B be the closed linear manifold spanned by the elements of the form $\Delta B(I_1)\Delta B(I_2) \cdots \Delta B(I_n)$ with pairwise disjoint I_j . By the above remark (*) it is enough to show that

$$(4.7) \quad N(E_1)^{p_1} N(E_2)^{p_2} \cdots N(E_m)^{p_m} \in N$$

and

$$(4.8) \quad \Delta B(I_1)^{q_1} \Delta B(I_2)^{q_2} \cdots \Delta B(I_n)^{q_n} \in B$$

whenever the E_i or the I_j are disjoint. (4.8) was proved in [4, Theorem 4.2].

It remains to prove (4.7). Consider a subdivision $\{F_i\}$, $i=1, \dots, s$, of $\{E_i\}$, $i=1, \dots, m$, so fine that $\nu(F_i) < \min(\epsilon/\nu(E), 1)$ where $\epsilon > 0$ and $E = F_1 \cup F_2 \cup \dots \cup F_s$. Then we have the following expression:

$$N = N(E_1)^{p_1} N(E_2)^{p_2} \cdots N(E_m)^{p_m} = \sum N(F_{i(1)})^{i_1} \cdots N(F_{i(r)})^{i_r}$$

with $i(1) < i(2) < \dots < i(r)$.

Since $N(F_i)$ takes only non-negative integral values, we have

$$N \geq \sum N(F_{i(1)}) N(F_{i(2)}) \cdots N(F_{i(r)}) \equiv N_\epsilon \in N,$$

and also

$$\begin{aligned} P(N \neq N_\epsilon) &= P(N(F_i) \geq 2 \text{ for some } i) \\ &\leq \sum_{i=1}^s P(N(F_i) \geq 2) \leq \sum_{i=1}^s \nu(F_i)^2 < \epsilon. \end{aligned}$$

Therefore $N_\epsilon \rightarrow N$ in probability as $\epsilon \rightarrow 0$. Thus we can choose a sequence $\epsilon(n) (\rightarrow 0)$ such that $N_{\epsilon(n)} \rightarrow N$ almost everywhere in ω . Further we have $0 \leq N_{\epsilon(n)} \leq N$ and $N \in L^2(\Omega)$. Therefore we have $\|N_{\epsilon(n)} - N\| \rightarrow 0$ and so $N \in N$.

3°. Now we shall deduce Theorem 2 from Lemma 2. It is enough to show that Y in (4.6) is expressible as

$$(4.9) \quad Y = I_0(f_0) + I_1(f_1) + \cdots + I_{m+n}(f_{m+n}).$$

Using the notation in §3, we set

$$f(\xi_1, \cdots, \xi_m, \xi_{m+1}, \cdots, \xi_{m+n}) \\ = u_1^{-1} \cdots u_m^{-1} \sigma^{-n} \chi_{E_1}(\xi_1) \cdots \chi_{E_n}(\xi_n) \chi_{I_1}(\xi_{m+1}) \cdots \chi_{I_{m+n}}(\xi_{m+n}),$$

where χ_I denote the characteristic function of the interval $I \times \{0\}$ (in the plane π) and $\xi_i = (t_i, u_i)$. Then we have

$$I_{m+n}(f) = (N(E_1) - \nu(E_1)) \cdots (N(E_m) - \nu(E_m)) \Delta B(I_1) \cdots \Delta B(I_n) \\ = N(E_1) \cdots N(E_m) \Delta B(I_1) \cdots \Delta B(I_n) + R,$$

where R is a linear combination of the elements of the form:

$$N(E_{i(1)}) \cdots N(E_{i(p)}) \Delta B(I_1) \cdots \Delta B(I_n), \quad p < m,$$

and $R=0$ in case $m=0$. Therefore we obtain (4.9) by induction on m . Thus our theorem is completely proved.

5. Spectral type of $\{T_\tau\}$. In the last section we proved that

$$(5.1) \quad H_X = \sum_{p \geq 0} \oplus H_X^{(p)}$$

and that each $H_X^{(p)}$ is isomorphic to $\tilde{L}_p^2$ by V_p . Now we shall investigate the behavior of the group of unitary transformations U_τ on H_X derived from the shift transformations T_τ of the process $X(t, \omega)$.

Let $U_\tau^{(p)}$ be the restriction of U_τ to $H_X^{(p)}$. Then we have

LEMMA 1. $U_\tau^{(p)}$ is a unitary operator on $H_X^{(p)}$ which is transformed by V_p into the following unitary operator $\tilde{S}_\tau^{(p)}$ on $\tilde{L}_p^2$.

$$(5.2) \quad \tilde{S}_\tau^{(p)} \tilde{f}(t_1, u_1, \cdots, t_p, u_p) = \tilde{f}(t_1 - \tau, u_1, \cdots, t_p - \tau, u_p), \quad \tilde{f} \in \tilde{L}_p^2.$$

Corresponding to the decomposition (5.1), we have

$$(5.3) \quad U_\tau = \sum_{p \geq 0} \oplus U_\tau^{(p)}.$$

Proof. By the same expression as in (5.2) we shall define a unitary operator $S_\tau^{(p)}$ on L_p^2 . It is clear that $S_\tau^{(p)}$ is an extension of $\tilde{S}_\tau^{(p)}$. Then we have

$$(5.4) \quad I_p(S_\tau^{(p)} f) = U_\tau I_p(f).$$

This is clear by the definition if f has the form (3.5), and so it holds also if $f \in L_p^2$, because both sides of (5.4) are bounded and linear in f .

Since U_τ transforms $H_X^{(p)}$ onto $H_X^{(p)}$ by (5.4), the restriction $U_\tau^{(p)}$ of U_τ to

$H_X^{(p)}$ is a unitary operator on $H_X^{(p)}$. By (5.4) and the definition of V_p and $\tilde{S}_\tau^{(p)}$ we have

$$U_\tau^{(p)} = V_p \tilde{S}_\tau^{(p)} V_p^{-1}.$$

Thus we can easily verify (5.3), since U_τ is a unitary operator on H_X .

Lemma 1 reduces the investigation of $\{U_\tau\}$ to that of $\{\tilde{S}_\tau^{(p)}\}$. $\tilde{S}_\tau^{(p)}$ is only the identity operator on L_0^2 , which is a one-dimensional Hilbert space. We consider $\tilde{S}_\tau^{(p)}$, $p \geq 1$. We shall introduce two transformation groups, $\{(\tau)\}$ and $\{(\epsilon)\}$, on the $2p$ -dimensional space π^p as follows:

$$(\tau)(t_1, u_1, t_2, u_2, \dots, t_p, u_p) = (t_1 - \tau, u_1, t_2 - \tau, u_2, \dots, t_p - \tau, u_p),$$

$$(\epsilon)(t_1, u_1, t_2, u_2, \dots, t_p, u_p) = (t_{\epsilon(1)}, u_{\epsilon(1)}, t_{\epsilon(2)}, u_{\epsilon(2)}, \dots, t_{\epsilon(p)}, u_{\epsilon(p)}),$$

where τ is a real number and $\epsilon = \{\epsilon(1), \epsilon(2), \dots, \epsilon(p)\}$ is an arrangement of $\{1, 2, \dots, p\}$.

To make it easier to see how these transformations act on π^p , we shall consider the following coordinate transformation:

$$(t_1, u_1, t_2, u_2, \dots, t_p, u_p)$$

$$\rightarrow (t, s_2, \dots, s_{p-1}, u_1, \dots, u_p) = (t, v), v \in R^{2p-1}$$

which is defined by

$$(5.5) \quad t = \frac{1}{p} (t_1 + t_2 + \dots + t_p),$$

$$(5.6) \quad s_i = \sum_{j=1}^p \alpha_{ij} t_j, \quad i = 1, 2, \dots, p-1,$$

where $(\alpha_{ij}; 1 \leq i \leq p-1, 1 \leq j \leq p)$ is a certain real matrix satisfying

$$(5.7) \quad \sum_j \alpha_{ij} = 0, \quad 1 \leq i \leq p-1,$$

$$(5.8) \quad \begin{vmatrix} 1/p & \dots & 1/p \\ \alpha_{11} & \dots & \alpha_{1p} \\ \cdot & \dots & \cdot \\ \alpha_{p-1,1} & \dots & \alpha_{p-1,p} \end{vmatrix} = 1.$$

By (5.8) we have

$$dt_1 d\mu'(u_1) \dots dt_p d\mu'(u_p) = dt ds_1 \dots ds_{p-1} d\mu'(u_1) \dots d\mu'(u_p) = dt d\lambda_p(v)$$

where

$$d\lambda_p(v) = ds_1 \dots ds_{p-1} d\mu'(u_1) \dots d\mu'(u_p).$$

Since t is symmetric in $(t_1, \dots, t_p)$, the transformation (ϵ) will leave t invariant, and we have

$$(\epsilon)(t, \mathbf{v}) = (t, (\bar{\epsilon})\mathbf{v}),$$

where $(\bar{\epsilon})$ is defined as follows. Given t and $\mathbf{v} = (s_1, \dots, s_{p-1}, u_1, \dots, u_p)$, let $(t_1, t_2, \dots, t_p)$ be the solution of (5.5) and (5.6) and set

$$(\bar{\epsilon})\mathbf{v} = (s'_1, \dots, s'_{p-1}, u_1, \dots, u_p), \quad s'_i = \sum_j \alpha_{ij} t_{\epsilon(j)}, \quad i = 1, \dots, p-1.$$

It follows from (5.7) and (5.8) that $(\bar{\epsilon})\mathbf{v}$ is quite independent of t , so that we may consider $(\bar{\epsilon})\mathbf{v}$ to be a transformation on $\mathbf{v}$.

Since the transformation (τ) will leave s_i and accordingly $\mathbf{v}$ invariant by (5.7), we have

$$(\tau)(t, \mathbf{v}) = (t + \tau, \mathbf{v}).$$

As the transformation (ϵ) preserves the measure $dt_1 \cdots dt_p d\mu'(u_1) \cdots d\mu'(u_p)$, we have

$$dt d\lambda_p((\bar{\epsilon})\mathbf{v}) = dt d\lambda_p(\mathbf{v}) \text{ i.e. } d\lambda_p((\bar{\epsilon})\mathbf{v}) = d\lambda_p(\mathbf{v}).$$

Hereafter we shall consider the functions in L_p^2 with respect to these new coordinates $(t, \mathbf{v})$. Then we see that the condition

$$f(t, (\bar{\epsilon})\mathbf{v}) = f(t, \mathbf{v})$$

is necessary and sufficient for f to belong to $\tilde{L}_p^2$.

We consider the L^2 -space over the measure space $(R^{2p-1}, d\lambda_p)$ which will be denoted by $\tilde{\mathcal{L}}_{2p-1}^2$. The totality of the functions in $\tilde{\mathcal{L}}_{2p-1}^2$ invariant under the group $\{(\bar{\epsilon})\}$ constitutes a closed linear manifold in $\tilde{\mathcal{L}}_{2p-1}^2$, say $\tilde{\mathcal{L}}_{2p-1}^2$. Excluding the trivial case that $X(t, \omega) = \gamma t + \alpha$, the measure $d\lambda_p$ is not identically zero for $p = 1, 2, \dots$, so that $\tilde{\mathcal{L}}_{2p-1}^2$ is at least one-dimensional. In addition to this, the dimension of $\tilde{\mathcal{L}}_{2p-1}^2$ is at most countable. Let $\tilde{\phi}_{pi}(\mathbf{v})$, $i = 1, 2, \dots$, be a complete orthonormal system in $\tilde{\mathcal{L}}_{2p-1}^2$. Then $f(t, \mathbf{v}) \in \tilde{L}_p^2$ is expressed as a sum of orthogonal components:

$$f(t, \mathbf{v}) = \sum_n f_n(t) \tilde{\phi}_{pn}(\mathbf{v}), \quad f_n(t) \in L^2(R^1)$$

and we have

$$\|f(t, \mathbf{v})\|^2 = \sum_n \|f_n\|^2$$

$$(\tilde{\mathcal{S}}_\tau^{(p)} f)(t, \mathbf{v}) = f(t + \tau, \mathbf{v}) = \sum_i f_i(t + \tau) \tilde{\phi}_{pi}(\mathbf{v}).$$

Thus $\tilde{L}_p^2$ is the direct sum of at most a countable number (>0) of subspaces which reduce $\{\tilde{\mathcal{S}}_\tau^{(p)}\}$ and on each of which $\tilde{\mathcal{S}}_\tau^{(p)}$ acts just as the unitary transformation $f(t) \rightarrow f(t + \tau)$ does on $L^2(R^1)$.

Summing up the above arguments we obtain the following

FUNDAMENTAL THEOREM. *Except for the trivial case $X(t, \omega) = \gamma t + \alpha$, $\mathbf{H}_X$ is isomorphic to the direct sum of the complex number field $\mathbb{C}$ (one-dimensional*

Hilbert space) and a countable number of Hilbert spaces, each isomorphic to $L^2(R^1)$, i.e.

$$H_X \cong C \oplus L^2(R^1) \oplus L^2(R^1) + \cdots,$$

in such a way that this isomorphism transforms U_τ into the following operator:

$$\Phi_\tau: (c, f_1(t), f_2(t), \cdots) \rightarrow (c, f_1(t + \tau), f_2(t + \tau), \cdots).$$

In other words, $\{U_\tau\}$ has spectra [2] of multiplicity one over the unitary measure and of uniform multiplicity $\aleph_0$ over the ordinary Lebesgue measure and only these spectra.
