T-FAITHFUL SUBCATEGORIES AND LOCALIZATION

ABSTRACT. For any additive functor from a category of modules into an abelian category there is a largest Giraud subcategory for which the functor acts faithfully on homomorphisms into the subcategory. It is the largest Giraud subcategory into which the functor reflects exact sequences, and under certain conditions it is just the largest Giraud subcategory on which the functor acts faithfully. If the functor is exact and has a right adjoint, then the subcategory is equivalent to the quotient category determined by the kernel of the functor. In certain cases, the construction can be applied to a Morita context in order to obtain a recent theorem of Mueller.

Similarly, the functor defines a certain reflective subcategory and an associated radical, which is a torsion radical in case the functor preserves monomorphisms. Certain results concerning this radical, when defined by an adjoint functor, can be applied to obtain two theorems of Morita on balanced modules.

This paper is a continuation of the author's work [2] on T-faithful subcategories of module categories. For the category $R^{\mathbb{N}}$ of unital left R-modules over a ring R with identity, and for any additive functor $T: R^{\mathbb{N}} \to \mathbb{B}$ into an abelian category \mathbb{B} , a subcategory \mathbb{C} of $R^{\mathbb{N}}$ will be called T-faithful if T is faithful when restricted to \mathbb{C} . (Similarly, \mathbb{C} is left T-faithful if $T(f) \neq 0$ for every nonzero R-homomorphism $f: M \to A$, with $A \in \mathbb{C}$.) If T is exact and has an adjoint, one can form the quotient category $R^{\mathbb{N}}/K$ or $R^{\mathbb{N}}$ which is then equivalent to a certain Giraud subcategory of $R^{\mathbb{N}}$. This Giraud subcategory can be characterized as the largest left T-faithful Giraud subcategory, and if R is commutative and Noetherian, it is the largest T-faithful Giraud subcategory of $R^{\mathbb{N}}$ (Corollary 3.10).

For any functor $T: {}_R\mathbb{M} \to \mathbb{B}$ it is possible to construct the largest Giraud subcategory of ${}_R\mathbb{M}$ which is left T-faithful, thus generalizing in a certain sense the construction of the quotient category ${}_R\mathbb{M}/\mathrm{Ker}(T)$. If T is exact, this subcategory is determined by the smallest hereditary torsion class of ${}_R\mathbb{M}$ which contains $\mathrm{Ker}(T)$. The construction is useful even when T is not exact. has shown in [12] that any Morita context induces an equivalence between appropriate quotient categories. In certain cases these subcategories are precisely the ones constructed in the above manner.

§1 studies reflective T-faithful subcategories, and gives the construction of a subcategory $\mathfrak{L}(T)$ which is the largest left T-faithful reflective subcategory of $R^{\mathbb{M}}$. This determines a radical rad T of T which is a torsion radical if T is a monofunctor (Theorem 1.8). A characterization of rad T is given when T has a right adjoint. §2 gives some examples, and shows that if $T = Hom_R(P, -)$ for a module T0, then rad T1 is determined by the trace ideal of T2. In this case conditions are given under which the torsion class determined by rad T3 is a TTF-class.

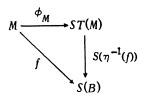
§3 is concerned with the construction of a Giraud subcategory determined by rad_T . This is characterized in Theorem 3.7 as the largest Giraud subcategory \mathfrak{A} (with exact reflector $Q: {}_R \mathbb{M} \to \mathfrak{A}$) which satisfies any one of the following conditions: (i) \mathfrak{A} is T-faithful and T(f) = 0 implies TQ(f) = 0 for all T-homomorphisms T; (ii) T(f) = 0 implies T in T is exact. Thus one might loosely say that the construction gives the largest Giraud subcategory into which T reflects exact sequences, generalizing the statement that T reflects exact sequences if it is faithful.

§4 gives an application to Morita contexts, and also generalizes several theorems of Morita [11]. If T is covariant and has a right adjoint S or is contravariant with S adjoint on the right, then for each module $M \in {}_R \mathbb{M}$, rad_T determines a module $Q_T(M) \in \mathfrak{L}^r(T)$ which is analogous to a module of quotients, and coincides with the usual module of quotients if T is exact. Theorem 4.9 shows that the homomorphism $M \to ST(M)$ induced by the adjoint situation is an isomorphism if and only if $Q_T(M) = ST(M)$ and there exists an exact sequence $0 \to M \to S(B) \to N$, for some $B \in \mathcal{B}$ and $N \in \mathfrak{L}^r(T)$. As an application of the theorem, it is shown that a faithful module $Q_T(M)$ is balanced if and only if $Q_T(M)$ and $Q_T(M)$ is a module of type $Q_T(M)$ are sult due to Morita [11, Theorem 5.1].

The results have been stated for categories of modules, since the examples and applications of interest to the author are found in module categories, but the proofs can be extended immediately. The construction of $\mathfrak{LF}(T)$ in §1 requires an abelian category which is complete and locally small. The construction of $\mathfrak{LF}_2(T)$ in §3 requires in addition the existence of enough injectives.

1. Reflective T-faithful subcategories. In this section $T\colon {}_R\mathbb{M}\to \mathbb{B}$ will denote an additive functor (either covariant or contravariant) into an abelian category \mathbb{B} . The full subcategory of ${}_R\mathbb{M}$ determined by those modules ${}_R\mathbb{M}$ such

that $T(f) \neq 0$ for all R-homomorphisms $0 \neq f: {}_RX \to {}_RM$ will be denoted by $\mathfrak{LF}(T)$. (See [2].) Recall that if T is covariant, then a covariant functor $S: \mathfrak{B} \to {}_RM$ is a right adjoint for T (and T is a left adjoint for S) if there exists a natural equivalence of set-valued bifunctors $\eta: \operatorname{Hom}_{\mathfrak{B}}(T(\cdot), -) \to \operatorname{Hom}_{R}(\cdot, S(-))$. For any $M \in {}_RM$ and $B \in \mathfrak{B}$, the natural equivalence induces morphisms $\phi_M = \eta(1_{T(M)}): M \to ST(M)$ and $\psi_B = \eta^{-1}(1_{S(B)}): TS(B) \to B$, and for any morphism $f: M \to S(B), \ \eta^{-1}(f)$ is the unique R-homomorphism for which the following diagram commutes



Furthermore, $\eta^{-1}(f) = \psi_B T(f)$, and so $f \neq 0$ implies $T(f) \neq 0$, which shows that S(B) belongs to $\mathfrak{L}(T)$.

If T is covariant and has a right adjoint, then the dual of [2, Proposition 1.7] shows that, for any $M \in {}_R\mathbb{M}$, $M \in \mathfrak{LF}(T)$ if and only if ϕ_M is a monomorphism. Note that $\mathfrak{LF}(T) = \mathfrak{LF}(ST)$. It is immediate that $\mathfrak{LF}(ST) \subseteq \mathfrak{LF}(T)$, and on the other hand, if $M \in \mathfrak{LF}(T)$, then $\phi_M \colon M \to ST(M)$ is a monomorphism, so $\phi_M f \neq 0$ for any R-homomorphism $0 \neq f \colon X \to M$. But then $ST(f)\phi_{ST(X)} \neq 0$ and this implies $ST(f) \neq 0$.

A subcategory $\mathfrak A$ of $_R\mathbb M$ is called a reflective subcategory if the inclusion functor Inc: $\mathfrak A \to _R\mathbb M$ has a left adjoint (or reflector) $Q\colon _R\mathbb M \to \mathfrak A$. That Q is a left adjoint is equivalent to the existence, for each $M\in _R\mathbb M$, of an R-homomorphism $\phi_M\colon M\to Q(M)$ such that any R-homomorphism $f\colon M\to A$, with $A\in \mathfrak A$, factors uniquely through ϕ_M . (Here A and Inc (A) have been identified.) The subcategory $\mathfrak A$ is called epireflective if ϕ_M is an epimorphism for each $M\in _R\mathbb M$. In this case Q preserves epimorphisms.

Definition (1.1) Let $T: {}_R \mathbb{M} \to \mathbb{B}$ be a functor. For each $M \in {}_R \mathbb{M}$, define $\operatorname{rad}_T (M) = \{ m \in M : f(m) = 0 \text{ for all } f \in \operatorname{Hom}_R (M, X) \text{ such that } X \in \mathfrak{LF}(T) \}.$

It can be checked easily that rad_T defines a radical of $_R\mathbb{M}$, that is, that, for all R-homomorphisms $f\colon {_R}M \to {_R}N$, $f(\operatorname{rad}_T(M)) \subseteq \operatorname{rad}_T(N)$, and moreover, that $\operatorname{rad}_T(M/\operatorname{rad}_T(M)) = 0$ for all $M \in {_R}\mathbb{M}$. Recall that a left exact radical is called a torsion radical. Theorem 1.8 gives conditions under which rad_T is a torsion radical. If T is covariant and has a right adjoint, then for all $M \in {_R}\mathbb{M}$, $\operatorname{rad}_T(M) = \ker (\phi_M)$. That $\operatorname{rad}_T(M) \subseteq \ker (\phi_M)$ follows since $\phi_M \colon M \to ST(M)$ and $ST(M) \in \mathfrak{L}(T)$. On the other hand, any R-homomorphism $f\colon M \to {_R}X$ yields the following commutative diagram.

$$\ker (\phi_{M}) \xrightarrow{i} M \xrightarrow{\phi_{M}} ST(M)$$

$$f \downarrow \qquad \qquad \downarrow ST(f)$$

$$X \xrightarrow{\phi_{X}} ST(X)$$

If $X \in \mathfrak{L}(T)$, then ϕ_X is a monomorphism, and so $ST(f)\phi_M i = 0$ implies $\phi_X f i = 0$ and therefore f i = 0. Thus $\ker (\phi_M) \subseteq \operatorname{rad}_T(M)$.

Proposition (1.2) For any functor $T: \mathbb{R}^{\mathbb{M}} \to \mathbb{B}$, $\mathfrak{LF}(T)$ is an epireflective subcategory, and $\mathfrak{LF}(T) = \mathfrak{LF}(Q)$ for the reflector $Q: \mathbb{R}^{\mathbb{M}} \to \mathfrak{LF}(T)$.

Proof. Since $\mathcal{L}(T)$ is complete [2, Corollary 1.6] and closed under submodules, it is epireflective [9, Chapter V, Proposition 6.1]. For $M \in \mathbb{R}^{M}$, $Q(M) = M/\operatorname{rad}_{T}(M)$ defines the reflector Q, and by the preceding remarks $M \in \mathcal{L}(Q) \iff \operatorname{rad}_{T}(M) = 0 \iff M \in \mathcal{L}(T)$. \square

Lemma (1.3) Let G be a reflective subcategory of $R^{\mathbb{M}}$ with reflector Q, and let $T: R^{\mathbb{M}} \to \mathbb{B}$. If $M \in R^{\mathbb{M}}$ and $Q(M) \in \mathfrak{LF}(T)$, then T(f) = 0 implies Q(f) = 0, for any R-homomorphism $f: R^{\mathbb{M}} \to R^{\mathbb{M}}$.

Proof. If T(f) = 0, then $T(\phi_M f) = 0$, and since $Q(M) \in \mathfrak{L}^p(T)$ this implies that $\phi_M f = 0$. But then Q(f) = 0 since Q(f) is the unique homomorphism which makes the following diagram commutative. \square

Theorem (1.4) Let $\mathfrak A$ be a reflective subcategory of ${}_R\mathbb M$ with reflector Q, and let $T\colon {}_R\mathbb M\to \mathfrak B$ be any functor. Then the following conditions are equivalent:

- (a) \mathcal{C} is a subcategory of $\mathfrak{LF}(T)$.
- (b) A is T-faithful, and T(f) = 0 implies TQ(f) = 0, for all R-homomorphisms f.
- (c) T(f) = 0 implies Q(f) = 0, for all R-homomorphisms f.

Proof. (a) \Rightarrow (b). If \mathcal{C} is a subcategory of $\mathfrak{LF}(T)$, then \mathcal{C} is T-faithful since $\mathfrak{LF}(T)$ is T-faithful. For any R-homomorphism $f: {}_RX \to {}_RM$, $Q(M) \in \mathfrak{LF}(T)$ and so by Lemma 1.3, T(f) = 0 implies Q(f) = 0 and hence TQ(f) = 0.

- (b) \Rightarrow (c). If T(f) = 0, then by assumption TQ(f) = 0. But Q(f) is in \mathfrak{A} and \mathfrak{A} is T-faithful, so $Q(f) \doteq 0$.
- (c) \Rightarrow (a). If T(f) = 0 implies Q(f) = 0, then $\mathcal{LF}(Q) \subseteq \mathcal{LF}(T)$. The conclusion follows from previous remarks about adjoints, since the inclusion functor is a

right adjoint for Q, and hence $A \in \mathfrak{L}(Q)$ for all $A \in \mathbb{N}$. \square

This shows that $\mathfrak{L}^{r}(T)$ is the largest reflective T-faithful subcategory whose reflector Q satisfies the condition T(f)=0 implies TQ(f)=0. The next corollaries are attempts to remove the last condition. A functor will be called an epifunctor if it is covariant and preserves epimorphisms or contravariant and carries epimorphisms to monomorphisms.

Corollary (1.5) Let \mathfrak{A} be an epireflective subcategory of $\mathfrak{R}^{\mathfrak{M}}$, and let $T: \mathfrak{R}^{\mathfrak{M}} \to \mathfrak{B}$ be a functor, with reflector $Q: \mathfrak{R}^{\mathfrak{M}} \to \mathfrak{LF}(T)$.

- (a) If T is an epifunctor, then \mathfrak{A} is T-faithful $\Leftrightarrow \mathfrak{A} \subset \mathfrak{LF}(T)$.
- (b) \mathcal{C} is Q-faithful $\Leftrightarrow \mathcal{C} \subseteq \mathfrak{LF}(T)$.
- **Proof.** (a) Assume that \mathcal{C} is T-faithful, with reflector $Q_0: {}_R \mathcal{M} \to \mathcal{C}$, and that T is a covariant epifunctor. If $f \in \operatorname{Hom}_R(M, N)$ and T(f) = 0, then $TQ(f)T(\phi_M) = T(\phi_N)T(f) = 0$, so TQ(f) = 0 since by assumption $T(\phi_M)$ is an epimorphism. By Theorem 1.4(b), $\mathcal{C} \subseteq \mathcal{L}f(T)$.
 - (b) This follows from (a), since Q is an epifunctor and $\mathfrak{LF}(Q) = \mathfrak{LF}(T)$. \square

Corollary (1.6) If $T: \mathbb{R}^{\mathbb{N}} \to \mathbb{B}$ is an epifunctor, then $\mathfrak{LF}(T)$ is the largest epireflective T-faithful subcategory of $\mathbb{R}^{\mathbb{N}}$.

Corollary (1.7) Let \mathfrak{A} be a reflective subcategory of $_R\mathbb{M}$, with reflector $T\colon _R\mathbb{M} \to \mathfrak{A}$. Then T is naturally isomorphic to TQ, for the reflector $Q\colon _R\mathbb{M} \to \mathfrak{L}(T)$, and for all $M\in _R\mathbb{M}$, $M\to Q(M)\to TQ(M)$ is the factorization of $M\to T(M)$ into an epimorphism followed by a monomorphism.

Proof. For any $M \in {}_R \mathbb{M}$, $M \to \mathcal{Q}(M)$ is an epimorphism, and $\mathcal{Q}(M) \to T\mathcal{Q}(M)$ is a monomorphism since $\mathcal{Q}(M) \in \mathfrak{LF}(T)$. If $A \in \mathfrak{A}$ and $f : M \to A$, then f factors uniquely through $\mathcal{Q}(M)$ since $A \in \mathfrak{LF}(T)$. But then f further factors uniquely through $T\mathcal{Q}(M)$, and so this shows that $T\mathcal{Q}$ is a left adjoint for the inclusion functor. Since adjoints are unique up to natural isomorphism, $T\mathcal{Q}$ is naturally isomorphic to T. \square

A class C of modules is called a torsion class if it is closed under formation of homomorphic images, direct sums, and (group) extensions, and a torsionfree class if it is closed under submodules, direct products, and (group) extensions. A torsion class is called hereditary if it is closed under submodules. There is a one-to-one correspondence between hereditary torsion classes, torsion radicals, and torsionfree classes closed under essential extensions [13, Proposition 2.6].

Theorem (1.8) Let $T: {}_{R}\mathbb{M} \to \mathbb{B}$ be a functor.

- (a) If T is a monofunctor, then rad_T is a torsion radical.
- (b) If T is exact, then the torsion class of rad_T is the smallest hereditary torsion class containing Ker(T).

- **Proof.** (a) If T is a monofunctor, then by the dual of [2, Proposition 2.4], $\mathfrak{L}(T)$ is closed under (group) extensions, and by [2, Proposition 2.5], it is closed under essential extensions. Therefore the radical rad T determined by $\mathfrak{L}(T)$ is a torsion radical.
- (b) By [2, Proposition 2.6], $M \in \mathfrak{L}^{\sigma}(T)$ if and only if $\operatorname{Hom}_{R}(K, M) = 0$ for all $K \in \operatorname{Ker}(T)$. The torsion class of rad_{T} is the collection of modules ${}_{R}N$ such that $\operatorname{Hom}_{R}(N, M) = 0$ for all M in $\mathfrak{L}^{\sigma}(T)$, and so this is precisely the hereditary torsion class generated by $\operatorname{Ker}(T)$. \square
- 2. Examples. For modules $_RM$ and $_RP$, the functors $\operatorname{Hom}_R(-,M)$ and $\operatorname{Hom}_R(P,-)$ will be denoted by H_M and H^P respectively. In [2], $\mathfrak{L}^r(H_M)$ and $\mathfrak{R}^r(H^P)$, $(\mathfrak{R}^r(H^P))$ is defined dually) were studied. Every torsion radical has the form rad_T for $T=H_M$ for an appropriate injective module $_RM$, since $\mathfrak{L}^r(T)$ is just the full subcategory of modules cogenerated by M. The main purpose of this section is to study $\mathfrak{L}^r(H^P)$, which by Theorem 1.8 determines a torsion radical since H^P is always left exact.

For modules $_RM$ and $_RP$, let $\operatorname{tr}_M(P)$ be the sum in M of all R-homomorphic images of P. An ideal A of R will be called a trace ideal if $A = \operatorname{tr}_R(P)$ for some module $_RP$. It is evident that A is a trace ideal if and only if $A = \operatorname{tr}_R(A)$, and that trace ideals are just the torsion ideals of idempotent preradicals. In particular, any idempotent ideal is a trace ideal. (See [3].)

Proposition (2.1) Let $P \in \mathbb{R}^{M}$, and let \mathbb{R}^{U} be a generator for \mathbb{R}^{M} .

- (a) $\mathfrak{L}(H^P) = \mathfrak{L}(H^V)$, for $_RV = \operatorname{tr}_U(P)$.
- (b) $M \in \mathfrak{L}(H^P) \iff \operatorname{Hom}_{P}(U/V, M) = 0$.
- **Proof.** (a) Since P generates V, $H^V(f) \neq 0$ implies $H^P(f) \neq 0$, for any R-homomorphism f, and so $\mathfrak{LF}(H^V) \subseteq \mathfrak{LF}(H^P)$. On the other hand, if $M \in \mathfrak{LF}(H^P)$ and $0 \neq f: {}_R X \to {}_R M$, then since U is a generator there exists a homomorphism $b: U \to X$ with $fb \neq 0$. Since $H^P(fb) \neq 0$ by assumption, there exists $g: P \to U$ with $fbg \neq 0$, and then $fb(V) \neq 0$ because $g(P) \subseteq V$. Thus $H^V(f) \neq 0$, and $M \in \mathfrak{LF}(H^V)$.
- (b) (\Longrightarrow). If $M \in \mathcal{QF}(H^P)$ and $\operatorname{Hom}_R(U/V, M) \neq 0$, say $0 \neq f \colon U/V \to M$, then $H^P(fp) \neq 0$ for the projection $p \colon U \to U/V$, so there exists $g \colon P \to U$ with $fpg \neq 0$. But $g(P) \subseteq V$ since $V = \operatorname{tr}_U(P)$, a contradiction.
- (\Leftarrow). If $0 \neq f$: $X \to M$, then there exists $g: U \to X$ with $fg \neq 0$, since U is a generator. But then if $\operatorname{Hom}_R(U/V, M) = 0$, $fg(V) \neq 0$, since otherwise fg would factor through U/V. Therefore $M \in \mathfrak{LF}(H^V) = \mathfrak{LF}(H^P)$. \square

Corollary (2.2) Let $P \in {}_R \mathbb{M}$ and $A = \operatorname{tr}_R(P)$. Then $M \in \mathfrak{LF}(H^P) \Leftrightarrow \operatorname{Ann}_M(A) = 0$.

Proof. By Proposition 2.1, $M \in \mathfrak{LF}(H^P) \Leftrightarrow \operatorname{Hom}_R(R/A, M) = 0$, and this occurs if and only if $\operatorname{Ann}_M(A) = \{m \in M: Am = 0\} = 0$. \square

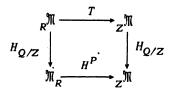
Corollary (2.3) Let $P \in \mathbb{R}^{M}$, and let $T = H^{P}$. Then rad_{T} is the identity functor on \mathbb{R}^{M} if and only if $tr_{R}(P)$ is a right t-nilpotent ideal.

Proof. An ideal A of R is called right t-nilpotent if for any sequence (a_1, a_2, a_3, \cdots) of elements of A the product $a_n \cdots a_2 a_1 = 0$ for some n. An unpublished lemma of G. Azumaya shows that an ideal A is right t-nilpotent if and only if $Ann_M(A) \neq 0$ for all modules R^M , and so it follows from Corollary 2.2 that $\mathfrak{L}_R^{F}(H^P)$ contains only the zero module if and only if $\operatorname{tr}_R(P)$ is right t-nilpotent. \square

Proposition (2.4) Let P_R be a right R-module, and let $T: {}_R\mathbb{M} \to {}_Z\mathbb{M}$ be the functor $T=P\otimes_R$. For $M\in {}_R\mathbb{M}$, $M_R^*=\operatorname{Hom}_Z(M,Q/Z)_R$ will denote the character module of M.

- (a) $M \in \mathfrak{L}^{r}(T)$ if P_{R} generates M_{R}^{*} .
- (b) If P_R is flat, then $M \in \mathfrak{LF}(T) \Leftrightarrow \operatorname{Hom}_R(P, M_0^*) \neq 0$ for all nonzero R-submodules $M_0 \subseteq M$.
 - (c) If P_R is projective, then $\mathfrak{LT}(T) = \mathfrak{LT}(H^A)$, for $A = \operatorname{tr}_R(P_R)$.

Proof. (a) The natural isomorphism $\operatorname{Hom}_Z(P \otimes_R M, Q/Z) \simeq \operatorname{Hom}_R(P, \operatorname{Hom}(M, Q/Z))$ shows that the following diagram is commutative.



Since Q/Z is a cogenerator in $_Z\mathbb{M}$, $H_{Q/Z}$ is faithful and therefore $\mathfrak{L}F(T) = \mathfrak{L}F(H_{Q/Z}T) = \mathfrak{L}F(H^PH_{Q/Z})$. Since $H_{Q/Z}$ is contravariant, $M \in \mathfrak{L}F(T)$ if $M_R^* = H_{Q/Z}(M) \in \mathfrak{R}F(H^P)$.

- (b) Since T is right exact, the dual of [2, Proposition 2.3] shows that $M \in \mathfrak{L}^{r}(T)$ if and only if $\operatorname{Hom}_{R}(P, i^{*})$: $\operatorname{Hom}_{R}(P, M^{*}) \to \operatorname{Hom}_{R}(P, M^{*})$ is nonzero for the homomorphism i^{*} induced by the inclusion mapping $i \colon M_{0} \to M$ for any nonzero submodule M_{0} of M. When T is exact, this can be strengthened to condition (b), again by using the dual of [2, Proposition 2.3].
- (c) If P_R is projective, then $P \otimes_R M = 0$ if and only if AM = 0, where $A = \operatorname{tr}_R(P_R)$. Since T is exact, $M \in \mathfrak{L}(T)$ if and only if M has no nonzero submodules in Ker (T), and this occurs if and only if $\operatorname{Ann}_M(A) = 0$. Because A is an idempotent ideal, it is a trace ideal when viewed as a left ideal, and applying Corollary 2.2 shows that $\mathfrak{L}(T) = \mathfrak{L}(H^A)$. \square

A class of modules is called a TTF-class if it is both a torsion class and a torsionfree class. There is a one-to-one correspondence between TTF-classes and idempotent ideals of the ring R, and this correspondence is given by associating to an idempotent ideal A the class of modules annihilated by A [6]. The corresponding torsionfree class is then just the class of modules M such that Ann_M (A) = 0. This proves the following proposition.

Proposition (2.5) A class C of modules is the torsionfree class of a TTF-class $\Leftrightarrow C = \mathcal{L}F(H^A)$ for an idempotent ideal A.

Proposition (2.6) For a module $_RP$ such that $P \in \mathfrak{LF}(H^P)$, $\mathfrak{LF}(H^P)$ is a TTF-class $\Leftrightarrow \mathfrak{LF}(H^P) = \mathfrak{LF}(H^A)$ for an ideal A = Re generated by a central idempotent e.

Proof. Let \mathcal{C} be the torsion class corresponding to $\mathfrak{LF}(H^P)$, and let $\mathfrak{D} = \{M: \operatorname{Hom}_R(X, M) = 0\}$ for all $X \in \mathfrak{LF}(H^P)$.

- (⇒). Since H^P is left exact, Theorem 1.8 shows that \mathcal{C} is hereditary. Furthermore, \mathfrak{D} is closed under factor modules, since if $M \in \mathfrak{D}$, $0 \neq p$: ${}_RM \to {}_RN$ is an epimorphism and $0 \neq f$: $X \to N$, for $X \in \mathfrak{LF}(H^P)$, then since $\mathfrak{LF}(H^P)$ is a TTF-class it is closed under epimorphisms and so $f(X) \in \mathfrak{LF}(H^P)$. Thus for $M_0 = p^{-1}(f(X))$, $0 \neq p$: $M_0 \to f(X)$, and hence there exists g: $P \to M_0$ with $pg \neq 0$. This is impossible since $P \in \mathfrak{LF}(H^P)$ and $M_0 \in \mathfrak{D}$. By [1, Corollary 7], $\mathcal{C} = \mathfrak{D}$ and $\mathfrak{LF}(H^P) = \{M: BM = 0\}$ for a principal left ideal B generated by a central idempotent e. If A = R(1 e), then $BM = 0 \Leftrightarrow \operatorname{Ann}_M(A) = 0$, so by Corollary 2.2, $\mathfrak{LF}(H^P) = \mathfrak{LF}(H^A)$.
- (\Leftarrow). If A = Re, then let B = R(1 e). Then it follows from Corollary 2.2 that $\mathfrak{L}(H^A) = \{M: \operatorname{Ann}_M(A) = 0\} = \{M: BM = 0\}$. Since B is an idempotent ideal, the correspondence between idempotent ideals and TTF-classes shows that $\mathfrak{L}(H^A)$ is a TTF-class. \square

Note that if $\mathfrak{LF}(H^P) = \mathfrak{RF}(H^P)$, then $P \in \mathfrak{LF}(H^P)$ and $\mathfrak{LF}(H^P)$ is a TTF-class. Thus if R has no central idempotents other than 0 and 1, then for ${}_RP \neq 0$, $\mathfrak{LF}(H^P) = \mathfrak{RF}(H^P)$ if and only if P is a generator for ${}_RM$, and so in such a case $\mathfrak{LF}(H^P)$ and $\mathfrak{RF}(H^P)$ rarely coincide. On the other hand, if A = Re for a central idempotent e, then $\mathfrak{LF}(H^A)$ is just the full subcategory of A-modules, and so $\mathfrak{LF}(H^A) = \mathfrak{RF}(H^A)$.

Proposition (2.7) For $P \in {}_{R}\mathbb{N}$, $\Re \mathcal{F}(H^P)$ is closed under products if and only if P is finitely generated as a module over $\operatorname{End}_{R}(P)$.

Proof. (\Rightarrow). If $\Re f(H^P)$ is closed under products, then P generates $\prod_{\alpha \in I} P_{\alpha}$, where $P_{\alpha} = P$ and the index set I is P itself. Let $x \in \prod_{\alpha \in I} P_{\alpha}$ be the element with pth component $x_p = p$. Then $x = \sum_{j=1}^n f_j(p_j)$ for elements

 $p_j \in P$ and $f_j \in \operatorname{Hom}_R(P, \Pi_{\alpha \in I} P_\alpha)$. For the projections $\pi_p \colon \Pi_{\alpha \in I} P_\alpha \to P_p$, $p = \pi_p(x) = \sum_{j=1}^n \pi_p f_j(p_j)$, with $\pi_p f_j \in \operatorname{End}_R(P)$. Thus P is generated over $\operatorname{End}_R(P)$ by the elements p_1, \dots, p_n .

(\Leftarrow). If the modules $\{M_{\alpha}\}_{\alpha\in I}$ are each generated by P, then given $x\in \Pi_{\alpha\in I}$ M_{α} the α th component satisfies $x_{\alpha}=\sum_{i=1}^{m}\int_{i}^{\alpha}(x_{i}^{\alpha})$ for elements $x_{i}^{\alpha}\in P$ and $\int_{i}^{\alpha}\in P$ and

The above proposition is related to Proposition 3.6 of [4]. The proof of the next proposition is easy, so it has been omitted. A similar result is that $\mathcal{R}(H^P)$ = $\mathcal{L}(H_P)$ if and only if P is a generator and a cogenerator as an R/Ann (P)-module.

Proposition (2.8) The following conditions are equivalent for $P \in \mathbb{R}^{n}$.

- (a) RF(HP) is closed under submodules and products.
- (b) P is a generator as an R/Ann (P)-module.
- (c) $\Re F(H^P)$ is the full subcategory of R/Ann (P)-modules.
- 3. T-faithful Giraud subcategories. A Giraud subcategory of $_R\mathbb{M}$ is a full reflective subcategory whose reflector is exact. (See [13].) Such a subcategory is a Grothendieck category, and in fact any Grothendieck category is equivalent to a Giraud subcategory of some category of modules. Throughout this section $T:_R\mathbb{M} \to \mathbb{B}$ will be a fixed additive functor into an abelian category \mathbb{B} .

Definition (3.1) The full subcategory of $_R\mathbb{M}$ determined by all modules $_RM$ such that there exists an injective resolution $0\to M\to X_0\to X_1\to\cdots$ with $X_0\in \mathfrak{L}(T)$ will be denoted by $\mathfrak{L}_1(T)$. Similarly, $\mathfrak{L}_2(T)$ will denote the full subcategory determined by all modules $_RM$ such that there exists an injective resolution $0\to M\to X_0\to X_1\to X_2\to\cdots$ with X_0 and X_1 in $\mathfrak{L}_1(T)$.

If T is a monofunctor, then $\mathfrak{L}^{\sigma}(T)$ is closed under essential extensions, so $\mathfrak{L}^{\sigma}(T) = \mathfrak{L}^{\sigma}(T)$. This is not the case in general, since for the functor $H_Z: \mathbb{Z}^{m} \to \mathbb{Z}^{m}$, $\mathfrak{L}^{\sigma}(H_Z)$ is the class of torsionless abelian groups, but $\mathfrak{L}^{\sigma}(H_Z)$ contains only the zero group since no nonzero divisible group is torsionless. If $\mathbb{Z}^{\sigma}(H_Z)$ is an injective module, then $M \in \mathfrak{L}^{\sigma}(H_Z)$ if and only if V-dom dim $M \geq 2$, as is shown by Storrer [7, Proposition A.5]. The definition is thus motivated by the notion of dominant dimension used by Tachikawa in [15].

Lemma (3.2) Let $M \in {}_{R}\mathbb{M}$, with injective envelope E(M).

- (a) $M \in \mathfrak{LF}_1(T) \Leftrightarrow E(M) \in \mathfrak{LF}(T)$.
- (b) $M \in \mathfrak{LF}_2(T) \Leftrightarrow E(M)$ and E(E(M)/M) belong to $\mathfrak{LF}(T)$.

Proof. Each term in the minimal injective resolution of M, given by $0 \to M \to E(M) \to E(E(M)/M) \to \cdots$, is a direct summand of the corresponding term in every injective resolution [7, Lemma A.3]. The result follows since $\mathfrak{L}F(T)$ is closed under submodules. \square

Proposition (3.3) $\mathfrak{L}_{1}(T)$ is the torsion free class of a torsion radical.

Proof. By Lemma 3.2 (a), $\mathfrak{LF}_1(T)$ is closed under submodules, direct products, and injective envelopes. If $0 \to M' \to M \to M'' \to 0$ is an exact sequence in ${}_R \mathfrak{M}$ with M', $M'' \in \mathfrak{LF}_1(T)$, then M can be embedded in $E(M') \oplus E(M'')$, and so $M \in \mathfrak{LF}_1(T)$. \square

Theorem (3.4) $\mathfrak{LF}_{2}(T)$ is a Giraud subcategory.

Proof. Since $\mathfrak{LF}_1(T)$ is the torsionfree class of a torsion radical, by [13, Theorem 10.2] there is a corresponding Giraud subcategory consisting of those modules R^M such that E(M) and E(E(M)/M) belong to $\mathfrak{LF}_1(T)$. By Lemma 3.2 this is precisely $\mathfrak{LF}_2(T)$. \square

By construction, $\mathfrak{LF}_1(T)$ is the largest torsionfree class (of a torsion radical) which is contained in $\mathfrak{LF}(T)$, and similarly, $\mathfrak{LF}_2(T)$ is the largest Giraud subcategory contained in $\mathfrak{LF}(T)$, so $\mathfrak{LF}_2(T)$ can be characterized as the largest left T-faithful Giraud subcategory of $R^{\mathbb{M}}$. Theorem 3.4 can also be deduced from [9, Chapter V, Theorem 6.8] and the following proposition, for which it is interesting to have a proof which uses only Lemma 3.2.

Proposition (3.5) Let $0 \to M' \to M \to M'' \to 0$ be an exact sequence in $R^{\mathfrak{M}}$, with $M \in \mathfrak{LF}_1(T)$. If $M' \in \mathfrak{LF}_2(T)$, then $M'' \in \mathfrak{LF}_1(T)$ and the converse holds if $M \in \mathfrak{LF}_2(T)$.

Proof. Assume that $M \in \mathfrak{L}_2(T)$. Then $E(M) = E(M') \oplus X$, where RX is injective, and $X \in \mathfrak{L}_1(T)$ since $M \in \mathfrak{L}_1(T)$. Now $M'' \simeq M/M' \subseteq E(M)/M' = (E(M')/M') \oplus X$, and so $E(M'') \simeq E(M/M') \subseteq E(E(M')/M') \oplus X$. The last module belongs to $\mathfrak{L}_1(T)$ by Lemma 3.2 since $M' \in \mathfrak{L}_2(T)$, so $E(M'') \in \mathfrak{L}_1(T)$ and thus $M'' \in \mathfrak{L}_1(T)$.

Conversely, assume that $M \in \mathfrak{L}_2^{\mathbf{T}}(T)$ and $M'' \in \mathfrak{L}_1^{\mathbf{T}}(T)$. First, $E(M') \subseteq E(M) \in \mathfrak{L}(T)$. Next, let $f: E(M) \to (E(M)/M) \oplus E(M'')$ be the homomorphism induced by the projections $E(M) \to E(M)/M$ and $M \to M''$. Then $\ker(f) = M'$ since f(m) = 0 implies $m \in M$ and therefore $m \in M'$, by examining the first component of the homomorphism and then the second. Thus $E(M')/M' \subseteq E(M)/M'$ is isomorphic to a submodule of $E(E(M)/M) \oplus E(M'')$, which belongs to $\mathfrak{L}(T)$ by assumption, and so it follows that $E(E(M')/M') \in \mathfrak{L}(T)$. By Lemma 3.2 this completes the proof. \square

Proposition (3.6) If T is exact and Ker (T) is an hereditary torsion class, then $\mathfrak{LF}_2(T)$ is equivalent to $\mathfrak{g}M/\mathrm{Ker}(T)$.

Proof. If T is exact and Ker (T) is an hereditary torsion class, then by Theorem 1.8, $\mathfrak{L}(T)$ is the torsionfree class determined by Ker (T) and $\mathfrak{L}(T)$ is the Giraud subcategory corresponding to Ker (T). It then follows from [13, Corollary 7.9] that $\mathfrak{L}(T)$ is equivalent to the quotient category $\mathfrak{L}(T)$ constructed in the usual way. (See [13] or [14].) \square

Theorem (3.7) Let \mathfrak{A} be a Giraud subcategory of $R^{\mathfrak{M}}$ with exact reflector $Q: R^{\mathfrak{M}} \to \mathfrak{A}$. The following conditions are equivalent:

- (a) \mathfrak{A} is a subcategory of $\mathfrak{LF}_{2}(T)$.
- (b) A is T-faithful and T(f) = 0 implies TQ(f) = 0, for all R-homomorphisms f.
- (c) T(f) = 0 implies Q(f) = 0, for all R-homomorphisms f.
- (d) If $M' \to M \to M''$ is any sequence of R-modules, then if the image under T of $M' \to M \to M''$ is exact, so is $Q(M') \to Q(M') \to Q(M'')$.

Proof. Since $\mathfrak{LF}_2(T) \subseteq \mathfrak{LF}(T)$, (a) \Rightarrow (b) and (b) \Rightarrow (c) follow directly from Theorem 1.4. Assume that T is covariant.

- (c) \Rightarrow (d). Suppose that $M' \xrightarrow{f} M \xrightarrow{g} M''$ is a sequence such that $T(M') \xrightarrow{T(f)} T(M) \xrightarrow{T(g)} T(M'')$ is exact in \mathcal{B} . Then T(gf) = 0 implies Q(gf) = 0. Let $u: K \to M$ be the kernel of g and $p: M \to C$ be the cokernel of f. Then T(u) factors through the kernel of T(g) and T(p) factors through the cokernel of T(g). Hence T(pu) = 0, and this implies that Q(pu) = 0. But Q is exact, so it preserves kernels and cokernels, which means that $Q(u) = \ker(Q(g))$ and $Q(p) = \operatorname{coker}(Q(f))$. Since Q(p)Q(u) = 0, this implies that $Q(M') \to Q(M') \to Q(M'')$ is exact.
- (d) \Rightarrow (c). Suppose that T(f) = 0 for $f: M \to M''$. Then for the identity 1: $M \to M$, the sequence $T(M) \xrightarrow{1} T(M) \xrightarrow{T(f)} T(M'')$ is exact. By assumption, $Q(M) \xrightarrow{1} Q(M) \xrightarrow{Q(f)} Q(M'')$ is exact, which implies Q(f) = 0.
- (c) \Rightarrow (a). If T(f)=0 implies Q(f)=0, then by Theorem 1.4, $C\subseteq \mathfrak{LF}(T)$. If $A\in C$, then since C is abelian and has enough injectives, there exists an injective resolution $0\to A\to X_0\to X_1$ in C. The inclusion functor is left exact and preserves injectives, so in C, C is an injective resolution with C, C is an injective resolution, C is an injective resolution with C is an injective resolution, C is an injective resolution.

Lemma (3.8) If T = TQ for the reflector $Q: {}_R\mathbb{M} \to \mathfrak{LF}_2(T)$ and \mathfrak{A} is a T-faithful Giraud subcategory of ${}_R\mathbb{M}$, then $M \in \mathfrak{LF}(T)$ if M and Q(M) are in \mathfrak{A} .

Proof. If M, $Q(M) \in \mathcal{C}$, let $\phi_M : M \to Q(M)$ be the homomorphism given by the adjoint situation. Since \mathcal{C} is a Giraud subcategory, it follows that $\ker (\phi_M) \in \mathcal{C}$. For the identity 1 of $\ker (\phi_M)$ it follows that T(1) = TQ(1) = 0, and then since \mathcal{C}

is T-faithful, 1=0 and $\ker\left(\phi_{M}\right)=0$, which shows that $M\in\mathfrak{LF}(T)$. \square Note that it is not true in general that T=TQ, since it is possible to have $T\neq 0$ but Q=0, for example $T=H_{Z}\colon {}_{Z}\mathbb{M} \longrightarrow {}_{Z}\mathbb{M}$. Recall that an hereditary torsion class is called stable if it is closed under essential extensions.

Proposition (3.9) If T is exact and Ker (T) is a stable, bereditary torsion class, then $\mathfrak{LF}_{2}(T)$ is the largest T-faithful Giraud subcategory of $p^{\mathfrak{M}}$.

Proof. To show that $\mathfrak{LF}_2(T)$ is a maximal T-faithful Giraud subcategory it is not necessary to assume that Ker (T) is stable. If T is exact and Ker (T) is an hereditary torsion class, then T=TQ by [14, p. 40], so if \mathfrak{C} is a Giraud subcategory containing $\mathfrak{LF}_2(T)$ which is T-faithful, then the conditions of Lemma 3.8 are satisfied for each $M \in \mathfrak{C}$, and so $\mathfrak{C} \subseteq \mathfrak{LF}(T)$. Since $\mathfrak{LF}_2(T)$ is the largest Giraud subcategory contained in $\mathfrak{LF}(T)$, $\mathfrak{C} \subseteq \mathfrak{LF}_2(T)$.

Corollary (3.10) If R is commutative and Noetherian, and T is covariant and bas a right adjoint, then $\mathfrak{LF}_2(T)$ is characterized as the largest T-faithful Giraud subcategory of $_R\mathbb{M}$.

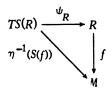
Proof. Since T has an adjoint, Ker (T) is an hereditary torsion class. Furthermore, Ker (T) is stable since R is commutative and Noetherian [13, Proposition 5.12]. \square

4. Applications.

Proposition (4.1) Let $\mathcal B$ be an additive category, and suppose the covariant functor $S: {}_R \mathbb M \to \mathcal B$ has a left adjoint T, with $\psi\colon TS \to \mathrm{Id}$ the associated natural transformation. Let $A=\mathrm{Im}\ (\psi_R)$.

- (a) $_{R}M \in \mathfrak{LF}(S) \Leftrightarrow \operatorname{Ann}_{M}(A) = 0.$
- (b) $_R^M \in \mathfrak{LF}_2(S) \Leftrightarrow the \ natural \ mapping \ _R^M \to _R^{Hom}_R(A, M) \ is \ an \ isomorphism.$

Proof. (a) For any homomorphism $f: R \to M$, the following diagram is commutative.



Thus $S(f) \neq 0 \Leftrightarrow \eta^{-1}(S(f)) \neq 0 \Leftrightarrow f\psi_R \neq 0$, and so $S(f) \neq 0 \Leftrightarrow f(A) \neq 0$. It follows from this that if $M \in \mathcal{L}(S)$, then $\operatorname{Hom}_R(R/A, M) = 0$. Conversely, if $f: {}_RX \to {}_RM$, then there exists $g: R \to X$ with $fg \neq 0$, and if $\operatorname{Hom}_R(R/A, M) = 0$, then $fg(A) \neq 0$, which implies $S(fg) \neq 0$ and therefore $S(f) \neq 0$, so that $M \in \mathcal{L}(S)$. This proves (a), since $\operatorname{Ann}_M(A) = 0 \Leftrightarrow \operatorname{Hom}_R(R/A, M) = 0$.

(b) This follows immediately from (a) and the characterization of the quotient category determined by an ideal A given by Mueller [12, Proposition 1]. Note that S is a monofunctor, and so $\mathfrak{LF}_1(S) = \mathfrak{LF}(S)$. \square

Proposition (4.2) In the above situation, the inclusion functor from $\mathfrak{LF}_2(S)$ into $_R\mathbb{M}$ preserves direct sums.

Proof. If $\{M_{\alpha}\}_{\alpha \in I}$ is a set of modules in $\mathfrak{LF}_{2}(S)$, then the factor module $E(\bigoplus_{\alpha \in I} M_{\alpha})/\bigoplus_{\alpha \in I} M_{\alpha}$ is in $\mathfrak{LF}(S)$. To show this, if $x \in E(\bigoplus_{\alpha \in I} M_{\alpha})$, with $Ax \in \bigoplus_{\alpha \in I} M_{\alpha}$, then $Ax \in \bigoplus_{\alpha \in F} M_{\alpha}$ for some finite subset F of I. But this finite direct sum is in $\mathfrak{LF}_{2}(S)$, and so $E(\bigoplus_{\alpha \in I} M_{\alpha})/\bigoplus_{\alpha \in F} M_{\alpha}$ belongs to $\mathfrak{LF}(S)$, and therefore $x \in \bigoplus_{\alpha \in F} M_{\alpha}$. Thus by Proposition 3.5, $\bigoplus_{\alpha \in I} M_{\alpha}$ belongs to $\mathfrak{LF}_{2}(S)$. \square

Note that this proof applies to the quotient category determined by any ideal, and so in particular it applies to $\mathfrak{LF}_2(T)$ for $T = P \otimes_R -$, where P_R is projective.

A Morita context consists of two rings R and R' and two bimodules $_R, P_R$ and $_R, M_R$, together with two bimodule homomorphisms $(-, -): _R, M \otimes _R, P_R \to R$ and $[-, -]: _{R'}, P \otimes _R, M_{R'} \to R'$ satisfying the conditions m[p, m'] = (m, p)m' and p(m, p') = [p, m]p' for all $p, p' \in P$ and $m, m' \in M$. Let A and A' be the respective images of the maps (-, -) and [-, -]. A context is nondegeneratable if the two ideals A and A' are faithful as left and right modules [12, Proposition 12]. Let $_R Hom_{R'}(P, -) = H^P: _{R'}, M \to _R, M$ and $_R'Hom_{R'}(M, -) = H^M: _R, M \to _R, M$.

Theorem (4.3) Let $\langle P, M \rangle$ be a nondegeneratable Morita context. Then the categories $\mathfrak{LF}_2(H^PH^M)$ and $\mathfrak{LF}_2(H^MH^P)$ are equivalent.

Proof. With the notation previously given, the result holds if it is merely assumed that A_R and $_R$, A' are faithful. By [12, Theorem 3], if A_R is faithful, then $\operatorname{Ann}_R A = 0$ and so every R-homomorphism $f: {}_R M \otimes_R P \to {}_R R$ factors through A, so that A is the trace ideal of the module ${}_R M \otimes_R P$. Similarly,

A' is the trace ideal of $P \otimes_R M_{R'}$. Using Corollary 2.2 to translate Mueller's terminology into that of this paper, [12, Theorem 3] shows that the categories $\mathfrak{ZF}_2(H^A)$ and $\mathfrak{ZF}_2(H^{A'})$ are equivalent. By Corollary 2.2 and the fact that A is the trace ideal of $_R M \otimes_{R'} P$, it follows that $\mathfrak{ZF}_2(H^{M\otimes P})$ is equivalent to $\mathfrak{ZF}_2(H^{P\otimes M})$. This completes the proof, since $\operatorname{Hom}_R(M \otimes_{R'} P, -)$ is naturally equivalent to $\operatorname{Hom}_{R'}(P, \operatorname{Hom}_R(M, -))$ and $\operatorname{Hom}_{R'}(P \otimes_R M, -)$ is naturally equivalent to $\operatorname{Hom}_R(M, \operatorname{Hom}_{R'}(P, -))$. \square

Until noted otherwise, $T: {}_R\mathbb{M} \to \mathbb{B}$ will be a covariant functor, with right adjoint S. If T is exact, then Ker (T) is an hereditary torsion class, and $\mathfrak{LF}_2(T)$ is the corresponding Giraud subcategory. For any $B \in \mathbb{B}$ and any exact sequence $0 \to M' \to M \to M'' \to 0$ in ${}_R\mathbb{M}$ with $M'' \in \mathrm{Ker}(T)$, the natural isomorphism

$$0 \to \operatorname{Hom}_{R}(M'', S(B)) \to \operatorname{Hom}_{R}(M, S(B)) \to \operatorname{Hom}_{R}(M', S(B))$$

$$\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow$$

$$0 \to \operatorname{Hom}_{\mathfrak{F}}(T(M''), B) \to \operatorname{Hom}_{\mathfrak{F}}(T(M), B) \to \operatorname{Hom}_{\mathfrak{F}}(T(M'), B)$$

shows, since T(M'')=0, that S(B) is torsionfree and injective with respect to Ker (T). Hence $S(B)\in \mathfrak{LF}_2(T)$. The module of quotients for any $M\in_R\mathbb{M}$ is then given by $\ker (\phi_{ST(M)}-ST(\phi_M))$, as is shown by Proposition 4.5. Using rad_T this can be generalized to functors which are not necessarily exact.

Definition (4.4) Let $T: {}_R\mathbb{M} \to \mathbb{B}$ be covariant, with right adjoint S. For any $M \in {}_R\mathbb{M}$, define $Q_T(M) = \ker (\phi_{ST(M)} - ST(\phi_M))$, where $\phi_M: M \to ST(M)$ and $\phi_{ST(M)}: ST(M) \to STST(M)$ are the homomorphisms determined by the adjoint situation.

Proposition (4.5) Let $T: \mathbb{R}^{M} \to \mathbb{R}$ have a right adjoint S.

- (a) For any $B \in \mathcal{B}$, $Q_T(S(B)) = S(B)$.
- (b) For any $M \in \mathbb{R}^{n}$, $Q_{T}(M)$ is the rad_T-closure of $\phi_{M}(M)$ in ST(M).
- (c) For any $M \in {}_R\mathbb{M}$, $Q_T(M) \in \mathfrak{LF}(T)$, and $Q_T(M)$ is a direct summand of $Q_T(Q_T(M))$.

Proof. Recall that for a radical ρ , the ρ -closure of a submodule M' in M is the inverse image in M of $\rho(M/M')$. Equivalently, it is the intersection of all submodules of M which contain M' and have ρ -torsionfree quotient.

- (a) S(B) is a direct summand of STS(B), since $S(\psi_B)\phi_{S(B)}=1_{S(B)}$, and so $STS(B)/\phi_{S(B)}(S(B))$ is rad_T-torsionfree. Part (b) shows that $Q_T(S(B))=S(B)$.
 - (b) The diagram

$$\begin{array}{ccc}
M & \xrightarrow{\phi_{M}} & ST(M) \\
\downarrow^{\phi_{ST(M)}} & & \downarrow^{\phi_{ST(M)}} \\
ST(M) & \xrightarrow{ST(\phi_{M})} & STST(M)
\end{array}$$

is commutative, and so $(\phi_{ST(M)} - ST(\phi_M))\phi_M = 0$. Thus $\phi_M(M) \subseteq Q_T(M)$.

It follows immediately from the definition of $Q_T(M)$ that it is rad_T -closed in ST(M), since $STST(M) \in \mathfrak{LF}(T)$. Thus $Q_T(M)$ contains the rad_T -closure of $\phi_M(M)$. On the other hand, if $f \colon ST(M) \to N$, with $N \in \mathfrak{LF}(T)$, then the following diagram is commutative

$$\begin{array}{cccc}
M & \xrightarrow{\phi_{M}} & ST(M) & \xrightarrow{f} & N \\
\downarrow \phi_{M} & & \downarrow \phi_{ST(M)} & & \downarrow \phi_{N} \\
ST(M) & \xrightarrow{ST(\phi_{M})} & STST(M) & \xrightarrow{ST(f)} & ST(N)
\end{array}$$

If $f\phi_M=0$, then $ST(f)ST(\phi_M)=0$ and so $ST(f)ST(\phi_M)(Q_T(M))=0$. But then $ST(f)\phi_{ST(M)}(Q_T(M))=0$ since $ST(\phi_M)=\phi_{ST(M)}$ when restricted to $Q_T(M)$. Thus $\phi_N f(Q_T(M))=0$, which shows that $f(Q_T(M))=0$, because $N\in \mathcal{QF}(T)$ and consequently ϕ_N is a monomorphism. It now follows that $Q_T(M)$ is contained in the rad_T-closure of $\phi_M(M)$.

(c) $Q_T(M) \in \mathcal{Z}f(T)$ since $ST(M) \in \mathcal{Z}f(T)$. The exact sequence

$$0 \to Q_T(M) \to ST(M) \xrightarrow{\phi_{ST(M)} - ST(\phi_M)} STST(M)$$

shows, by the following lemma, that $Q_T(M)$ is a direct summand of $Q_T(Q_T(M))$. \square

Lemma (4.6) Let $T: \mathbb{R}^{\mathbb{M}} \to \mathbb{B}$, with right adjoint S, and let $M \in \mathbb{R}^{\mathbb{M}}$. The homomorphism $\phi_M: M \to Q_T(M)$ splits if there exist $B \in \mathbb{B}$ and $N \in \mathfrak{LF}(T)$ together with an exact sequence $0 \to M \to S(B) \to N$.

Proof. Consider the following diagram, if the hypotheses are satisfied.

$$0 \to M \xrightarrow{f} S(B) \xrightarrow{g} N$$

$$\phi_{M} \downarrow \qquad \phi_{S(B)} \downarrow \uparrow S(\psi_{B})$$

$$ST(M) \xrightarrow{ST(f)} STS(B)$$

Then $gS(\psi_B)ST(f)\phi_M = gS(\psi_B)\phi_{S(B)}f = gf = 0$ since $S(\psi_B)\phi_{S(B)} = 1_{S(B)}$. Since

 $N \in \mathfrak{L}^{r}(T)$, and $Q_{T}(M)$ is the rad_T-closure of M in ST(M), $gS(\psi_{B})ST(f)(Q_{T}(M)) = 0$. Thus $S(\psi_{B})ST(f)(Q_{T}(M)) \subseteq f(M)$, and so $f^{-1}S(\psi_{B})ST(f)$ gives the splitting homomorphism, since f is a monomorphism and $S(\psi_{B})ST(f)\phi_{M} = f$. \square

In fact, the same proof can be used to show that $M \to Q_T(M)$ splits if there exist $B \in \mathcal{B}$, M', $N \in \mathcal{QF}(T)$, and an exact sequence $0 \to M \oplus M' \to S(B) \to N$. This condition is also necessary.

Lemma (4.7) Let $T: \mathbb{R}^{\mathbb{M}} \to \mathbb{B}$, with right adjoint S. The following conditions are equivalent for any $M \in \mathbb{R}^{\mathbb{M}}$.

- (a) $Q_T(M) = ST(M)$.
- (b) The mapping $\operatorname{Hom}_{\mathfrak{B}}(T(M),\,T(N)) \to \operatorname{Hom}_{R}(ST(M),\,ST(N))$ induced by S is onto for all $N \in {}_{R}\mathbb{M}$.
 - (c) $\psi_{T(M)}$ is an isomorphism.
 - (d) $T(\phi_M)$ is an isomorphism.
 - (e) $\phi_{ST(M)}$ is an isomorphism.

Proof. Recall that for any $M \in {}_R \mathbb{M}$, $B \in \mathcal{B}$, $f: M \to S(B)$, and $g: T(M) \to B$, the adjoint mapping η satisfies $\eta^{-1}(f) = \psi_B T(f)$ and $\eta(g) = S(g)\phi_M$. From the first it follows that $\psi_{T(M)}T(\phi_M) = 1_{T(M)}$ and $S(\psi_{T(M)})ST(\phi_M) = 1_{ST(M)}$, and from the second that $S(\psi_{T(M)})\phi_{ST(M)} = 1_{ST(M)}$.

(a) \Rightarrow (b). Given $f: ST(M) \rightarrow ST(N)$, consider $g = \psi_{T(N)} T(f) T(\phi_M)$. Then

$$S(g) = S(\psi_{T(N)})ST(f)ST(\phi_{M}) = S(\psi_{T(N)})ST(f)\phi_{ST(M)}$$

$$= S(\psi_{T(N)})\phi_{ST(N)}f = 1_{ST(N)}f = f$$

since $ST(\phi_M) = \phi_{ST(M)}$, and so (b) holds.

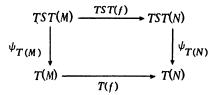
- (b) \Rightarrow (c). If (b) holds, then $\operatorname{Hom}_{\mathfrak{F}}(T(M), TST(M)) \to \operatorname{Hom}_{R}(ST(M), STST(M))$ is onto, so there exists $g \in \operatorname{Hom}_{\mathfrak{F}}(T(M), TST(M))$ with $S(g) = \phi_{ST(M)}$. Then $\eta(g\psi_{T(M)}) = S(g\psi_{T(M)})\phi_{ST(M)} = S(g)S(\psi_{T(M)})\phi_{ST(M)} = S(g) = \phi_{ST(M)} = \eta(1_{T(M)}),$ which implies $g\psi_{T(M)} = 1_{T(M)}$, and so $\psi_{T(M)}$ is an isomorphism.
 - (c) \Leftrightarrow (d). This is obvious, since $\psi_{T(M)}^{(M)}T(\phi_M)=1_{T(M)}^{(M)}$.
- (c) \rightarrow (e). If $\psi_{T(M)}$ is an isomorphism, then so is $S(\psi_{T(M)})$, and so $\phi_{ST(M)}$ is an isomorphism since $S(\psi_{T(M)})\phi_{ST(M)} = 1_{ST(M)}$.
- (e) \Rightarrow (a). If $\phi_{ST(M)}$ is an isomorphism, then so is $S(\psi_{T(M)})$, and $S(\psi_{T(M)})ST(\phi_M) = S(\psi_{T(M)})\phi_{ST(M)}$ implies $ST(\phi_M) = \phi_{ST(M)}$.

Note that since $\phi \colon ST \to STST$ is a natural transformation, a finite direct sum of modules satisfies the conditions of the lemma if and only if each summand satisfies the condition. If $f \colon_R M \to_R N$ and ST(f) is an epimorphism, then condition (d) of Lemma 4.7 can be used to show that $Q_T(N) = ST(N)$ if $Q_T(M) = ST(M)$. Note that the last three conditions only require, respectively, that $\psi_{T(M)}$ is a

monomorphism, that $T(\phi_M)$ is an epimorphism, or that $\phi_{ST(M)}$ is an epimorphism.

Proposition (4.8) Let $T: \mathbb{R}^{\mathbb{M}} \to \mathbb{R}$, with right adjoint S, and let M, $N \in \mathbb{R}^{\mathbb{M}}$ with $f: M \to N$ and $Q_T(N) = ST(N)$. Then $Q_T(M) = ST(M)$ if TST(f) is a monomorphism. This condition is satisfied if T is exact and $\ker(f) \in \ker(T)$.

Proof. Consider the following commutative diagram.



Since $Q_T(N) = ST(N)$, $\psi_{T(N)}$ is a monomorphism, so $\psi_{T(N)}TST(f)$ is also a monomorphism, and consequently $\psi_{T(M)}$ is a monomorphism. Thus $Q_T(M) = ST(M)$ by Lemma 4.7.

If T is exact, then $0 \to T(\ker(f)) \to T(M) \to T(N)$ is exact, and so T(f) is a monomorphism. Since T is exact and S is a monofunctor, TST(f) must be a monomorphism, and the previous condition holds. \square

Theorem (4.9) Let $T: \mathbb{R}^{\mathbb{M}} \to \mathbb{B}$, with right adjoint S, and let $M \in \mathbb{R}^{\mathbb{M}}$. Then $\phi_M: M \to ST(M)$ is an isomorphism if and only if $Q_T(M) = ST(M)$ and there exists an exact sequence $0 \to M \to S(B) \to N$, for some $B \in \mathbb{B}$ and $N \in \mathfrak{LF}(T)$.

Proof. If $Q_T(M) = ST(M)$ and there exists an exact sequence $0 \to M \to S(B)$ $\to N$, with $B \in \mathcal{B}$ and $N \in \mathcal{L}(T)$, then by Lemma 4.6 $\phi_M : M \to Q_T(M) = ST(M)$ splits. By Proposition 4.5, $Q_T(M)$ is the rad_T-closure of $\phi_M(M)$ in ST(M), and if ϕ_M splits, then $\phi_M(M)$ is rad_T-closed in ST(M), so $\phi_M(M) = Q_T(M) = ST(M)$.

Conversely, if ϕ_M is an isomorphism, then the sequence $0 \to M \to ST(M) \to 0$ is exact. \square

If T is contravariant, then the above results can be dualized. In this case, a contravariant functor $S: \mathcal{B} \to_R \mathbb{M}$ is said to be an adjoint on the right for T if there exists a natural equivalence $\eta: \operatorname{Hom}_{\mathfrak{B}}(\cdot, T(-)) \to \operatorname{Hom}_R(-, S(\cdot))$. For any $M \in_R \mathbb{M}$ and $B \in \mathcal{B}$, η induces $\phi_M = \eta(1_{T(M)})$: $M \to ST(M)$ and $\psi_B = \eta^{-1}(1_{S(B)})$: $B \to TS(B)$.

The above results yield as corollaries several theorems of Morita [11]. If $_RV\in _R\mathbb{M}$, then V is a right E-module for the opposite ring E of $\operatorname{End}_R(V)$, and the functor $T=\operatorname{Hom}_R(-,V)_E\colon _R\mathbb{M}\to\mathbb{M}_E$ has an adjoint on the right $S=R^{\operatorname{Hom}_E}(-,V)\colon \mathbb{M}_E\to _R\mathbb{M}$. In this situation $\phi_V\colon V\to ST(V)$ is an isomorphism, and ST(R) is the bicommutator $\operatorname{End}_E(V)$ of V, which will be denoted by $\operatorname{Bic}_R(V)$. The module $_RV$ is said to be of type F_b if $\psi_{T(R)}$ is an isomorphism. (It follows from [10, Lemma 2.1] that this definition is equivalent to Morita's definition in

[11].) If $_RV$ is injective, then $Q_T(R)$ is the ring of quotients determined by rad_T , as is shown by [7, Proposition 3.1]. It then follows from Lemma 4.7 that the ring of quotients determined by V coincides with $\operatorname{Bic}_R(V)$ if and only if V is of type F_b . Furthermore, since $V = Q_T(V) = ST(V)$, Proposition 4.8 implies the well-known result that the ring of quotients determined by V coincides with $\operatorname{Bic}_R(V)$ if there exists a homomorphism $f: {}_RR \to {}_RV^n$ for some n, such that $\operatorname{ker}(f) = \operatorname{Ann}_R(V)$.

A module $_RM$ is said to have V-dom dim $M \ge 2$ if there exists an exact sequence $0 \to M \to X_0 \to X_1$ such that X_0 and X_1 are isomorphic to a direct product of copies of V. Since a module $_RN$ belongs to $\mathfrak{L}(T)$ if and only if it can be embedded in a direct product of copies of V, and a direct product of copies of V is of the form S(B) for a free E-module B_E , it follows that V-dom dim $M \ge 2$ if and only if there exists an exact sequence $0 \to M \to S(B) \to N$, such that B_E is a free E-module and $N \in \mathfrak{L}(T)$. For any $B \in \mathbb{M}_E$, it can be shown by merely considering a free E-resolution of E that E-dom dim E-dom dim E-module and E-module if E-module if E-module and E-module and E-module in E-module and E-module in E-module and E-module a

Corollary (4.10) Let V be a faithful left R-module. Then V is balanced if and only if V is of type F_h and V-dom dim $_RR \ge 2$.

If P_R is a right R-module, then P is a left E-module for the ring $E = \operatorname{End}_R(P)$, and the functor $T = P \otimes_R - P \otimes_$

Corollary (4.11) Let P_R be a faithful right R-module, and let $E = \operatorname{End}_R(P)$. If $W \in {}_E\mathbb{M}$ is a cogenerator, let ${}_R\operatorname{Hom}_E(P,W) = V$. Then P is balanced if and only if P is of type F, and V-dom dim ${}_RR \geq 2$.
