

INVARIANCE OF SOLUTIONS TO INVARIANT PARAMETRIC VARIATIONAL PROBLEMS

ABSTRACT. Let G be a compact Lie group of diffeomorphisms of a connected orientable manifold M of dimension $n + 1$. Assume the orbits of highest dimension to be connected. Let Ψ be a convex positive even parametric integrand of degree n on M which is invariant under the action of G . Let T be a homologically Ψ -minimizing rectifiable current of dimension n on M , and assume there exists a G -invariant rectifiable current T' which is homologous to T . It is shown that T is G -invariant provided Ψ satisfies a symmetry condition which makes it no less efficient for the tangent planes of T to lie along the orbits. This condition is satisfied by the area integrand in case G is a group of isometries of a Riemannian metric on M . Consequently, one obtains the corollary that if a rectifiable current T is a solution to the n -dimensional Plateau problem in M with G -invariant boundary ∂T , and if ∂T bounds a G -invariant rectifiable current T' such that $T - T'$ is a boundary, then T is G -invariant. An application to the Plateau problem in S^3 is given.

1. Introduction. Let G be a compact (but not necessarily connected) Lie group of diffeomorphisms of a connected orientable manifold M of dimension $n + 1$. Assume the orbits of highest dimension to be connected. Let Ψ be a convex positive even parametric integrand of degree n on M which is invariant under the action of G . Let T be a homologically Ψ -minimizing rectifiable current of dimension n on M , and assume there exists a G -invariant rectifiable current T' which is homologous to T . We show that T is G -invariant provided Ψ satisfies a symmetry condition which makes it no less efficient for the tangent planes of T to lie along the orbits. This condition is satisfied by the area integrand in case G is a group of isometries of a Riemannian metric on M . Consequently, one obtains the corollary that if a rectifiable current T is a solution to the n -dimensional Plateau problem in M with G -invariant boundary ∂T , and if ∂T bounds a G -invariant rectifiable current T' such that $T - T'$ is a boundary, then T is G -invariant.

The first result in this direction was obtained by Fleming and Lawson [L2] for the area integrand in $\mathbf{R}^{n+1}$. They showed that if G is a group of orientation preserving isometries which leave invariant a compact connected oriented $(n - 1)$ -dimensional submanifold B of $S^n \subset \mathbf{R}^{n+1}$, then *there exists* an absolutely area

minimizing G -invariant rectifiable current T in $\mathbf{R}^{n+1}$ with $\partial T = B$. Our theorem implies this result for the case where the orbits of highest dimension are connected.

The next result was obtained by Bindschadler [BD] for the area integrand on a Riemannian manifold M under the assumption that G is a group of isometries of M such that the distribution of orthogonal complements to the tangent spaces of the orbits is involutive. He showed that if T is an absolutely area minimizing rectifiable current of dimension $m + 1$ on M (m is the maximal dimension of the orbits) such that there exists a G -invariant rectifiable current T' with $\partial T' = \partial T$, then T is G -invariant.

Bindschadler's assumption concerning the orthogonal complements to the tangent spaces of the orbits is, unfortunately, rather restrictive. Although it is satisfied by the actions considered in [L2] (in case $m = n - 1$), it does not hold for the action of the group S^1 of complex numbers of modulus one on the unit sphere $S^3 \subset \mathbf{R}^4 = \mathbf{C}^2$ defined by complex scalar multiplication. Our investigation was motivated by a desire to understand this situation, as well as to extend the result of Fleming and Lawson to arbitrary manifolds in the stronger form suggested by Bindschadler in which *all* solutions to the Plateau problem are invariant.

Our main result is in §4. The proof is based on a theorem of Federer [F3] which asserts that in codimension one a Ψ -minimizing rectifiable current is also a solution to a less restrictive variational problem which allows as candidates for the minimum currents with real coefficients as well as integer coefficients. This allows us to use averaging techniques, which when applied to rectifiable currents that are candidates for the minimum of Ψ yield the more general flat currents, which are thereby also candidates for the minimum. We also make essential use of results in [BD]; in particular, Lemma 3.6 was suggested by [BD, 4.8].

§5 contains regularity results for invariant Ψ -minimizing currents which are implied by the general regularity theory in [F1] and [SSA].

In §6 we apply the lifting theory developed in [BJ1] and [BD] to develop the relationship between invariant Ψ -minimizing currents in M and solutions to a related variational problem in M/G . This is especially useful if $m = n - 1$, in which case the problem of finding invariant minimizing currents in M reduces to that of finding solutions to a one-dimensional variational problem, a procedure previously used in [L2].

§7 contains applications of our theory to the discussion of several examples, including the action of S^1 on S^3 mentioned above. We also discuss the relevance to our results of the counterexample to the question of existence of invariant solutions to the Plateau problem which was given by Federer in [F1].

2. Preliminaries. The purpose of this section is to fix basic notation and terminology, and discuss general concepts which will be used in the paper. Notations which are not explained below may be found in [F1, pp. 669–671]. Basic facts concerning transformation groups may be found in [BG].

2.1. Throughout the paper M and G will be as in §1. K and L will denote local Lipschitz neighborhood retracts in M which are G -invariant, with K compact and L closed. We also assume that $K \cap L$ is a Lipschitz neighborhood retract, and that

K is the union of a countable family of submanifolds of class 1 of M . k will be an integer with $0 \leq k \leq n + 1$.

We denote the tangent space to M at $x \in M$ by $T_x(M)$ and the tangent bundle by $T(M)$. $\mathfrak{X}(M)$ is the vector space of smooth vector fields on M ; $\mathfrak{X}_G(M)$ is the subspace of vector fields tangent to the orbits of G . If V is a vector space, $\bigwedge_k(V)$ denotes the vector space of k -vectors in V . $\bigwedge_k T(M)$ is the k -vector bundle of M .

2.2. *Orbits.* For each $x \in M$ the *isotropy subgroup* at x is

$$G_x = G \cap \{g: g(x) = x\}.$$

It is well known (see, for example, [BG, IV, 3.1 and VI, 2.4]) that there exists $x_0 \in M$ such that for each $x \in M$, $H = G_{x_0}$ is conjugate to a subgroup of G_x . Recalling that if x and y are on the same orbit then G_x and G_y are conjugate, we call an orbit $G(x)$ *principal* if G_x is conjugate to H ; denote $m = \dim G(x_0)$. The union M_0 of the set of principal orbits is open and dense in M . Orientability of M implies that the principal orbits are orientable [BG, IV, 3.11]; orient G/H . Consider $x \in M$ and a subgroup H_x of G_x conjugate to H . The orbit $G(x)$ is *singular* if $\dim G_x/H_x > 0$ and *exceptional* if $\dim G_x/H_x = 0$. $G(x)$ is a *special exceptional* orbit if G_x/H_x has order 2. An *orbit type* is an equivalence class of orbits under the equivalence relation of conjugacy of isotropy subgroups.

It is well known (see, for example, [BG, II, 5.8]) that $M_0^* = M_0/G$ is a smooth manifold of dimension $n + 1 - m$ and the projection $\pi: M_0 \rightarrow M_0^*$ is the projection map of a smooth fibre bundle $\mathfrak{M}_0$ with fibre G/H and structure group $\mathcal{N}(H)/H$ acting by right translation on G/H . ($\mathcal{N}(H)$ is the normalizer of H in G .) Furthermore, bundle coordinate maps are equivariant.

It will be useful to provide M with a G -invariant Riemannian metric b . Such a metric may be obtained from an arbitrary metric b_0 by averaging b_0 with respect to the action of G . Corresponding to b there is a unique Riemannian metric b_π on M_0^* such that for each $x \in M_0$, $\pi_*|T_x(G(x))^\perp$ is an isometry.

We define the *volume function* V on M/G by

$$V(z) = \iota(z) \mathcal{H}^m(z) \quad \text{for } z \in M/G,$$

where $\iota(z)$ is the index of a suitable conjugate of H in G_x for $x \in z$ in case z is an exceptional orbit, and $\iota(z) = 1$ otherwise. V is continuous on M/G and smooth on M_0^* .

2.3. *Currents.* $\mathbf{M}_k(M)$ is the vector space of k -dimensional currents $S \in \mathfrak{E}_k(M)$ with compact support and finite mass $\mathbf{M}(S)$. $\mathbf{M}_k^{\text{loc}}(M)$ is the space of currents $T \in \mathfrak{D}_k(M)$ such that $\mathbf{M}(T \llcorner \gamma) < \infty$ whenever $\gamma \in \mathfrak{D}^0(M)$. $\|T\|$ is the *variation measure* of T and one has the representation

$$T(\phi) = \int \langle \vec{T}, \phi \rangle d\|T\|$$

whenever ϕ is a continuous differential k -form with compact support in M , where $\vec{T}(x)$ is a k -vector of unit mass for $\|T\|$ almost all $x \in M$. $\mathbf{F}_k(M)$ is the vector space of k -dimensional *flat* currents (with compact support) in M . $\mathcal{R}_k(M)$ is the group of k -dimensional *rectifiable* currents in M .

$$\mathfrak{F}_k(M) = \mathcal{R}_k(M) + \partial \mathcal{R}_{k+1}(M)$$

is the group of k -dimensional *integral flat* currents in M .

$$\mathbf{I}_k(M) = \mathcal{R}_k(M) \cap \{T: \partial T \in \mathcal{R}_{k-1}(M) \text{ or } k = 0\}.$$

is the group of k -dimensional *integral* currents in M . One has the inclusions $\mathbf{I}_k(M) \subset \mathcal{R}_k(M) \subset \mathcal{F}_k(M) \subset \mathbf{F}_k(M)$.

$\mathbf{F}_k^{\text{loc}}(M)$ and $\mathbf{R}_k^{\text{loc}}(M)$ are respectively the sets of *locally flat* and *locally rectifiable* currents in M .

Whenever $B \subset A \subset M$ we define the vector spaces of k -dimensional *real flat cycles*

$$\mathbf{Z}_k(A, B) = \{T: T \in \mathbf{F}_k(M), \text{spt } T \subset A, \text{spt } \partial T \subset B \text{ or } k = 0\}$$

and the subspace of k -dimensional *real flat boundaries*

$$\mathbf{B}_k(A, B) = \{T + \partial S: T \in \mathbf{F}_k(M), \text{spt } T \subset B, S \in \mathbf{F}_{k+1}(M), \text{spt } S \subset A\}.$$

We define the group of k -dimensional *integral flat cycles*

$$\mathcal{Z}_k(A, B) = \mathbf{Z}_k(A, B) \cap \mathcal{R}_k(M)$$

and the subgroup of k -dimensional *integral flat boundaries*

$$\mathcal{B}_k(A, B) = \{T + \partial S: T \in \mathcal{F}_k(M), \text{spt } T \subset B, S \in \mathcal{F}_{k+1}(M), \text{spt } S \subset A\}.$$

We also define the k -dimensional *real homology group*

$$\mathbf{H}_k(A, B; \mathbf{R}) = \mathbf{Z}_k(A, B) / \mathbf{B}_k(A, B)$$

and the k -dimensional *integral homology group*

$$\mathbf{H}_k(A, B; \mathbf{Z}) = \mathcal{Z}_k(A, B) / \mathcal{B}_k(A, B);$$

in case A and B are local Lipschitz neighborhood retracts these groups are respectively isomorphic to the singular homology groups of the pair (A, B) with real and integer coefficients [F1, §4.4].

Let W be a G -invariant open subset of M_0 . We will call $T \in \mathcal{D}_k(W)$ a *local product* if for each $x \in W$ there exist an open subset U of $\pi(W)$ containing $\pi(x)$, a bundle coordinate map $\phi_U: U \times G/H \rightarrow W$, and $T_U \in \mathcal{D}_{k-m}(U)$ such that

$$T|_{\mathcal{D}_k(\pi^{-1}U)} = \phi_{U*}(T_U \times G/H).$$

2.4. Integrands. A *parametric integrand of degree k* on M is a continuous function

$$\Psi: \bigwedge_k \mathbf{T}(M) \rightarrow \mathbf{R}$$

satisfying the condition

$$\Psi(r\alpha) = r\Psi(\alpha) \quad \text{for } \alpha \in \bigwedge_k \mathbf{T}(M), r > 0.$$

Ψ is *positive* if

$$\Psi(\alpha) > 0 \quad \text{for } 0 \neq \alpha \in \bigwedge_k \mathbf{T}(M).$$

Ψ is *even* if

$$\Psi(-\alpha) = \Psi(\alpha) \quad \text{for } \alpha \in \bigwedge_k \mathbf{T}(M).$$

Ψ is *convex* if

$$\Psi(\alpha + \beta) \leq \Psi(\alpha) + \Psi(\beta) \quad \text{for } x \in M \text{ and } \alpha, \beta \in \bigwedge_k \mathbf{T}_x(M).$$

Ψ is called an *integrand of class q* if the restriction of Ψ to the set of nonzero elements of $\bigwedge_k \mathbf{T}(M)$ is of class q . We associate with each $x \in M$ the *constant coefficient integrand*

$$\Psi_x = \Psi|_{\mathbf{T}_x(M)}.$$

Whenever Ψ is positive and $T \in \mathbf{M}_k^{\text{loc}}(M)$, the function which corresponds $\Psi(\vec{T}(x))$ with $x \in M$ is $\|T\|$ integrable; one denotes

$$\int \Psi \circ \vec{T} d\|T\| = \int_T \Psi.$$

The *parametric area integrand of degree k* on M is the function

$$\Psi(\alpha) = |\alpha|, \quad \alpha \in \bigwedge_k \mathbf{T}(M).$$

In this case $\int_T \Psi = \mathbf{M}(T)$ whenever $T \in \mathcal{R}_k(M)$.

Let Ψ be a parametric integrand of degree k and class 2 on M . One says that Ψ satisfies a *parametric Legendre condition* if for each compact subset A of M there exists $c_A > 0$ such that for each $x \in A$,

$$D^2\Psi_x(\alpha)(\beta, \beta) > c_A |\beta \wedge \alpha|^2 / |\alpha|^3$$

whenever $\alpha, \beta \in \bigwedge_k \mathbf{T}_x(M)$ and $\alpha \neq 0$. (Here $D^2\Psi_x$ is the second differential of Ψ_x .) The area integrand satisfies this condition with $c_A = 1$. If Ψ satisfies this condition then Taylor's Theorem implies that Ψ is convex; in fact, Ψ is elliptic [F1, 5.1.2]. Moreover, the argument in [F1, 5.1.2] can be adapted to show that ellipticity is equivalent to a parametric Legendre condition for $k = n$ or $k = 1$.

Let Ψ be a parametric integrand of degree k on M and $A, B, C \subset M$ with $B \subset A$. A current T will be called *homologically Ψ -minimizing in C with respect to (A, B)* if $T \in \mathcal{R}_k(M)$, $\text{spt } T \subset C$, and

$$\int_T \Psi \leq \int_{T+Q} \Psi$$

whenever $Q \in \mathcal{B}_k(A, B)$ with $\text{spt } Q \subset C$.

Suppose A, B, C are local Lipschitz neighborhood retracts, B is relatively closed in A and C is compact. The following existence theorem is implied by the discussion in [F3, 5.9]: Let Ψ be a positive convex integrand. If $T_0 \in \mathcal{R}_k(M)$ with $\text{spt } T_0 \subset C$, then there exists $T \in \mathcal{R}_k(M)$ such that T is homologically Ψ -minimizing in C with respect to (A, B) and

$$T - T_0 \in \mathcal{B}_k(A, B).$$

We remark that if T is absolutely Ψ -minimizing with respect to $(C, C \cap B)$ as defined in [F1, 5.1.6], then T is homologically Ψ -minimizing in C with respect to (A, B) which in turn implies that T is homologically Ψ -minimizing with respect to $(C, C \cap B)$. Neither of the reverse implications holds in general; however, it is true that if T is homologically Ψ -minimizing with respect to (M, B) then T is homologically Ψ -minimizing in C with respect to (M, B) whenever $C \supset \text{spt } T$.

Finally, we observe that if Ψ is an elliptic integrand on $\mathbf{R}^{n+1}$, A is a convex subset of $\mathbf{R}^{n+1}$ and $B \subset A$, then $T \in \mathcal{R}_n(M)$ is absolutely Ψ -minimizing with respect to $(\mathbf{R}^{n+1}, B)$ if and only if T is absolutely Ψ -minimizing with respect to

(A, B). This follows directly from the definition of “elliptic integrand” [F1, 5.1.2] and is useful in application of our results in $\mathbf{R}^{n+1}$.

2.5. *Invariant integrands.* The action of G on M induces an action on $\mathbf{T}(M)$ and hence an action on $\bigwedge_k \mathbf{T}(M)$. For each $x \in M_0$ we choose $0 \neq \alpha \in \bigwedge_m \mathbf{T}_x(G(x))$ and define for $k \geq m$,

$$\mathcal{V}_{k,x} = \{ \alpha \wedge \beta : \beta \in \bigwedge_{k-m} \mathbf{T}_x(M) \}.$$

$\mathcal{V}_{k,x}$ is clearly independent of the choice of α and is a linear subspace of $\bigwedge_k \mathbf{T}_x(M)$ of dimension

$$\nu = \binom{n+1-m}{k-m}.$$

$$\mathcal{V}_k = \bigcup \{ \mathcal{V}_{k,x} : x \in M_0 \}$$

is a G -invariant subbundle of $\bigwedge_k \mathbf{T}(M_0)$.

Let Ψ be a parametric integrand of degree k on M . We will say that Ψ is G -invariant provided

- (i) Ψ is invariant under the action of G on $\bigwedge_k \mathbf{T}(M)$, and
- (ii) there exists a G -invariant continuous linear bundle map

$$\Pi_\Psi : \bigwedge_k \mathbf{T}(M_0) \rightarrow \mathcal{V}_k$$

such that

$$\Pi_\Psi|_{\mathcal{V}_k} = \mathbf{1}_{\mathcal{V}_k}$$

and

$$\Psi \circ \Pi_\Psi(\alpha) \leq \Psi(\alpha) \quad \text{whenever } \alpha \in \bigwedge_k \mathbf{T}(M_0),$$

with strict inequality for $\alpha \notin \mathcal{V}_k$.

We extend Π_Ψ to $\bigwedge_k \mathbf{T}(M)$ so that $\Pi_\Psi|_{\bigwedge_k \mathbf{T}(M)} \sim \bigwedge_k \mathbf{T}(M_0) = 0$, and denote $\Pi_{\Psi,x} = \Pi_\Psi|_{\bigwedge_k \mathbf{T}_x(M_0)}$ for $x \in M_0$. We also observe that (i) is equivalent to G -invariance of the integral of Ψ : If $T \in \mathbf{M}_k^{\text{loc}}(M)$ then

$$\int_{g^*T} \Psi = \int_T \Psi \quad \text{whenever } g \in G.$$

(Compare [F1, 5.1.1].) Note that the area integrand will satisfy (ii) if Π_Ψ is the orthogonal projection onto $\mathcal{V}_k$.

In case Ψ is a positive integrand of class 2 which satisfies a parametric Legendre condition and is such that (i) holds, Taylor's Theorem can be used to show that (ii) is equivalent to the requirement that for each $x \in M_0$, $\{D\Psi_x(\alpha) : 0 \neq \alpha \in \mathcal{V}_{k,x}\}$ spans a linear subspace of $\bigwedge_k \mathbf{T}_x(M_0)^*$ of dimension not greater than ν .

Next we suppose there exists a smooth invariant unit m -vector field $\mathbf{v}$ on M_0 such that for $x \in M_0$, $\mathbf{v}(x)$ is tangent to $G(x)$. Let Ψ be a parametric integrand of degree $k+m$ and class q on M_0 such that $g^*\Psi = \Psi$ for $g \in G$. We define a parametric integrand Ψ^* of degree k and class q on M_0^* as follows: Let $z \in M_0^*$, $x \in z$ and $\lambda_x : \mathbf{T}_z(M_0^*) \rightarrow \mathbf{T}_x(M_0)$ be such that $\pi_{\#} \circ \lambda_x$ is the identity. Then

$$\Psi^*(\alpha) = V(z)\Psi(\bigwedge_k \lambda_x(\alpha) \wedge \mathbf{v}(x)) \quad \text{for } \alpha \in \bigwedge_k \mathbf{T}_z(M_0^*).$$

It is clear that $\Psi^*(\alpha)$ does not depend on the choice of λ_x or $x \in z$. Smoothness follows through use of local cross sections. Finally, we remark that in case Ψ is even, existence of Ψ^* does not depend on the existence of v .

3. Invariant flat currents.

3.1. If $\xi \in \mathcal{X}(M)$ and A is a smooth tensor field on M , then $L_\xi A$ denotes the Lie derivative of A with respect to ξ . For each current $T \in \mathcal{D}_k(M)$ we define the Lie derivative $L_\xi T \in \mathcal{D}_k(M)$ so that

$$(L_\xi T)(\phi) = -T(L_\xi \phi) \quad \text{for } \phi \in \mathcal{D}^k(M).$$

LEMMA. If $\xi \in \mathcal{X}(M)$ and $T \in \mathcal{D}_k(M)$, then

$$\partial(T \wedge \xi) = (\partial T) \wedge \xi + (-1)^{k-1} L_\xi T.$$

PROOF. Using ι_ξ to denote interior multiplication by ξ [KN, p. 35] we have $\xi(x) \lrcorner \omega = (-1)^k \iota_{\xi(x)} \omega$ for $\omega \in \bigwedge^{k+1} T_x(M)$. Consequently, for $\phi \in \mathcal{D}^k(M)$,

$$L_\xi \phi = \iota_\xi(d\phi) + d\iota_\xi \phi = (-1)^k [\xi \lrcorner d\phi - d(\xi \lrcorner \phi)],$$

hence our identity follows from the definition

$$T \wedge \xi(\psi) = T(\xi \lrcorner \psi) \quad \text{for } \psi \in \mathcal{D}^{k+1}(M).$$

3.2. Let μ be the Haar measure on G with $\mu(G) = 1$, and denote

$$\mathfrak{N}_* = \mathbf{M}_*(M) + \partial \mathbf{M}_*(M).$$

There exists a chain map $A: \mathfrak{N}_* \rightarrow \mathfrak{N}_*$ characterized by the formula

$$A(T)(\phi) = \int_G g_* T(\phi) d\mu g \quad \text{for } T \in \mathfrak{N}_k, \phi \in \mathcal{E}^k(M);$$

compare [BD, 4.4]. We also denote $A(T) = T_G$.

LEMMA. (i) T_G is G -invariant whenever $T \in \mathfrak{N}_*$.

(ii) $A: \mathbf{F}_*(M) \cap \mathfrak{N}_* \rightarrow \mathbf{F}_*(M) \cap \mathfrak{N}_*$.

(iii) Let Ψ be a convex positive integrand of degree k such that $g^* \Psi = \Psi$ for $g \in G$. If $T \in \mathbf{M}_k(M)$, then

$$\int_{T_G} \Psi < \int_T \Psi.$$

PROOF. (i) and (ii) follow from the definition of A and the fact that $\partial \circ A = A \circ \partial$. (iii) follows from [F3, 2.1] and the observation that if $\Psi > \phi \in \mathcal{D}^k(M)$, then $\Psi > g^* \phi$ for $g \in G$ and thus

$$T_G(\phi) = \int_G T(g^* \phi) d\mu g < \int_T \Psi.$$

3.3. LEMMA. Suppose $T \in \mathbf{B}_n(M, L)$ is G -invariant. Then $T \wedge \xi = 0$ whenever $\xi \in \mathcal{X}_G(M)$ with $\text{spt } \xi \subset M_0 \sim L$.

PROOF. Choose $S \in \mathbf{F}_{n+1}(M)$ with $\text{spt}(\partial S - T) \subset L$. Then $S_G \in \mathbf{F}_{n+1}(M)$ and $\text{spt}(\partial S_G - T) \subset L$ since L is invariant. Suppose $\xi_G \in \mathcal{X}_G(M)$ is induced on M by the action of a one-parameter subgroup of G . Then $L_{\xi_G} S_G = 0$, hence 3.1 implies

that $(\partial S_G) \wedge \xi_G = 0$ and so $\text{spt}(T \wedge \xi_G) \subset L$. From this we conclude that $T \wedge \xi = 0$ because the set of vector fields ξ_G spans $\mathcal{X}_G(M_0)$.

3.4. REMARK. Simple examples in $\mathbf{R} \times \mathbf{S}^1$ show that if S does not exist, then the conclusion of Lemma 3.3 may not be true even if $\partial T = 0$.

3.5. LEMMA. Suppose $T \in \mathbf{F}_n(M)$ is G -invariant.

(i) If $\text{spt } T \cap M_0 = \emptyset$, then $T = 0$.

(ii) If $\mathbf{M}(T) < \infty$, then $\|T\|(M \sim M_0) = 0$.

PROOF. (ii) follows from (i) because $M \sim M_0$ is closed and $T \lfloor (M \sim M_0) \in \mathbf{F}_n(M)$ by [F1, 4.1.17].

Assuming $\text{spt } T \cap M_0 = \emptyset$ we use [BG, VI, 2.4, 2.5 and IV, 1.2] to infer that $\text{spt } T \subset M_1 \cup \cdots \cup M_\alpha$, where each M_i is a smooth proper submanifold of M and is the union of the set of all orbits corresponding to a fixed orbit type. Now lower semicontinuity of orbit type [BG, II, 5.5] implies that if M_i is the union of the set of all orbits of a fixed special exceptional orbit type, then M_i is a relatively open subset of $M \sim M_0$. We will show that $\text{spt } T \cap M_i = \emptyset$, hence infer using [BG, IV, 3.8 and 3.10] that $\mathcal{H}^n(\text{spt } T) = 0$, which implies by [F1, 4.1.20 and 2.10.6] that $T = 0$.

In order to show that $\text{spt } T \cap M_i = \emptyset$ it will suffice to show that $T \lfloor f = 0$ whenever $f \in \mathcal{D}^0(M)$ is G -invariant with $\text{spt } f \subset M_i \cup M_0$. We can also assume $\pi(\text{spt } f|_{M_i})$ to lie in an orientable open subset U of the manifold $\pi(M_i)$. Fixing f we infer from the second proposition on [F1, p. 373] that $T \lfloor f$ corresponds to $T_f \in \mathbf{F}_n(M_i)$. Consequently, $T \lfloor f = 0$ unless $\dim M_i = n$; assuming this to be the case we observe that for $\mathcal{H}^{n-m}$ almost all $z \in U$ the slice $T_f(z) = \langle T_f, \pi|_{M_i}, z \rangle \in \mathbf{F}_m(z)$ [F1, 4.3.1]. Moreover, $T_f(z)$ is G -invariant by [F1, 4.3.2] and we infer using Lemma 3.1 that $\partial T_f(z) = 0$, hence $T_f(z)$ represents a real m -dimensional homology class of z . But z is not orientable [BG, IV, 3.11], hence $T_f(z) = 0$ and we conclude using [F1, 4.3.2] that $T_f = 0$.

3.6. LEMMA. Suppose $T \in \mathbf{F}_n(M) \cap \mathbf{M}_n(M)$ and $T' \in \mathbf{F}_n(M)$ are such that

(i) $T - T' \in \mathbf{B}_n(M, L)$,

(ii) $g_\# T' = T'$ whenever $g \in G$,

(iii) $T' \wedge \xi = 0$ whenever $\xi \in \mathcal{X}_G(M)$ with $\text{spt } \xi \subset M_0 \sim L$, and

(iv) there exists $\xi_0 \in \mathcal{X}_G(M)$ with $\text{spt } \xi_0 \subset M_0 \sim L$ such that $T \wedge \xi_0 \neq 0$.

Then $T - T_G \in \mathbf{B}_n(M, L)$ and

$$\int_{T_G} \Psi \leq \int_T \Psi$$

whenever Ψ is a convex positive G -invariant integrand of degree n on M .

PROOF. We choose a G -invariant open set U with compact closure in $M_0 \sim L$ such that $\text{spt } \xi_0 \subset U$; denote $T_0 = T \lfloor U$. Referring to 2.5 we see that

$$\sup\{\|\Pi_{\Psi, x}\|: x \in U\} < \infty,$$

hence

$$\Pi T_0 = \|T_0\| \wedge \Pi_{\Psi} \vec{T}_0 \in \mathbf{M}_n(M),$$

and we infer using Lemma 3.2 that

$$\int_{(\Pi T_0)_G} \Psi \leq \int_{\Pi T_0} \Psi < \int_{T_0} \Psi.$$

Now the G -invariance and linearity of Π_Ψ imply that $(\Pi T_0)_G = \Pi(T_{0G})$. Thus our assertion will follow if we can show that $\Pi(T_{0G}) = T_{0G}$ because $T_G = T_{0G} + (T - T_0)_G$, hence

$$\int_{T_G} \Psi < \int_{T_0} \Psi + \int_{T - T_0} \Psi = \int_T \Psi.$$

Choose $S \in \mathbf{F}_{n+1}(M)$ with $\text{spt}[\partial S - (T - T')] \subset L$ and observe that

$$\text{spt}[\partial S_G - (T_G - T')] \subset L$$

since L is invariant, hence $\text{spt}[\partial(S - S_G) - (T - T_G)] \subset L$ and thus $T - T_G \in \mathbf{B}_n(M, L)$. Further, in view of Lemma 3.2 we can apply Lemma 3.3 to obtain

$$0 = (T_G - T') \wedge \xi = T_G \wedge \xi$$

whenever $\xi \in \mathcal{X}_G(M)$, $\text{spt } \xi \subset M_0 \sim L$, which implies that on $M_0 \sim L$, $\Pi_\Psi \vec{T}_G = \vec{T}_G$. Finally, since $\vec{T}_G|U = (T_{0G})^\rightarrow|U$, we conclude that

$$\Pi(T_{0G}) = T_{0G}.$$

4. Ψ -minimizing currents.

4.1. LEMMA. *Let U and Y be oriented Riemannian manifolds with Y connected and $\dim Y = m$. Suppose $T \in \mathbf{F}_{k+m}^{\text{loc}}(U \times Y) \cap \mathbf{M}_{k+m}^{\text{loc}}(U \times Y)$ is such that*

- (i) $\vec{T} \wedge \xi = 0$ whenever $\xi \in \mathcal{X}(U \times Y)$ is such that $\xi|_{\{z\} \times Y}$ is tangent to $\{z\} \times Y$ for $z \in U$, and
- (ii) $\partial T = 0$.

Then there exists $R \in \mathbf{F}_k^{\text{loc}}(U) \cap \mathbf{M}_k^{\text{loc}}(U)$ such that $T = R \times Y$. Furthermore, if $T \in \mathcal{R}_{k+m}^{\text{loc}}(U \times Y)$, then $R \in \mathcal{R}_k^{\text{loc}}(U)$.

PROOF. The existence of R is obtained in [BD, 3.5]. If p and q denote the projections of $U \times Y$ on U and Y , respectively, we infer from the definition of the slice $\langle R \times Y, q, y \rangle$ corresponding to $y \in Y$ [F1, 4.3.1] that $R = p_\# \langle R \times Y, q, y \rangle$. Thus by [F1, 4.3.6] R is rectifiable if T is rectifiable.

4.2. COROLLARY. *Suppose there exists $T \in \mathbf{F}_{k+m}(M_0) \cap \mathbf{M}_{k+m}(M_0)$ which is G -invariant and is such that $\|T\|(M_0 \sim \text{spt } \partial T) \neq 0$ and $T \wedge \xi = 0$ whenever $\xi \in \mathcal{X}_G(M)$ with $\text{spt } \xi \subset M_0$. Then the action of G preserves the orientation of G/H .*

PROOF. Let U be an open subset of the open set $M_0^* \sim \pi(\text{spt } \partial T)$ such that $T|U \neq 0$ and there exists a coordinate map $\phi_U: U \times G/H \rightarrow \pi^{-1}U$. Applying Lemma 4.1 we infer that

$$T|_{\mathcal{O}^{k+m}}(\pi^{-1}U) = \phi_{U\#}(R \times G/H).$$

Our assertion now follows from the invariance of T and the equivariance of ϕ_U .

4.3. LEMMA. Let Ψ be a convex positive G -invariant integrand of degree n on M . Assume $0 \neq T \in \mathbf{F}_n(M) \cap \mathbf{M}_n(M)$ is such that $\text{spt } T \subset K$ and the following hold:

- (i) $\int_T \Psi = \inf\{\int_{T+Q} \Psi: Q \in \mathbf{B}_n(M, L), \text{spt } Q \subset K\}$.
- (ii) $\|T\|(B) = 0$ where $B = M_0 \cap \text{spt } \partial T \sim L$.
- (iii) There exists $T' \in \mathbf{F}_n(M) \cap \mathbf{M}_n(M)$ with $T - T' \in \mathbf{B}_n(M, L)$ such that T' is G -invariant, $\|T'\|(M \sim B) \neq 0$, and $T' \wedge \xi = 0$ whenever $\xi \in \mathcal{X}_G(M)$ with $\text{spt } \xi \subset M_0 \sim L$.

Then the following are true:

- (1) $T|\mathcal{D}^n(M_0 \sim (B \cup L))$ is a local product.
- (2) $\|T\|([M \sim (M_0 \sim (B \cup L))]) = 0$.
- (3) T is G -invariant.

PROOF. Note that B is G -invariant because $\text{spt}(\partial T - \partial T') \subset L$ and $\text{spt } \partial T'$ is invariant. Now $T'L(M \sim L) \neq 0$ because if $\text{spt } T' \subset L$ then $T = 0$. Consequently, since $\|T'\|(M \sim M_0) = 0$ by Lemma 3.5, and $M_0 \cap \text{spt } \partial T' \subset B \cup L$, Corollary 4.2 implies that the action of G preserves the orientation of G/H .

Next we infer using Lemma 3.6 and (i) that

$$\int_{T_G} \Psi = \int_T \Psi \quad (*)$$

because K is invariant, and therefore $T \wedge \xi = 0$ whenever $\xi \in \mathcal{X}_G(M)$ with $\text{spt } \xi \subset M_0 \sim L$. Let U be an open subset of the open set $M_0^* \sim \pi(B \cup L)$ such that there exists an equivariant coordinate map $\phi_U: U \times G/H \rightarrow \pi^{-1}U$; assume also that U has compact closure in $M_0^* \sim \pi(B \cup L)$. It follows from Lemma 4.1 that $T|\mathcal{D}^n(\pi^{-1}U)$ is a product, hence (1) is clear. Moreover, it is also clear that $T\pi^{-1}U$ is invariant; choosing a locally finite open cover of $M_0^* \sim \pi(B \cup L)$ consisting of open sets such as U one uses a subordinate partition of unity to show that $T\pi(M_0 \sim (B \cup L))$ is invariant. Thus (3) will follow once (2) is verified.

For the proof of (2) we first observe that $T\pi L \in \mathbf{B}_n(M, L)$ by [F1, 4.1.17], hence because Ψ is positive and $\mathcal{I}^n(B) = 0$, we have

$$\|T_G\|(B \cup L) \leq \|T\|(B \cup L) = 0.$$

Thus since $T\pi(M_0 \sim (B \cup L)) = T_G\pi(M_0 \sim (B \cup L))$, we have

$$\int_{T\pi(M \sim M_0)} \Psi = \int_{T_G\pi(M \sim M_0)} \Psi = 0$$

by Lemma 3.5 and (*). Finally, positivity of Ψ implies that $T\pi(M \sim M_0) = 0$.

4.4. THEOREM. Let Ψ be a convex positive even G -invariant integrand of degree n on M and $T \in \mathcal{R}_n(M)$ be homologically Ψ minimizing in K with respect to (M, L) . Assume that conditions (ii) and (iii) of Lemma 4.3 are satisfied. Then the conclusions of Lemma 4.3 hold for T .

PROOF. With the help of [F1, 4.1.12, 4.1.15 and 4.1.29] we observe that

$$\mathbf{B}_{n,K}(M, L) = \mathbf{F}_{n,K}(M, L) \cap \mathbf{B}_n(M, L) = \mathbf{B}_n(M, L) \cap \{Q: \text{spt } Q \subset K\}$$

and

$$\mathcal{B}_{n,K}(M, L) = \mathcal{F}_{n,K}(M, L) \cap \mathcal{B}_n(M, L) = \mathcal{B}_n(M, L) \cap \{Q: \text{spt } Q \subset K\}.$$

Using this we apply [F3, 2.13 and 5.10] to infer that

$$\int_T \Psi = \inf \left\{ \int_{T+Q} \Psi: Q \in \mathbf{B}_n(M, L), \text{spt } Q \subset K \right\};$$

consequently, Lemma 4.3 applies.

4.5. REMARKS. (1) Suppose $M = \mathbf{R}^{n+1}$ and G is a group of linear transformations. In case ∂T is G -invariant and rectifiable we can take T' to be the cone over ∂T , $T' = \delta_0 \times \partial T$ [F1, p. 365], which is clearly invariant; moreover, $T - T' \in \mathbf{B}_n(\mathbf{R}^{n+1})$ because $\partial T' = \partial T$. If $\xi \in \mathcal{X}_G(M)$ we infer with the help of [FF, 8.16] that $\partial T \wedge \xi = 0$, from which it follows that $T' \wedge \xi = 0$.

On the other hand, invariance of ∂T does not in general imply existence of T' even if $\mathbf{H}_{n-1}(M; \mathbf{R}) = 0$. In 7.2 we will show that if $G = \mathbf{S}^1$ acts on $M = \mathbf{S}^3 \subset \mathbf{C}^2$ by means of complex scalar multiplication and $\partial T = c_1 + c_2$ where

$$c_1 = \mathbf{S}^3 \cap \mathbf{C} \times \{0\}, \quad c_2 = \mathbf{S}^3 \cap \{0\} \times \mathbf{C}$$

with their usual orientations when regarded as subsets of $\mathbf{C}$, then T cannot be $\mathbf{S}^1$ -invariant. Furthermore, since this action is the restriction to $\mathbf{S}^3$ of an action of $\mathbf{S}^1$ on $\mathbf{R}^4$, this example shows that our theorem does not hold in codimension 2 for the case where $M = \mathbf{R}^4$, $K = \mathbf{S}^3$ and $L = \emptyset$.

Finally, we observe that if G is a group of linear transformations of $M = \mathbf{R}^{n+1}$, $T \in \mathbf{F}_n(M)$ is G -invariant, and $\text{spt } \partial T \cap M_0$ is compact, then $\text{spt } \partial T \subset M_0$. (Compare [L2, Proposition 4.4].) Indeed, $\partial T = S_0 + S_1$ with $S_0, S_1 \in \mathbf{F}_{n-1}(M)$, $\text{spt } S_0 \subset M_0$, $\text{spt } S_1 \subset M \sim M_0$. S_1 is invariant hence so is $S'_1 = \delta_0 \times S_1 \in \mathbf{F}_n(M)$; moreover, $\text{spt } S'_1 \subset M \sim M_0$ and therefore Lemma 3.5 implies that $S'_1 = 0$. This is not, however, true in general. Simple examples can be found in $M = \mathbf{S}^3$ with $G = \mathbf{S}^1$ as in 7.2.

(2) If M is a manifold with boundary N with G acting smoothly on $M \cup N$, then $M \cup N \subset M'$ where M' is an orientable $(n+1)$ -dimensional manifold to which the action of G can be extended and is such that $M \cup N$ is a smooth deformation retract of M' . Thus

$$\mathbf{B}_n(M \cup N) = \mathbf{B}_n(M') \cap \{Q: \text{spt } Q \subset M \cup N\}$$

and one can apply the theorem with M replaced by M' and $K, L \subset M \cup N$ to obtain the analogous result for manifolds with boundary.

(3) With M, N, M' as in (2) we discuss the case where the dimension of the principal orbits (in M) is n . It is easy to see that the action of G preserves the orientation of M if and only if the action preserves orientation of the principal orbits; assume this to be the case. By [BG, IV, 3.1 and 3.11], $(M \cup N)_0^*$ is connected, hence each two principal orbits are homotopic and, when suitably oriented, represent the same homology class $\mathbf{P} \in \mathbf{H}_n(M \cup N; \mathbf{Z})$. In case there exists a nonprincipal orbit $z \in M \cup N/G$ it follows from the existence of linear tubes [BG, VI, 2.4] that there is an n -dimensional rectifiable cycle S_z supported on z which is homotopic to an oriented principal orbit $z' \in \mathbf{P}$. But unless z is a special exceptional orbit $\dim z < n$ [BG, IV, 3.8 and 3.10], hence $S_z = 0 = \mathbf{P}$. If z is special exceptional then z is not orientable [BG, IV, 3.11], hence again $S_z = 0 = \mathbf{P}$.

Conversely, if all orbits in M' are principal and $T \in \mathbf{B}_n(M \cup N)$ with $\text{spt } T \in M \cup N/G$, then one can use the lifting theory in [BD, §3] (see also 6.1) to show that $\text{spt } T \in B_0(M'/G)$, which is impossible. We therefore conclude that $\mathbf{P} \neq 0$ if and only if all orbits are principal. (See [BG, IV, §8] also.)

Suppose $M \cup N$ is compact with $\mathbf{P} \neq 0$. It follows from Theorem 4.4 and the remarks in (2) that $T \in \mathbf{P}$ has least n -dimensional area in $\mathbf{P}$ if and only if $\text{spt } T$ is an orbit with

$$V(\text{spt } T) = \inf V|(M \cup N)/G.$$

For example, applying this to the flat $(n+1)$ -dimensional torus $\mathbf{T}^{n+1}$ with $\mathbf{P}$ the homology class containing $\mathbf{T}^n \times \{x_0\}$, $x_0 \in \mathbf{S}^1$, we see that $T \in \mathbf{P}$ has least area if and only if

$$T = \mathbf{T}^n \times \{x\}, \quad x \in \mathbf{S}^1.$$

Finally, turning to the case where M is arbitrary and the action of G preserves orientation of the principal orbits, we assume V to have a local minimum at $z_0 \in M_0^*$. Choose a closed arc $I^* \subset M_0^*$ such that $V|I^*$ has a minimum at $z_0 \in \text{int } I^*$, and denote $I = \pi^{-1}I^*$. Let T_0 be a current obtained by orienting z_0 . Then $T_0 \in \mathbf{P} \in \mathbf{H}_n(I; \mathbf{Z})$, and applying the preceding discussion with $M \cup N = I$ we infer that T_0 is of least area in $\mathbf{P}$. It follows from [F1, p. 525] that z_0 is minimal and stable. (It is of interest here to recall that if z is a special exceptional orbit then z is minimal [HL, §3]; however, we do not know whether z is in general stable.)

Simple examples of the above can be found in surfaces of revolution in $\mathbf{R}^3$ obtained by rotating the graph $\{(x, f(x)): x \in (a, b)\}$ of a smooth positive function $f: (a, b) \rightarrow \mathbf{R}$ about the x -axis. The meridian circle corresponding to $x \in (a, b)$ is a geodesic if and only if $f'(x) = 0$, and is a stable geodesic if and only if f has a local minimum at x . In this case, $V(z) = 2\pi f(z)$ for $z \in M/\mathbf{S}^1 = (a, b)$.

On the other hand, consider the action of $\mathbf{S}^1$ on $\mathbf{S}^3$ mentioned in (1). The orbits of this action are all principal, are all geodesics, and are all unstable. However, V is constant, $V = 2\pi$. This, together with the example discussed in (1), illustrates the difficulties which are evidently inherent in the problem of extending our results to codimensions greater than one.

5. Regularity.

5.1. Let Ψ be a positive integrand of degree $m+1$ and class 3 on M_0 such that

- (i) Ψ is invariant under the action of G on $\bigwedge_{m+1} \mathbf{T}(M)$, and
- (ii) for each compact subset A of M_0 there exists $c_A > 0$ such that for each $x \in A$,

$$D^2\Psi_x(\alpha)(\beta, \beta) \geq c_A |\beta \wedge \alpha|^2 / |\alpha|^3$$

whenever $\alpha, \beta \in \mathcal{V}_{m+1, x}$ and $\alpha \neq 0$. Note that the area integrand satisfies this condition with $c_A = 1$.

LEMMA. Let $T \in \mathbf{I}_{m+1}(M_0)$ be homologically Ψ -minimizing with respect to M_0 , and suppose $g_*T = T$ for $g \in G$. Then $\text{spt } T \sim \text{spt } \partial T$ is an $(m+1)$ -dimensional submanifold of class 2 of M_0 .

PROOF. Assume $\text{spt } T \sim \text{spt } \partial T \neq \emptyset$. Let U be an open subset of the open set $M_0^* \sim \pi(\text{spt } \partial T)$ such that there exist an equivariant coordinate map $\phi_U: U \times G/H \rightarrow \pi^{-1}U$ and a coordinate map $\chi: U \rightarrow \mathbf{R}^{n+1-m}$ with $\chi(U) = \mathbf{R}^{n+1-m}$. Inasmuch as T is rectifiable and invariant, we infer using [FF, 8.16] that $T \wedge \xi = 0$ for $\xi \in \mathcal{X}_G(M)$, hence Corollary 4.2 implies that if $\mathbf{v}$ is a smooth unit m -vector field on $\pi^{-1}U$ which is tangent to the orbits, then $\mathbf{v}$ is invariant. Using $\mathbf{v}$ to define the integrand Ψ^* of degree 1 on U as in 2.5 we see that if A^* is a compact subset of U and $z \in A^*$ then

$$D^2\Psi_z^*(\alpha^*)(\beta^*, \beta^*) \geq c_{\pi^{-1}A^*} |\beta^* \wedge \alpha^*|^2 / |\alpha^*|^3$$

for $\alpha^*, \beta^* \in T_z(M_0^*)$, $\alpha^* \neq 0$. In view of [F1, 5.1.3 and 5.1.2] we can therefore apply [F1, 5.3.20] in U to conclude that if $R_0 \in \mathbf{I}_1(U)$ is absolutely Ψ^* -minimizing with respect to U , then $\text{spt } R_0 \sim \text{spt } \partial R_0$ is a 1-dimensional submanifold of class 2 of M_0^* .

Next apply Lemma 4.1 to obtain $R \in \mathcal{R}_1^{\text{loc}}(U)$ such that

$$T|_{\mathcal{O}^{m+1}(\pi^{-1}U)} = \phi_{U\#}(R \times G/H),$$

use [F1, 4.2.1, 4.3.4 and 4.3.6] to choose $r > 0$ such that

$$R_r = R \llcorner \chi^{-1}\{y: |y| < r\} \in \mathbf{I}_1(U),$$

and denote

$$T_r = \phi_{U\#}(R_r \times G/H) = T \llcorner (\chi \circ \pi)^{-1}\{y: |y| < r\}.$$

Referring to [F1, 4.1.28] we see that for $\|T\|$ almost all $x \in U$,

$$\vec{T}(x) = \lambda_x(\vec{R}(\pi x)) \wedge \mathbf{v}(x),$$

where λ_x is chosen as in 2.5. Applying the coarea formula [F1, 3.2.22] we conclude that

$$\pi_{\#}\|T_r\| = \|R_r\| \llcorner V$$

and use this to verify that $\int_{T_r} \Psi = \int_{R_r} \Psi^*$. Finally, consider $Q \in \mathcal{L}_1(U) = \mathcal{B}_1(U)$. Then

$$S = \phi_{U\#}(Q \times G/H) \in \mathcal{B}_{m+1}(\pi^{-1}U),$$

and reasoning as above with T_r replaced by $T_r + S$ we obtain

$$\int_{T_r+S} \Psi = \int_{R_r+Q} \Psi^*.$$

Consequently, R_r is absolutely Ψ^* -minimizing with respect to U and the remarks in the first paragraph imply that $\text{spt } R \cap \chi^{-1}\{y: |y| < r\}$ is smooth. We conclude that $\text{spt } R$, hence $(\text{spt } T) \cap (\pi^{-1}U)$, is smooth.

5.2. REMARK. The conclusion of the lemma also holds in case $m = n - 2$ and $T \in \mathbf{I}_n(M_0)$. To verify this one uses [SSA, II.7] in place of [F1, 5.3.20] in the proof of the lemma.

5.3. COROLLARY TO THEOREM 4.4. Assume $m \in \{n-1, n-2\}$ and Ψ is elliptic and of class 3 on M . Then

$$\text{spt } T \cap \text{int } K \cap M_0 \sim \text{spt } \partial T$$

is an n -dimensional G -invariant submanifold of class 2 of M .

PROOF. Using local coordinates in $W = \pi(K_0 \sim \text{spt } \partial T)$, $K_0 = \text{int } K \cap M_0$, and using [F1, 4.2.1, 4.3.4 and 4.3.6] as in the proof of Lemma 5.1 we cover W with open sets U such that

$$T_U = T \llcorner \pi^{-1}U \in \mathbf{I}_n(M), \quad \text{spt } T_U \subset K_0, \quad \text{spt } \partial T_U \subset \text{boundary } U.$$

Since T_U is homologically Ψ -minimizing with respect to K_0 and is invariant by Theorem 4.4, we can apply Lemma 5.1 or Remark 5.2 with M_0 replaced by K_0 to infer that $\text{spt } T \cap U$ is smooth.

5.4. REMARK. For integrands which are close to the area integrand one has much more information concerning the regularity of $\text{spt } T$. Recall that $x \in \text{spt } T \sim \text{spt } \partial T$ is called *singular* if there is no neighborhood U of x such that $U \cap \text{spt } T$ is a connected n -dimensional manifold of class 2.

It is a consequence of [SSA, II.8] that there exists a neighborhood $\mathcal{U}$ of the area integrand in the class 2 topology such that the following is true: If $\Psi \in \mathcal{U}$ is a positive elliptic integrand of degree n and class 3 in M and $T \in \mathcal{R}_n(M)$ is G -invariant and homologically Ψ -minimizing with respect to M , then no singular point of T lies on an orbit of dimension greater than $n-7$.

6. **Minimizing currents in M_0^* .** Assume that M_0^* is orientable (which follows in particular if $H_1(M; \mathbb{Z}_2) = 0$ [BG, IV, 4.4]); this, together with orientability of M_0 , implies that the standard fibre $Y = G/H$ and the bundle $\mathcal{N}_0$ are orientable. Also assume that the action of G on Y preserves orientation; in view of Corollary 4.2 this assumption will result in no essential loss of generality, while the first example on [BG, p. 189] shows that it does not imply orientability of M_0^* . Denote $K^* = \pi(K \cap M_0)$ and $L^* = \pi(L \cap M_0)$. Assume $\mathcal{I}^{n+1}(L) = 0$.

6.1. Orientability of $\mathcal{N}_0$ implies that the structure group $\mathcal{N}(H)/H$ can be reduced to the subgroup $\mathcal{K}$ of orientation preserving transformations of Y . From now on we will regard $\mathcal{K}$ as the structure group of $\mathcal{N}_0$; as remarked in 2.2, coordinate functions for $\mathcal{N}_0$, hence admissible maps of the fibre Y , are equivariant.

Assign an $\mathcal{K}$ -invariant metric to Y such that $\mathcal{I}^m(Y) = 1$, choose a unit orientation $\omega_0 \in \mathcal{D}^m(Y)$, and denote by $\vec{Y}$ the m -vector field on Y such that $\langle \vec{Y}, \omega_0 \rangle = 1$. There exists a unique smooth unit m -vector field $\mathbf{v}$ on M_0 such that

$$f_* \vec{Y} = (V \circ \pi) \mathbf{v} | f(Y)$$

whenever $f: Y \rightarrow M_0$ is admissible. Furthermore, $\mathbf{v}$ is G -invariant. Let $\Omega \in \mathcal{E}^m(M_0)$ be dual to $(V \circ \pi) \mathbf{v}$ with respect to the metric b . Then Ω is G -invariant, $|\Omega| = 1/V \circ \pi$, and $f^* \Omega = \omega_0$ whenever f is admissible. One uses Ω to show that the action of G preserves orientation of M .

The *projection operator* for $\mathfrak{N}_0$ is the continuous linear map

$$P_{\mathfrak{N}_0}: \mathfrak{D}_*(M_0) \rightarrow \mathfrak{D}_*(M_0^*)$$

of degree $-m$ such that for $T \in \mathfrak{D}_k(M_0)$,

$$P_{\mathfrak{N}_0}(T) = (-1)^{m(k-m)} \pi_*(T \lrcorner \Omega), \quad m \leq k,$$

$$P_{\mathfrak{N}_0}(T) = 0, \quad m > k.$$

The *lifting operator* for $\mathfrak{N}_0$ is the linear map

$$L_{\mathfrak{N}_0}: \mathbf{M}_*^{\text{loc}}(M_0^*) \rightarrow \mathbf{M}_*^{\text{loc}}(M_0)$$

of degree m characterized in [BD, 3.2]. $L_{\mathfrak{N}_0}(R)$ is locally equal to the image of $R \times Y$ under a bundle coordinate map. Finally,

$$P_{\mathfrak{N}_0} \circ L_{\mathfrak{N}_0}(R) = R$$

whenever $R \in \mathbf{M}_*^{\text{loc}}(M_0^*)$. We remark that although $L_{\mathfrak{N}_0}$ has a unique extension to a chain map defined on the chain complex spanned by $\mathbf{M}_*^{\text{loc}}(M_0)$ [BD, 3.3], such an extension does not exist for $P_{\mathfrak{N}_0}$ unless $d\Omega = 0$, which is true only if $\mathbf{H}^m(M_0; \mathbf{R}) \neq 0$.

6.2. LEMMA. Suppose $R_0 \in \mathbf{M}_k^{\text{loc}}(M_0^*)$ and $T_0 = L_{\mathfrak{N}_0}R_0$. Then

- (i) $T_0 \in \mathbf{M}_{k+m}^{\text{loc}}(M_0)$ and $\pi_* \|T_0\| = \|R_0\| \lrcorner V$,
- (ii) for $\|T\|$ almost all $x \in M_0$,

$$\vec{T}_0(x) = \bigwedge_k \lambda_x(\vec{R}_0(\pi x)) \wedge v(x)$$

whenever λ_x is a linear right inverse of $\pi_*|_{\mathbf{T}_x(M_0)}$, and

- (iii) $\int_{T_0} \Psi = \int_{R_0} \Psi^*$ whenever Ψ is a positive integrand of degree $k + m$ on M .

PROOF. (i) is [BD, 3.2 and 4.9] (for the proof of which it is not necessary to assume G connected). (ii) follows from [BD, 3.3(4)]. (iii) follows from (i), (ii) and the definition of Ψ^* in 2.5.

6.3. LEMMA. Let Ψ be a positive integrand of degree k on M .

- (i) To each $T_0 \in \mathfrak{R}_k^{\text{loc}}(M_0)$ with $\int_{T_0} \Psi < \infty$ and $\text{spt } T_0 \subset K$ there corresponds a unique $T \in \mathfrak{R}_k(M)$ such that

$$T|_{\mathfrak{D}^k(M_0)} = T_0 \quad \text{and} \quad \int_T \Psi = \int_{T_0} \Psi.$$

- (ii) Let $k = n$. Then $L_{\mathfrak{N}_0}$ induces a one-to-one correspondence, also denoted $L_{\mathfrak{N}_0}$, between

$$\mathfrak{R}^* = \mathfrak{R}_{n-m}^{\text{loc}}(M_0^*) \cap \left\{ R: \int_R \Psi^* < \infty, \text{spt } R \subset K^* \right\}$$

and

$$\mathfrak{R} = \mathfrak{R}_n(M) \cap \{ T: \text{spt } T \subset K, g_* T = T \text{ for } g \in G \}.$$

- (iii) Let $k = n$ and denote

$$\mathfrak{B}^* = \{ Q + \partial P: P \in \mathfrak{R}_{n-m+1}^{\text{loc}}(M_0^*), \|P\|(V) < \infty, Q \in \mathfrak{D}_{n-m}^{\text{loc}}(M_0^*), \text{spt } Q \subset L^* \}.$$

Then

$$L_{\mathfrak{N}_0}(\mathfrak{B}^* \cap \mathfrak{R}^*) = \mathfrak{B}_n(M, L) \cap \mathfrak{R}.$$

PROOF. Choose a neighborhood U of K and $\lambda > 0$ so that $\|\alpha\| \leq \lambda \Psi(\alpha)$ for $x \in U$ and $\alpha \in \bigwedge_k T_x(M)$. Then $M(T_0) \leq \lambda \int_{T_0} \Psi < \infty$ and so there is a unique $T \in \mathcal{M}_k(M)$ such that

$$T|_{\mathcal{D}^k(M_0)} = T_0 \quad \text{and} \quad \|T\|(M \sim M_0) = 0;$$

T is clearly rectifiable. Moreover,

$$\int_T \Psi - \int_{T_0} \Psi = \int_{M \sim M_0} \Psi(\vec{T}) d\|T\|,$$

whence follows (i).

In case $k = n$ we infer using Lemma 3.5 that if T_0 is also invariant then T_0 is the restriction to $\mathcal{D}^n(M_0)$ of a unique $T \in \mathcal{R}_n(M)$; T is clearly invariant. Furthermore, it follows from [FF, 8.16], [BD, 4.2], Lemma 6.2(iii) and the proof of the last assertion of Lemma 4.1 that $L_{\mathcal{R}_0}$ maps $\mathcal{R}^*$ univalently onto

$$\mathcal{R}_n^{\text{loc}}(M_0) \cap \left\{ T_0: \int_{T_0} \Psi < \infty, g_* T_0 = T_0 \text{ for } g \in G, \text{spt } T_0 \subset K \right\}.$$

(ii) is now clear.

In order to verify (iii) we first consider P, Q as in the definition of $\mathcal{B}^*$ with $Q + \partial P \in \mathcal{R}^*$. Denoting $T = L_{\mathcal{R}_0}(Q + \partial P) \in \mathcal{R}$ we infer using Lemma 6.2(i) that there exists $S \in \mathcal{R}_{n+1}(M)$ such that $S|_{\mathcal{D}^{n+1}(M_0)} = L_{\mathcal{R}_0}P$, hence

$$\text{spt}(\partial S - T) \subset L \cup (M \sim M_0).$$

Moreover, $\|S\|(M \sim M_0) = 0$ because $\mathcal{I}^{n+1}(M \sim M_0) = 0$, hence [BD, 4.2] implies that S is invariant. Consequently, Lemma 3.5 implies that $\text{spt}(\partial S - T) \subset L$.

On the other hand, suppose $\partial S + T \in \mathcal{R}$ with $S \in \mathcal{R}_{n+1}(M)$, $T \in \mathcal{F}_n(M)$, $\text{spt } T \subset L$. Using Lemma 3.1 and the fact that $\mathcal{I}^{n+1}(L \cup (M \sim M_0)) = 0$ we infer that S is invariant hence there exists $P \in \mathcal{R}_{n-m+1}^{\text{loc}}(M_0^*)$ such that $L_{\mathcal{R}_0}P = S|_{\mathcal{D}^{n+1}(M_0)}$; moreover, $\|P\|(V) < \infty$ by Lemma 6.2(i). Denoting $R = P_{\mathcal{R}_0}(\partial S + T) \in \mathcal{R}^*$ we conclude with the help of [BD, 3.3(8)] that

$$T|_{\mathcal{D}^n(M_0)} = L_{\mathcal{R}_0}(R - \partial P),$$

hence $\text{spt}(R - \partial P) \subset L^*$.

6.4. THEOREM. Let Ψ be a convex positive even G -invariant integrand of degree n on M . Fix $0 \neq R \in \mathcal{R}^*$ (in the notation of Lemma 6.3) and denote

$$\mu^* = \inf \left\{ \int_{R+Q} \Psi^*: Q \in \mathcal{B}^* \cap \mathcal{R}^* \right\}, \quad T = L_{\mathcal{R}_0}R \in \mathcal{R}_n(M).$$

Assume $\mathcal{I}^n(B) = 0$ where

$$B = M_0 \cap \text{spt } \partial T \sim L = \pi^{-1}(\text{spt } \partial R \sim L^*).$$

Then T is homologically Ψ -minimizing in K with respect to (M, L) if and only if $\int_R \Psi^* = \mu^*$.

PROOF. Suppose $\int_R \Psi^* = \mu^*$ and $T_1 \in \mathcal{R}_n(M)$ is homologically Ψ -minimizing in K with respect to (M, L) with $T - T_1 \in \mathcal{B}_n(M, L)$ (see 2.4). Then

$$M_0 \cap \text{spt } \partial T_1 \sim L \subset B,$$

and in view of the fact that $\|T\|((M \sim M_0) \cup B) = 0 = \|T_1\|(B)$ by Lemma 6.3(i) and [F1, 4.1.20 and 2.10.6] we infer from [BD, 4.2] that T satisfies the assumptions on T' in Lemma 4.3 with T replaced by T_1 . Consequently, Theorem 4.4 implies that T_1 is invariant, and referring to 6.1 and Lemma 6.3 we conclude that

$$R_1 = P_{\mathfrak{R}_0} T_1 \in \mathfrak{R}_{n-m}^{\text{loc}}(M_0^*), \quad \text{spt } R_1 \subset K^*, \quad R - R_1 \in \mathfrak{B}^* \cap \mathfrak{R}^*.$$

Thus by Lemma 6.2(iii),

$$\int_{R_1} \Psi^* \geq \int_R \Psi^* = \int_T \Psi \geq \int_{T_1} \Psi = \int_{R_1} \Psi^*.$$

Finally, we suppose T minimizes Ψ and use Lemma 6.3 to infer that whenever $Q \in \mathfrak{B}^* \cap \mathfrak{R}^*$,

$$\int_R \Psi^* = \int_T \Psi \leq \int_{T+L_{\mathfrak{R}_0} Q} \Psi = \int_{R+Q} \Psi^*.$$

6.5. REMARK. It follows from [F1, 2.10.25 and 2.10.45] that

$$\mathfrak{H}^n(B) = 0 \quad \text{if and only if } \mathfrak{H}^{n-m}(\pi B) = 0.$$

7. Examples.

7.1. An orthogonal action of S^1 on $\mathbf{R}^3$ can be represented as the action of a one-parameter subgroup G of $\text{SO}(3)$. The members of G have a common eigenvector v ; denote by Λ the linear subspace spanned by v . Then G is the group of rotations of $\mathbf{R}^3$ about Λ . Let c_1 and c_2 be circles centered on Λ lying in planes orthogonal to Λ and oriented in the same way. Let k_1 and k_2 be integers, $Q = k_1 c_1 + k_2 c_2$, and T be an absolutely area minimizing rectifiable current with $\partial T = Q$. Then by [F1, 5.4.15], $\text{spt } T \sim (c_1 \cup c_2)$ is a smooth 2-dimensional minimal submanifold of $\mathbf{R}^3$ which is a surface of revolution by Theorem 4.4. It is an elementary exercise in differential geometry to show that $\text{spt } T$ is a subset of the union of a catenoid and the discs spanned by c_1 and c_2 .

7.2. Let $S^3 = C^2 \cap \{(z, w): |z|^2 + |w|^2 = 1\}$ and $k_2 > k_1 > 0$ be relatively prime integers. We define an orthogonal action of S^1 on S^3 by means of the function which for $\alpha \in \mathbf{R}$ maps (z, w) to $(e^{ik_1 \alpha} z, e^{ik_2 \alpha} w)$, and denote the corresponding subgroup of $\text{SO}(4)$ by G_{k_1, k_2} . Each G_{k_1, k_2} represents a distinct action of S^1 on S^3 , and each closed one-parameter subgroup of $\text{SO}(4)$ is conjugate to some G_{k_1, k_2} .

Let c_1 and c_2 be oriented geodesic circles in S^3 which are invariant under the action of G_{k_1, k_2} , p and q be integers, $Q = pc_1 + qc_2$, and T be an absolutely area minimizing rectifiable current with $\partial T = Q$. In contrast with the preceding example the existence of inequivalent actions of S^1 on S^3 gives rise to many more possibilities for T ; in fact, there may exist no G_{k_1, k_2} -invariant T . The case where

$$c_1 = S^3 \cap C \times \{0\}, \quad c_2 = S^3 \cap \{0\} \times C$$

is particularly interesting because in this case Q is G_{k_1, k_2} -invariant for all choices of k_1, k_2 . We assume the orbits of G_{k_1, k_2} to have the orientation induced by the natural orientation of S^1 ; this means in particular that c_1 and c_2 have their usual orientations when regarded as subsets of C .

As we saw in §6, in order to understand the structure of an invariant T it is sufficient to study the solutions to a suitable one-dimensional variational problem in the orbit space $X_{k_1, k_2} = \mathbf{S}^3 / G_{k_1, k_2} = \pi_{k_1, k_2}(\mathbf{S}^3)$. The structures of these spaces are presented in detail in [HL, Chapters III and IV]; assuming $k_1 > k_2 > 0$ we summarize the discussion therein:

- (1) X_{k_1, k_2} is a smooth manifold which is diffeomorphic to $\mathbf{S}^2$.
- (2) For $k_1 = k_2 = 1$ all orbits are principal and the projection $\pi_{1,1}: \mathbf{S}^3 \rightarrow X_{1,1}$ is the Hopf map.
- (3) For $k_1 > k_2 > 1$ all orbits except c_1 and c_2 are principal and have trivial isotropy groups. c_1 and c_2 are exceptional orbits with isotropy groups $\mathbf{Z}_{k_1}$ and $\mathbf{Z}_{k_2}$, respectively. If $k_2 = 1$ then c_2 is a principal orbit.
- (4) Define $\psi: \mathbf{R} \times (0, \pi) \rightarrow \mathbf{S}^3$ by

$$\psi(\theta, \phi) = (\cos(\phi/2), e^{i\theta} \sin(\phi/2)).$$

Then $\pi_{k_1, k_2} \circ \psi$ is an immersion onto $X_{k_1, k_2} \sim \{c_1, c_2\}$.

- (5) With respect to the coordinates induced by $\pi_{k_1, k_2} \circ \psi$ the metric b_π of 2.2 is given by the formula

$$\frac{1}{4} \left[k_1^2 \sin^2 \phi (k_1^2 \cos^2(\phi/2) + k_2^2 \sin^2(\phi/2))^{-1} d\theta^2 + d\phi^2 \right].$$

Further, the volume function is

$$V(\theta, \phi) = 2\pi (k_1^2 \cos^2(\phi/2) + k_2^2 \sin^2(\phi/2))^{1/2}.$$

- (6) If Ψ is the two-dimensional area integrand on $\mathbf{S}^3$, then the associated integrand Ψ^* on $X_{k_1, k_2} \sim \{c_1, c_2\}$ is $\sqrt{\pi/2}$ times the length integrand with respect to the metric

$$\begin{aligned} b^*(\theta, \phi) &= (2/\pi)(V^2 b_\pi)(\theta, \phi) \\ &= k_1^2 \sin^2 \phi d\theta^2 + (k_1^2 \cos^2(\phi/2) + k_2^2 \sin^2(\phi/2)) d\phi^2. \end{aligned}$$

- (7) b^* extends to a metric of class 2 on X_{k_1, k_2} which is the metric of a surface of revolution on which c_1 and c_2 correspond to axis points and ϕ and θ respectively parametrize the longitudes and meridians. In case $k_1 = 1 = k_2$, b^* is the metric of the unit sphere $\mathbf{S}^2$ in $\mathbf{R}^3$.

(8) The normalizer $\mathcal{N}(G_{k_1, k_2})$ of G_{k_1, k_2} in $\mathbf{SO}(4)$ is the torus acting on $\mathbf{S}^3$ by means of the function which for $(u, v) \in \mathbf{R}^2$ maps (z, w) to $(e^{iu}z, e^{iv}w)$. The group $\mathcal{N}(G_{k_1, k_2})/G_{k_1, k_2}$ acts on X_{k_1, k_2} and preserves the coordinate ϕ , hence acts as the group of revolutions of X_{k_1, k_2} (about the axis through c_1 and c_2).

- (9) For each $a \in \mathbf{R}$ the longitude γ_a consisting of the closure of these points of $X_{k_1, k_2} \sim \{c_1, c_2\}$ with θ coordinate equal to a is (when properly parametrized) a geodesic on X_{k_1, k_2} with endpoints c_1, c_2 . $\gamma_a \cup \gamma_{\pi+a}$ is a closed geodesic whose inverse image $\tau_{k_1, k_2; a} = \pi_{k_1, k_2}^{-1}(\gamma_a \cup \gamma_{\pi+a})$ is a minimally immersed torus, and any two of these surfaces are congruent. In particular, $\tau_{k_1, k_2; 0}$ is the real algebraic variety

$$\mathbf{S}^3 \cap \{(z, w): \operatorname{Im} z^k \bar{w}^{k_1} = 0\}$$

discussed in [L1, §7]. $\tau_{1,1;a}$ is congruent to the Clifford torus

$$S^3 \cap \{(z, w) : |z| = |w|\}.$$

The immersion $\Phi: \mathbf{R}^2 \rightarrow S^3$ defined by

$$\Phi(\phi, \alpha) = (e^{ik_1\alpha} \cos(\phi/2), e^{i(k_2\alpha + a)} \sin(\phi/2))$$

maps $\mathbf{R}^2$ onto $\tau_{k_1, k_2; a}$. Moreover,

$$\sigma_{k_1, k_2; a} = \pi_{k_1, k_2}^{-1}(\gamma_a) \sim (c_1 \cup c_2)$$

is the image under Φ of $(0, \pi) \times [0, 2\pi)$, hence is an embedded cylinder. We orient $\sigma_{k_1, k_2; a}$ so that the current

$$\sigma_{k_1, k_2; a} = \Phi_{\#}((0, \pi) \times [0, 2\pi));$$

this implies that

$$\partial\sigma_{k_1, k_2; a} = k_2c_2 - k_1c_1.$$

Finally, note that $\sigma_{k_1, k_2; a}$ is G_{k_1, k_2} -invariant and that if $a_1, a_2 \in \mathbf{R}$ then there exists $F \in \mathbf{SO}(4)$ such that $F_{\#}\sigma_{k_1, k_2; a_1} = \sigma_{k_1, k_2; a_2}$.

THEOREM. *Let $T \in \mathcal{R}_2(S^3)$ be absolutely area minimizing with $\text{spt } \partial T = c_1 \cup c_2$, and k_1, k_2 be relatively prime positive integers. Then T is G_{k_1, k_2} -invariant if and only if there exists an integer r such that*

$$\partial T = r(k_2c_2 - k_1c_1).$$

If T is G_{k_1, k_2} -invariant, then there exist

$$\beta = \pm 1, \quad a_j \in \mathbf{R}, \quad 0 < \alpha_j \in \mathbf{Z}, \quad j = 1, \dots, \nu,$$

such that $r = \beta(\alpha_1 + \dots + \alpha_{\nu})$ and

$$T = \beta \sum_{j=1}^{\nu} \alpha_j \sigma_{k_1, k_2; a_j}.$$

PROOF. Assuming $\partial T = r(k_2c_2 - k_1c_1)$ we apply Theorem 4.4 with $T' = r\sigma_{k_1, k_2; a}$ and conclude that T is invariant.

In that which follows we always refer to the metric b^* on X_{k_1, k_2} . Setting $K = S^3$ we denote the lifting operator of Lemma 6.3(ii) by L_{k_1, k_2} , or simply L , where the form $\omega_0 \in \mathcal{D}^1(S^1)$ used in defining L (see 6.1) is positively oriented with respect to the usual orientation of S^1 . Observing that

$$\mathcal{R}^* = \{R | \mathcal{D}^1(X_{k_1, k_2} \sim \{c_1, c_2\}) : R \in \mathcal{R}_1(X_{k_1, k_2})\}$$

we see that L_{k_1, k_2} induces an isomorphism

$$L_{k_1, k_2}: \mathcal{R}_1(X_{k_1, k_2}) \rightarrow \mathcal{R}_2(S^3) \cap \{T' : T' \text{ is } G_{k_1, k_2}\text{-invariant}\}.$$

Furthermore, in this case the set $\mathcal{B}^*$ of Lemma 6.3(iii) (with $L = \emptyset$) is equal to $\mathcal{B}_1(X_{k_1, k_2})$. Finally, we observe that if γ_a is oriented so that $\partial\gamma_a = c_2 - c_1$ then the current $\sigma_{k_1, k_2; a} = L_{k_1, k_2}(\gamma_a)$. (See [BJ1, 3.5(6)].)

Suppose T is G_{k_1, k_2} -invariant. Then there exists $R \in \mathcal{R}_1(X_{k_1, k_2})$ such that $T = L(R)$; moreover, R minimizes length by Theorem 6.4. [F1, 5.3.20] implies that $\text{spt } R \sim \{c_1, c_2\}$ is smooth, hence there exist

$$a_j \in \mathbf{R} \quad \text{and} \quad 0 \neq \beta_j \in \mathbf{Z}, \quad j = 1, \dots, \nu,$$

such that

$$R = \beta_1 \gamma_{a_1} + \cdots + \beta_\nu \gamma_{a_\nu}.$$

Thus

$$T = \sum_{j=1}^{\nu} \beta_j \sigma_{k_1, k_2; a_j}$$

and

$$\partial T = \sum_{j=1}^{\nu} \beta_j (k_2 c_2 - k_1 c_1);$$

inasmuch as T minimizes area, the latter expression implies that all β_j have the same sign.

REMARKS. (1) It follows in particular from the theorem that although $pc_1 + qc_2 \in \mathcal{R}_1(\mathbf{S}^3)$ is invariant under the action of every G_{k_1, k_2} , for a given pair of nonzero integers p, q there may exist no $T \in \mathcal{R}_2(\mathbf{S}^3)$ with $\partial T = pc_1 + qc_2$ which is invariant under a given action.

(2) The classification of those area minimizing rectifiable currents T with $\partial T = rc_1$ can be carried out in a manner similar to the above through application of our theory to the group $G_{r,0}$ using the discussion of the orbit space $\mathbf{S}^3/G_{r,0}$ in [HL, Chapter III]. However, the structure of such currents also follows directly from [BJ2, 4.5]; in particular, the group action is irrelevant:

There exist oriented two-dimensional great hemispheres $\sigma_1, \dots, \sigma_\nu$ and

$$\beta = \pm 1, \quad 0 < \alpha_j \in \mathbf{Z}, \quad j = 1, \dots, \nu,$$

such that $\partial \sigma_j = c_1$, $r = \beta(\alpha_1 + \cdots + \alpha_\nu)$ and

$$T = \beta \sum_{j=1}^{\nu} \alpha_j \sigma_j.$$

(3) Finally, to complete the classification of those area minimizing rectifiable currents T with $\partial T = pc_1 + qc_2$, we observe that if $pq > 0$, then

$$\partial F_{\#} T = qc_2 - pc_1$$

where F is the isometry of $\mathbf{C}^2$ such that $F(z, w) = (\bar{z}, w)$. The structure of $F_{\#} T$ can now be inferred from the theorem.

7.3. Let $M = \mathbf{R}^\lambda \times \mathbf{R}^\lambda = \mathbf{R}^{2\lambda}$, $\lambda \geq 2$, and G be the subgroup of $\mathbf{O}(2\lambda)$ generated by $\mathbf{SO}(\lambda) \times \mathbf{SO}(\lambda) \cup \{\alpha\}$, where we define

$$\begin{aligned} \sigma(x) &= (x^1, -x^2, \dots, -x^\lambda) \in \mathbf{R}^\lambda \quad \text{for } x \in \mathbf{R}^\lambda, \\ \alpha(x, y) &= (y, \sigma(x)) \in \mathbf{R}^\lambda \times \mathbf{R}^\lambda \quad \text{for } (x, y) \in \mathbf{R}^\lambda \times \mathbf{R}^\lambda. \end{aligned}$$

We also denote by $\mathbf{SO}(\lambda - 1)'$ the isotropy subgroup at e_1 of the action of $\mathbf{SO}(\lambda)$ on $S^{\lambda-1}$. Note that each isotropy subgroup $G_{(x,y)}$ is conjugate to $G_{(|x|e_1, |y|e_1)}$. In view of the fact that α is in the normalizer of $\mathbf{SO}(\lambda) \times \mathbf{SO}(\lambda)$ it is not difficult to verify that for $r, s \in R$, $G_{(re_1, se_1)}$ is generated by

$$\begin{aligned}
& \text{SO}(\lambda - 1)' \times \text{SO}(\lambda - 1)' \cup \{\alpha^2\}, & \text{for } 0 \neq r \neq s \neq 0, \\
& \text{SO}(\lambda - 1)' \times \text{SO}(\lambda - 1)' \cup \{\alpha\}, & \text{for } r = s \neq 0, \\
& \text{SO}(\lambda - 1)' \times \text{SO}(\lambda) \cup \{\alpha^2\}, & \text{for } r \neq 0, s = 0, \\
& G, & \text{for } r = s = 0.
\end{aligned}$$

Consequently, the orbit $G(x, y)$ is principal for $0 \neq |x| \neq |y| \neq 0$, special exceptional for $|x| = |y| \neq 0$, and singular for $|x| |y| = 0$ (but in verifying this one must keep in mind that $\alpha^2 \in \text{SO}(\lambda - 1)' \times \text{SO}(\lambda - 1)'$ if and only if λ is odd).

Inasmuch as G is not connected, the principal orbits are not connected. Furthermore, the union of the set of nonprincipal orbits contains

$$S = \mathbf{R}^\lambda \times \mathbf{R}^\lambda \cap \{(x, y): |x| = |y|\},$$

which contains the support of a nonzero invariant rectifiable current of dimension $2\lambda - 1$, hence the conclusion of the fundamental Lemma 3.5 is not true. Note also that G does not lie in $\text{SO}(2\lambda)$, hence the proposition in [L2] asserting existence of invariant solutions to the least area problem does not apply.

Assign an orientation to $S^{\lambda-1}$, denote

$$Q = S^{\lambda-1} \times S^{\lambda-1} \in \mathcal{R}_{2\lambda-2}(M),$$

and suppose $T \in \mathcal{R}_{2\lambda-1}(M)$ is absolutely area minimizing with $\partial T = Q$. It is shown in [F1, 5.4.17] that if T were G -invariant, then $\text{spt } T$ would be equal to $S \cap \{(x, y): |x| \leq 1\}$, a contradiction to the regularity theorem [F1, 5.4.15] in case $\lambda = 2$ or $\lambda = 3$.
