REPORT OF ACTIONS BY THE DIRECTORS

A. Pursuant to action taken at the 109th Annual Meeting of the Association, the Directors met on October 14, 1978, in New York, City, New York, at the Waldorf-Astoria Hotel. The Directors voted:

4. To delay further action with respect to the Committee on Basic Research Tools pending a report from John F. Oates, chairman of the committee.
5. To approve the following resolution forwarded from a meeting of journal editors held during the 110th Annual Meeting of the Association: "That multiple membership on editorial boards is in principle undesirable (though there are legitimate exceptions)."
6. To instruct the Secretary to compile a list of the editorial boards and editorial policies of classical journals in the U. S. A. and Canada.
7. To hold the 1982 Annual Meeting of the Association in Philadelphia and the 1983 Annual Meeting of the Association in Cincinnati (provided adequate hotel facilities are available).
8. To continue the practice of introducing the list on the ballot of nominees for election to the Board of Directors with the statement VOTE FOR THREE and of counting all legitimate ballots even if three votes were not cast.

9. To establish a standing Committee on Awards for Excellence in the Teaching of the Classics as outlined in the report from the *ad hoc* Committee on Awards for Excellence in the Teaching of the Classics and to review the work of this committee after three years.
10. To instruct the Secretary to include an advisory referendum with the annual ballot with the following three choices: strongly favor changing the 1980 meeting from New Orleans; strongly oppose changing the 1980 meeting from New Orleans; neither of the above expresses my opinion.
11. To table until December 27 the recommendation from the Committee on the Status of Women and of Minority Groups that an advisory referendum be conducted on the question: whether the Association should hold all its meetings thereafter (i.e., 1980) in those states that have ratified the ERA, assuming that the ERA is still an issue at the time of the arrangements.
12. To authorize the President to appoint a committee to review recruitment practices and the Placement Service.
13. To accept (with modifications noted above) the following reports: Report of the Secretary, Report of the Treasurer, Report of the Finance Committee, Report of the Program Committee, Report of the Nominating Committee, Report of the Editorial Board, Report of the Committee on Awards for Excellence in the Teaching of the Classics, Report of the Representatives to the American Classical League, Report of the Committee on Smaller Classics Departments, Report of the Delegate to the American Council of Learned Societies, Report of the Representative to the *Thesaurus Linguae Latinae*, Report of the Advisory Committee to the *Thesaurus Linguae Graecae*, Report of the Advisory Committee on Computer Activities, Informal Report from the *Catalogus Translationum et Commentariorum*, September Draft of the Committee on the Status of Women and of Minority Groups, Report of the Committee on the Classical Tradition in North America, Report of the Delegate to the Fédération Internationale des Associations d'Etudes Classiques, Report of the Representative to the Governing Board of the *Thesaurus Linguae Graecae*.

4. To accept the following reports: Report of the Secretary, Report of the Treasurer, Report of the Finance Committee (with approval of the proposed budget for 1979), Report of the Program Committee, and Report of the chairman of the Committee on Basic Research Tools.
 5. To instruct the Secretary to discuss the Association's interest in sponsoring a proposal to NEH for the support of intensive seminars for Community College faculty during the summer of 1980 with Karl Galinsky and Mark Morford.
 6. To approve the appointment of George Kennedy and William S. Anderson as a committee to prepare a position paper with respect to the President's Commission on Foreign Languages and International Studies.
 7. To approve a resolution of congratulations to our sister societies in Great Britain on the occasion of their centenary and 75th anniversary and to authorize George Kennedy to present this resolution at their joint meeting in April 1979.
 8. To authorize the Treasurer to contribute \$200.00 to the support of the National Coordinating Office for the Promotion of Latin in the Schools.
 9. To approve the following resolution: The extraordinary Placement Meeting scheduled for January 19, 1979, in New York City was an experiment undertaken for the benefit of student candidates for teaching positions; however, unforeseen disadvantages have arisen and the Board of Directors therefore urges that the scheduling of extraordinary Placement Meetings apart from the Annual Meeting not be undertaken again within the present context of the Association's conduct of its affairs.
 10. To leave tabled the recommendation from the Committee on the Status of Women and of Minority Groups that an advisory referendum be conducted on the question whether the Association should hold all its meetings after 1980 in those states that have ratified the ERA, assuming that the ERA is still an issue at the time of the arrangements. (Future sites approved by the Directors are: San Francisco in 1981, Philadelphia in 1982, and Cincinnati in 1983 pending the availability of adequate facilities.)
 11. To authorize George Kennedy to appoint a Search Committee to identify candidates for the position of Secretary and Treasurer and to examine the structure of the office of Secretary.
 12. To encourage the President to write letters to Oxford University Press, Cambridge University Press, St. Martin's Press, and to other publishers where necessary, expressing the Association's deep concern over the unavailability of text books.
- C. Pursuant to the 110th Annual Meeting of the Association the Directors met on December 30, 1978, in Vancouver, British Columbia, at the Hotel Vancouver. The Directors voted:
1. To establish a Search Committee for the Offices of Secretary and Treasurer and to approve the President's appointment to this committee of Bernard Knox, Mervin Dilts, Eva Keuls, James Settle (Chairman), plus one other. (Susan Treggiari has accepted appointment.)
 2. To appoint Karl Galinsky, Mark Morford, and Harold Evjen to the Committee on Classics in the Community College, to designate Harry Avery as consultant to the committee, and to authorize the committee to prepare a proposal for summer seminars for Community College faculty for submission to NEH by April 1, 1979.
 3. To accept, with modification, a text prepared by Gilbert Lawall as the position paper of the Association with respect to the President's Commission on Foreign Languages and

International Studies, to appoint William S. Anderson, Karl Galinsky, Gilbert Lawall, and George Kennedy to represent the Association at regional meetings of the Commission scheduled in San Francisco, Houston, Boston, and Raleigh, to advertise these regional meetings in the NEWSLETTER, and to urge members who wish to participate to contact the regional representatives and to write to the Washington office of the Commission.

4. To meet on October 13, 1979, in New York City at a location to be announced.

ANNUAL BUSINESS MEETING

The forty-second Annual Business Meeting of the American Philological Association, Incorporated, for the transaction of business, being the one hundred and tenth since the organization of the unincorporated Association, was held in the Vancouver Island Room of the Hotel Vancouver, British Columbia, Canada, on Saturday, December 30, 1978, at 11:40 a. m. President Copley was in the chair and announced that New Orleans would be the site of the 1980 Annual Meeting and stated that the Board of Directors, while recognizing the legitimacy of the request not to meet in New Orleans and the stress which this action may cause, decided that the possible legal and financial implications of removing the meeting from New Orleans plus the results of the referendum required confirmation of the earlier commitment to the Fairmont Hotel in New Orleans. The Report of the Secretary was read, including the names of members whose death had been reported during the past year. Lloyd Daley and Zeph Stewart read memorials in honor of Walton Brooks McDaniel and William Chase Greene, both former presidents of the Association. The Report of the Treasurer was read and discussed briefly. First Vice President George Kennedy announced the resignation of the Secretary and the formation of a committee to seek a successor. Ronald Stroud presented the report from the Committee on Resolutions, which was accepted by vigorous acclamation. President Copley called for new business. Helen North, Chairman of the Nominating Committee, asked members to suggest names of qualified candidates to the Committee. There being no further new business, the Secretary reported the election of officers, directors, and members of committees as follows:

INSTRUCTIONS FOR THE PREPARATION OF COPY

In general, model your copy on recent issues of *TAPA*. The best general treatment of problems of style remains *The MLA Style Sheet*, reprinted from *PMLA* 66.3 (April, 1951) 3–27. Excellent rules for articles on classical subjects will be found in *AJA* 74 (1970) 1–8, which also includes a helpful list of abbreviations of journals and standard reference works.

Attention is called to the following points:

1. TYPE IN DOUBLE OR TRIPLE SPACE AND LEAVE AMPLE MARGINS. No article exceeding *forty* typewritten pages (notes included) will be considered for publication in the *Transactions*. For a speedier decision concerning suitability for publication, send two copies of your typescript.

2. On a separate page type your name, university affiliation and the title of your article. Repeat the title on the first page of the article itself and make every effort to conceal your identity from the Association's referees.

3. Where possible, include in the first or last paragraph a brief statement summarizing the main points of the article.

4. Assemble footnotes on separate sheets at the end of the article, typed in double space with triple space between notes.

5. Avoid large numbers of very short footnotes. In citing passages from ancient authors, put the references in the text, within parentheses.

6. For subsequent references to a work already cited, use the formula, "Jones (above, note 6) 49." If many references to the same work have to be made, list the titles of all such works in an early bibliographical note with their respective abbreviations.

7. Use cross references sparingly. When they occur, use the formula "see above, page 000," or "see below, pages 000–000," and supply the editor with an exact key, giving the page and line numbers of your manuscript to which the cross reference refers.

8. Long quotations in any language should be set off in separate paragraphs, indented and typed in double space like all the rest.

9. Use moderation in quoting Greek. Make the Greek forms look like the type used in recent volumes of *Transactions*. Be careful of spacing within and between Greek words. Allow ample space in your typescript for the Greek to be inserted. Verify accents. Be careful to write accents and breathings directly above the letters to which they belong.

10. Transliterate Greek words as follows, at least in all work dealing with literature:

(a) Personal names and place names should be Latinized according to the best Roman practice: *Thucydides*, *Museum*, *Samos*, etc.

(b) Other words, except those whose Latinized forms are familiar in English, should be transliterated directly from the Greek, distinguishing original *omega* and *eta* as *ô* and *ê* respectively: *Nikê*, *koinônia*, *phyteuma*, etc.

11. Use Arabic (not Roman) numerals wherever possible.

12. Italicize (single underline) titles of books and periodicals, names of classical works, and single foreign words, but not quotations in foreign languages.

13. Use quotation marks, not italics, for the titles of articles in periodicals or encyclopedias and of chapters in books.

14. Do not italicize the common abbreviations: cf., e.g., etc., f., i.e., s.v., viz., vol. Do not use l., n., or v. as abbreviations, since confusion may result. Use p. and pp. only when indispensable. Avoid excessive use of ff. and f. for page and line references.

15. Indicate columns or sections of columns in standard texts by letters in small capitals (two underlines) placed immediately after the page number: Arist. *Pol.* 1252A1–22.

16. Give place and date of publication (within parentheses) of all books except very well-known handbooks.

17. Use standard abbreviations for the title of periodicals, collections, and handbooks; but do not abbreviate titles consisting of a single word. Base abbreviated references to ancient works upon their Latin titles, not English or Greek. For standard titles, see *LSJ*, *TLL*, or *OCD*; but abbreviations for both titles and authors' names must often be expanded, in order to insure ease of comprehension. Capitalize the first letter of titles.

18. Verify all quotations and references against the original source. Record the verifications on a carbon copy of the article, and hold this copy until the article appears in print.

19. Clarity and avoidance of ambiguity are the first desideratum, consistency within the article the second, strict conformity to any external standard a poor third.
