

LOCAL PARTIAL DIFFERENTIAL ALGEBRA

1. **Introduction.** An algebraic theory for the solution of initial value problems for systems of algebraic differential equations has been given in [3]. In the present paper, we extend the theory to systems of partial differential equations.

The concept of a partial differential ring with n derivations has been defined by J. F. Ritt [2]. For our present purpose we have to supplement this definition by a homomorphism into a partial differential ring with $n - 1$ differentiations, which corresponds to the surface on which the initial values are given. Thus, the formal setting within which we shall carry out our investigation is as follows: A localized partial differential ring (l.p.d.r.) is a system $\Omega = (R, R_0, H)$ such that:

R is an integral domain and a partial differential ring with n derivations $D_1, \dots, D_n$, $n \geq 2$;

R_0 is an integral domain and (partial, for $n \geq 2$, ordinary, for $n = 2$) differential ring with $n - 1$ derivations, $\Delta_1, \dots, \Delta_{n-1}$; $H(a)$ is a homomorphic mapping of R into R_0 , $H(1) = 1$;

there exists a matrix of elements of R , $\hat{A} = (a_{ik})$, $i = 1, \dots, n - 1$, $k = 1, \dots, n$, such that $(H(a_{ik}))$ is of rank $n - 1$ and

$$(1.1) \quad H\left(\sum_{k=1}^n a_{ik} D_k a\right) = \Delta_i H(a), \quad i = 1, \dots, n - 1, \text{ for all } a \in R.$$

An l.p.d.r. will be called normal if $a_{ik} = \delta_{ik}$, i.e.,

$$H(D_i a) = \Delta_i H(a), \quad i = 1, \dots, n - 1.$$

2. **Equivalent systems of derivations.** Let $G = (g_{ik})$, $i = 1, \dots, r$, $k = 1, \dots, n$, be a rectangular matrix whose elements belong to R , where $r \geq 1$. We say that G is *normal* with respect to R if

$$(2.1) \quad \sum_{k=1}^n (g_{jk} D_k g_{il} - g_{ik} D_k g_{jl}) = 0 \quad \text{for every } i, j = 1, \dots, r, \quad l = 1, \dots, n.$$

Let $E = (e_{ik})$ be a matrix of order $n \times n$ over R . We define n new derivations on R by

$$(2.2) \quad \hat{D}_i = \sum_{k=1}^n e_{ik} D_k.$$

The system $\langle \hat{D}_i \rangle$ is called equivalent to the system $\langle D_i \rangle$ if

- (2.3) (i) E possesses an inverse over R ,
 (ii) For every extension $\tilde{R}$ of R , $\tilde{R}$ with the derivations $\hat{D}_1, \dots, \hat{D}_n$, is a partial differential ring.

By the definition of a partial differential ring, condition (ii) will be satisfied if and only if the $\hat{D}_i$ commute on the elements of $\tilde{R}$.

2.4. THEOREM. *The system $\langle \hat{D}_i \rangle$ is equivalent to the system $\langle D_i \rangle$ if and only if the matrix E has an inverse and is normal.*

Proof. We have

$$\begin{aligned} \hat{D}_j \hat{D}_i &= \sum_{k=1}^n e_{jk} D_k \left(\sum_{l=1}^n e_{il} D_l \right) = \sum_{k=1}^n \sum_{l=1}^n e_{jk} e_{il} D_k D_l + \sum_{l=1}^n \left(\sum_{k=1}^n e_{jk} D_k e_{il} \right) D_l, \\ \hat{D}_i \hat{D}_j &= \sum_{k=1}^n \sum_{l=1}^n e_{ik} e_{jl} D_k D_l + \sum_{l=1}^n \left(\sum_{k=1}^n e_{ik} D_k e_{jl} \right) D_l; \end{aligned}$$

hence

$$(2.5) \quad \hat{D}_j \hat{D}_i - \hat{D}_i \hat{D}_j = \sum_{l=1}^n \sum_{k=1}^n (e_{jk} D_k e_{il} - e_{ik} D_k e_{jl}) D_l.$$

If E is normal, the right hand side vanishes. Thus $\hat{D}_j \hat{D}_i - \hat{D}_i \hat{D}_j$ is the zero operator for every i and j .

Conversely, if E is not normal, then there exist i_0, j_0, l_0 such that

$$\sum_{k=1}^n (e_{j_0 k} D_k e_{i_0 l_0} - e_{i_0 k} D_k e_{j_0 l_0}) \neq 0.$$

Let $\tilde{R}$ be an extension of R containing an element a which satisfies $D_i a = 0$ for $i \neq l_0$ and $D_{l_0} a \neq 0$. (Standard methods of partial differential algebra ensure the existence of such extensions.) Then

$$(\hat{D}_{j_0} \hat{D}_{i_0} - \hat{D}_{i_0} \hat{D}_{j_0})a = \sum_{k=1}^n (e_{j_0 k} D_k e_{i_0 l_0} - e_{i_0 k} D_k e_{j_0 l_0}) D_{l_0} a \neq 0$$

and the derivations do not commute on $\tilde{R}$.

Let the system $\langle \hat{D}_i \rangle$ be equivalent to $\langle D_i \rangle$, then R with the derivations $\langle \hat{D}_i \rangle$ forms a partial differential ring which will be denoted by $\hat{R}$.

2.6. THEOREM. *If $\langle D_i \rangle$ is a system equivalent to $\langle \hat{D}_i \rangle$ and $\langle \tilde{D}_i \rangle$ is a system equivalent to $\langle \hat{D}_i \rangle$ (with respect to $\hat{R}$), then $\langle \tilde{D}_i \rangle$ is equivalent to $\langle D_i \rangle$.*

Proof. Let E be the matrix transforming $\langle D_i \rangle$ to $\langle \hat{D}_i \rangle$ and let F be the matrix transforming $\langle \hat{D}_i \rangle$ to $\langle \tilde{D}_i \rangle$; E and F possess inverses, hence FE , which trans-

forms $\langle D_i \rangle$ to $\langle \tilde{D}_i \rangle$, possesses an inverse. If $\tilde{R}$ is an extension of R , then $\tilde{R}$ regarded as a partial differential ring with the derivations $\langle \tilde{D}_i \rangle$ is an extension of $\hat{R}$. It follows that the derivations $\langle \tilde{D}_i \rangle$ commute on $\tilde{R}$. This proves the theorem.

2.7. THEOREM. *If $\langle \hat{D}_i \rangle$ is equivalent to $\langle D_i \rangle$ then $\langle D_i \rangle$ is equivalent to $\langle \hat{D}_i \rangle$.*

Proof. Let $E = (e_{ij})$ be the matrix transforming $\langle D_i \rangle$ to $\langle \hat{D}_i \rangle$. By Theorem 2.5, E is normal and has an inverse. Let $F = (f_{ij})$ be the inverse matrix to E . F transforms $\langle \hat{D}_i \rangle$ to $\langle D_i \rangle$. We shall show that F is normal with respect to $\hat{R}$.

Since E is normal it follows that $\hat{D}_j e_{il} = \hat{D}_i e_{jl}$ for every $1 \leq i, j, l \leq n$. Let $1 \leq r, s, t \leq n$ be fixed, then

$$(2.8) \quad \sum_{i=1}^n \sum_{j=1}^n \sum_{l=1}^n f_{ri} f_{sj} f_{lt} \hat{D}_j e_{il} = \sum_{i=1}^n \sum_{j=1}^n \sum_{l=1}^n f_{ri} f_{sj} f_{lt} \hat{D}_i e_{jl}.$$

Note that

$$\sum_{i=1}^n f_{ri} \hat{D}_j e_{il} + \sum_{i=1}^n e_{il} \hat{D}_j f_{ri} = \hat{D}_j \sum_{i=1}^n f_{ri} e_{il} = \hat{D}_j \delta_{rl} = 0.$$

Thus,

$$\sum_{i=1}^n f_{ri} \hat{D}_j e_{il} = - \sum_{i=1}^n e_{il} \hat{D}_j f_{ri}.$$

Transforming the left hand side of (2.8) we get

$$\begin{aligned} \sum_{i,j,k=1}^n f_{ri} f_{sj} f_{lt} \hat{D}_j e_{il} &= \sum_{j=1}^n f_{sj} \sum_{l=1}^n f_{lt} \sum_{i=1}^n f_{ri} \hat{D}_j e_{il} = - \sum_{j=1}^n f_{sj} \sum_{l=1}^n f_{lt} \sum_{i=1}^n e_{il} \hat{D}_j f_{ri} \\ &= - \sum_{j=1}^n f_{sj} \sum_{i=1}^n \hat{D}_j f_{ri} \delta_{it} = - \sum_{j=1}^n f_{sj} \hat{D}_j f_{rt}. \end{aligned}$$

In the same manner, the right hand side equals $-\sum_{j=1}^n f_{rj} \hat{D}_j f_{st}$. Hence $\sum_{j=1}^n f_{sj} \hat{D}_j f_{rt} = \sum_{j=1}^n f_{rj} \hat{D}_j f_{st}$, proving that F is normal with respect to $\hat{R}$. This shows that the system $\langle D_i \rangle$ is equivalent to $\langle \hat{D}_i \rangle$.

3. **Normalization.** Let $\Omega = (R, R_0, H)$ and $\Omega' = (R', R'_0, H')$ be two l.p.d.r. Ω' is called an extension of Ω if R' and R'_0 are extensions of R and R_0 , respectively, $H'(a) = H(a)$ for every $a \in R$, and if condition (1.1) is valid in Ω for the same matrix $\hat{A}$.

In this section it will be shown that if the matrix A is normal, then Ω can be extended to an l.p.d.r. $\Omega^* = (R^*, R_0^*, H^*)$ which is capable of normalization in the following sense: There exists in R^* a system of derivations $\bar{D}_1, \dots, \bar{D}_n$, equivalent to $D_1, \dots, D_n$, such that if $\bar{R}^*$ is the partial differential ring consisting of the ring R^* with the derivations $\bar{D}_1, \dots, \bar{D}_n$, then $\bar{\Omega}^* = (\bar{R}^*, R^*, H^*)$ is a normal l.p.d.r. We prove two lemmas which will be useful later:

3.1. LEMMA. Let R be a ring generated by a set of elements A in the sense that every element of R can be expressed as a rational combination of elements of A . Let D_1 and D_2 be two derivations on R whose range is in some extension of R , commuting on the elements of A .

Then D_1 and D_2 commute on R .

Proof. If D_1 and D_2 commute on a and b , then they commute on $a \pm b$, ab and on a^{-1} (if it exists in R). Therefore they commute on every rational combination of elements of A , which belong to R .

3.2. LEMMA. Let R be a partial differential ring with n derivations $D_1, \dots, D_n$, and let R be generated by the set A in the sense of Lemma 3.1. Let R_0 be a partial differential ring with $n-1$ derivations $\Delta_1, \dots, \Delta_{n-1}$. Let H be a homomorphism of R into R_0 , and let condition (1.1) be satisfied by all elements a of A . Then condition (1.1) is satisfied by all the elements of R .

Proof. It is easily seen that if condition (1.1) is satisfied by a and b , then it is satisfied by $a \pm b$, ab and a^{-1} (if a has an inverse in R). Therefore condition (1.1) is satisfied by all elements of R .

3.3. THEOREM. Let R be an integral domain and a partial differential ring with the derivations $D_1, \dots, D_n$. Let $\hat{A} = (a_{ik})$, $i = 1, \dots, n-1$, $k = 1, \dots, n$, be a matrix normal over R of rank $n-1$. Then there exist elements $a_{n1}, \dots, a_{nn}$ in some differential extension R^* of R , such that the matrix $A = (a_{ik})$, $i = 1, \dots, n$, $k = 1, \dots, n$, is normal and has an inverse in R^* .

Proof. Let $\langle x_{ij} \rangle$, $i = 1, \dots, n$, $j = 1, 2, \dots$, be an infinite set of elements transcendental over R . Let M be the matrix

$$\begin{bmatrix} a_{11}, \dots, a_{1n} \\ \vdots \\ a_{n-1\ 1}, \dots, a_{n-1\ n} \\ x_{11}, \dots, x_{n1} \end{bmatrix}$$

over $R[x_{11}, \dots, x_{n1}]$. Let $d = |M|$, then $d \neq 0$, and since $R[x_{11}, \dots, x_{n1}]$ is an integral domain, d^{-1} can be adjoined to it.

Let (R_i) be an increased sequence of rings defined in the following manner: $R_0 = R$, $R_1 = R[x_{11}, \dots, x_{n1}][d^{-1}]$, and for $i > 1$, $R_i = R_{i-1}[x_{1i}, \dots, x_{ni}]$.

We introduce a new derivation from R_0 into R_1 :

$$(3.4) \quad \delta(a) = \sum_{u=1}^n x_{u1} D_u a, \quad a \in R,$$

and we define the derivations $D_1, \dots, D_n$ on the elements $x_{11}, \dots, x_{n1}$ by requiring that for every fixed l , $l = 1, \dots, n$, the following system of n linear equations will be satisfied:

$$(3.5) \quad \sum_{k=1}^n a_{ik} D_k x_{l1} = \delta a_{il}, \quad i = 1, \dots, n-1,$$

$$\sum_{k=1}^n x_{k1} D_k x_{l1} = x_{l2}.$$

The matrix of the system is M , and since $|M|^{-1} \in R_1$ the system possesses a unique solution in R_2 . Using this solution we extend the definition of the derivations $D_1, \dots, D_n$ on R_1 , with range in R_2 . δ is extended to a derivation of R_1 into R_2 by Definition (3.4).

Suppose that the derivations $D_1, \dots, D_n$ have been extended to R_{t-1} ($t \geq 1$) so that every D_i transforms R_k into R_{k+1} ($k = 0, \dots, t-1$). δ can now be defined on R_{t-1} by Definition (3.4). δ^t is then an operator transforming R into R_t .

We define the derivations $D_1, \dots, D_n$ on $x_{1t}, \dots, x_{nt}$ so that the following system of linear equations is satisfied:

$$(3.6) \quad \sum_{k=1}^n a_{ik} D_k x_{lt} = \delta^t a_{il}, \quad i = 1, \dots, n-1,$$

$$\sum_{k=1}^n x_{k1} D_k x_{lt} = x_{l,t+1}.$$

For every fixed l , this is a system of n equations for $D_k x_{lt}$, with coefficients in R_{t+1} . The matrix of the system is M ; therefore, there exists a unique solution for the system in R_{t+1} . Accordingly, the definition of $D_1, \dots, D_n$ and δ can be extended to R_t , and their range will be in R_{t+1} .

Let $R^* = \bigcup_{i=0}^{\infty} R_i$. Having extended $D_1, \dots, D_n$ to R^* by induction, we are going to show that the derivations commute on R^* .

By Lemma 3.1, it is sufficient to show that the derivations commute on the x_{ik} , and this will be proved by induction. Suppose that the derivations commute on every x_{ik} for $k < t$ ($t \geq 1$). Then by Lemma 3.1, they commute on R_{t-1} . We shall prove that they commute on $x_{1t}, \dots, x_{nt}$.

We first prove that

$$(3.7) \quad \sum_{k=1}^n a_{jk} D_k \delta^t a_{il} = \sum_{k=1}^n a_{ik} D_k \delta^t a_{jl}, \quad i, j = 1, \dots, n-1, \quad l = 1, \dots, n.$$

Indeed

$$\begin{aligned} \sum_{k=1}^n a_{jk} D_k \delta^t a_{il} &= \sum_{k=1}^n a_{jk} D_k \sum_{u=1}^n x_{u1} D_u \delta^{t-1} a_{il} \\ &= \sum_{k=1}^n \sum_{u=1}^n a_{jk} (D_k x_{u1}) D_u \delta^{t-1} a_{il} + \sum_{k=1}^n \sum_{u=1}^n a_{jk} x_{u1} D_k D_u \delta^{t-1} a_{il} \\ &= \sum_{u=1}^n (\delta a_j)^{t-1} a_{il} + \sum_{k=1}^n a_{jk} \delta D_k \delta^{t-1} a_{il} = \delta \left(\sum_{k=1}^n a_{jk} D_k \delta^{t-1} a_{il} \right) \end{aligned}$$

($\delta^{t-1} a_{il} \in R_{t-1}$ and so the derivations commute on it).

Continuing in this way we get

$$\sum_{k=1}^n a_{jk} D_k \delta^t a_{il} = \delta^t \sum_{k=1}^n a_{jk} D_k a_{il},$$

and similarly

$$\sum_{k=1}^n a_{ik} D_k \delta^t a_{jl} = \delta^t \sum_{k=1}^n a_{ik} D_k a_{jl}.$$

The right hand sides are equal since $\hat{A}$ is normal. This proves (3.7).

Using equations (3.6) we get

$$\begin{aligned} \sum_{k=1}^n a_{jk} D_k \delta^t a_{il} &= \sum_{k=1}^n a_{jk} D_k \sum_{u=1}^n a_{iu} D_u x_{it} \\ &= \sum_{k=1}^n \sum_{u=1}^n a_{jk} (D_k a_{iu}) D_u x_{it} + \sum_{k=1}^n \sum_{u=1}^n a_{jk} a_{iu} D_k D_u x_{it}. \end{aligned}$$

The right hand side of (3.7) yields a similar expression. Hence

$$\begin{aligned} \sum_{k=1}^n \sum_{u=1}^n a_{jk} (D_k a_{iu}) D_u x_{it} + \sum_{k=1}^n \sum_{u=1}^n a_{jk} a_{iu} D_k D_u x_{it} \\ = \sum_{k=1}^n \sum_{u=1}^n a_{ik} (D_k a_{ju}) D_u x_{it} + \sum_{k=1}^n \sum_{u=1}^n a_{ik} a_{ju} D_k D_u x_{it}. \end{aligned}$$

The first sum on the right hand side is equal to the first sum on the left hand side since $\hat{A}$ is normal. Therefore

$$(3.8) \quad \sum_{u=1}^n \sum_{k=1}^n a_{ik} a_{ju} (D_k D_u - D_u D_k) x_{it} = 0, \quad i, j = 1, \dots, n-1, \quad l = 1, \dots, n.$$

Now let us calculate the following expressions:

$$\begin{aligned} \sum_{u=1}^n a_{ju} D_u \sum_{k=1}^n x_{k1} D_k x_{it} &= \sum_{u=1}^n a_{ju} D_u x_{it+1} = \delta^{t+1} a_{jl}, \\ \sum_{u=1}^n x_{u1} D_u \sum_{k=1}^n a_{jk} D_k x_{it} &= \sum_{u=1}^n x_{u1} D_u \delta^t a_{jl} = \delta^{t+1} a_{jl}. \end{aligned}$$

Thus the left hand sides are equal, and by expanding them we get

$$\begin{aligned} \sum_{u=1}^n \sum_{k=1}^n a_{ju} (D_u x_{k1}) D_k x_{it} + \sum_{u=1}^n \sum_{k=1}^n a_{ju} x_{k1} D_u D_k x_{it} \\ = \sum_{u=1}^n \sum_{k=1}^n x_{u1} (D_u a_{jk}) D_k x_{it} + \sum_{u=1}^n \sum_{k=1}^n x_{u1} a_{jk} D_u D_k x_{it}. \end{aligned}$$

The first term on the right hand side is equal to the first term on the left hand side since both are equal to $\sum_{k=1}^n \delta (a_{jk}) D_k x_{it}$. Thus

$$(3.9) \quad \sum_{u=1}^n \sum_{k=1}^n x_{k1} a_{ju} (D_k D_u - D_u D_k) x_{lt} = 0, \quad j = 1, \dots, n-1, \quad l = 1, \dots, n.$$

For a fixed l , let B be the $n \times n$ matrix whose (k, u) element is $(D_k D_u - D_u D_k) x_{lt}$. Then equalities (3.8) and (3.9) state that $MBM^* = 0$ (M^* is the transposed matrix). Since M is regular, $B = 0$. This proves that the derivations commute on $x_{1t}, \dots, x_{nt}$.

Thus R^* is a differential extension of R . Putting $a_{nk} = x_{k1}$, $k = 1, \dots, n$, the matrix $A = (a_{ik})$, $1 \leq i, k \leq n$, is equal to the matrix M and thus has an inverse in R^* . Moreover, A is normal. Conditions (2.1) are satisfied for $1 \leq i, j \leq n-1$ because $\hat{A}$ is normal, and for $i = n, j \leq n-1$ and $j = n, i \leq n-1$ because

$$\sum_{k=1}^n a_{jk} D_k x_{11} = \delta a_{j1} = \sum_{k=1}^n x_{k1} D_k a_{j1}.$$

This completes the proof of Theorem 3.3.

We now state and prove the fundamental theorem.

3.10. THEOREM. *Let $\Omega = (R, R_0, H)$ be an l.p.d.r. such that its transforming matrix $\hat{A}$ is normal. Then there exists an extension $\Omega^* = (R^*, R_0^*, H^*)$ for Ω such that Ω^* can be normalized.*

Proof. R and the matrix $\hat{A}$ satisfy the conditions of Theorem 3.3. We define R^* as in the proof of that theorem, using the same notation. Let (v_{ij}) , $i = 1, \dots, n$, $j = 1, 2, \dots$, be a set of elements transcendental over R_0 . Let

$$d_0 = \begin{vmatrix} H(a_{11}) \cdots H(a_{1n}) \\ \cdot \\ \cdot \\ \cdot \\ H(a_{n-1\ 1}) \cdots H(a_{n-1\ n}) \\ v_{11} \dots v_{n1} \end{vmatrix}.$$

Then d_0 belongs to $R_0[v_{ij}]$. The matrix $H(\hat{A})$ is of rank $n-1$, thus $d_0 \neq 0$, and since $R_0[v_{ij}]$ is an integral domain, we can adjoin d_0^{-1} to it.

We define $R_0^* = R_0[v_{ij}](d_0^{-1})$.

Let H^* be a homomorphism of R^* into R_0^* defined in the following way: $H^*(a) = H(a)$ for $a \in R$, $H^*(x_{ij}) = v_{ij}$ for $i = 1, \dots, n$, $j = 1, 2, \dots$. This defines H^* on $R[x_{ij}]$. Moreover, we have $H^*(d) = d_0$. Accordingly, H^* can be defined on d $H^*(d^{-1}) = d_0^{-1}$, and thus H^* can be extended to a homomorphism of R^* into R_0^* .

We extend $\Delta_1, \dots, \Delta_{n-1}$ to derivations on R_0^* by defining

$$(3.11) \quad \Delta_t v_{lt} = H^*(\delta^t a_{lt}), \quad i = 1, \dots, n-1, \quad l = 1, \dots, n, \quad t = 1, 2, \dots.$$

We are going to prove that (1.1) is satisfied for every $a \in R^*$. Since (1.1) is satisfied by every $a \in R$, it is sufficient to show that it is valid for every x_{lt} (Lemma

3.2). Indeed, $H^*(\sum_{k=1}^n a_{ik} D_k x_{it}) = H^*(\delta^t a_{it}) = \Delta_i v_{it} = \Delta_i(H^*(x_{it}))$. Finally we shall show that the derivations $\Delta_1, \dots, \Delta_{n-1}$ commute on R_0^* . By Lemma 3.1, it is sufficient to prove that they commute on every v_{it} :

$$\Delta_i \Delta_j v_{it} = \Delta_j H^*(\delta^t a_{it}) = H^*\left(\sum_{k=1}^n a_{jk} D_k \delta^t a_{it}\right),$$

$$\Delta_i \Delta_j v_{it} = H^*\left(\sum_{k=1}^n a_{ik} D_k \delta^t a_{jt}\right).$$

The right hand sides are equal (by (3.7)); hence $(\Delta_i \Delta_j - \Delta_j \Delta_i) v_{it} = 0$. Thus R_0^* is a differential extension of R_0 and therefore $\Omega^* = (R^*, R_0^*, H^*)$ is an extension of Ω . The matrix A as defined in the proof of 3.3 is normal and possesses an inverse in R^* ; hence the system of derivations

$$(3.12) \quad \bar{D}_i = \sum_{j=1}^n a_{ij} D_j, \quad i = 1, \dots, n,$$

is equivalent to the system $D_1, \dots, D_n$. If we define $\bar{R}^*$ as the ring R^* with the derivations $\bar{D}_1, \dots, \bar{D}_n$, then $(\bar{R}^*, R_0^*, H^*)$ is a normal l.p.d.r., since

$$H^*(\bar{D}_i(a)) = H^*\left(\sum_{j=1}^n a_{ij} D_j a\right) = \Delta_i H^*(a) \text{ for every } a \in \bar{R}^*.$$

This proves Theorem (3.10).

The vector $(a_{n1}, \dots, a_{nn})$ is called a *transversal vector*, the derivations $\bar{D}_1, \dots, \bar{D}_{n-1}$ will be called inner derivations, and $\bar{D}_n$ a transversal derivation.

From now on we shall treat only localized partial differential rings which admit normalization.

4. Polynomial extensions. The ring of differential polynomials in m variables $u_1, \dots, u_m$ over a partial differential ring was defined in [2] and will be denoted by $R\{u_1, \dots, u_m\}$.

Let $\hat{D}_1, \dots, \hat{D}_n$ be a system of derivations equivalent to $D_1, \dots, D_n$ over R and let $\hat{R}$ be the differential ring consisting of the ring R with the derivations $\hat{D}_1, \dots, \hat{D}_n$. Then we can construct the two polynomial extensions,

$$R\{u_1, \dots, u_m\} = R[D^{(\alpha_1, \dots, \alpha_n)} u_i] \quad i = 1, \dots, n,$$

$$\hat{R}\{y_1, \dots, y_m\} = \hat{R}[\hat{D}^{(\alpha_1, \dots, \alpha_n)} y_i] \quad \alpha_j = 0, 1, \dots,$$

$D^{(\alpha_1, \dots, \alpha_n)}$ being the operator $D_1^{\alpha_1} \dots D_n^{\alpha_n}$, and similarly $\hat{D}^{(\alpha_1, \dots, \alpha_n)}$. Each of these rings is a partial differential ring with each of the two systems of derivations. This follows from the definition of equivalence between systems, taking into account Theorem 2.7.

We prove

4.1. THEOREM. $R\{u_1, \dots, u_m\}$ and $\hat{R}\{y_1, \dots, y_m\}$ are differentially isomorphic with regard to each of the two systems of derivations.

Proof. We define

$$\begin{aligned}\phi: R\{u_1, \dots, u_m\} &\longrightarrow \hat{R}\{y_1, \dots, y_m\}, \\ \psi: \hat{R}\{y_1, \dots, y_m\} &\longrightarrow R\{u_1, \dots, u_m\},\end{aligned}$$

in the following way: $\phi(a) = \psi(a) = a$ for the elements of R (which are also the elements of $\hat{R}$) and

$$\begin{aligned}\phi(D^{(\alpha_1, \dots, \alpha_n)} u_i) &= D^{(\alpha_1, \dots, \alpha_n)} y_i, \\ \psi(\hat{D}^{(\alpha_1, \dots, \alpha_n)} y_i) &= \hat{D}^{(\alpha_1, \dots, \alpha_n)} u_i.\end{aligned}$$

With these definitions ϕ can be extended to a homomorphism of $R\{u_1, \dots, u_m\}$ into $\hat{R}\{y_1, \dots, y_m\}$, and ψ can be extended to a homomorphism in the other direction.

We shall show that ϕ commutes with the derivations $D_1, \dots, D_n$. For $a \in R$, $\phi(D_j a) = D_j(a) = D_j \phi(a)$, and

$$\begin{aligned}\phi(D_j D^{(\alpha_1, \dots, \alpha_n)} u_i) &= \phi(D^{(\alpha_1, \dots, \alpha_j+1, \dots, \alpha_n)} u_i) = D^{(\alpha_1, \dots, \alpha_j+1, \dots, \alpha_n)} y_i \\ &= D_j(\phi D^{(\alpha_1, \dots, \alpha_n)} u_i).\end{aligned}$$

Moreover, if ϕ and D_j commute on p and q , it is easy to see that they commute on $p + q$ and $p \cdot q$. Therefore they commute on every element of $R\{u_1, \dots, u_m\}$. ϕ also commutes with $\hat{D}_1, \dots, \hat{D}_n$ since

$$\phi \hat{D}_i = \sum_{j=1}^n \phi(b_{ij}) \phi D_j = \sum_{j=1}^n b_{ij} D_j \phi = \hat{D}_i \phi.$$

In the same way it can be shown that ψ commutes with the $\langle D_i \rangle$ and the $\langle \hat{D}_i \rangle$. $\psi \phi$ is the identity on $R\{u_1, \dots, u_m\}$, because $\psi \phi(a) = a$ for $a \in R$ and $\psi \phi(D^{(\alpha_1, \dots, \alpha_n)} u_i) = D^{(\alpha_1, \dots, \alpha_n)} (\psi \phi u_i) = D^{(\alpha_1, \dots, \alpha_n)} u_i$. Similarly $\phi \psi$ is the identity on $\hat{R}\{y_1, \dots, y_m\}$. Therefore ϕ is a one-to-one correspondence "on". This completes the proof.

We are now in a position to define the polynomial extension of an l.p.d.r. Ω . We first introduce the polynomial extension for a particular normalization $\bar{\Omega} = (\bar{R}, R_0, H)$ of Ω :

$$\begin{aligned}\bar{\Omega}' = \bar{\Omega} \{y, z\} &= (\bar{R}', R_0', \bar{H}'), \quad \text{where } \bar{R}' = \bar{R}\{y_1, \dots, y_m\}, \quad \bar{R}'_0 = R_0\{z_{ik}\}, \\ & \quad i = 1, \dots, m, \quad k = 0, 1, 2, \dots,\end{aligned}$$

and $\bar{H}'$ is the homomorphism defined by $\bar{H}'(a) = H(a)$ for $a \in R$ and

$$\bar{H}'(D^{(\alpha_1, \dots, \alpha_n)} y_i) = \Delta^{(\alpha_1, \dots, \alpha_n-1)} z_{i\alpha}.$$

It is easy to see that $\bar{\Omega}'$ is a normal l.p.d.r. extending $\bar{\Omega}$.

The polynomial ring of Ω is now defined by $\Omega' = \Omega\{u, z\} = (R', R'_0, H')$, where $R' = R\{u_1, \dots, u_m\}$, R'_0 is the same as before, and $H' = \bar{H}'\phi$, ϕ being the differential isomorphism from $R\{u_1, \dots, u_m\}$ to $\bar{R}\{y_1, \dots, y_m\}$ as defined in the proof of Theorem 4.1. Ω' is an extension of Ω since $R' \supseteq R$, $R'_0 \supseteq R_0$, $H'(a) = H(a)$, for the elements of R , and for every $p \in R'$,

$$H'\left(\sum_{k=1}^n a_{ik} D_k p\right) = \bar{H}'\phi(\bar{D}_i p) = \bar{H}'\bar{D}_i \phi(p) = \Delta_i \bar{H}'\phi(p) = \Delta_i H'(p).$$

This shows that condition (1.1) is satisfied.

5. S-ideals. Let R be a partial differential ring with unit element and let S be a nonempty multiplicative subset of R which does not include 0.

Given any set $K \subseteq R$, we define K_S as the set of all $b \in R$ such that $ab \in K$ for some $a \in S$. An ideal J in R will be called an S -ideal if $J_S \subseteq J$. A perfect (prime) ideal which is an S -ideal is called S -perfect (prime).

We have as in [3, §3]:

5.1. If J is an ideal, then J_S is an S -ideal which includes J .

5.2. If J is a perfect ideal, then J_S is S -perfect.

Next we have

5.3. A prime ideal $J \neq R$ is an S -ideal if and only if $J \cap S$ is empty.

Indeed if $a = a \cdot 1 \in J \cap S$, then $1 \in J$, $J = R$ (this is true for all S -ideals). Conversely, if $J \cap S$ is empty, then $ab \in J$, $a \in S$ implies $a \notin J$, $b \in J$, and so J is an S -ideal.

5.4. THEOREM. Every S -perfect ideal J is the intersection of S -prime ideals which are minimal over J (as prime ideals).

Proof. It is known that every perfect ideal J is the intersection of prime ideals. (See [2], where the theorem is proved for ordinary differential rings. The proof is similar for partial differential rings.) A familiar argument then shows that we may restrict the set of prime ideals to those prime ideals which are minimal over J . We are going to show that in case J is S -perfect, these prime ideals are also S -ideals.

Indeed, let J' be a prime-ideal which is minimal over J . If $J = R$, then $J' = J$ is an S -ideal, trivially. Suppose $J \neq R$, so that $J' \neq R$, and let $T = R - J'$. T is multiplicative since J' is prime. Let T' be the set of all products ab where $a \in S$, $b \in T$, and let $T_1 = T' \cup T$. Then T_1 is the multiplicative set which is generated by S and T . $T_1 \cap J = (T' \cap J) \cup (T \cap J)$ is empty for $T \cap J$ is empty by the definition of T , and $c \in T' \cap J$, $c = ab$, $a \in S$, $b \in T$ implies $b \in J$, which is impossible. By a familiar argument, there exists a prime ideal J^* which includes J and excludes T_1 . But then $J' \supseteq J^*$ and so $J' = J^*$ since J' is minimal over J . We conclude that $J' \cap S \subseteq J' \cap T_1$ is empty. Hence J' is S -ideal, by 5.3.

Alternatively, we may prove 5.4 by the methods of [3, §3], without the bracketed qualification *as prime ideals*. This yields a slightly weaker result.

6. Theory of bi-ideals. Let $\Omega = (R, R_0, H)$ be any given l.p.d.r. and let S be a multiplicative subset of R , $0 \notin S$. A bi-ideal is defined similarly as in [3, §4]. Thus, (J, J_0) is a bi-ideal if J is an S -perfect ideal in R and J_0 is a *perfect* ideal in R_0 such that $H(J) \subseteq J_0$. We introduce a partial ordering in the set of bi-ideals as in [3] using the same notation.

Let $K \subseteq R$, $K_0 \subseteq R_0$. Then the bi-ideal α which is generated by K and K_0 is given by

$$(6.1) \quad \alpha = (\{K\}_S, \{H(\{K\}_S) \cup K_0\}).$$

Prime and maximal bi-ideals are defined as in [3]. We have the theorem

6.2. *Every proper bi-ideal α is included in a maximal proper bi-ideal.*

Next we prove

6.3. **THEOREM.** *Let T_0 be a nonempty multiplicative subset of R_0 and let the bi-ideal $\alpha = (J, J_0)$ be maximal with respect to the exclusion of T_0 from J_0 . Then α is prime.*

Proof. Since J_0 excludes T_0 there exists a prime ideal J'_0 in R_0 such that $J'_0 \supseteq J_0$ and $J'_0 \cap T_0 = \emptyset$. Let $T = H^{-1}(R_0 - J'_0)$, then T is multiplicative. Indeed, if $H(t_1) \in R_0 - J'_0$, $H(t_2) \in R_0 - J'_0$, then $H(t_1 t_2) = H(t_1)H(t_2) \in R_0 - J_0$ since J'_0 is prime. J excludes T for if $a \in J$, then $H(a) \in J_0 \subseteq J'_0$, and so $a \notin T$.

Let J' be any prime ideal which excludes T and is minimal over J . (Such J' exists by standard ideal theory.) Since J is S -perfect it follows from the proof of 5.4 above that J' is S -prime. $H(J')$ excludes $R_0 - J'_0$ since J' excludes T . Hence $H(J') \subseteq J'_0$ and $\alpha' = (J', J'_0)$ is a prime bi-ideal. But $\alpha < \alpha'$ and J'_0 excludes T_0 . Hence, $\alpha' = \alpha$ in view of the maximal property of α .

For $T_0 = 1$ we obtain from 6.3 as a special case:

6.4. *Every maximal proper bi-ideal is prime.*

Combining 6.2 and 6.4 we obtain:

6.5. *Every proper bi-ideal is included in a prime (proper) bi-ideal.*

The closure $\bar{\alpha}$ of a bi-ideal α is defined as in [3]. Theorem 4.5 and 4.6 of that paper are valid in our present theory, and for the same reasons.

7. Polynomial bi-ideals. Let $\Omega = (R, R_0, H)$ be any l.p.d.r. Throughout this section, we shall suppose that R_0 is a field. If this is not the case from the outset we can clearly achieve it by passing to the field of quotients.

Let $\Omega' = \Omega\{u, z\} = (R', R'_0, H')$ be the polynomial extension of Ω which is obtained by the adjunction of the m differential indeterminates $u_1, \dots, u_m$, and let

$S = R - \langle 0 \rangle$. Let R^* be the field of quotients of R , and let R' and R^{**} be the differential rings $R\{u\}$ and $R^*\{u\}$, respectively. Then the relation between the ideals of R' and of R^{**} is described by the following theorem:

7.1. THEOREM. *J is an S -ideal in R' if and only if it is of the form $J = J^* \cap R'$ where J^* is an ideal in R^* . J is perfect (prime) if and only if J^* is perfect (prime). The correspondence $J^* \rightarrow J$ is one-to-one.*

Proof. Let J^* be any ideal in R^* and let $J = J^* \cap R'$. We see without difficulty that J is an ideal and that if J^* is differential (or perfect, or prime), then J is differential (or perfect, or prime). Now let $ab \in J$ where $a \in S$ and $b \in R'$. Then $ab \in J^*$, $a^{-1} \in R^*$ and so $b = a^{-1}(ab) \in J^*$, $b \in J^* \cap R' = J$. This shows that J is an S -ideal.

Conversely, let J be an S -ideal in R' and let J^* be the set of all products $a^{-1}b$ where $a \in R - \langle 0 \rangle = S$ and $b \in J$. It will be seen that J^* is an ideal in R^* . Moreover, if $a^{-1}b \in R'$, then $a(a^{-1}b) \in J$ and so $a^{-1}b \in J$, $J \supseteq J^* \cap R'$. Since $J \subseteq J^*$, we conclude that $J = J^* \cap R'$. The correspondence between the ideals J , J^* established in this way is one-to-one for if J_1^*, J_2^* determine the same J , let $c \in J_1^*$, $c = a^{-1}b$, where $a \in S$, $b \in R'$. Then $b \in J_1^*$ and so $b \in J_1^* \cap R' = J_2^* \cap R' \subseteq J_2^*$. Hence $c = a^{-1}b \in J_2^*$, $J_1^* \subseteq J_2^*$, and similarly $J_2^* \subseteq J_1^*$, so we have $J_2^* = J_1^*$. Also, whenever J is differential (perfect, prime) J^* is differential (perfect, prime). This completes the proof of 7.1.

7.2. THEOREM. *If R^{**} satisfies the finite ascending chain condition for perfect ideals, then R' satisfies the finite ascending chain condition for S -perfect ideals.*

Proof. Let $J_1 \subseteq J_2 \subseteq J_3 \subseteq \dots$ be an ascending chain of S -perfect ideals in R' and let $J_1^* \subseteq J_2^* \subseteq J_3^* \subseteq \dots$ be the chain of the corresponding perfect ideals in R^* . Then for some $N \geq 1$, $J_N^* = J_{N+1}^* = \dots$ and hence $J_N = J_{N+1} = \dots$.

As a corollary to 7.2 we have

7.3. If R is a Ritt algebra then R' satisfies the finite ascending chain condition for S -perfect ideals.

Let $\tilde{\Omega} = (\tilde{R}, \tilde{R}_0, \tilde{H})$ be any l.p.d.r. which is an extension of Ω and let $\tilde{R}^m$ be the m -dimensional vector space over $\tilde{R}$. A vector $\eta = (\eta_1, \dots, \eta_m)$ in $\tilde{R}^m$ is said to satisfy the polynomial $p\{u\} = p\{u_1, \dots, u_m\} \in R'$ if $p\{\eta_1, \dots, \eta_m\} = 0$. η is said to satisfy $q\{z_{10}, \dots, z_{m0}, z_{11}, \dots, z_{m1}, \dots\} \in R_0$ if

$$q\{H(\eta_1) \dots H(\eta_m), H(\bar{D}_n(\eta_1)), \dots, H(\bar{D}_n(\eta_m)), H(\bar{D}_n^2(\eta_1)), \dots, H(\bar{D}_n^2(\eta_m)), \dots\} = 0.$$

We prove, as in [3], that the set of all polynomials in R' and R'_0 which are satisfied by all the vectors of a given subset of $\tilde{R}^m$ constitute a bi-ideal in Ω' . Given a bi-ideal α in Ω' we again define the *variety* of α as the set of all vectors which satisfy the polynomials of α , and we introduce the concept of a generic point, as before.

7.4. THEOREM. Let $\alpha = (J, J_0)$ be a proper bi-ideal in Ω' . Then α possesses a generic point if and only if α is prime.

Proof. Suppose first that α is prime. Let $\tilde{R}$ be the residue ring R'/J . Since J is prime, $\tilde{R}$ is a partial differential integral domain, and since J is a proper S -ideal, it contains no elements of R other than 0. It follows that the images of the elements of R in R'/J constitute a partial differential ring which is isomorphic to R . Thus, $\tilde{R}$ may be regarded as an extension of R , and similarly, $\tilde{R}_0 = R'/J_0$ may be regarded as an extension of R_0 . Also, the natural homomorphisms

$$\Phi: R' \rightarrow R'/J \quad \text{and} \quad \Phi_0: R'_0 \rightarrow R'_0/J_0$$

are differential homomorphisms which map the elements of R and R_0 (individually) on themselves.

Consider now the mapping $\Phi_0 H'$. This is a homomorphism from R' into R_0 . Moreover, the kernel of Φ is contained in the kernel of $\Phi_0 H'$ so that the equation $\tilde{H}\Phi(a) = \Phi_0 H'(a)$, for $a \in R'$, defines a unique homomorphism $\tilde{H}$ from $\tilde{R}$ into $\tilde{R}_0$. $\tilde{H}$ satisfies the condition (1.1) above since, for all $a \in R'$,

$$\begin{aligned} \tilde{H} \left(\sum_{k=1}^n a_{ik} D_k \Phi(a) \right) &= \tilde{H} \Phi \sum_{k=1}^n a_{ik} D_k a = \Phi_0 H' \left(\sum_{k=1}^n a_{ik} D_k a \right) \\ &= \Phi_0 (\Delta_i H'(a)) = \Delta_i \Phi_0 H'(a) = \Delta_i \tilde{H} \Phi(a). \end{aligned}$$

We have thus shown that $\tilde{\Omega} = (\tilde{R}, \tilde{R}_0, \tilde{H})$ is an l.p.d.r. which is an extension Ω . The required generic point is now given by $\eta = (\Phi(u_1), \dots, \Phi(u_m))$.

This proves the sufficiency of the condition of 7.4. Necessity is obvious.

7.5. THEOREM. Let $V = \bigcap_{\mu} V_{\mu}$ be the intersection of a set of varieties $\langle V_{\mu} \rangle$. Then V is a variety.

Proof. For each μ , let V_{μ} be the variety of a bi-ideal $\alpha_{\mu} = (J_{\mu}, J_{0\mu})$. Let α be the bi-ideal which is generated by the sets of polynomials $K = \bigcup_{\mu} J_{\mu}$ and $K_0 = \bigcup_{\mu} J_{0\mu}$, and let V' be the variety of α . Then the elements of V satisfy the polynomials of K and K_0 and so $V \subseteq V'$. On the other hand, any point which does not belong to V will not satisfy some polynomials of K or K_0 and hence can not belong to V' . Hence $V = V'$, V is a variety.

As remarked in [3], the union of two varieties is not necessarily a variety.

The same methods as in [3] yield the relation $\alpha \rightarrow V \rightarrow \bar{\alpha}$ where $\bar{\alpha}$ is the closure of α .

A system of polynomials (K, K_0) in Ω' is said to be consistent if the polynomials which belong to K or K_0 possess a joint zero in some extension of Ω . It follows from the preceding discussion that this will be the case if and only if the system (K, K_0) generates a proper bi-ideal. Now by (6.1), the bi-ideal generated by (K, K_0) is $(J, J_0) = (\{K\}_S, \{H'(\{K\}_I) \cup K_0\})$. Hence

7.6. THEOREM. *In order that the system (K, K_0) be consistent, it is necessary and sufficient that*

$$1 \notin \{H'(\{K\}_S) \cup K_0\}.$$

For any set of polynomials K (in R' or R'_0), we denote by $d(K)$ the set of all derivatives of elements of K , including K . With this notation we may replace 7.6 by a more effective test in case R_0 is a Ritt algebra. Note that in that case R also is a Ritt algebra. The test in question is then given by

7.7. THEOREM. *Let R be a Ritt algebra; then a system (K, K_0) in Ω' is consistent if and only if*

$$1 \notin (H'([K]_S) \cup d(K_0)).$$

Proof. If (J, J_0) is generated by (K, K_0) , then, in accordance with an earlier remark, a necessary and sufficient condition for consistency is $1 \notin J_0$. We shall show that if R is a Ritt algebra, $J_0 = \sqrt{(H'([K]_S) \cup d(K_0))}$. But 1 belongs to the radical of an ideal if and only if it belongs to that ideal, and so the conclusion of the theorem will follow.

In order to establish the equation $J_0 = \sqrt{(H'([K]_S) \cup d(K_0))}$, we observe that

$$J_0 = \{H'(\{K\}_S) \cup K_0\} = \sqrt{[H'(\{K\}_S) \cup K_0]} = \sqrt{(d(H'(\{K\}_S)) \cup d(K_0))}.$$

Now $H'(\{K\}_S)$ is closed under differentiation, i.e., it is equal to $d(H'(\{K\}_S))$ for if a is any element of $\{K\}_S$, then $D_i(a) \in \{K\}_S$ for all D_i and so, for $i = 1, \dots, n$,

$$\Delta_i H'(a) = H' \left(\sum_{k=1}^n a_{ik} D_k a \right) \in H'(\{K\}_S),$$

as required. Hence

$$\begin{aligned} J_0 &= \sqrt{(d(H'(\{K\}_S)) \cup d(K_0))} = \sqrt{(H'(\sqrt{[K]_S}) \cup d(K_0))} \\ &\subseteq \sqrt{(H'([K]_S) \cup d(K_0))} \subseteq J_0, \end{aligned}$$

and so

$$J_0 = \sqrt{(H'([K]_S) \cup d(K_0))},$$

as required.

Let (K, K_0) be a system of polynomials as above and let $p\{u\}$ be any other polynomial in R' . We may ask under what conditions $p\{u\}$ vanishes for all joint zeros of (K, K_0) . As in the case treated in [3], this will be the case if and only if p belongs to all admissible prime components of $\{K\}_S$. (A prime component J_i of $\{K\}_S$ is admissible if and only if the system (J_i, K_0) is consistent.) In particular, we obtain the following result for Ritt algebras:

7.8. THEOREM. *Let $\{K\}_S = J_1 \cap \dots \cap J_k$ be the representation of $\{K\}_S$ by its prime components. In order that the polynomial $p \in R'$ vanish for all zeros*

of the system (K, K_0) , it is necessary and sufficient that for any J_i ($i = 1, \dots, k$) either $p \in J_i$ or $1 \in (H'(J_i) \cup d(K_0))$, or both.

Again, we may ask under what conditions a polynomial $q \in R'_0$ is satisfied by all zeros of (K, K_0) . For Ritt algebras, the answer to this question is provided by

7.9. THEOREM. *In order that the polynomial $q\{z\} \in R'_0$ vanish for all zeros of the system (K, K_0) , it is necessary and sufficient that there exists a positive integer ρ such that*

$$q^\rho \in (H'([K]_S) \cup d(K_0)).$$

Proof. Let $\alpha = (J, J_0)$ be the bi-ideal generated by (K, K_0) and let $\bar{\alpha} = (\bar{J}, \bar{J}_0)$ be the closure of α . Then $\bar{J}_0 = J_0$ and $\alpha \rightarrow V \rightarrow \bar{\alpha}$ where V is the variety of α . Thus, q vanishes for all zeros of (K, K_0) if and only if $q \in \bar{J}_0 = J_0$. But, as shown above (see the proof of 7.6), $J_0 = (H'(\sqrt{[K]_S}) \cup d(K_0))$. This proves 7.9.

Finally, we consider the classical Cauchy problem for a system of first order partial differential equations within the framework of local partial differential algebra.

7.10. THEOREM. *Let $\Omega = (R, R_0, H)$ be an l.p.d.r. such that R is a Ritt algebra. Let*

$$(7.11) \quad \bar{D}_n u_i = p_i(u_1, \dots, u_m), \quad i = 1, \dots, m,$$

be a set of partial differential equations with the "initial conditions"

$$(7.12) \quad z_{i0} = a_i, \quad i = 1, \dots, m,$$

where $\bar{D}_n$ denotes the transversal derivative (the transversal vector having been specified in advance) and where

$$p_i \in R(u_1, \dots, u_m), \quad a_i \in R_0, \quad i = 1, \dots, m.$$

Then (7.11), (7.12) possess a solution in some l.p.d.r. which is an extension of Ω .

Proof. Let $K = \langle \bar{D}_n u_i - p_i \rangle$, $i = 1, \dots, m$, and $K_0 = \langle z_{i0} - a_i \rangle$, $i = 1, \dots, m$. According to Theorem 7.7, the conclusion of 7.10 will have been proved if we can show that $1 \notin (H'([K]_S) \cup d(K_0))$. Suppose on the contrary that $1 \in (H'([K]_S) \cup d(K_0))$. If so, there exists an identity

$$(7.13) \quad 1 = r_1 t_1 + \dots + r_k t_k + s_1 v_1 + \dots + s_l v_l,$$

where $r_i, s_i \in R'_0$, $t_i = H(T_i)$, with $T_i \in [K]_S$ and $v_i \in d(K_0)$.

By 3.1, the $\bar{D}_i$ are linear combinations of the $\bar{D}_i$. It follows, taking into account 7.1, that we may write the T_i in the form

$$(7.14) \quad T_i = \sum_{j, \alpha_1, \dots, \alpha_n} P_{j, \alpha_1, \dots, \alpha_n} \bar{D}_1^{\alpha_1} \dots \bar{D}_n^{\alpha_n} (\bar{D}_n u_j - P_j),$$

where the $P_{j, \alpha_1, \dots, \alpha_n}$ belong to R^{*} .

Among all the terms which occur on the right hand side of the equations (7.14), we choose one for which $\alpha_1 + \dots + \alpha_n$ is as large as possible. Replacing $\bar{D}_1^{\alpha_1} \dots \bar{D}_n^{\alpha_n+1} u_j$ in this term by $\bar{D}_1^{\alpha_1} \dots \bar{D}_n^{\alpha_n} p_j$ eliminates the term without affecting the remaining expressions. Repeating this procedure a finite number of times we obtain 0 on all right hand sides of (7.14). Applying the corresponding substitutions in R'_0 , i.e., replacing expressions $\Delta_1^{\alpha_1} \dots \Delta_{n-1}^{\alpha_{n-1}} z_{j, \alpha_n+1} = H'(\bar{D}_1^{\alpha_1} \dots \bar{D}_n^{\alpha_n+1} u_j)$ by $\Delta_1^{\alpha_1} \dots \Delta_{n-1}^{\alpha_{n-1}} (H' \bar{D}_n^{\alpha_n} p_j)$ in the same order, we eliminate $t_1, \dots, t_k$ from (7.13), i.e., we obtain an identity of the form

$$(7.15) \quad 1 = s'_1 v'_1 + \dots + s'_l v'_l,$$

where $s'_i \in R'_0$ and $v'_i \in d(K_0)$. But this identity expresses the fact that 1 belongs to the differential ideal $[K_0]$, and this is impossible since $[K_0]$ possesses the (differential) zero $z_{i_0} = a_i$, $i = 1, \dots, m$. This shows that an identity of the type of (7.13) can not exist and completes the proof of the theorem.

The theory of regular local partial differential rings will be treated elsewhere.
