The President of the Council declared open the 2011 substantive session of the Economic and Social Council.

The Council adopted the provisional agenda, as contained in section I of document E/2011/100 and E/2011/100.Corr.1, and approved the proposed programme of work, as contained in document E/2011/L.12 and the non-paper containing revisions to the programme of work, with the understanding that the item would remain open throughout the session and that, should the need arise, modifications could be made to the programme of work as the session progressed.

The Council also took note of the list of documents for the session, as contained in document E/2011/L.11, which would be updated in document E/2011/CRP.1.

Requests from non-governmental organizations to be heard by the Council

The Council approved the recommendation of the Committee on Non-Governmental Organizations at its 2011 resumed session, to hear the non-governmental organizations listed in document E/2011/127, under agenda item 2 (b).

The President of the Council made an opening statement.

A statement was made by the President of the sixty-fifth session of the General Assembly, H.E. Mr. Joseph Deiss (Switzerland).

The Deputy Secretary-General of the United Nations addressed the Council.

Keynote addresses

The Council heard keynote addresses by the former Prime Minister of the United Kingdom of Great Britain and Northern Ireland, Mr. Gordon Brown; the DirectorGeneral of the United Nations Educational, Scientific and Cultural Organization, Ms. Irina Bokova; the Global Vice-President of CISCO, Mr. Simon Willis; and the Executive Director and Co-Founder of Ushahidi, Ms. Juliana Rotich.

Policy messages from annual ministerial review preparatory meetings

Policy messages were made by the Minister of Education and Higher Education of Qatar, H.E. Mr. Saad bin Ibrahim al-Mahmoud, on the Western Asia Regional Meeting held in Doha on 9 December 2010; the Deputy Permanent Secretary of the Ministry of Education of Thailand, H.E. Ms. Churairat Sangboonnum, on the Asia and Pacific Regional Meeting held in Chonburi on 24 March 2011; the Minister of Literacy and Primary and Secondary Education of Togo, H.E. Ms. Essossimna Legzim-Balouki, on the Africa Regional Meeting held in Lomé on 12 April 2011; and the Under-Secretary for Education Planning, Ministry of Education of Argentina, H.E. Mr. Eduardo Aragundi, on the Latin America and Caribbean Regional Meeting held in Buenos Aires on 12 and 13 May 2011.

The President of the Council suspended the meeting.

Special policy dialogue on "Accelerating education for all (EFA): Mobilizing resources and partnerships"

The President resumed the meeting and welcomed the panellists and the moderator for the special policy dialogue.

The dialogue was moderated by Ms. Irina Bokova, Director-General of the United Nations Educational, Scientific and Cultural Organization, and the panellists were: H.E. Mr. Muhammad Nuh, Minister of National Education of Indonesia; H.E. Mr. Erik Solheim, Minister of the Environment and Development Cooperation of Norway; and Ms. Wendy Hawkins, Executive Director, Intel Foundation.

Following the presentations by the panellists, an interactive discussion ensued, during which interventions were made by the representatives of the United States, the Republic of Korea, Finland and Senegal.

A statement was also made by the representative of the World Food Programme, also on behalf of the Food and Agriculture Organization of the United Nations and the International Fund for Agricultural Development

Statements were made by the representatives of the following non-governmental organizations in consultative status with the Council: Save the Children; and CIVICUS – World Alliance for Citizen Participation.

The panellists responded to the comments made and the questions raised during the dialogue.

Keynote address

The Council heard a keynote address by H.E. Ms. Micheline Calmy-Rey, President of the Swiss Confederation.

High-level segment: Annual ministerial review: Implementing the internationally agreed goals and commitments in regard to education [2 (b)]

The Council resumed its consideration of the sub-item.

Special face-to-face debate on "Education, human rights and conflict"

The President opened the special event.

Introductory statements were made by Ms. Irina Bokova, Director-General of the United Nations Educational, Scientific and Cultural Organization, and H.E. Mr. Erik Solheim, Minister of the Environment and Development Cooperation of Norway.

A short film produced by UNTV was shown to the Council.

The debate was moderated by Ms. Imogen Foulkes, BBC Correspondent, Geneva, and the panellists were Ms. Tove Wang, Chief Executive Officer of Save the Children Norway and Chair of the Rewrite the Future Campaign; Ms. Asma Jahangir, Laureate of the 2010 UNESCO/Bilbao Prize for the Promotion of a Culture of Human Rights and President of the Supreme Court Bar Association of Pakistan; Mr. Mamadou Diouf, Leitner Family Professor of African Studies and Director of the Institute for African Studies, Columbia University; and H.E.
