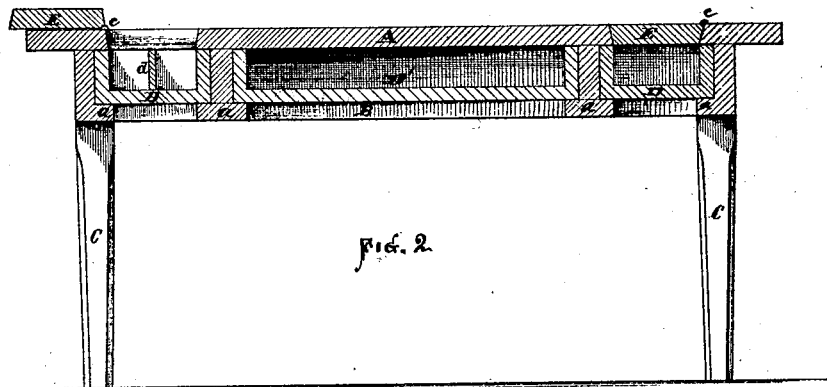
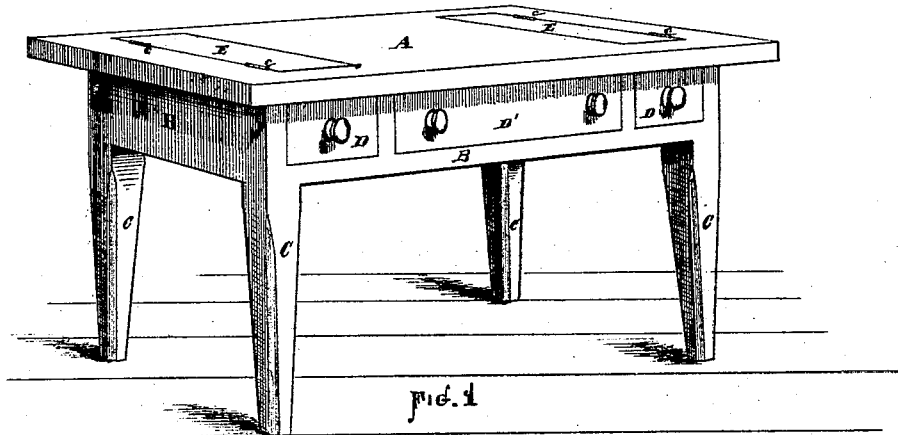

IMPROVED COOKING-TABLE.

The Schedule referred to in these Letters Patent and making part of the same.

To all whom it may concern :

Be it known that I, ELIZA D. DODGE, of the city and county of Worcester and State of Massachusetts, have invented certain new and useful Improvements in Cooking-Tables ; and I do hereby declare the following to be a full, clear, and exact description of the same, reference being had to the accompanying drawing which forms a part of this specification, in which—

Figure 1 represents a perspective view of my improved cooking-table, and

Figure 2 represents a central longitudinal section of the same.

To enable those skilled in the art to which my invention belongs to make and use the same, I will proceed to describe it more in detail.

The nature of my invention consists in an improved cooking-table, as hereinafter explained.

In the drawing the parts marked A represent the top of the table ;

B, the frame ; and

C, the legs upon which the frame is supported in the ordinary manner.

Drawers, D D', are arranged in the frame B, which run upon suitable ways, *a*. In the present instance there are three drawers, a wide one, D', in the center, and a narrow one at each side, but a greater or lesser number may be used if preferred.

In the table-top A, directly above the narrow drawer D', are arranged covers, E, hinged to the table-top, as indicated at *c*, and which open into the drawer beneath.

The covers E are so constructed that, when open, they will be flat upon the table-top, as shown in fig. 2.

By the use of my improvement a person engaged in preparing pastry can work with great dispatch and convenience, inasmuch as all spices and other ingredients of a like nature may be taken from the side-drawers D, through the opening in the top of the table, without the trouble of stepping back and pulling out the drawers, while, at the same time, the spice-boxes, or other receptacles, are not in the way to interfere with the movements of the operator, as is the case when they are allowed to stand upon the table-top.

The side drawers may be divided into compartments by partitions, *d*, if desired, and the spices and other articles deposited directly into the several compartments, without the use of other receptacles, or tin boxes may be made to fit closely into said compartments.

The covers E may be provided with knobs to facilitate the operation of opening them, or they may be fitted with any other trimmings, as desired.

Having described my improved cooking-table,

What I claim therein as new and of my invention, and desire to secure by Letters Patent, is—

A cooking-table provided with one or more side drawers D, and cover or covers to the same, substantially as and for the purposes set forth.
