


IMPROVEMENT IN HANDLES FOR CANES AND UMBRELLAS.

The Schedule referred to in these Letters Patent and making part of the same

To all whom it may concern:

Be it known that I, Albert Wanner, of Hoboken, in the county of Hudson and State of New Jersey, have invented a new and useful Improvement in Perfumed Parasol and Cane-Head; and I do hereby declare that the following is a full, clear, and exact description thereof, which will enable others skilled in the art to make and use the same, reference being had to the accompanying drawing forming part of this specification.

My invention relates to parasol-handles, canes, &c., and has for its object to arrange some convenient re-

ceptacle therein for perfumery.

The invention consists in an improvement upon the English patent No. 1,452, of 1863, and will be particularly specified in claim.

In the drawing—

Figure 1 is a vertical section of a cane or parasolhead, constructed according to my invention, the section being on the line x x, fig. 2.

Figure 2 is a top view of the same.

Similar letters of reference indicate corresponding parts.

A is a cavity made in the head, which contains

sponge, or any other absorbing material.

The top of the head is perforated with one or more holes, as seen in the drawing, and it is covered by a cap or perforated disk, B, fastened to the top of the head by a central pivot, C, so that it may be turned on its pivot.

The holes in the top of the head and those in the

cap are so placed or arranged that they are made to register with each other, thereby giving access to the cavity A for the introduction of liquid, and for the escape of the perfume.

D is a stop-pin on the head, and

E is a little recess in the cap. The length of this recess determines the extent of the movement of the cap.

When the cap is turned in one direction, the apertures or holes register, as seen in the drawing. When turned in the other direction the holes in the head are closed, preventing, thereby, the escape of the perfume.

This invention may be applied to the heads of the umbrella-staff, as well as to heads of parasols or canes.

I do not confine myself to perfumes exclusively. The absorbent may be saturated with camphor or other restoring liquid, if desired.

Having thus described my invention,

I claim as new and desire to secure by Letters Patent—

The combination, with a cane or parasol having hollow and perforated head, with pin D thereon, of the vibrating cup B, pivoted at C, and having arc-slot E therein, as and for the purpose described.
