

## IMPROVEMENT IN IRONING-STANDS.

Specification forming part of Letters Patent No. 216,297, dated June 10, 1879; application filed September 27, 1878...

To all whom it may concern:

Be it known that I, HARRY BLAKE SUM-MERS, of Southington, in the county of Trumbull and State of Ohio, have invented certain new and useful Improvements in Folding Ironing-Stands; and I do hereby declare that the following is a full, clear, and exact description of the invention, which will enable others skilled in the art to which it appertains to make and use the same, reference being had to the accompanying drawings, which form a part of this specification, and in which-

Figure 1 is a perspective view of my improved ironing-stand folded out, ready for use. Fig. 2 is a longitudinal section of the same folded up, ready to be stowed away, and Fig. 3 is a detached view of one of the clothes-

frames.

Similar letters of reference indicate corre-

sponding parts in all the figures.

The nature of my invention consists in the combination of certain parts constituting an ironing-stand, the whole arranged in such a manner that when not in use it may be conveniently folded together into comparatively small space, all as hereinafter more fully shown and described.

In the drawings, A is the ironing-board. This may be secured, by means of pins a a, between two cross-pieces, b b, secured to an upright, B, which again is hinged upon a board, C, which latter forms the bottom piece of my improved ironing-stand. D is a prop or brace hinged to the under side of board A, and having at the lower end a lug, d, fitting in a recess, d', in board C. E is another brace, hinged to brace D in such a manner that both may be folded under board A.

To the under side of board C are secured two slats or bars, F' F', which serve as feet or

braces to prevent the stand, when folded out, from falling over sidewise. ee are two hooks secured to the brace or prop D, and engaging with staples cc, attached to brace F' for the purpose of giving rigidity to the stand when folded out.

G G are frames or brackets, upon which clothes may be deposited before or after ironing. These, of which there may be one or a larger number, consist of bars or rods gg, having lateral arms ii, upon which the clothes are hung in the usual manner. Bars g have hooks k k, by which they may be easily adjusted upon upright B in the position shown in Fig. 1, the upright being provided with staples l l for this purpose.

The advantages of my invention and the method of using the same will be readily understood from the foregoing description. It is convenient, easily put up for use, and may, when not in use, be folded up, so as to occupy

but little space.

Having thus described my invention, I claim and desire to secure by Letters Patent of the

United States-

The combination, with the base-board C, having the hinged upright B and recess d', which upright is provided with the cleats b, of the table A, having the hinged prop D, provided with a stud or tenon, d, and a hinged prop, E, substantially as and for the purpose set forth.
