

BUCKLE.

SPECIFICATION forming part of Letters Patent No. 264,032, dated September 5, 1882.

Application filed May 31, 1882. (No model.)

To all whom it may concern:

Be it known that I, JOSEPH L. FOLLETT, of the city, county, and State of New York, have invented a certain and useful Improvement in Buckles, of which the following is a specifica-

My invention is designed to overcome an objection to the use of ordinary buckles, which is the liability—for instance, in harness or on 10 shawl or other straps—of hair, thread, or portions of garments, wearing-apparel, or the like catching between the front bar of the buckleframe and the strap. This is particularly annoying in harness, for the horse in switching 15 his tail frequently has it caught in this way by

a buckle.

My improvement consists in forming or providing the buckle at the front on each side with a guard flange or lip, which projects to the rear 20 or under side of the buckle far enough to cause the two to form a recess on the under face of the buckle, which receives the strap and prevents effectually the catching of anything between the strap and the front bar of the buckle.

The nature of my improvements will be readily understood by reference to the accom-

panying drawings, in which-

Figure 1 is a plan of my improved buckle with straps attached. Fig. 2 is a longitudinal 30 section of the same on line 22, Fig. 1. Fig. 3 is a transverse section on line 3 3, Fig. 1.

The buckle, except in the feature hereinafter more particularly described, does not differ materially from an ordinary buckle, consisting of a frame, A, and tongue B. The tongue is hinged on the rear bar of the frame, to which bar is also secured the strap C in the usual

My improvement consists in providing the 40 buckle on each side, at the front, with the guard lips or flanges a, which extend rearwardly or to the under side of the buckle a sufficient dis-

tance to form a strap-receiving recess, b. The end of the strap passes under the front bar of the frame into the buckle, where it engages the 45 tongue in the ordinary way. When the strap is thus placed and drawn taut its side edges will be covered by the guard a to an extent sufficient to prevent hair or any other filaments from being drawn crosswise between the 50 front part of the buckle and the strap. convenient way of making the buckle of this form is to have the front bar of the frame above the side bars, as indicated in the drawings; but the same result can be produced by 55 providing the ordinary buckle-frame at the front with side guards, fingers, or lips, between which the strap which passes under the front bar will lie.

I am aware that a buckle has heretofore 60 been proposed in which the rear of the buckleframe is recessed for the purpose of bringing the strap at that point into nearly the same plane as the lower edge of the front bar of the frame; but this buckle has no such provision 65 as that contemplated by me, and is open to all the objections hereinbefore stated as attending the use of ordinary buckles.

What I claim as new and of my invention

The improved buckle hereinbefore described, consisting of the frame having the tongue pivoted to its rear cross-bar, and provided at its front end with side guard lips or flanges which form a strap receiving recess on the under side 75 of the front bar, as and for the purposes set forth.
