

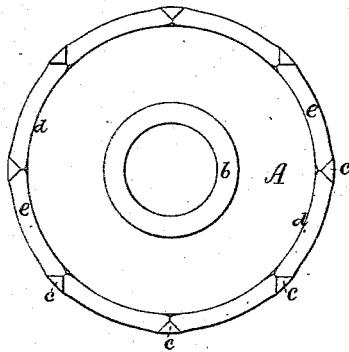

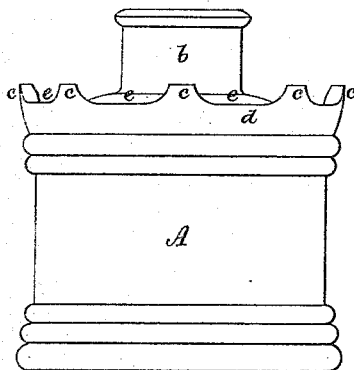

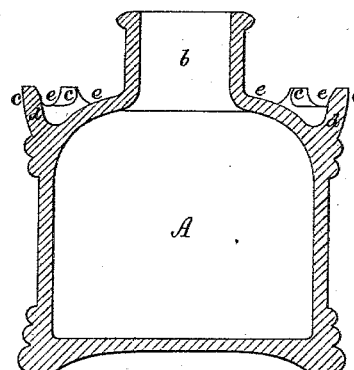

## INK-BOTTLE.

SPECIFICATION forming part of Letters Patent No. 303,310, dated August 12, 1884.

Application filed May 31, 1884. (No model.)

*To all whom it may concern:*

Be it known that I, ISAAC ELIJAH MOORE, of Warren, in the county of Worcester, of the Commonwealth of Massachusetts, have invented a new and useful Improvement in Ink-Bottles; and I do hereby declare the same to be described in the following specification and represented in the accompanying drawings, of which—

10 Figure 1 is a top view, Fig. 2 a front elevation, and Fig. 3 a vertical and transverse section, of an ink-bottle containing my invention, the nature of which is defined in the claim hereinafter presented.

15 This bottle has extended upward from it, and around the neck *b* of its body *A*, a series of ears or projections, *c*, for supporting one or more pens. It also has a flange or lip, *d*, going around the neck at a distance therefrom, and  
20 upward from the body, such flange or lip being to form around the neck an annular groove or channel to intercept and prevent from running down and off the body any ink that may flow down upon the outer surface of the neck.  
25 This flange has within it, from its upper edge downward, and at or about at equal distances apart, a series of notches or recesses, *e*, or to extend upward from such edge a series of projections or ears, *c*, such notches or spaces be-

tween the ears being, with such ears, to sustain one or more pens when placed across the top of the body and aside of the neck and within two or more of the notches.

I do not claim an inkstand having its mouth or neck or dipping-orifice wholly on one side 35 of the ink-reservoir, and not to project from the top thereof, and having to the latter a pen-rack, all being as shown in the United States Patent No. 156,862; for in my ink-bottle both the neck and the pen-rack extend upward con- 40 centrically with each other from the top of the body of the article, in which case the pen-rack composed of the flange and series of ears answers the two purposes, as hereinbefore described. 45

I claim—

An ink-bottle provided with the circular waste-intercepting flange or lip extending upward from the upper part of the body and around and at a distance from the neck, and 50 having at its upper edge a series of ears or recesses, as described, such flange, ears, and notches being for the purposes as specified.
