

## MUSICAL CIGAR SHOW-BOX.

SPECIFICATION forming part of Letters Patent No. 342,986, dated June 1, 1886.

Application filed July 27, 1885. Serial No. 172,809. (No model.)

To all whom it may concern:

Be it known that I, ANTHONY WARD, of Brooklyn, in the county of Kings and State of New York, have invented a new and useful 5 Improvement in Musical Cigar Show-Boxes, of which the following is a full, clear, and exact description.

Reference is to be had to the accompanying drawings, forming a part of this specification. 10 in which similar letters of reference indicate

corresponding parts in all the figures.

Figure 1 is a sectional front elevation of one of my musical eigar show-boxes taken through the line ww, Fig. 3. Fig. 2 is a sectional end 15 elevation of the same, taken through the line y y, Fig. 1. Fig. 3 is a sectional end elevation of the same, taken through the line zz, Fig.1. Fig. 4 is a plan view of a part of the same, the cover being removed.

The object of this invention is to provide attractive show-boxes for offering cigars to

The invention consists in a musical cigar show-box made with grooves in the inner sur-25 faces of its front and rear sides, and provided with removable partitions, and a music-box so arranged that the music will be started and stopped by opening and closing the show-box cover, as will be hereinafter fully described, 30 and then claimed.

A represents the body of the show-box, which is made with its front a little lower than its back, to give the cover B a downward inclination. The box A is made of such a width that 35 a cigar-box, C, can be readily placed within it of a depth a little greater than the depth of a cigar-box, and of a length so much greater than the length of the cigar-box C as to leave at one end of the said eigar-box sufficient space 40 to receive a small music-box, D.

In the inner surfaces of the front and back of the show-box A are formed vertical grooves EF, to receive the edges of the partitions GH. The grooves E are so located as to be at the 45 end of the eigar-box C, so that the partition G, when placed in the said grooves E, will be directly above, and its lower edge will rest upon the upper edge of, the inner end of the eigarbox C. Several pairs of grooves, F, are formed, 50 so that one or more partitions, H, can be used, as may be desired.

titions H are cut away, so that the lower part of the said partitions will fit into the eigarbox C and rest upon the bottom of the said 55 cigar-box, while the upper parts of the side edges of the said partition rest in the upper parts of the grooves F, as shown in Fig. 2.

The partition H divides the cigar-box into two compartments, so that different brands of 60 cigars can be placed in the said compartments, and will be entirely separated from each other.

One, two, or more, partitions, H, can be used as the number of different brands of eigars to be placed in the cigar-box C may require. With 65 this construction the cigar-box C can be removed from the show-box B by taking out the partitions GH; or the cigar-box C and the partition H can be taken out together when required.

To the center of the rear side of the showbox A is attached a handle, I, for convenience

in handling the said show-box.

In the end of the show-box A, adjacent to the end of the music-box D, is formed a per- 75 foration, in which is placed a rod, J. Upon the lower end of the rod J is formed an inwardly-projecting arm, K, which, when the rod J is forced downward, is brought into contact with the escapement L of the driving 80 mechanism of the music-box D, and holds the said mechanism from operating. Upon the lower part of the rod J is placed a spiral spring, M, the upper end of which rests against a collar, N, formed upon or attached to the 85 said rod J. The spring M is made of sufficient strength to raise the rod J when left free, and thus withdraw the arm K from the escapement L, and thus allow the music-box D to play. With this construction, when the cover B is 90 closed it rests upon the upper end of the rod J, and its weight depresses the said rod and holds the arm K in gear with the escapement L. When the cover B is raised, the spring M raises the rod J and withdraws the arm K 95 from the escapement L, allowing the musicbox to play, so that the music will be started by opening the cover Band stopped by closing the said cover.

Having thus fully described my invention, 100 I claim as new and desire to secure by Letters Patent-

2. In a musical eigar show-box, the combination, with the show-box A and its cover B, and the music-box escapement L, of the rod J, having arm K, and the spiral spring M, sub-

stantially as herein shown and described, whereby the music will be started and stopped 10 by the opening and closing of the show-box cover, as set forth.
