

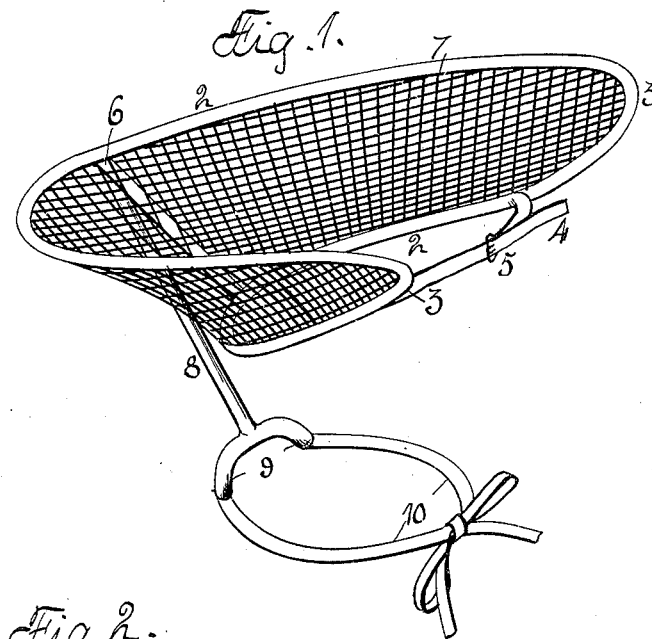

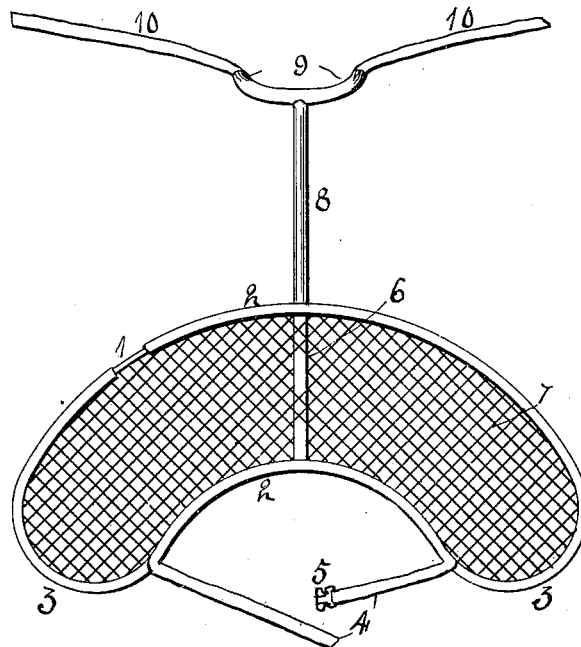

## HAIR-DRIER.

SPECIFICATION forming part of Letters Patent No. 649,608, dated May 15, 1900.

Application filed September 14, 1899. Serial No. 730,512. (No model.)

*To all whom it may concern:*

Be it known that I, ANNA M. KELLOGG, a citizen of the United States, residing at Chicago, in the county of Cook and State of Illinois, have invented certain new and useful Improvements in Hair-Driers, of which the following is a specification.

The object of this invention is to provide means for holding in a distended position a lady's hair from the neck after washing in such a manner as to protect the clothing from the dampness and cause it to dry quickly and thoroughly.

In the accompanying drawings, Figure 1 is a perspective view of my improved hair-drier. Fig. 2 is an outstretched view.

The drier is of segmental form when outstretched and consists of the edge band 1, having a cloth covering 2. The ends 3 are rounded. To the ends are secured tapes 4, which are connected by a buckle 5. A cross-bar 6 connects the inner and outer edges of the band. The space between the inner and outer edges of the band is filled with netting 7, of any suitable material. To the center of the outer edge of the band is flexibly connected a brace 8, its lower end provided with branches 9, and to the branches are connected tapes 10.

Fig. 1 of the drawings shows the application of my improved hair-drier. After a lady has washed her hair the band is passed under the hair at the back of the neck and the ends brought toward each other at the temples and connected across the forehead by the tapes 4 and buckle 5. The branches 9 of the brace 8 rest upon the back of the neck and the tapes 10 pass around the neck and are connected under the chin. This brace-bar holds the rear portion of the band elevated, so that the hair will be held free from the body and clothing.

The netting permits air to pass through the hair and quickly and thoroughly dries it.

I claim as my invention—

A hair-drier composed of a flexible band in segmental form having its center filled with flexible open-work, tapes connecting the band and adapted to be secured across the forehead, a support for the rear portion of the band adapted to rest at the back of the neck and tapes connecting the lower end of the support and adapted to pass around the neck.
