FIG. 12 depicts a right view of the handheld file in FIG. 8.


FIG. 13 depicts a front view of the handheld file in FIG. 8.


FIG. 14 depicts a rear view of the handheld file in FIG. 8; and.


FIG. 15 depicts an exploded view of the handheld file in FIG. 8.


The broken lines depict portions of the handheld file in which the design is embodied that form no part of the claimed design.






















