DESCRIPTION

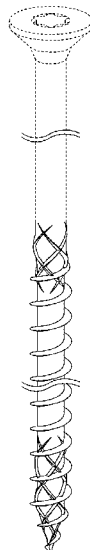
FIG. 1 is a front, right-side and top perspective view of a screw showing my new design;

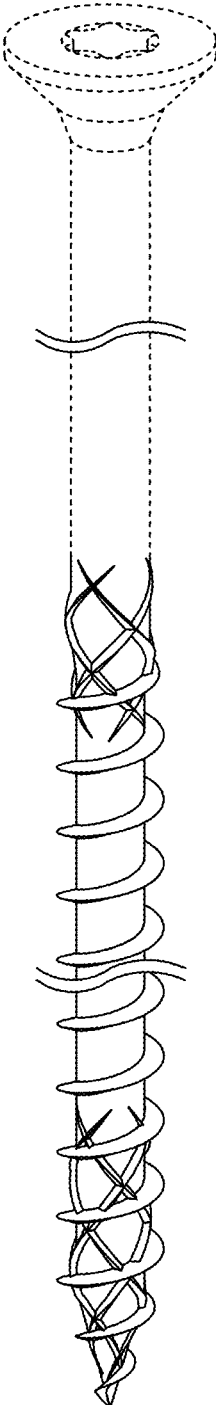

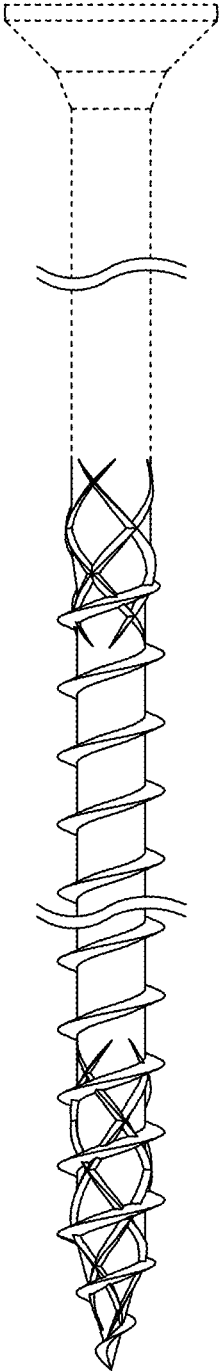

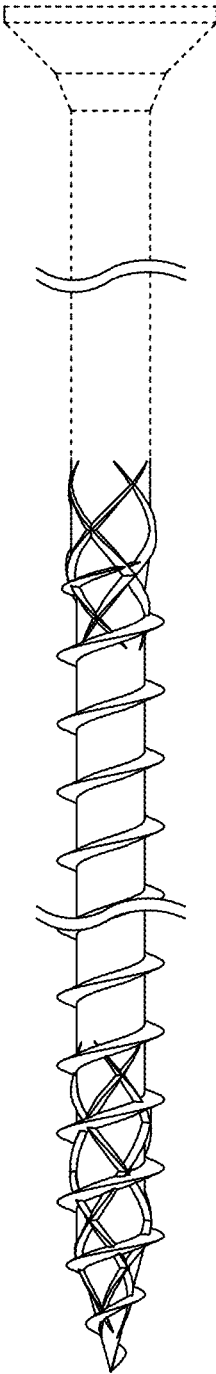

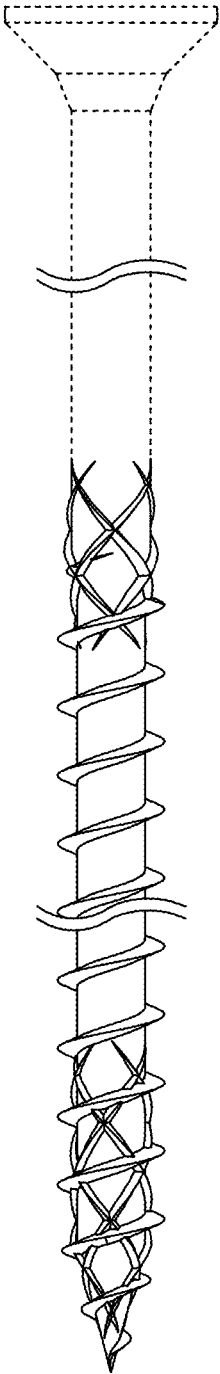

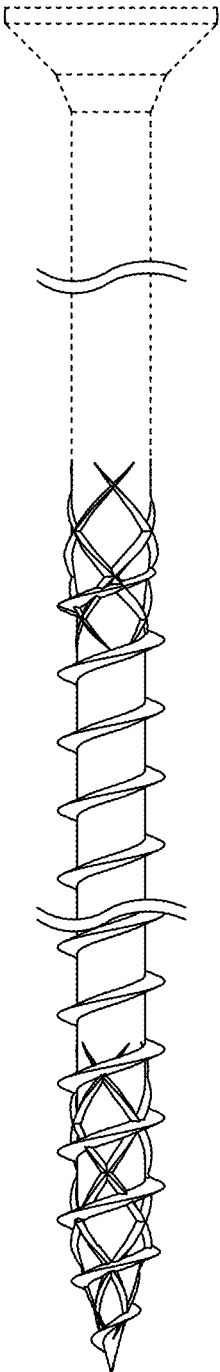

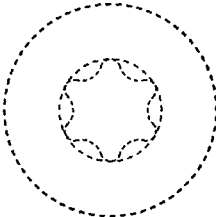

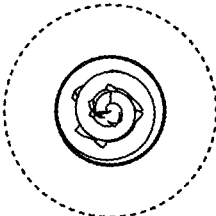
