(57) **CLAIM**

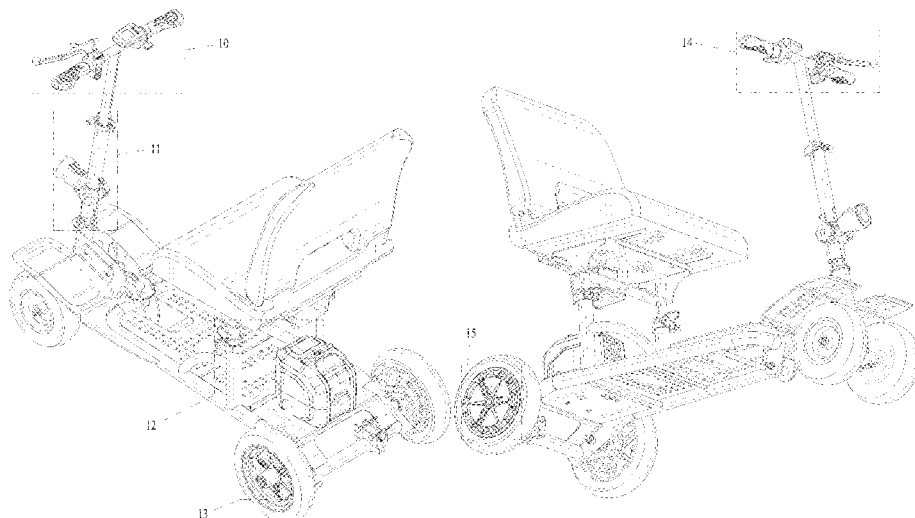
The ornamental design for a portable mobility scooter, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, top perspective view of a portable mobility scooter showing our new design;
FIG. 2 is a back, left, bottom perspective view thereof;
FIG. 3 is a folding state of the portable mobility scooter after the seat is removed as shown in FIG. 1;
FIG. 4 is a front view thereof;
FIG. 5 is a back view thereof;
FIG. 6 is an enlarged left view thereof;
FIG. 7 is an enlarged right view thereof;
FIG. 8 is a top view thereof;
FIG. 9 is a bottom view thereof;
FIG. 10 is an enlarged view of the encircled area 10 of FIG. 1;
FIG. 11 is an enlarged view of the encircled area 11 of FIG. 1;
FIG. 12 is an enlarged view of the encircled area 12 of FIG. 1;

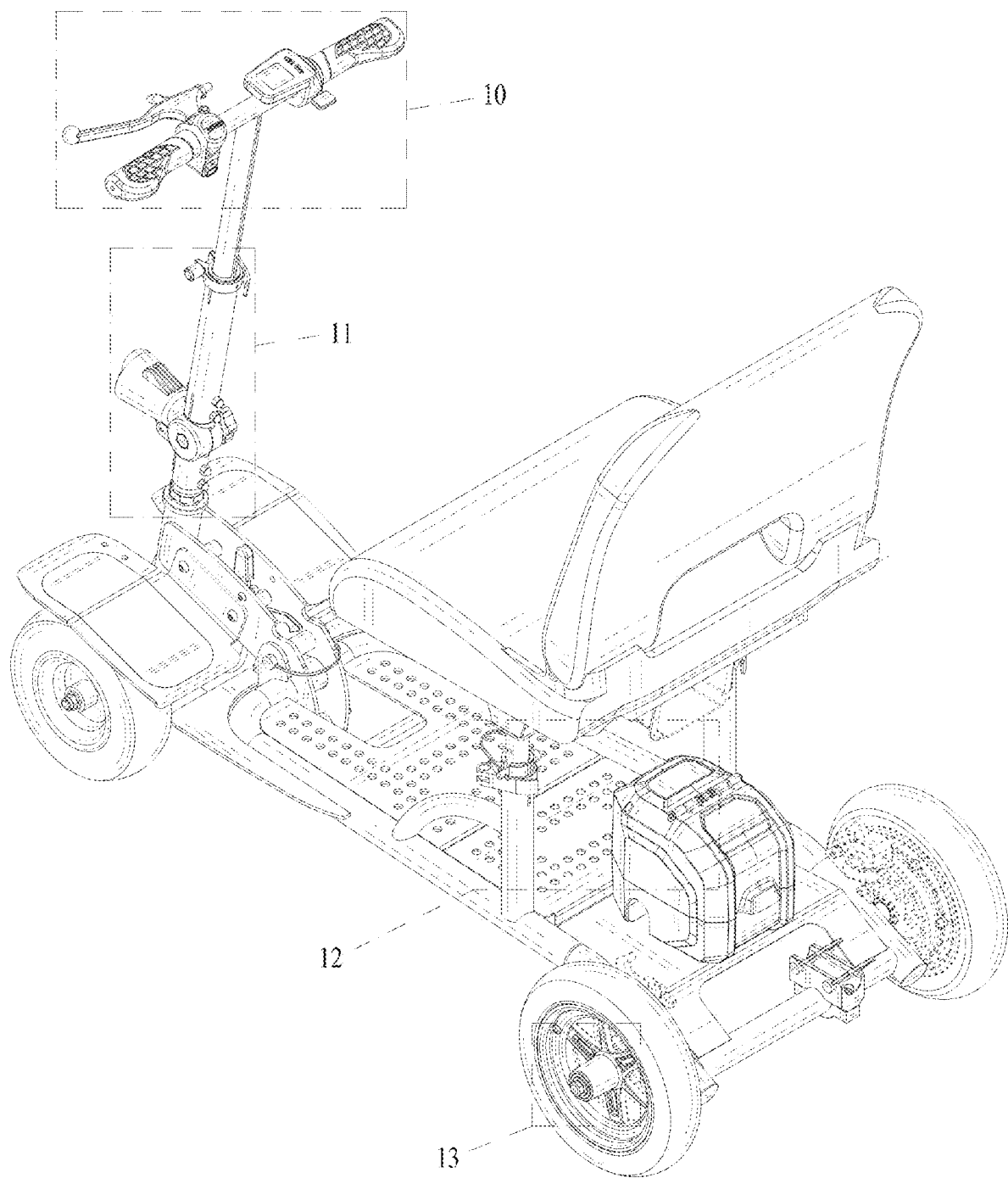

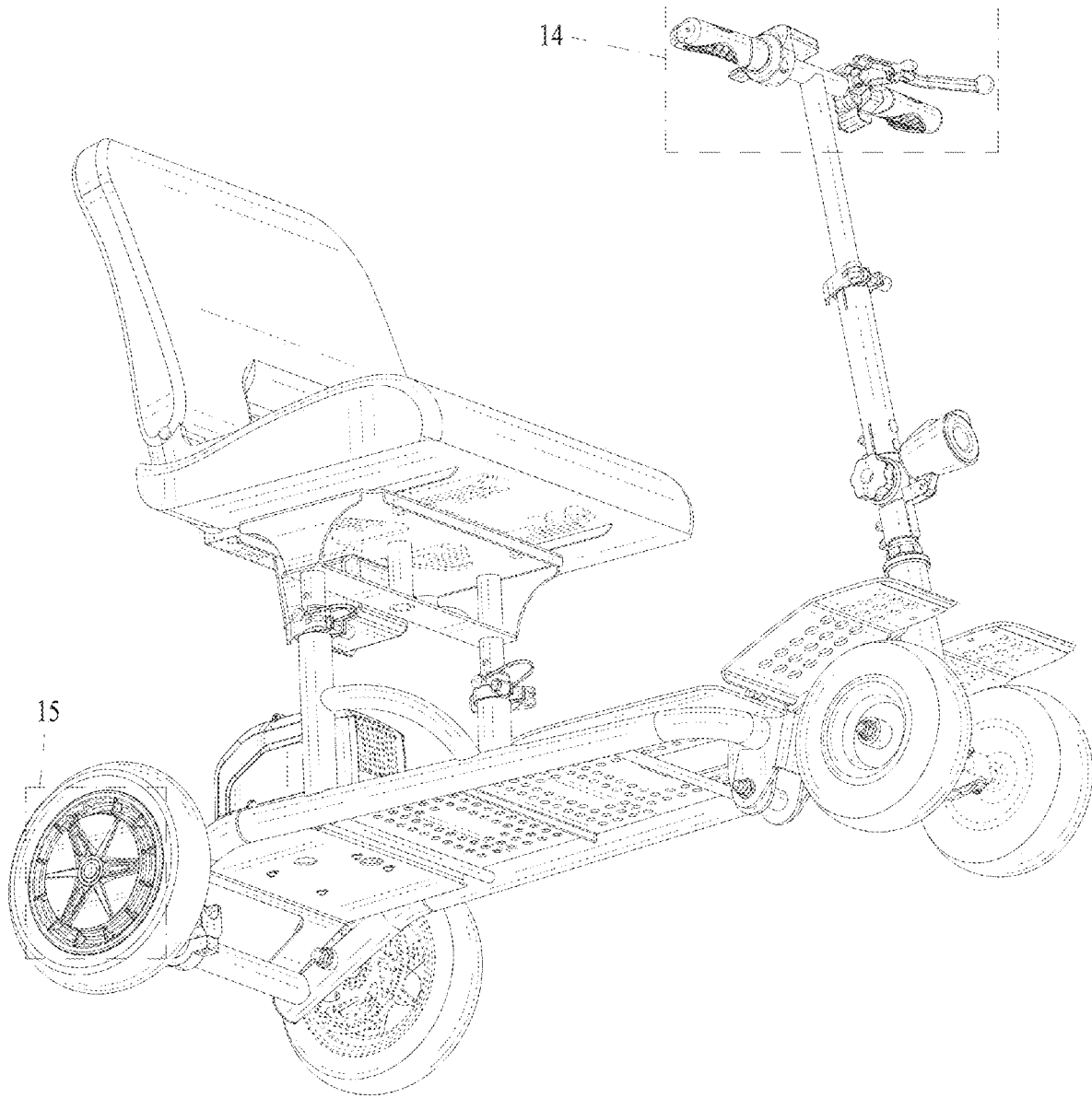

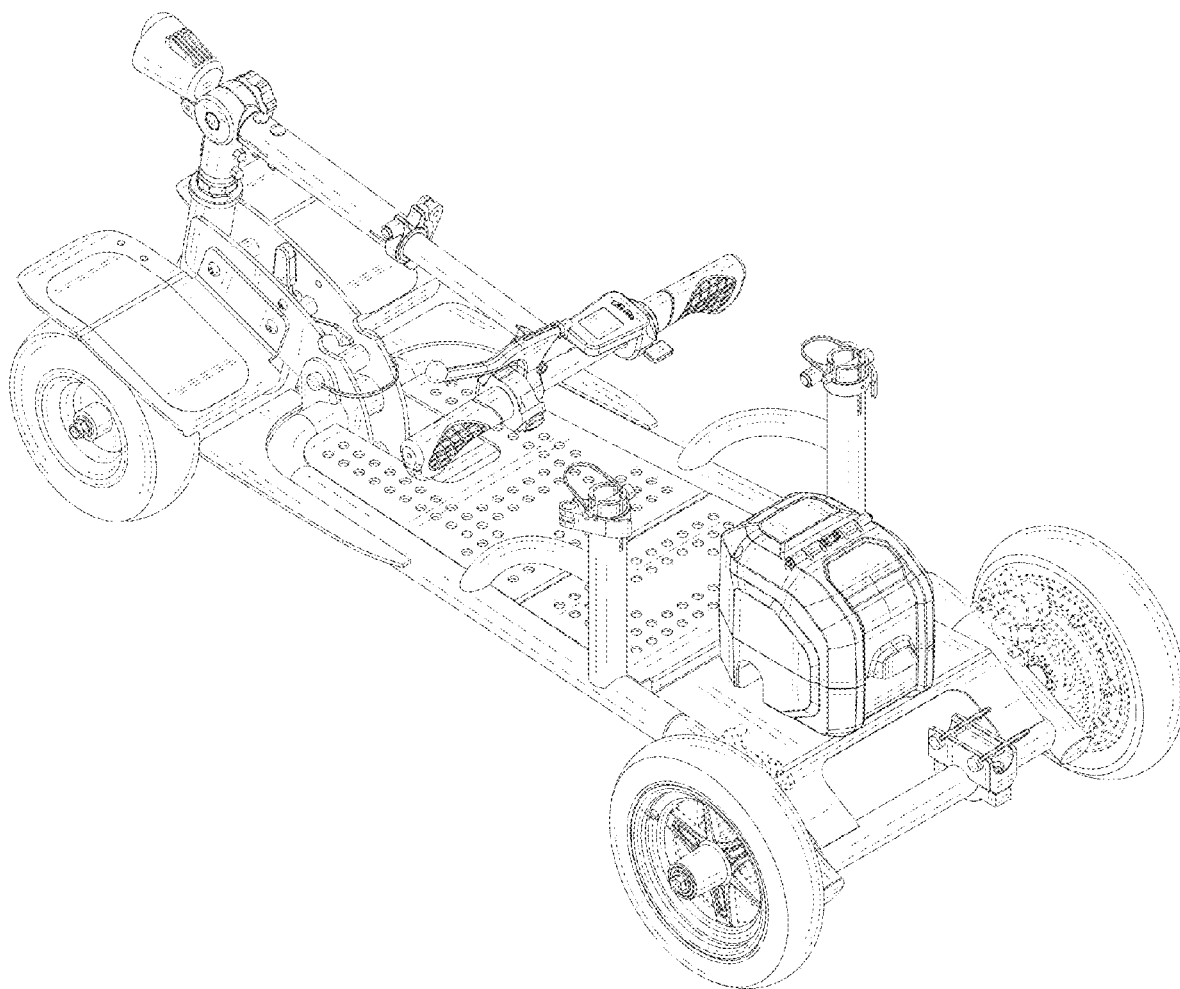

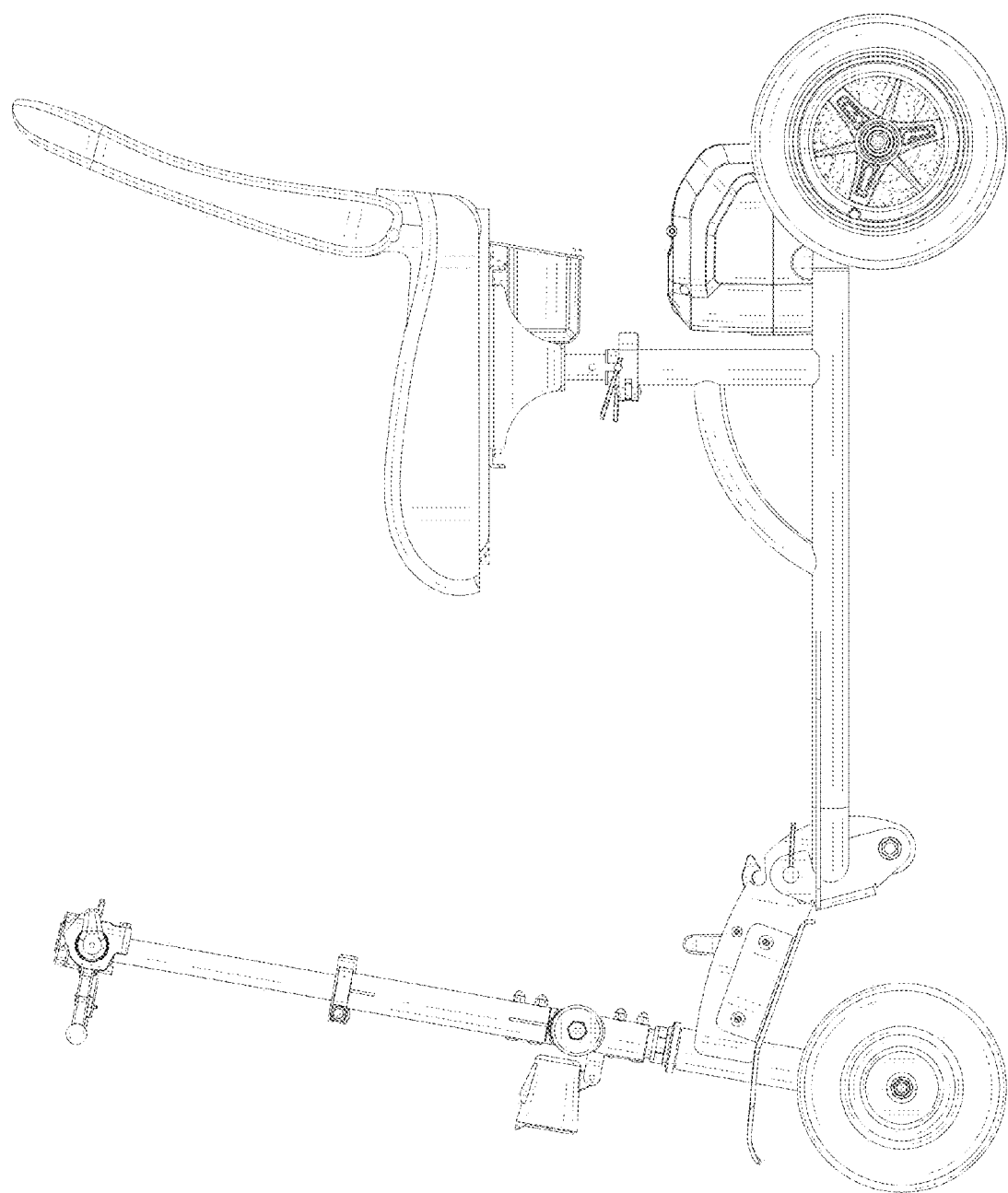

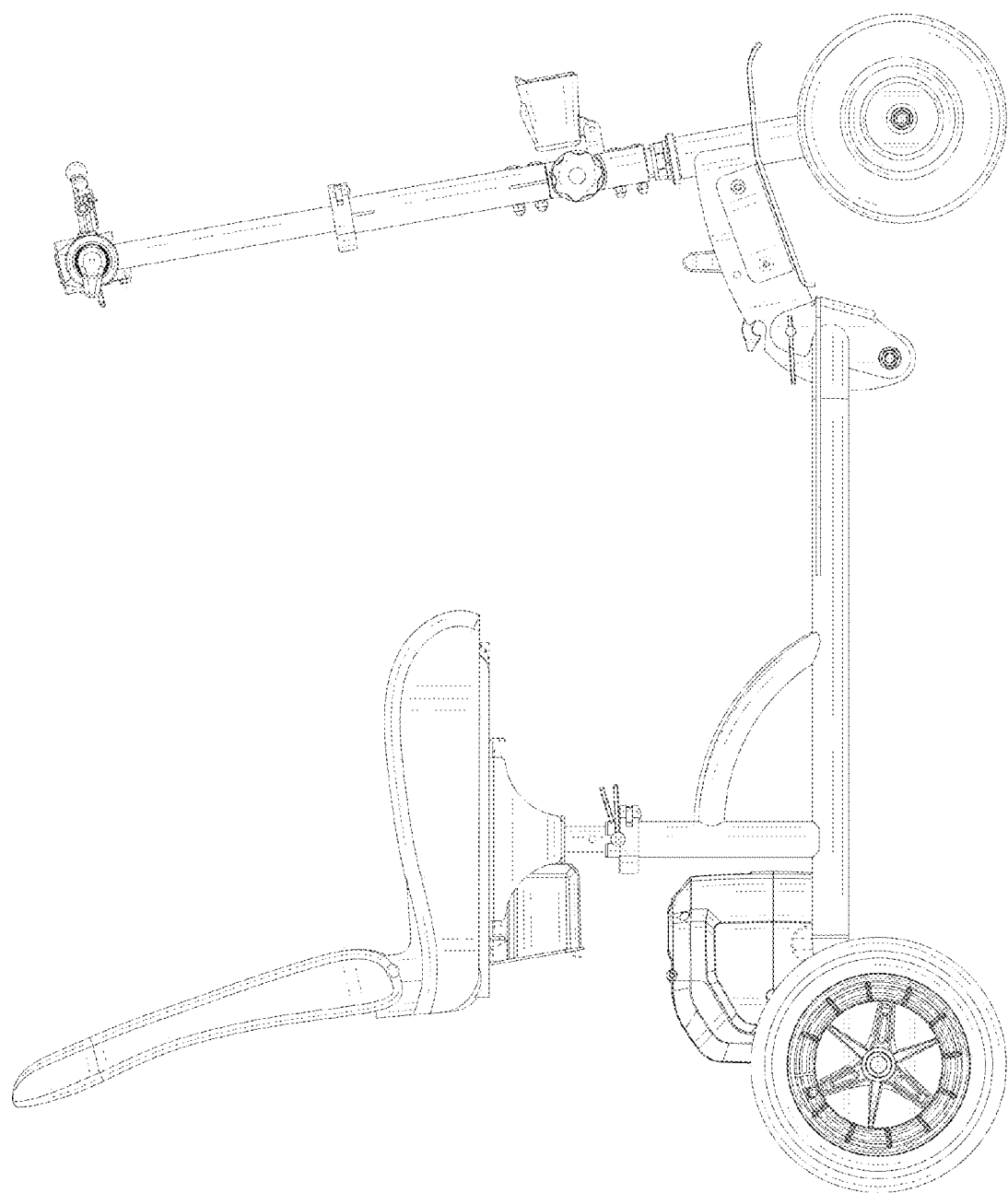

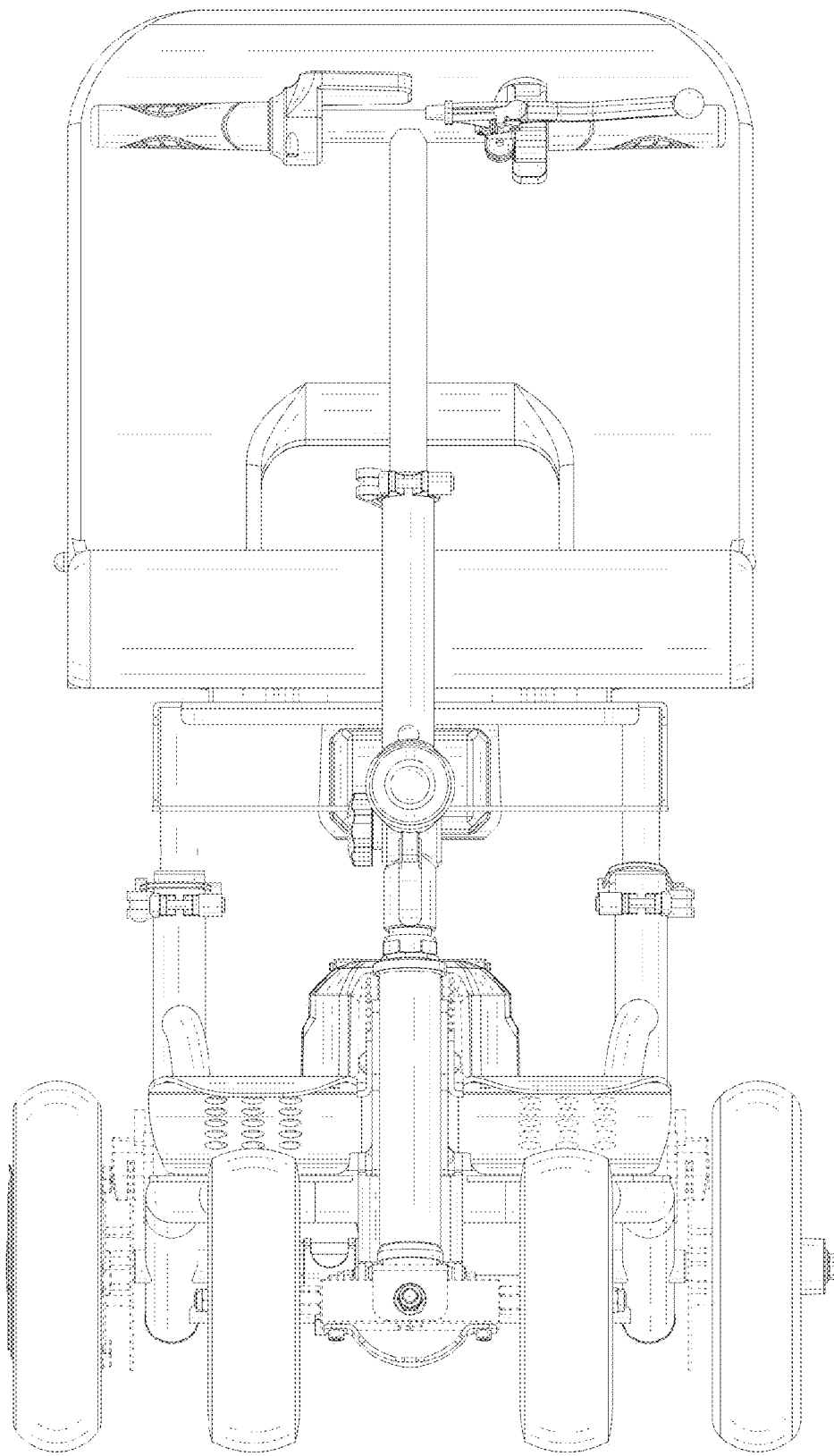

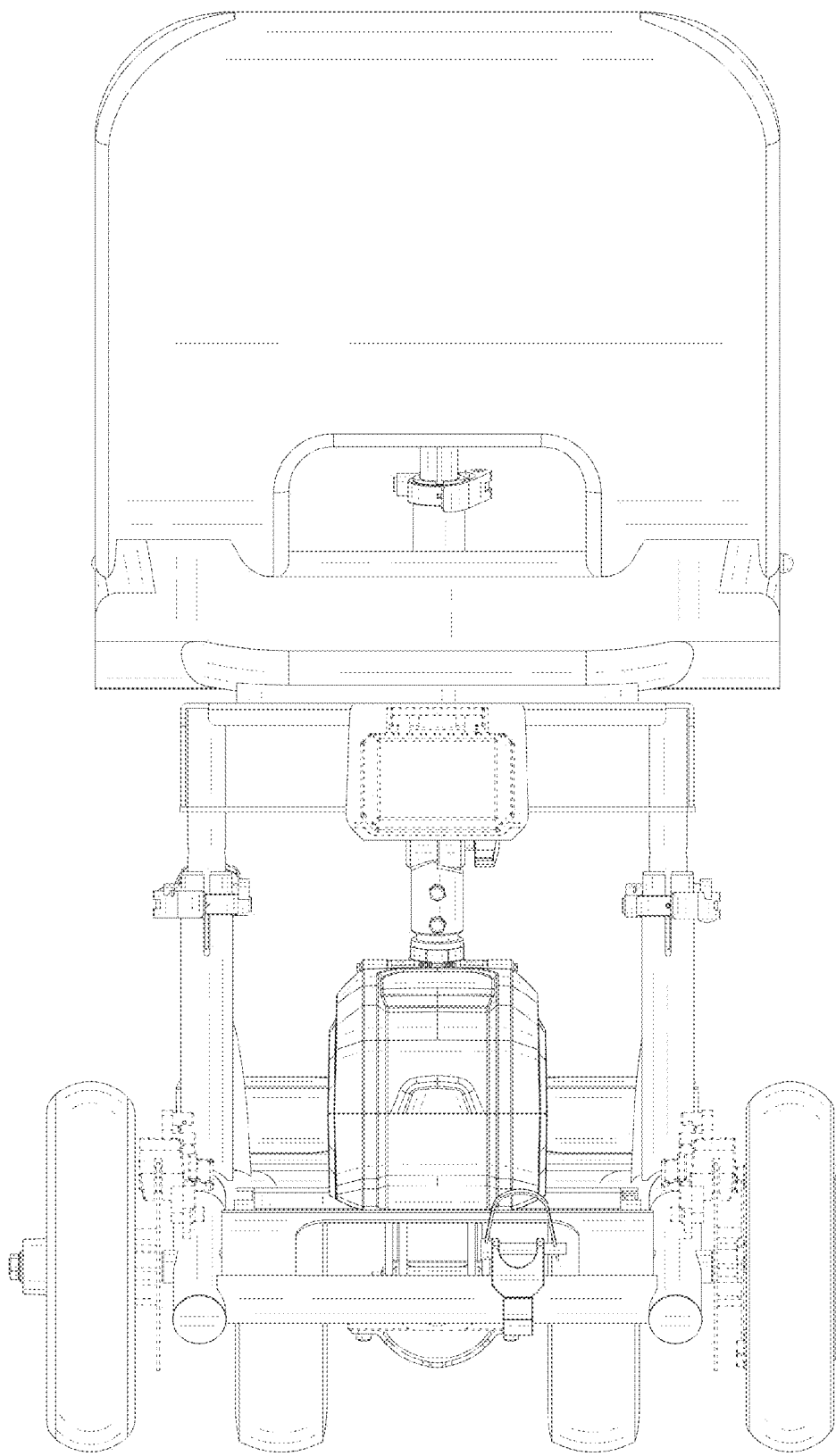

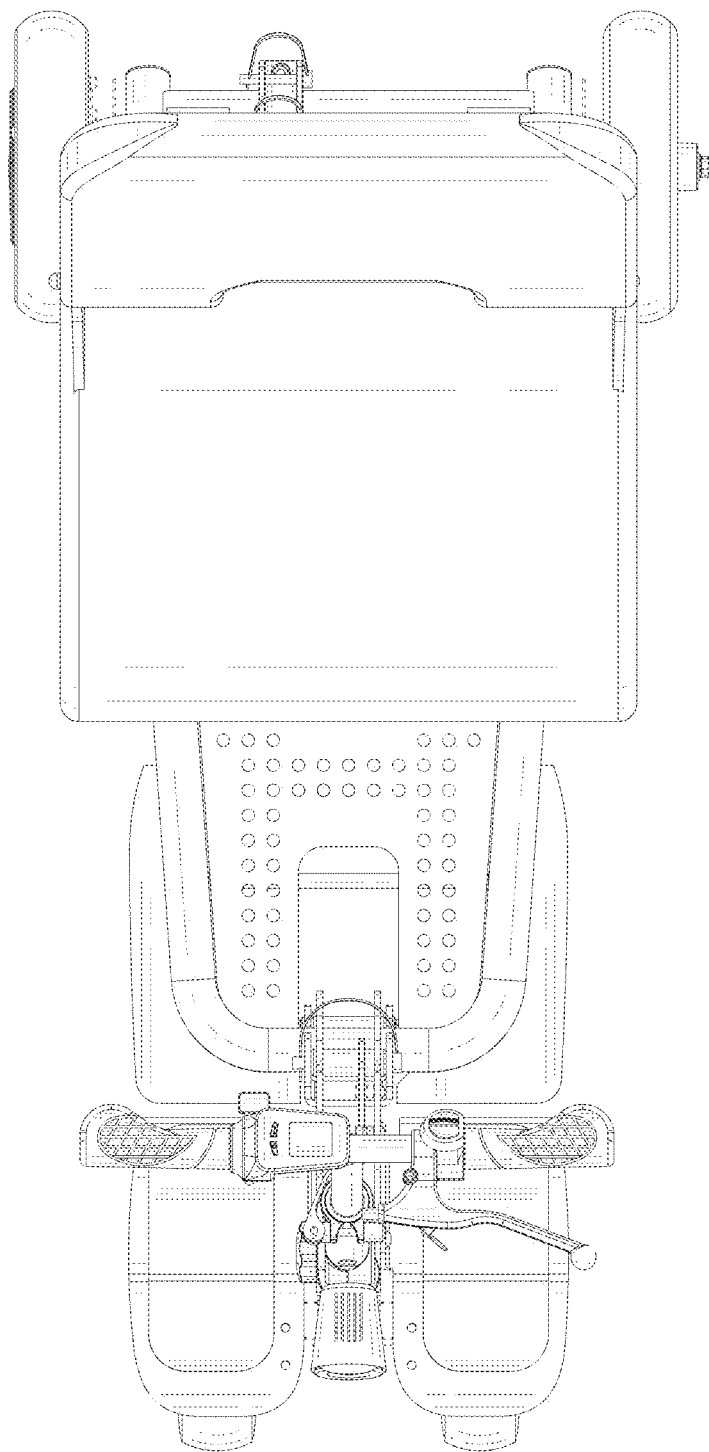

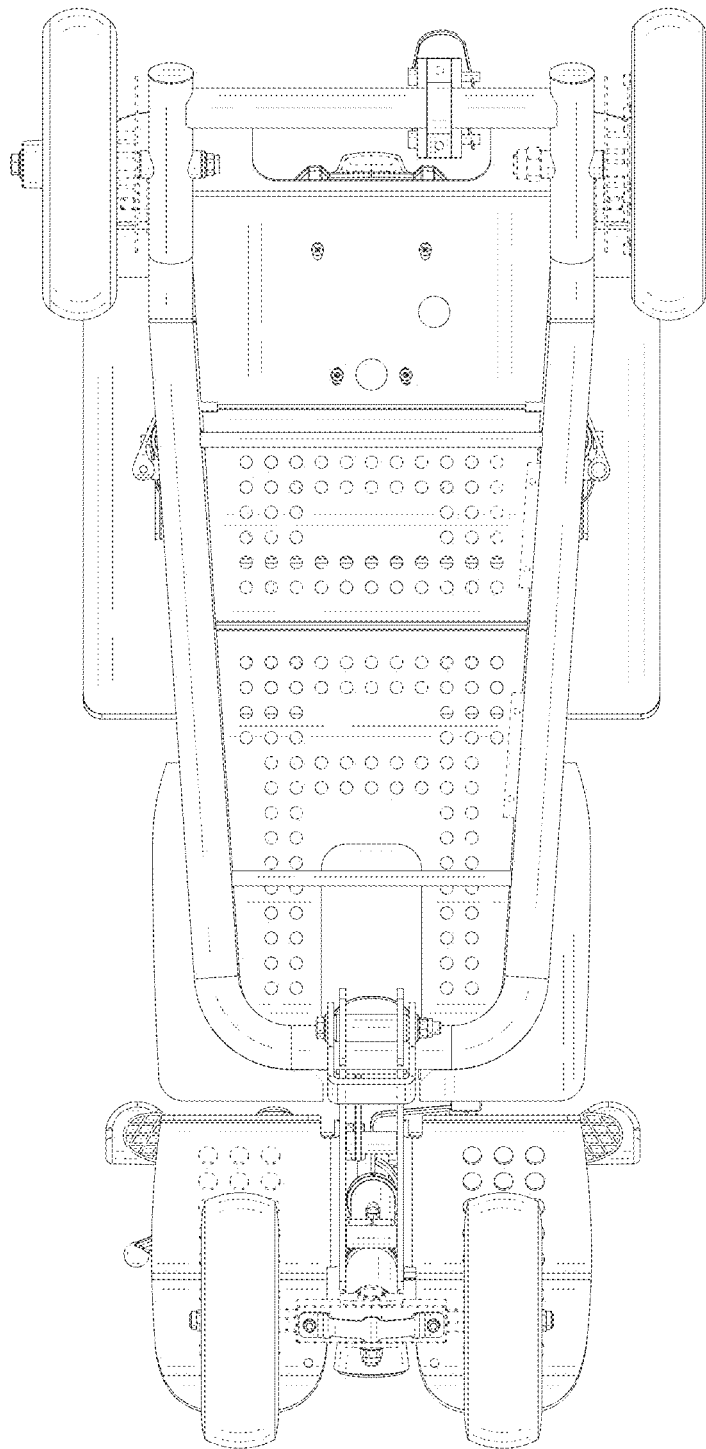

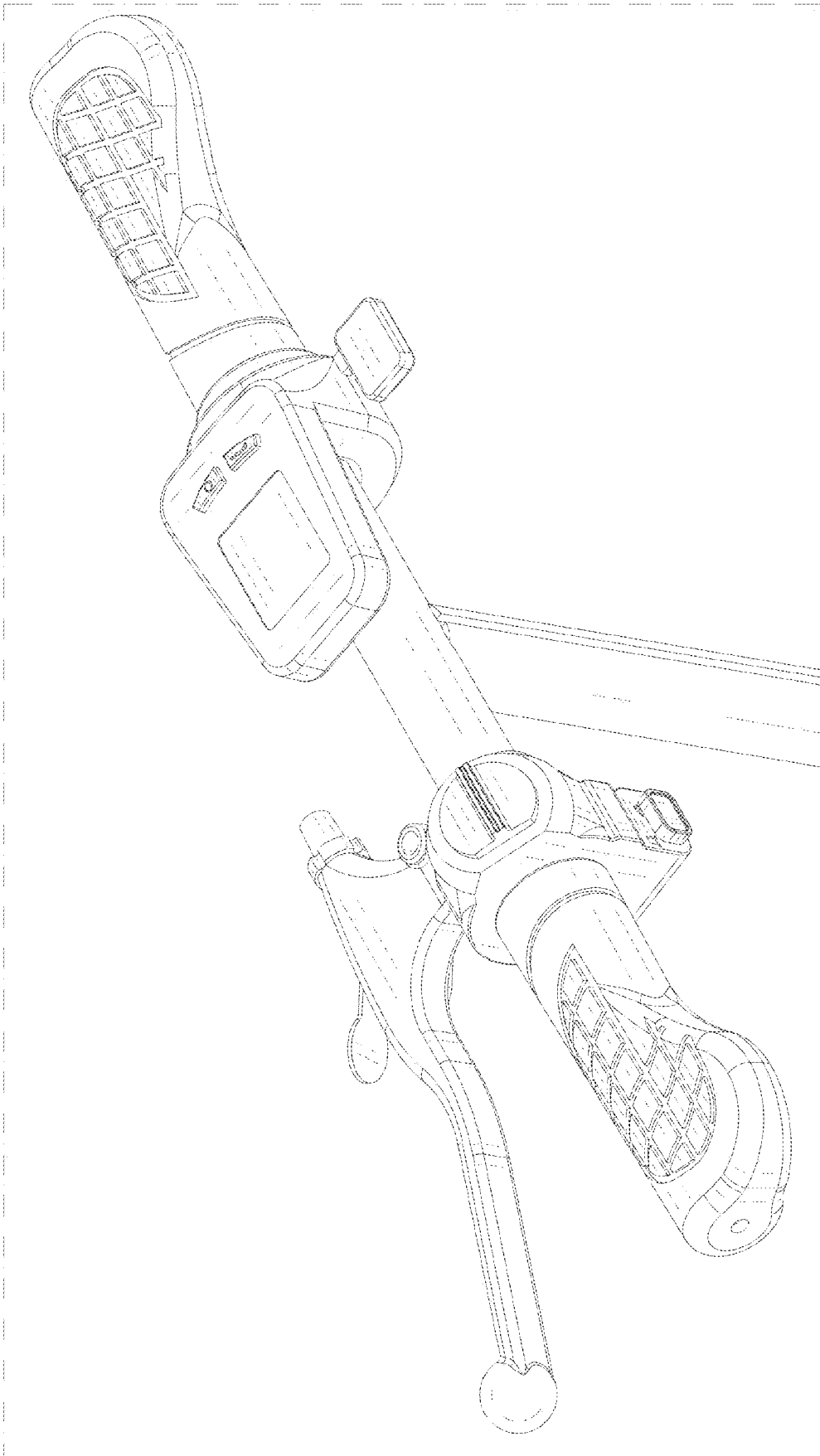

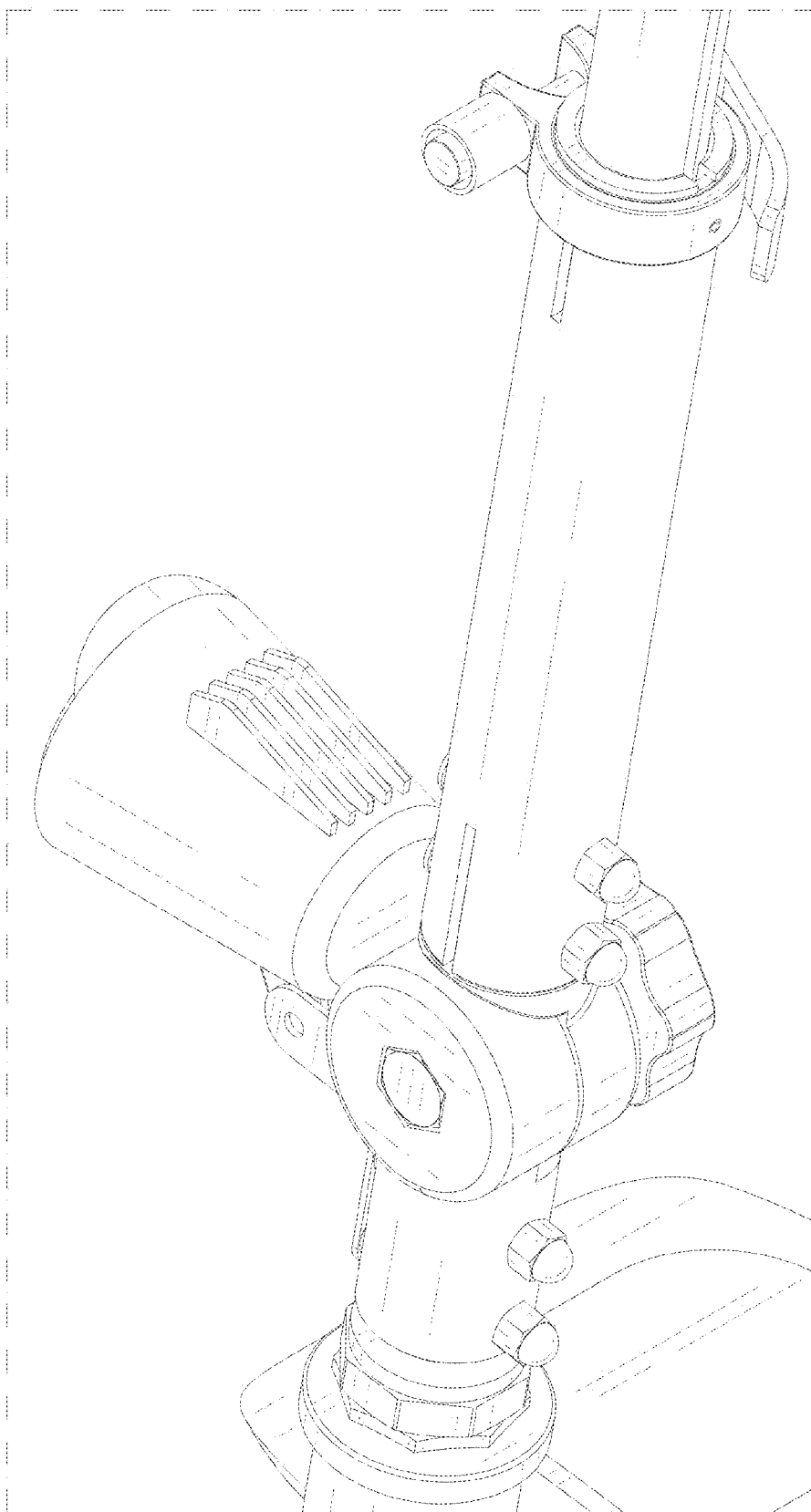

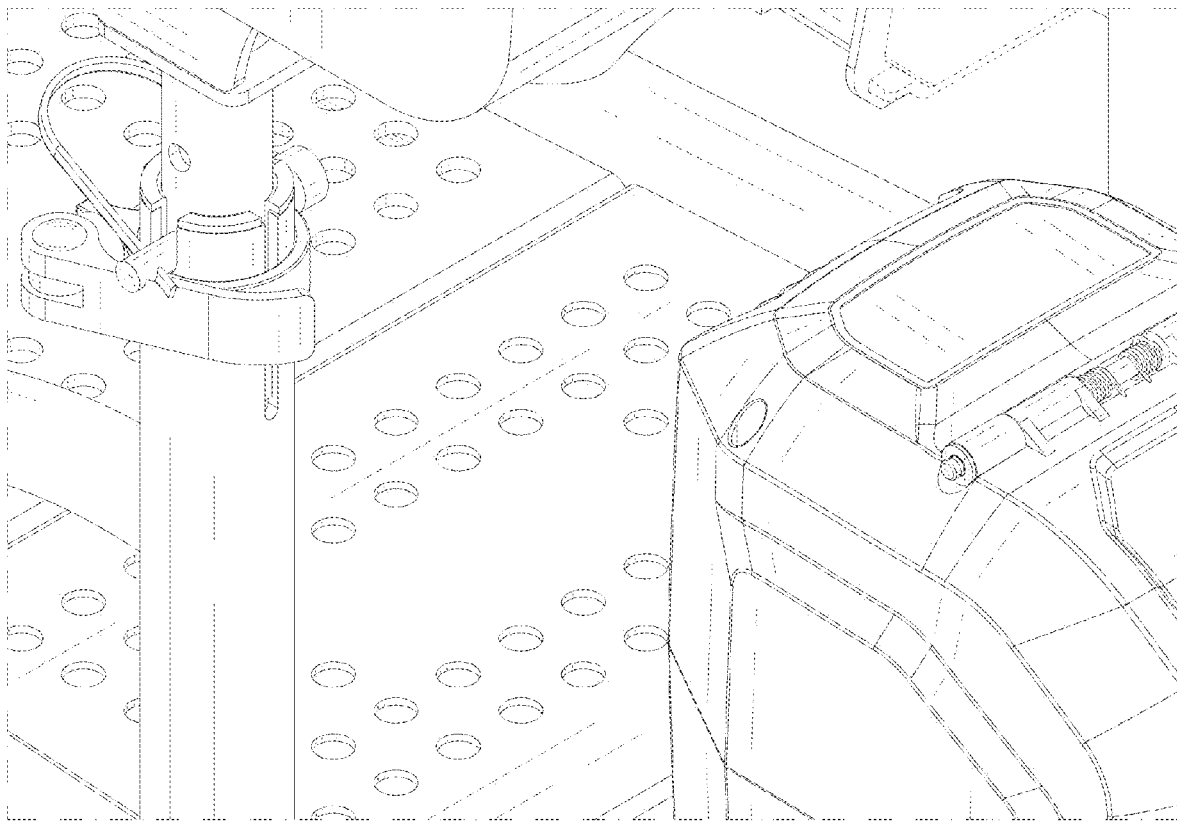

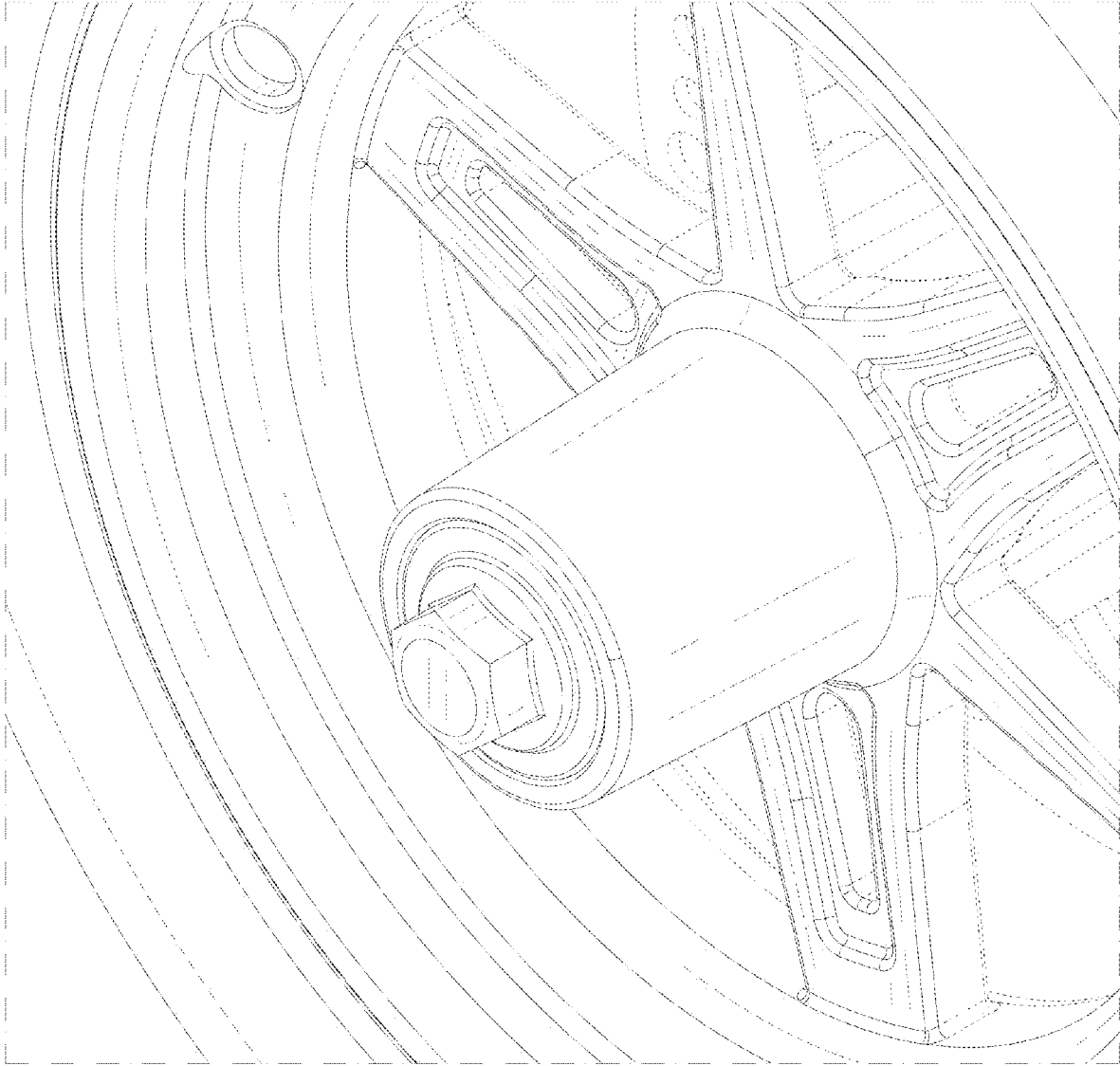

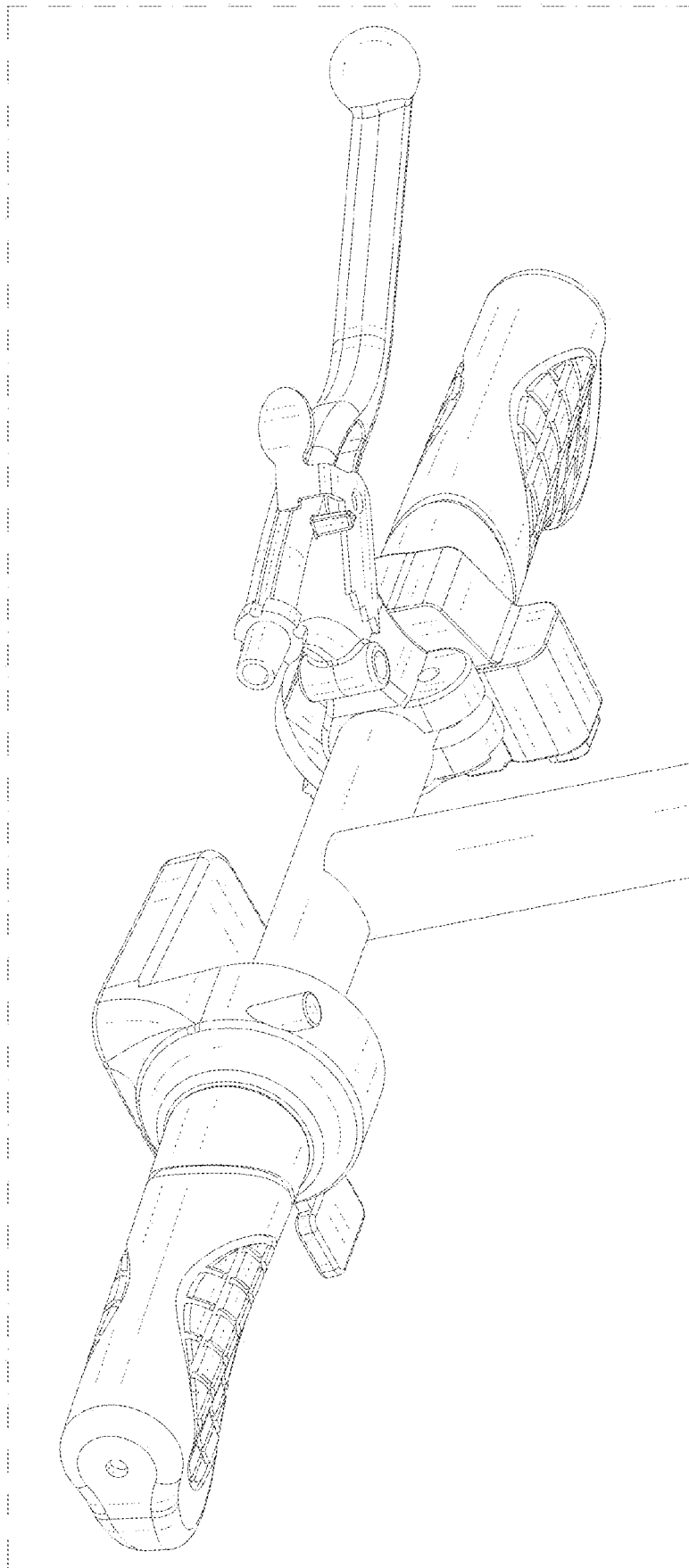

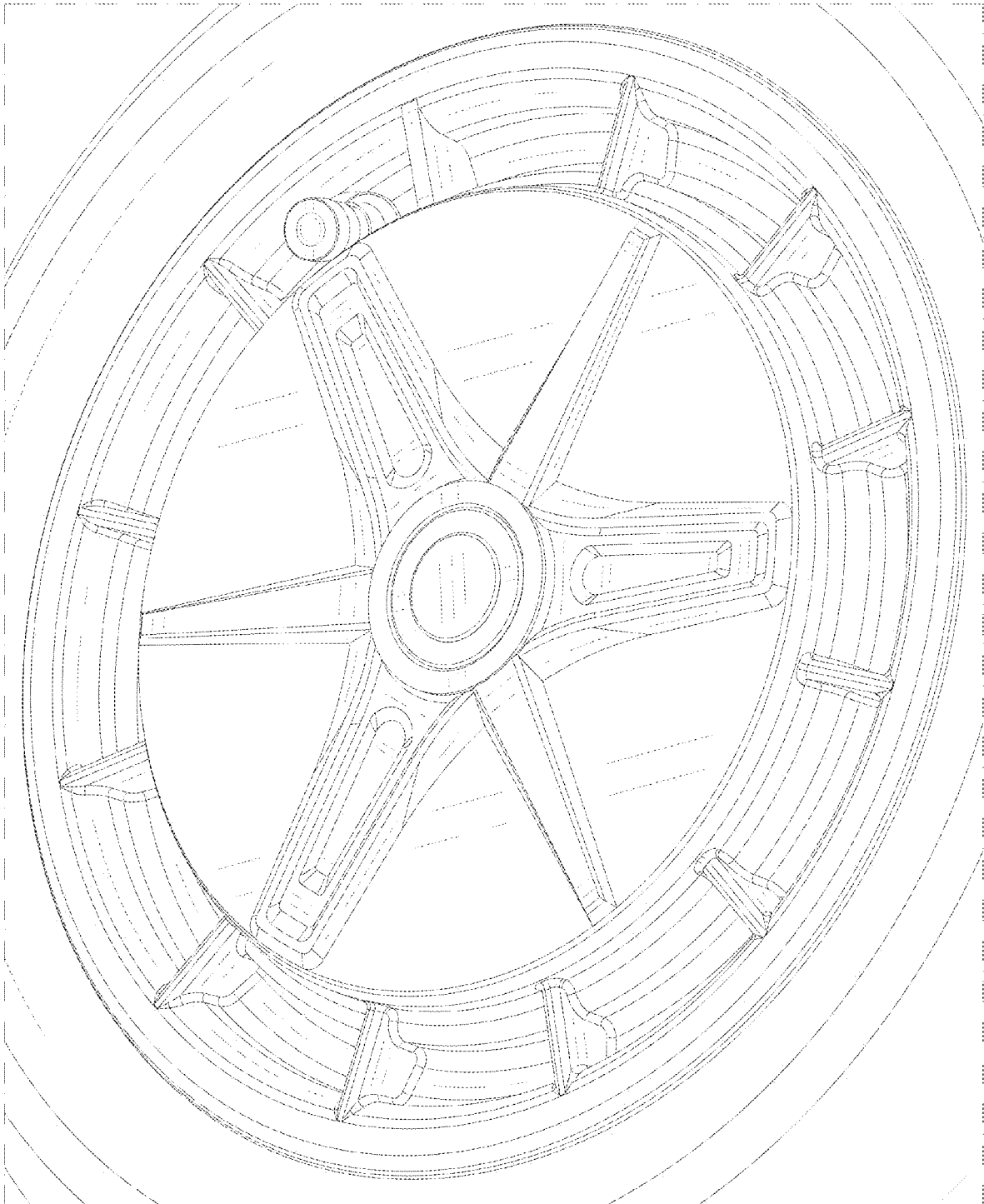
