(57) **CLAIM**

The ornamental design for the set of switches, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the set of switches showing our new design, shown removed from the environment for clarity of disclosure;

FIG. 2 is a front view thereof;

FIG. 3 is a back view thereof;

FIG. 4 is a first side view thereof;

FIG. 5 is a second side view thereof;

FIG. 6 is a top view thereof;


FIG. 7 is a bottom view thereof;




















