

ORDER

UPON HEARING Counsel for the Claimant

AND UPON HEARING the Claimant's application without notice dated 18th April 2008

AND UPON reading the witness statement of T.A Lowles of 18th April 2008.

IT IS ORDERED that:

- (1) This application shall be heard in private and the publication of all information relating to this application (including any documents filed or created in relation thereto) shall be prohibited and no public access granted to the same.
- (2) No person who is not a party to these proceedings may inspect or obtain from the Court records a copy of any of the statements of case or any other documents filed or served in these proceedings, save for the Claim Form, without the leave of the Court.
- (3) Any application for such leave must be made with notice in writing in advance to the Claimant's solicitors.

- (4) The Defendant shall not disclose a copy of any of the statements of case in these proceedings to any third party, save for the purposes of these proceedings.
- (5) The Court considering that this order is necessary in order to protect the interests of potential and likely witnesses and the Claimant the identity of the woman referred to in the witness statement of T.A Lowles of 18th April 2008 as Women 'A' to 'D' must not be disclosed by any party or person other than for the purposes of prosecuting or defending the claim.
- (6) a) Notice be given to the Defendant under CPR 23.9 and 23.10.
- (6) b) This Order is not to be varied or revoked unless the application is made on written notice to the Claimant's solicitors.

ORDER

UPON THE DEFENDANT'S APPLICATION by Notice issued on 20 May 2008

UPON HEARING Counsel for the Defendant and reading the Claimant's Solicitors' letter of 20 May 2008

IT IS ORDERED that:

1 Paragraph (2) of the Order of Master Leslie sealed on 18 April 2008 shall be varied so as to exclude reference to the Particulars of Claim in this case and accordingly paragraph (2) of the said Order is amended to add "*and the Particulars of Claim*" after "*the Claim Form*".

2 Paragraph (4) of the Order of Master Leslie sealed on 18 April 2008 shall be varied so as to exclude reference to the Particulars of Claim in this case and

accordingly paragraph (4) of the said Order is amended to add "*the Claim Form and the Particulars of Claim, save for*" after "*third party, save for*".

- 3 Paragraph (5) of the Order of Master Leslie sealed on 18 April 2008 shall be varied so as to include the identity of the woman referred to as woman "E" in the witness statement of T.A. Lowles of 18 April 2008.
- 4 Paragraph (5) of the Order of Master Leslie sealed on 18 April 2008 shall be further varied to the effect that should either party or person disclose the identity of any or all of women "A" to "E" to a third party or parties in compliance with that Order, then in doing so, such third party or parties must be advised by that party or person of the existence and terms of Master Leslie's Order of 18 April 2008 whereby there must be no identification of women "A" to "E" other than for the purposes of prosecuting or defending the Claim.
- 5 This Order is not to be drawn, sealed, perfected or to come into force until the Claimant's Solicitors have consented to its terms in writing.
