References:

- a. Your Freedom of Information Act (FOIA) request of March 29, 2001, for records concerning various dossiers. Your request was received in this office on April 18, 2001.
- b. Our letter of April 20, 2001, informing you that additional time was needed to review the records and we were unable to comply with the 20-day statutory time limit in processing your request.

We have conducted checks of the automated Defense Clearance and Investigations Index and a search of the Investigative Records Repository to determine the existence of Army intelligence investigative records responsive to your request. The records are enclosed for your use.

We have located the enclosed records pertaining to Cambodia U.S. Forces, ZF004000W. We have completed a mandatory declassification review in accordance with Executive Order 12958. As a result of our review, it has been determined that the information in the Army records no longer warrants security classification protection and is partially releasable to you. Fees for processing this request are waived.

Since the release of the information deleted from the records would result in an unwarranted invasion of the personal privacy rights of the individuals concerned, this information is exempt from the public disclosure provisions of the FOIA per Title 5 U.S. Code 552 (b)(6).

The withholding of information by this office is a partial denial of your request. This denial is made on behalf of Major General Keith B. Alexander, the Commanding General, U.S. Army Intelligence and Security Command, who is the Initial Denial Authority for Army intelligence investigative and security records under the FOIA. You may appeal this decision to the

Secretary of the Army. If you wish to file an appeal, you should forward it to this office. Your appeal must be postmarked no later than 60 calendar days from the date of this letter. After the 60 day period, the case may be considered closed; however, such closure does not preclude you filing litigation in the courts.

We are continuing to process your request for records regarding other titles you have requested and will respond to you by separate correspondence when our action is complete.

On 7 February 1975, [REDACTED], CW2, [REDACTED] Student, 63rd Company, 6th Battalion, Aviation Troop Brigade, US Army Aviation Center, Fort Rucker, Alabama, was interviewed in the Fort Rucker Resident Office, 902d Military Intelligence Group, Building 616, Fort Rucker. [REDACTED] a resident of [REDACTED] volunteered the following information:

During the period, June 1973 until November 1974, [REDACTED] was assigned to the 70th Aviation Detachment, Bangkok, Thailand. From June 1973 until June 1974, "Over The Fence" flights originating at the 70th Aviation Detachment were flown only to Phnom Penh on an infrequent basis. From June 1974 thru November 1974, 70th Aviation Detachment flights were scheduled on a daily basis to Phnom Penh, Ream/Kompong Som, and Battambang, Cambodia. These flights were in support of MEDTC (actual identity unknown to [REDACTED]) DTL, which [REDACTED] believed meant Defense Logistics, and OICC (actual identity unknown to Source). MEDTC was composed of US Army personnel wearing civilian clothes, whose office was located in the US Embassy, Phnom Penh, and had a mission of ensuring that US military aid arriving in Cambodia was actually received by Cambodia Ground Forces. DTL's headquarters in Bangkok, Thailand, was comprised of American civilian and military personnel who provided logistical and maintenance support to the Cambodian Air and Ground Forces. OICC was composed of civilian and military personnel, however, the military always wore civilian attire. Source knew nothing of this organizations mission, or their exact location. The purpose of the flights in support of these organizations was to transport American civilian and military personnel, administrative paperwork, and food supplies to American personnel located primarily in the locations mentioned previously. He believed that all flights were approved by the parent organization to the 70th Aviation Detachment (AD) which [REDACTED] thought was the Military Assistance Command Thailand (MACT), located in Samutprakan, Thailand, which was adjacent to the U-Tapao US Air Force Base, Thailand. 70th AD pilots who flew these "Over The Fence" missions were not provided before mission briefings or after mission debriefings, intelligence briefings regarding hostile positions, AAA sites, or what action to take should the aircraft be downed, precisely what the pilots status was as US Army aviators in military uniforms, flying Army aircraft with routine markings, overflying hostile combat areas, or information regarding the pilots status while on the ground. Pilots were required to change to civilian attire immediately upon deplaning at point of arrival, and to remain in civilian clothes until they reported back to the airfield for takeoff. This caused the pilots to question exactly what their status would be if questioned, apprehended, or captured by hostile ground forces while dressed in civilian attire. [REDACTED] queried

various friendly intelligence sources and agencies located in Bangkok, and discovered that not one of these agencies or individuals had prior knowledge (b)(6) of "Over The Fence" flights conducted by the 70th AD.

\_\_\_\_\_ had two reasons why he reported the information stated above. Firstly, he feared that appropriate Pentagon officials had no knowledge of the "Over The Fence" flights conducted by the 70th AD, and Secondly, that the news media would discover this information and cause undue embarrassment to the US Government. \_\_\_\_\_ had no desire to release any information possessed by him to anyone except Military Intelligence personnel. \_\_\_\_\_ was willing to submit a sworn statement; to have his information released with his identity revealed; and to appear before any proceeding concerning these matters.

\_\_\_\_\_ departs Fort Rucker on 12 February 1975 for PCS assignment to the 21st Replacement Battalion, Fort Hood, Texas, with a tentative assignment to the 2d Brigade, 1st Cavalry Division, Fort Hood, per para 22, Special Order # 123, Headquarters, Support Group, United States MACT, APO SF 96232, as amended, EXHIBIT \_\_\_\_\_. 
