Hello Scott,

Thank you for the service agreement. I left you a voice mail today requesting some information.

We are sending a letter tonight to GDF to introduce you as the buyer of the equipment. However, we would like to include the ProEnergy primary contact person in our letter, so appreciate if you can provide today. If you would also like to include a short paragraph about ProEnergy's background, we can include this in the introduction.

After the introduction tonight, the intent would be for you to call GDF tomorrow to set up your meetings. If you wish to have personal introductions, this can be arranged.

One point of clarification I want to make you aware is that GDF expect to be paid in Euros and the negotiated price is 57 million Euros, where we converted the Euros at \$1.334 to arrive at the price of \$76 million. This should not be an issue as this is the current exchange rate.
